Historical Note:

Thomas F. Baker III was born on February 25, 1918, in Sikeston, Missouri. He attended Sikeston

public schools and Southeast Missouri State College, now university. He married Willie Burks in 1943 and they had three children. Baker was a captain during World War II in the United States Air Force and was president and owner of the Trailback Plantation, Inc. He was elected to the Missouri House of Representatives in 1960 and served for three terms for Stoddard County. He died on August 11, 1984.
