Historical Note:

John Kilmer was born on December 17, 1832, in Illinois. He was first married to Elizabeth J. (Ellsworth) Kilmer and they had five children. Elizabeth was born on January 8, 1838, to Aaron and Elizabeth (Parker) Ellsworth. Elizabeth died on March 17, 1869. In 1870 John Kilmer

married Emily (Riddle) Kilmer and they had one son, James Henry Kilmer. John died on January 8, 1898.
