Introduction

The records contain documents related to the purchase and subsequent resale of the Coates House, a historic hotel in Kansas City, Missouri, by the Historic Kansas City Foundation. The records include correspondence, newspaper and magazine articles, press releases, Coates House Task Force minutes, contracts, fundraising materials, and handwritten notes, covering the period 1886-1982.

Donor Information

This gift was received by the University of Missouri from William L. Bruning, chairperson of the Coates House Task Force, on 11/7/1986 (Accession No. KA0389).

Historical Sketch

The Coates House was completed in 1869 as the Broadway Hotel, under the proprietorship of Major Thomas Eldridge. In 1872, Colonel Kersey Coates purchased the hotel and commissioned Henry Van Brunt to redesign the structure. The Coates House prospered, and Colonel Coates's dream of a new wing was realized in 1886. He died in 1887 before the addition was completed, and in 1890 the original structure was rebuilt. The Hotel continued to prosper until the Great Depression. In 1945, the exterior was modernized in various ways. Neglect, vandalism, and remodeling all contributed to its loss of distinction.

In 1971 the Coates House was nominated for the National Register of Historic Places. In January 1978 the addition to the original hotel caught fire. In 1979 the Historic Kansas City Foundation purchased the building from Bruening Properties, which was applying for deregistration with the intent to put up a new parking lot. After boarding up and cleaning up the damaged building, the Foundation began looking for a buyer to renovate the Coates House in a fashion that would preserve its heritage.
