#### **Historical Note:**

The Galilee Association of General Baptists was organized in 1916, by dividing the Liberty Association. It consisted of General Baptist congregations, mostly in the rural areas of Bollinger, Butler, Cape Girardeau, Scott, Stoddard, and Wayne counties in southeastern Missouri. Each year, the Galilee Association meets in a general session at one of the member churches.

## **Arrangement:**

The collection has been arranged in its original order.

## **Scope and Content Note:**

This collection contains sixty-six volumes on microfilm containing the records of the Galilee and Liberty Baptist Associations. The first volume contains a 1976 reprint of Elder Benoni Stinson's 1858 speech titled "Sermon on the New Birth." The remaining sixty-five volumes contain the annual meeting proceedings and are filmed in chronological order. They include the minutes of the administrative meetings, as well as membership and financial statistics, lists of delegates, ministers, and congregational clerks, and brief lists of deceased members.
