AMENDMENT TO THE CHARTER OF THE UNIVERSITY OF BATH

**Delete** Article 3(b) and **substitute**:

- “(b) To confer Degrees, Diplomas, Certificates or other academic distinctions and awards either itself or jointly or in conjunction with other institutions having the power to grant such qualifications, which may be dual, joint or otherwise, on and to persons who shall have pursued a course of study approved by the University and who shall have passed examinations or other tests approved by the University.”.

AMENDMENTS TO THE CHARTER OF THE LONDON SCHOOL OF HYGIENE AND  
TROPICAL MEDICINE

1. In Article 7:
  - (a) *delete* "25" and *insert* "16";
  - (b) *delete* "Chairmen" and *insert* "Chairs".
2. In Article 8 after the first iteration of the word "shall" *insert* "normally".
3. *Delete* Article 9 and *insert*:

"The Council shall be deemed to be quorate when: at least 7 members are present; and the majority of those members present at any meeting are persons who are neither students nor members of staff of the London School. No business of Council shall be transacted at any inquorate meeting except the adjournment of the meeting. At a reconvened meeting following an adjournment

for lack of quorum then the business for which the original meeting was called may be completed in the absence of a quorum.”.

4. In Article 18:

- (a) *delete* “of at least 10 members”;
- (b) *insert* “members” before “voting”.

AMENDMENTS TO THE CHARTER OF THE ROYAL ACADEMY OF ENGINEERING

1. Wherever it appears in Articles 1, 3, 4, 5, 7 and renumbered Articles 8, 12, 13 and 17 *delete* "The Academy" and *substitute* "the Academy".
2. Wherever it appears in Articles 5, 6, 7 and renumbered Article 8 *delete* "Council" and *substitute* "Board".
3. *Delete* Article 2 and *substitute*:

"2. In this Our Charter and in the Statutes unless the context otherwise requires the following words shall have the following meanings:

"the Board" shall mean the Governing Body of the Academy;

"the Regulations" means the Regulations adopted in accordance with paragraph 15. Regulations shall be of two kinds to be known as "General Regulations" and "Board Regulations".

"the Statutes" means the Statutes set forth in the Schedule hereto or other the Statutes of the Academy for the time being in force;



“the Fellows” means the voting members of the Academy for the time being as defined in the Statutes;

“The Senior Fellow” means His Royal Highness The Prince Philip, Duke of Edinburgh, K.G., K.T., O.M., G.B.E.;

“Special Resolution” means a Resolution passed by not less than two-thirds of the members of the Board present and voting at a meeting of the Board, and passed

- i) at a General Meeting by a majority of not less than two thirds of the Fellows who vote in person or by proxy at the meeting, or
- ii) by written resolution, passed by a majority of not less than two thirds of the Fellows who vote, provided that no fewer than the number of Fellows required for a General Meeting quorum vote.

“Trustee” means a member of the Board;

“Written Resolution” means a resolution in writing passed by a majority of the Fellows who vote. Such a resolution shall be as valid and effectual as if it had been passed at a General Meeting provided no fewer than the number of Fellows required for a General Meeting quorum vote. Any such resolution in writing may consist of two or more documents in like form each signed by one or more of such Fellows and any such signed resolution may be transmitted in the manner prescribed by the Board including electronically; by telephone; by facsimile transmission or email and the same shall (for the avoidance of all doubt) be deemed to be in writing.”.

4. In Article 4, *delete* “members of the Council” and *insert* “Trustees”.
5. In Article 5(a):
  - (a) *delete* “The first Fellows shall be those persons who at the date of this Our Charter are members of the former fellowship. Fellows shall hereafter” and *insert* “Fellows shall”;
  - (b) *delete* “F.R.Eng” and *insert* “FREng”;
  - (c) after “General Meeting” *insert* “or by written resolution”.
6. *Delete* Article 6 and *substitute*:
  - “ 6. (a) There shall be a Board of the Academy consisting of such number of Trustees with such qualifications and to be elected, appointed, nominated or constituted as Trustees in such manner and to hold office for such period and on such terms as to re-election, re-appointment, re-nomination, removal or otherwise as the Statutes and General Regulations shall provide.

(b) The persons who at the date of this amendment of Our Charter are members of the Council shall (unless they cease to hold office) be the members of the Board until the Board is re-constituted in accordance with the Statutes.”.

7. **Renumber** Article 7A as 8.

8. In renumbered Article 8:

(a) **delete** “Financial Services Act 1986” and **insert** “Financial Services and Markets Act 2000”;

(b) **delete** “otherwise than by virtue of s.45(1)(j) of that Act”.

9. **Delete** existing Articles 8 to 10 and **substitute**:

“9. The Academy shall have such officers with such functions, tenure and terms of office as the Regulations shall prescribe and such other officers and employees as the Board may from time to time appoint.

10. Subject to the provisions of the Statutes the Board shall have power to delegate any of its powers either to committees appointed by it, or for the purpose of the investment of the Academy’s property to a suitably qualified and experienced person of repute appointed from time to time by the Board.

11. There shall be such General Meetings and such other Meetings of the Academy as may be convened by the Board in accordance with the Statutes and General Regulations. At such meetings Fellows and others shall have such rights of attending and voting and such other rights and privileges as are prescribed by the Statutes and General Regulations.”.

10. **Renumber** existing Articles 11 to 13 as 12 to 14.

11. In renumbered Article 12 before the words “may subject to” **delete** “Council” and **substitute** “Board”.

12. **Insert** new Article 15:

“15. Subject to terms of this Our Charter, the administration of the Academy and its affairs may be further prescribed or regulated by Regulations. No such further prescription or regulation shall be effective to any extent to which it is inconsistent with the provisions of this Our Charter or the Statutes. Regulations shall be of two kinds to be known as “General Regulations” and “Board Regulations”. General Regulations shall be made by the Fellows by Special Resolution. Board Regulations shall be made by the Board. Regulations of either kind may be added to, amended or revoked in like manner to that in which they were respectively made.”.

13. **Renumber** existing Articles 14 and 15 as 16 and 17.
14. In renumbered Article 16:
  - (a) **delete** “The Academy” after the words “affairs of”, liabilities of” and “dissolution of” and **substitute** “the Academy”;
  - (b) after the words “directions as the” **delete** “Council” and **substitute** “Board”.

AMENDMENTS TO THE CHARTER OF THE ROYAL COLLEGE  
OF PAEDIATRICS AND CHILD HEALTH

1. **Delete** Article 6 and **substitute**:

“6. The President shall be elected from the Fellows by those members of the College specified in bye-law 5(i) of the Bye-laws and shall hold office as President-Elect and then as President for such terms and periods of office as set out in the Bye-laws.”.

2. **Delete** Article 7 and **substitute**:

“7. The affairs of the College shall be controlled by a Council constituted in accordance with the Bye-laws. The Officers and Members of the Council shall be required to satisfy such eligibility criteria for election or appointment as may be prescribed in Bye-laws 3(i) and 5, whereupon the Officers and Members of the Council shall be elected or appointed in such manner and hold office on such terms and for such period as may be prescribed by or in accordance with the Bye-laws. The first Officers and Members of the Council shall be the Officers and Members of the Council of the British Paediatric Association at the date of this Our Charter.”.

3. In Article 8 *delete* the first sentence and *substitute*:

“Members of the College shall comprise the separate classes of Ordinary Members, Fellows, Senior Members, Senior Fellows, Honorary Fellows, Associate Members, Junior Members (as any such class may be redesignatd or cancelled by the Bye-laws) and such other classes of members of the College as the Bye-laws shall prescribe.”.

AMENDMENT TO THE CHARTER OF THE UNIVERSITY OF SURREY

*Delete* Articles 1 to 33 and *substitute:-*

- “1. By this Charter there shall be constituted and founded a University by the name of "The University of Surrey" ("the University").
2. The members of the Council, the Staff, the Graduates, the Students and the Chancellor of the University and all others who shall, pursuant to this Charter and the Statutes of the University, be Members of the University, are constituted and shall remain a single body corporate with perpetual succession and a Common Seal.
3. The objects of the University shall be to advance education, learning and teaching.
4. The University shall be a teaching and research body and shall in furtherance of the objects have the following powers:
  - (a) To award degrees and other academic awards and to withdraw such awards;

- (b) To acquire, own, maintain, manage and dispose of land and other property;
  - (c) To solicit, receive and administer fees, grants, subscriptions, donations, endowments, legacies, gifts and loans of any property whatsoever whether land or personal property;
  - (d) To act as trustee for and in relation to endowments, legacies and gifts;
  - (e) To invest any monies in the hands of the University and available for investment;
  - (f) In so far as permitted by charity law, to give guarantees;
  - (g) In so far as permitted by charity law, to borrow and raise money and give security for loans; and for those purposes the University shall have the authority to enter into any financial instrument which is ancillary or incidental to the exercise of such powers;
  - (h) To take such steps as may from time to time be deemed expedient for the purposes of procuring and receiving contributions to the funds of the University and to raise money in such other manner as the University may determine;
  - (i) To co-operate and collaborate with other institutions and individuals, award joint degrees or other awards, and affiliate or incorporate into the University any other institution and take over its property, rights, liabilities and staff;
  - (j) To enter into engagements and to accept obligations and liabilities in all respects without any restrictions whatsoever and in the same manner as an individual may manage his or her own affairs; and
  - (k) To do anything else necessary or convenient, whether incidental to these powers or not, in order to further the objects of the University as a place of teaching and research.
5. There shall be a Chancellor of the University who shall be entitled to confer Degrees, Joint Degrees and other academic awards of the University.
6. There shall be a Vice-Chancellor of the University who shall be the principal Academic and Administrative Officer of the University and Chair of the Senate and who shall in the absence of the Chancellor confer Degrees and other academic awards.
7. There shall be such other Officers of the University as the Council may from time to time determine who shall perform such functions and duties as may be decided by the Council.

8. There shall be a Council of the University which shall be the governing body of the University and shall have the custody and use of the Common Seal, and shall be responsible for the management and administration of the whole revenue and property of the University and the conduct of all the affairs of the University, both in the United Kingdom and internationally. The Council will be subject to the Statutes of the University.
9. There shall be a Senate of the University, which shall subject to the Statutes and Ordinances of the University and the control and approval of the Council, oversee the Academic Endeavour of the University.
10. There shall be Students' Union of the University in the United Kingdom, and there may be associations of students established at international campuses of the University.
11. The Statutes set out in the Schedule to this our Charter shall remain in force until they have been amended, varied or repealed in the manner prescribed below. The Council may make new or additional Statutes for the University and may amend or repeal existing Statutes. All Statutes which are not inconsistent with the provisions of this Our Charter shall be operative and have effect when allowed by Us in Council or by a Committee of Our Privy Council.
12. The Council of the University may make Ordinances and may amend or repeal any Ordinances so made.
13. The Senate may from time to time make, amend or repeal Regulations related to the Academic Affairs of the University. The Senate may request Council to make Ordinances relating to all other matters within the scope of its oversight of the Academic Endeavour.
14. It shall be the duty of the Council to bring before the Senate any matters which in its opinion should be dealt with by that body.
15. The University shall treat students, staff and other people solely on the basis of their merits, abilities and potential, regardless of gender, race, colour, nationality, ethnic or national origin, age, socio-economic background, disability, religious or political beliefs, trade union membership, family circumstance, sexual orientation or other irrelevant distinction.
16. The University shall not make any dividend, gift, division or bonus in money to or between any of its members except by way of prize, reward or special grant.
17. The property and funds of the University shall be used only for promoting the University's objects. If the University is dissolved, the assets (if any) remaining after providing for all its liabilities must be applied in one or more of the following ways:



- a) by transfer to one or more other bodies established for exclusively charitable purposes within, the same as or similar to the University's objects;
  - b) directly for the University's objects or for charitable purposes which are within or similar to those objects;
  - c) in such other manner consistent with charitable status as the Privy Council approves in writing in advance.
18. The Council may at any time amend, add to or repeal provisions of this Charter and such amendment, variation, addition or repeal shall when allowed by Us Our Heirs or Successors in Council have effect so that this Charter shall continue and operate as though it had been originally granted and made as so altered, amended, added to or repealed. This Article shall apply to this Charter as amended, added to or repealed.
19. In this Charter "Statutes" means the Statutes set out in the Schedule and any Statutes amending, adding to or repealing them which may be made in accordance with this Charter. "Ordinance" means Acts of the Council of the University under the powers conferred by this Charter to which Our further sanction is not required. "Regulations" except when otherwise required by the context means Regulations made pursuant to this Charter, the Statutes, or the Ordinances. "Academic Endeavour" includes "Academic Affairs", ethical conduct in research and teaching, innovations and intellectual property arising from research and teaching and the consequences of the Academic Endeavour upon the commercial activities of the University; "Academic Affairs" means all matters pertaining to the assessment, progression and conferment and rescission of higher education qualifications, quality assurance and academic standards, and matters relating to the fitness to practice, the conduct and the health and wellbeing of students including the grounds on which a student registration may be suspended or terminated.
20. We reserve unto Ourselves, Our Heirs and Successors, the right to appoint by Order in Council a Visitor of the University."

AMENDMENTS TO THE SUPPLEMENTAL CHARTER OF THE ROYAL SOCIETY FOR THE  
PROTECTION OF BIRDS

1. In the second paragraph of the preamble:
  - a) after "1957" *insert* "and amended on the 24th day of April 1996,";
  - b) *delete* "referred to as the Supplemental Charter" and *substitute* "referred to as the Supplemental Charters".
2. In Article 2 after "Objects of the Society" *insert* "(hereinafter referred to as 'the Objects')".
3. *Delete* Articles 3 and 4 and *substitute*:
  - "3. The Objects shall be:
    - 1) To promote the conservation of biological diversity and the natural environment for the public benefit, in particular but not exclusively by:
      - (a) conserving wild birds and other wildlife, and the environment on which they depend;

- (b) protecting, restoring and re-creating habitats.

And, in furtherance of that primary objective, to raise public understanding and awareness of, and to provide information on, such matters.

- 2) To advance education of the public in conservation of the natural environment.

In pursuing these Objects the Society shall:

- (a) undertake activities in Our United Kingdom, in the Channel Islands and the Isle of Man, the UK Overseas Territories and anywhere else in the world; and
- (b) by so doing seek to persuade the public not only that the beauty of birds and nature enriches the lives of many people but also that nature conservation is fundamental to a healthy environment upon which the survival of the human race depends.

The Society shall take no part in the question of the killing of game birds and legitimate sport of that character except when such practices have an impact on the Objects.

- 4. The Society shall have the power to do anything that is legal for a natural person to do within the laws of Our United Kingdom that is in furtherance of its Objects. Without prejudice to the generality of the foregoing and by way of clarification and illustration, the Society shall have the power:
  - (a) To seek support from individuals, corporations, institutions and others by promoting its Objects to anyone who may be prepared to support the Society, and  
  
to receive from them donations, membership fees, legacies, grants and any other form of financial support.
  - (b) To take a grant of letters of administration in a deceased estate through a nominee or nominees appointed by the directors.
  - (c) To draw, make, accept, endorse, discount, execute and issue promissory notes, bills, cheques and other instruments, and to operate bank accounts in the name of the Society.
  - (d) To borrow money, with or without security, for the Objects, and  
  
to lend money, with or without security and with or without the payment of interest for the Objects, and

to guarantee performance of obligations undertaken by others undertaking charitable activities if the performance of those obligations is in furtherance of the Objects.

- (e) To hold or invest any surplus money not immediately required for the purposes of the Society in accordance with the Statutes.
- (f) To enter into contracts with governments, institutions and others for the execution of work by the Society that is in furtherance of the Objects.
- (g) To enter into contracts for the employment of staff, (who shall not be members of the Council), the hiring of consultants or the employment of organisations to carry out work for the Society and to make all reasonable and necessary provision for the payment of pensions and superannuation to staff and their dependants.
- (h) To acquire and hold either beneficially or as trustee (whether sole or joint) any personal property and also any land and buildings by way of freehold or leasehold interest, or by way of licence, management agreement or in any other fashion, and also any tenements or hereditaments or any interest therein, and to alter, improve, mortgage, charge, sell, transfer, grant, assign, demise, let, surrender, exchange or otherwise dispose of or deal with all or any part of such property or interest.
- (i) To promote scientific and other studies by providing grants to individuals and institutions, sponsoring of competitions and exhibitions and in any other manner that might be appropriate, in furtherance of the Objects.
- (j) To promote knowledge of the conservation of biological diversity and the natural environment through education and research. To support the work of schools, universities and other educational establishments by the provision of information, training and in any other fashion. To conduct educational activities on the Society's nature reserves and elsewhere.
- (k) To encourage others to practise the conservation of wild birds, other wildlife and the environment on which they depend.
- (l) To publish books, journals and other written, visual, audio or electronic material to promote the Objects.
- (m) To promote an interest in and a knowledge of conservation of biological diversity and the natural environment among the general public by promoting local groups, organisations for young people, the provision of information and in any other appropriate way.

- (n) To advocate and campaign to influence changes in the law or public policy in pursuit of the Objects.
- (o) To collaborate with other charities, voluntary bodies, statutory authorities, individuals and any other entity in any country or internationally in furtherance of the Objects, to exchange information and advice with them and to participate in joint projects with them.
- (p) To contribute financially to projects in Our United Kingdom and internationally that further the Objects, and  
  
to support, financially and/or in other ways, the development of organisations or to fund the salaries and expenses of individuals where the work of such organisations or individuals further the Objects, and  
  
to be a member of regional, national or international organisations that further the Objects and to pay membership dues.
- (q) To pay the cost of insuring the charity trustees ( referred to in clause 5), directors and employees against personal liability arising from acts properly undertaken in the administration of the Society and any other acts provided that any such insurance shall not extend to any claim arising from any act which the charity trustees knew to be a breach of trust or breach of duty or which was committed by the charity trustees in reckless disregard of whether it was a breach of trust or breach of duty or not.
- (r) To form companies or other legal bodies or other such entities (hereinafter all referred to as ‘entities’), and  
  
to invest in such entities and to advance funds and to administer such entities with or without payment and with or without security.”.

4. In Article 5 *delete* “Council who” and *substitute* “Council, whose members”.
5. In Article 6 *delete* “has Objects similar” and *substitute* “has objects similar”.

That the Chief Pleas of the Island of Sark at a meeting held on 22nd January 2014 considered the *Projet de Loi* when a Resolution was passed agreeing to the application to Sark. That the *Projet de Loi* is as set forth in the attached Schedule. The Petition most humbly prays that Your Majesty might be graciously pleased to sanction the Criminal Justice (Sex Offenders and Miscellaneous Provisions) (Bailiwick of Guernsey) Law, 2013, and to order that it shall have force of law in the Bailiwick of Guernsey.

“The Committee have considered the *Projet de Loi* and have agreed to report that it may be advisable for Your Majesty to approve and ratify it”.

Her Majesty, having taken the report into consideration, was pleased, by and with the advice of Her Privy Council, to approve and ratify the *Projet de Loi* (a copy of which is annexed to this Order) and to order that it, together with this Order, shall have the force of law in the Bailiwick of Guernsey and shall be entered on the Register of the Island of Guernsey and observed accordingly.

Her Majesty’s Officers in the Bailiwick of Guernsey, and all others whom it may concern, are therefore to take notice of Her Majesty’s Order and to proceed accordingly.

The Secretary of State for Justice, after giving ten days' notice of his intention to do so, has, under the Burial Act 1853 as amended, made representation to Her Majesty in Council that, subject to the exceptions below, burials should be discontinued in the churchyard of St Mary Cogges, Witney, Oxfordshire.

The exceptions are that:-

- (a) in any vault or walled grave in the churchyard, burial may be allowed but every coffin in such vault or grave must be separately enclosed by stonework or brick work properly cemented; and
- (b) in any existing earthen grave in the churchyard, the burial may be allowed of the body of any member of the family of the person or persons previously buried in that grave, but no part of the coffin containing the body shall be less than one metre below the level of the surface of the ground adjoining the grave.

Her Majesty in Council is pleased to give Notice of this representation and to order that they be taken into consideration by a Committee of the Privy Council on 27th August 2014.

And Her Majesty is further pleased to direct that this Order should be published in the London Gazette, and that copies of it should be fixed on the door of the Church or Chapel of the above mentioned place, or displayed conspicuously inside them, for one month before 27th August 2014.

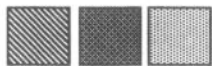
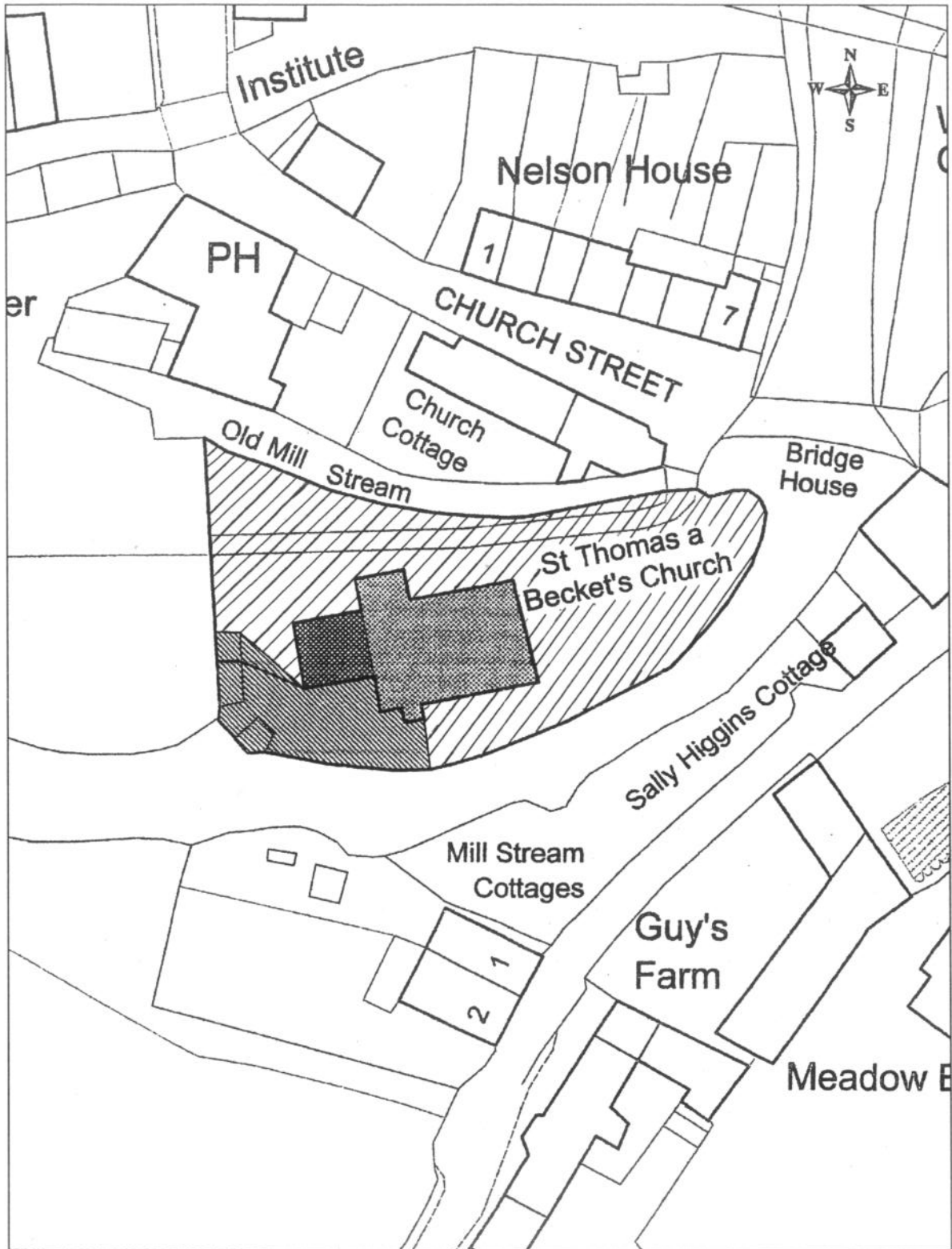
In pursuance of the Order in Council made on 28th April 2014 these representations have been published and taken into consideration by a Committee of the Privy Council.

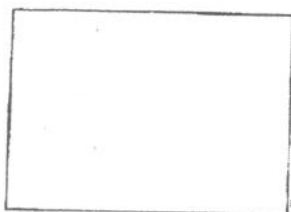
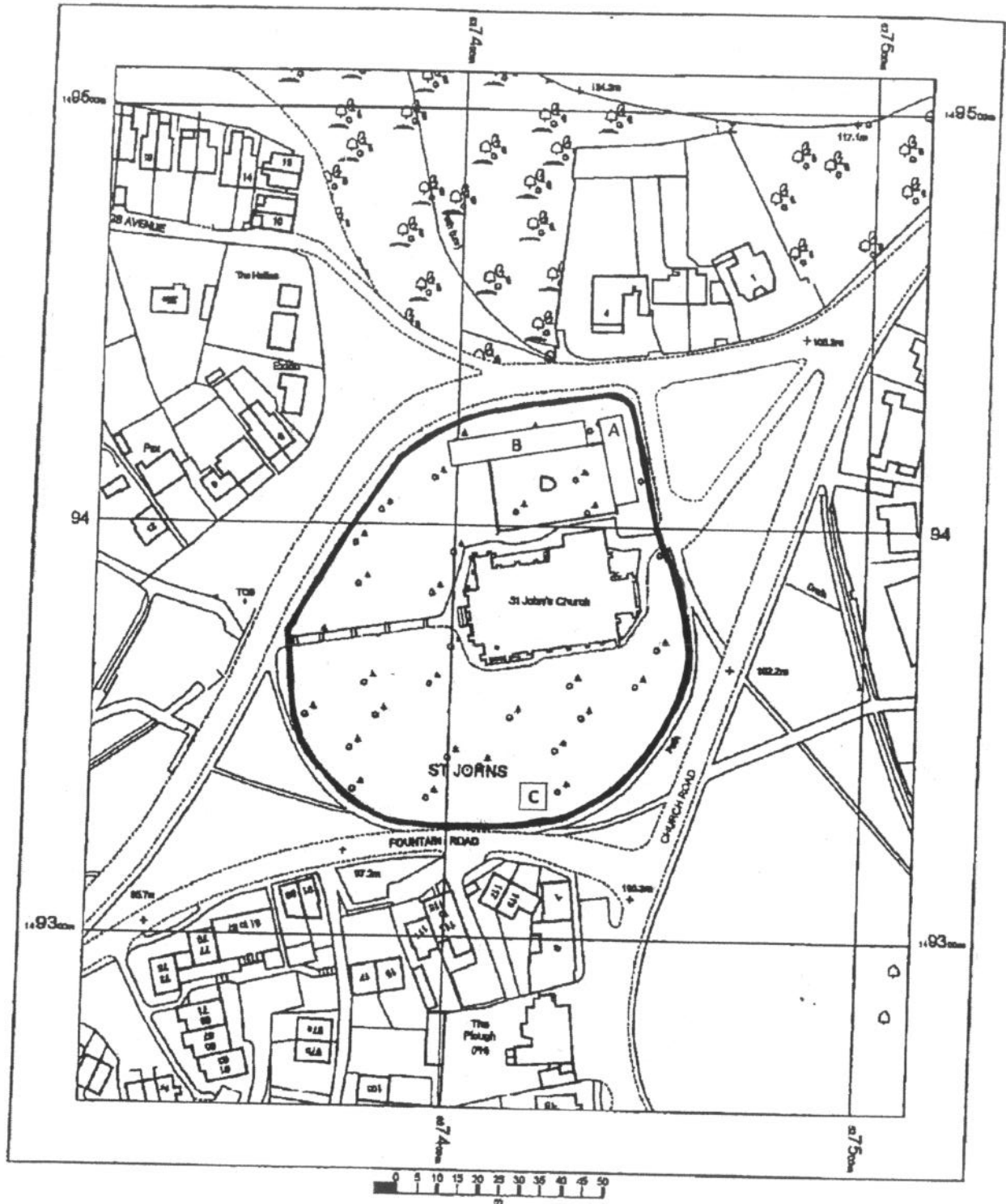
