Analyzing School Shootings in the US with Statistical Learning

Abstract— Public safety is vital to every country, especially school safety. As of September 19, 2024, students and educators have experienced 50 more school shootings in the United States. There have been 24 deaths and 66 injuries at 50 schools, including 13 colleges and 37 K-12 schools. However, there are critical needs to understand the patterns of school shootings. Without this understanding, we cannot take action to prevent school shootings. Here we show that statistical learning provides appropriate approaches to explore the patterns of school shootings. We found that mass shootings usually happen at lunch time with an average of 50 minutes from 11:50 am to 12:40 pm.

I. Introduction

Active shooter incidents in schools cause widespread attention across the nation. Students, faculty, and staff on campuses could be involved with these shootings, as victims, perpetrators, etc.[1]. These gun-related crimes jeopardize school safety. From 1999 to 2024, there have been approximately 43 mass school shootings, with over 500 school shootings altogether. By definition, mass shooting is defined as any event where four or more people are shot with a gun, but not counting the perpetrator. By studying school shooting cases, we concluded that most of the time, the shootings occur inside the classrooms. Existing research that includes statistical analysis usually focuses on public mass shootings or just shooting incidents that have occurred in the past and there are hardly any articles focusing on school mass shootings. This leads to schools being more vulnerable to mass shootings in the future. In this research, we have gathered school shooting data from various resources to analyze the results. By interpreting these data and conducting various statistical analysis, this will ultimately help the law enforcement to better prepare for future school shootings.

The major contributions of the research have been summarized as follows.

- 1) This paper critically examines the timeline of mass shootings in schools. Our focus is particularly on elucidating the four stages in mass school shootings.
- 2) After analyzing school shootings, that are broadly used in research papers. We built two regression models for understanding the statistical trend of school shootings and mass school shootings in the US.
- 3) The paper proposes correlation analysis for identifying the relationship between casualty and the distances of police stations, fire stations, and hospitals. To be best of our knowledge, this is a new approach to understand mass school shootings.

The remainder of the paper is organized as follows. Section II is the analysis of school shootings and mass shootings. Section III discusses correlation analysis. Section IV provides six case studies. VII and VIII are conclusion and future work, respectively.

II. ANALYSIS OF SCHOOL SHOOTINGS AND MASS SHOOTS

A. School Shootings

This map illustrates the number of school shootings that have occurred across the United States from 1999 to 2024. Each tile represents a state, with colors ranging from light orange to dark orange to indicate the frequency of incidents. For instance, California is marked in the darkest shade of orange, reflecting the highest number of school shootings at 40. Just one shade lighter, states like Texas, Florida, and North Carolina fall within the range of 20 to 22 shootings. In contrast, Vermont and Maine are left uncolored (white), signifying that no school shootings have been reported in those states. The lighter orange hues represent states with fewer incidents, ranging from 1 to 8 shootings. This color coding effectively highlights the stark disparities in school shooting occurrences across the nation.

B. Mass Shootings

From 1999 to 2023, the tragic occurrence of 15 mass school shootings has left a profound impact on communities across the United States, with the Columbine High School incident in Littleton, Colorado to the Covenant School in Nashville, Tennessee. The average duration of these events can be broken down into four critical phases: initially, the shooter arrives at the school and prepares to act, which lasts approximately 10 minutes (Phase One), followed by when the first is fired around 4 minutes (Phase Two). This is followed by when the first 911 is called (Phase Three) during which the shooting continues or escalates, and concludes with a prolonged standoff and response time of roughly 25 minutes (Phase Four) before law enforcement apprehends the shooter.

Notably, the timeline indicates that the shooter arrives at 11:43 AM and typically opens fire at 11:53 AM, leading to a 911 call just four minutes later at approximately 11:57 AM, and police intervention at 12:08 PM, culminating in the shooter's capture by 12:33 PM. Overall, these events unfold over an average of 50 minutes, marking a devastatingly brief yet impactful window that emphasizes the need for urgent responses and preventive measures in schools nationwide.




FIGURE 2. FOUR PHASES IN MASS SCHOOL SHOOTING.

According to fifteen different cases of school shootings from Columbine to Nashville, on average there were 12 people dead with 84 rounds shot by the shooter. The most common weapon being the AR-15 style rifle.




FIGURE 3. AMMUNITION IN MASS SHOOTINGS IN THE US FROM 1999 TO 2024

The following chart compares school shootings and mass shootings over the years from 1999 to 2024, detailing the states involved each year. In the line graph, the orange line tracks the number of school shootings over time, while the red line represents

mass shootings. Above the orange line plot, an accompanying graph highlights the top three states with the highest number of school shootings for each specific year. Similarly, below the red line plot, a corresponding graph shows the top three states with the highest casualty counts from mass shootings, when applicable. Each hexagon on the chart represents a state, with numbers indicating the casualties for that year. For instance, in 1999, mass school shootings occurred in three states—Colorado, Georgia, and Oklahoma—with corresponding casualties of 5, 6, and 37, respectively. Notably, 2023 saw the highest number of states involved in mass shootings, totaling six. The school with the most casualties was Virginia Tech University in Virginia, which tragically recorded 58 fatalities. This chart provides a comprehensive overview of the trends and impacts of these violent incidents over the years.




Figure 4. School shootings and mass shootings in the US from 1999 to 2024

III. CORRELATION ANALYSIS

The following charts show the plotting of correlation between school shootings and school mass shootings. The correlation of school shootings and school mass shootings is approximately 0.423, which shows a weak correlation. A weak positive correlation indicates that, although both variables tend to go up in response to one another, the relationship is not very strong. In this case, mass shootings are not strongly related to shootings.




FIGURE 5. CORRELATION OF BETWEEN SCHOOL SHOOTING AND MASS SHOOTINGS IN THE US FROM 1999 TO 2024




Figure 6. Correlation of between mass shootings and public places in the US from 1999 to 2024

In Figs 5 and 6, these charts show the correlation of distances between 5 different locations from a particular school. We took 43 different schools where at least one person had passed away from a school shooting occurring between 1999 to 2024 and measured the distance from the school to the nearest Police station, Hospital, Fire Station, Public Park, and a Business to see if there were any correlation.

In this chart the distance is on one axis and number of injuries on the other, a positive correlation would suggest that as the distance increases, the number of injuries also increases. Conversely, a negative correlation would imply that as the distance increases, the number of injuries decreases. For example if you point to "X" (death) in the 2nd column from the right and "business" and meet at the same point, the correlation is 0.04. This number is closer to 0 so this means that the two variables are not strongly correlated. The distance to the nearest business from the school does not affect the number of injured people during a school shooting.

Based on this chart, to pick the safest area for a school to be built, you should be looking for the lower number of correlations, as this indicates that there will be less injuries. The best place for a school would be an area closest to a Police Station, Public Park, and Fire Station.

IV. CASE STUDY

A. The Covenant School

On March 27, 2023, The Covenant School, a private Christian School in Nashville, Tennessee was shot by a transgender man named Aiden (Audrey Elizabeth) Hale and killed 6 people. Hale arrived at 9:54 a.m. at the parking lot and spent time sending Instagram messages to his friend. He then shot through the glass door at 10:11 a.m. and police received a phone call at 10:13 a.m. At 10:23 a.m. officers entered the building and at 10:27 the officers shot Hale. Hale fired more than 150 rounds with his AR-15, Kel-Tec SUB-2000 carbine, and a handgun. The perpetrator was 28 years old with no criminal record and was a former student. Hale was under care for an emotional disorder and had also legally purchased seven firearms.

B. Robb Elementary School

On May 24, 2022, a school in Uvalde, Texas named Robb Elementary School was shot by a eighteen year old former student, Salvador Ramos. He began by shooting his grandmother with an AR-15 before crashing her truck into a ditch outside the school at 11:28 a.m. and shot the first two people nearby. A teacher calls 911 at 11:29 a.m. and at 11:35 a.m. Uvalde Police officers

enter the school. Ramos shut himself in the classroom while shooting everyone with approximately 164 ammunition. Police Officers waited over an hour to shoot back and shot Ramos around 12:50 p.m. There were 22 deaths including the shooter. Ramos did not have any criminal record nor health issues, but showed strange behaviors such as abusing animals threatening others on social media.

C. Oxford High School

On November 30, 2021 a fifteen year old named Ethan Crumbly shot the Oxford High School in Oxford Township, Michigan. Crumbly was armed with a 9 mm semi-automatic handgun and killed 4 people with around 30 rounds of ammunition. At 12:50 p.m. he was seen entering the bathroom with a book sack and at 12:51 p.m. he was seen with a gun and began shooting. Police received their first 911 call at 12:52 p.m. and arrived at 12:56 p.m. Crumbly was arrested around 1:04. His parents were also charged with involuntary manslaughter for failing to secure the gun and negligence for not noticing warning signs by Crumbly.

D. Santa Fe High School

On May 18, 2018 10 people were shot at Santa Fe High School in Santa Fe, Texas. Dimitrios Pagourtzis, a 17 year old who was a student at the school, arrived around 7:00 a.m and began shooting at 7:32 a.m. Pagourtizs shot eight students and two teachers with a shotgun. Around 7:40 a.m. the first 911 was reported and police arrived five minutes later. He argued with the police officers and threatened to shoot but surrendered after being injured. At 8:09 a.m the shooter was arrested. The shooter shot 18 rounds of ammunition with a 12-gauge shotgun and Rossi .38-caliber revolver.

E. Marjory Stoneman Douglas High School

On February 14, 2018 17 people were shot at Marjory Stoneman Douglas High School in Parkland, Florida. Nineteen year old former student Nikolas Cruz, arrived at the school at 2:19 p.m. in an Uber and was armed with an AR-15 rifle. His first shot was around 2:21 p.m. The first 911 call was around 2:22 p.m. and police arrived around 2:23 p.m. The shooter was caught at 2:50 p.m.

F. Umpqua Community College

On October 1, 2015 9 people were shot to death by a 26 year old student who was attending Umpqua College. Chris Harper-Mercer shot 40 rounds killing a professor and eight students and eventually shot himself. Harper-Mercer was first seen at the location at 10:39 a.m and shot his first round at 10:32 a.m. The first 911 was made at 10:38 a.m. He asked the students for their religion before shooting and if they were Christians he would shoot them. Police had arrived at 10:44 a.m. and began shooting the perpetrator. Harper-Mercer had gotten wounded and later shot himself at 10:48 a.m.
