**THE ASSAM SPEAKER'S AND DEPUTY SPEAKER'S SALARIES,  
ALLOWANCES AND AMENITIES ACT, 2018.**

**AN  
ACT**

to fix the salaries, allowances and amenities for Speaker and Deputy Speaker of Assam Legislative Assembly.

**Preamble**

WHEREAS it is expedient to fix afresh the salaries and allowances of the Speaker and the Deputy Speaker of the Assam Legislative Assembly in the manner hereinafter appearing;

It is hereby enacted in the Sixty-ninth Year of the Republic of India as follows :-

**Short title and commencement**

1. (1) This Act may be called the Assam Speaker's and Deputy Speaker's Salaries, Allowances and Amenities Act, 2018.
- (2) It shall be deemed to have come into force with effect from the 1<sup>st</sup> day of April, 2018.

**Definitions**

2. In this Act, unless there is anything repugnant to the subject or context,-
  - (a) "Speaker" and "Deputy Speaker" means the Speaker and the Deputy Speaker of the Assam Legislative Assembly;
  - (b) "prescribed" means prescribed by rules made under this Act.

**Salaries of the Speaker and the Deputy Speaker**

3. There shall be paid,-
  - (a) to the Speaker a salary of rupees one lakh and twenty thousand per mensem;
  - (b) to the Deputy Speaker a salary of rupees one lakh per mensem.

**Allowances**

4. There shall be paid to the Speaker and the Deputy Speaker the following allowances in connection with their duties :-
  - (i) Parliamentary Assistance Allowance : Rs. 10,000 per month.

(ii) Sumptuary Allowance : Rs. 20,000 per month

(iii) Daily Allowance

While on tour and halt within the State of Assam in connection with performing official duties. : Rs. 1850 per day

While on tour and halt outside the State of Assam in connection with performing official duties. : Rs. 2500 per day

(iv) Sitting Allowance : Rs. 1850 per day :

Provided that the Sitting Allowance shall not be admissible if the Speaker or the Deputy Speaker as the case may be, performs the official tour within the State of Assam or outside the State of Assam and halts during the period of the Session of the Assam Legislative Assembly.

**Travel facilities** 5. Speaker and the Deputy Speaker shall be entitled to,-  
(a) while on tour for official purpose within the State of Assam as well as outside the State, to travelling allowance as may be prescribed;  
(b) for journeys performed in connection with medical treatment, to travelling allowance as may be prescribed.

**Amenities** 6. Speaker and Deputy Speaker shall be entitled to,-  
(a) free furnished residence at Guwahati throughout the year which shall be maintained at public expenses;  
(b) vehicles including vehicles for securities as may be necessary for security of the Speaker and the Deputy Speaker to be maintained at public expenses;

- (c) personal staff as may be prescribed:
- (d) newspapers and magazines as may be prescribed :

Provided that the Speaker shall be entitled to the privileges of using the free furnished residence. Government vehicles and personal staff on his ceasing to hold office for such period as may be prescribed.

Prohibition against practicing any profession during the tenure of office as Speaker or Deputy Speaker

7.

The Speaker and the Deputy Speaker shall not, during the tenure of their office in respect of which they draw salaries and allowances, -

- (a) practice any profession or engage in any trade or undertake for remuneration any employment other than their duties as Speaker and Deputy Speaker;
- (b) be entitled to any salary or allowances as are admissible to a Member of the Assam Legislative Assembly.

Power to make rules

8.

- (1) The Speaker may, by notification in the Official Gazette, constitute a Committee consisting of maximum ten Members of the Assam Legislative Assembly which may make rules in consultation with the State Government, for carrying out the provisions of this Act.
- (2) The Committee constituted under sub-section (1), shall elect its Chairman and shall have power to regulate its own procedure:

Provided that till the rules are made under this section and come into force, the procedure as they existed prior to commencement of this Act, shall be followed for the purpose of determining the allowances, amenities and facilities which were admissible to the Speaker and the Deputy Speaker prior to commencement of this Act for which rules are required to be prescribed under this Act.

- (3) All rules made under this Act shall be laid before the Assam Legislative Assembly, as soon as may be, after they are made.

THE ASSAM MINISTERS' AND LEADER OF THE OPPOSITION'S SALARIES,  
ALLOWANCES AND AMENITIES ACT, 2018.

**AN  
ACT**

to fix the salaries, allowances and amenities of the Ministers of the State of Assam and Leader of the Opposition in the Assam Legislative Assembly.

**Preamble**

Whereas it is expedient to fix afresh the salaries and allowances of the Ministers of the State of Assam and Leader of the Opposition in the Assam Legislative Assembly in the manner hereinafter appearing ;

It is hereby enacted in the Sixty-ninth Year of the Republic of India as follows :-

**Short title and commencement**

1. (1) This Act may be called the Assam Ministers' and Leader of the Opposition's Salaries, Allowances and Amenities Act, 2018.
- (2) It shall be deemed to have come into force on and with effect from the 1st day of April, 2018.

**Definitions**

2. In this Act, unless there is anything repugnant to the subject or context,-
  - (a) "Leader of the Opposition" means the Leader of the Opposition in the Assam Legislative Assembly ;
  - (b) "Minister" or Ministers" includes Chief Minister, Cabinet Ministers, Ministers of State and Deputy Ministers of the State of Assam;
  - (c) "prescribed" means prescribed by rules made under this Act;
  - (d) "Schedule" means the Schedule appended to this Act.

**Salaries of the Ministers and the Leader of the Opposition**

3. There shall be paid,-
  - (a) to the Chief Minister of Assam, a salary of rupees one lakh and thirty thousand per mensem;
  - (b) to each of the Cabinet Ministers and Leader of the Opposition a salary of rupees one lakh ten thousand per mensem ;



(c) to each of the Ministers of State a salary of rupees one lakh per mensem;

(d) to each of the Deputy Ministers a Salary of rupees ninety-five thousand per mensem.

Allowances 4. There shall be paid to the Ministers and the Leader of the Opposition, the allowances in connection with their duties as mentioned in the Schedule :

Provided that the Sitting Allowance shall not be admissible if the Minister or the Leader of the Opposition performs the official tour within the State of Assam or outside the State of Assam and halts during the period of the Session of the Assam Legislative Assembly.

Travel Facilities 5. The Ministers and the Leader of the Opposition shall be entitled to,-

(a) while on tour on public business within the State of Assam as well as outside the State, to travelling allowance as may be prescribed;

(b) for journeys performed in connection with medical treatment, to travelling allowances as may be prescribed.

Amenities 6. The Ministers and the Leader of the Opposition shall be entitled to,-

(a) free furnished residence at Guwahati throughout the year which shall be maintained at public expenses;

(b) vehicles including vehicle for securities as may be necessary for security of the Ministers and the Leader of the Opposition to be maintained at public expenses;

(c) personal staff as may be prescribed;

(d) newspapers and magazines as may be prescribed;

(e) any other allowances or facilities or amenities as may be prescribed.

- Prohibition against practicing any profession during the tenure of office as Minister or the Leader of the opposition
7. The Ministers and the Leader of the Opposition shall not, during the tenure of their office in respect of which they draw salaries and allowances,-
- (a) practice any profession or engage in any trade or undertake for remuneration any employment other than their duties as such Minister or the Leader of the Opposition, as the case may be.
  - (b) be entitled to any salary or allowances as are admissible to a Member of the Assam Legislative Assembly.
- Power to make rules
8. (1) The Speaker may, by notification in the Official Gazette, constitute a Committee consisting of maximum ten Members of the Assam Legislative Assembly, which may make rules in consultation with the State Government, for carrying out the provisions of this Act.
- (2) The Committee constituted under sub-section (1), shall elect its Chairman and shall have power to regulate its own procedure:
- Provided that till the rules are made under this section and come into force, the procedure as they existed prior to commencement of this Act, shall be followed for the purpose of determining the allowances, amenities and facilities which were admissible to Ministers and the Leader of the opposition prior to commencement of this Act for which rules are required to be prescribed under this Act.
- (3) All rules made under this Act, shall be laid before the Assam Legislative Assembly, as soon as may be, after they are made.

**THE ASSAM LEGISLATIVE ASSEMBLY MEMBERS' SALARIES,  
ALLOWANCES, AMENITIES AND PENSIONS ACT, 2018.**

AN

ACT

to fix the salary, allowances, and amenities and pensions of Members of the Assam Legislative Assembly.

**Preamble** WHEREAS it is expedient to fix afresh the salary, allowances, amenities and pensions of the Members of the Assam Legislative Assembly in the manner hereinafter appearing;

It is hereby enacted in the Sixty-ninth Year of the Republic of India as follows :-

**Short title and commencement** 1. (1) This Act may be called the Assam Legislative Assembly Members' Salaries, Allowances, Amenities and Pensions Act, 2018.

(2) It shall be deemed to have come into force on and with effect from the 1<sup>st</sup> day of April, 2018.

**Definitions** 2. In this Act, unless there is anything repugnant in the subject or context,-

(a) "Member" or "Members" means Member of the Assam Legislative Assembly, other than the Speaker, Deputy Speaker of the Assam Legislative Assembly, a Minister of the State of Assam and the Leader of the Opposition in the Assam Legislative Assembly;

(b) "Minister" or "Ministers" includes the Chief Minister, Cabinet Ministers, Ministers of State and Deputy Ministers of the State of Assam;

(c) "prescribed" means prescribed by rules made under this Act.

**Salary** 3. There shall be paid to each Member a salary of Rupees Eighty Thousand per mensem.

**Allowances** 4. There shall be paid to each Member, the following allowances in connection with his duties as a Member :-

(i) Constituency Allowance : Rs.20,000 per month

(ii) \*Camp Office Allowance : Rs. 10,000 per month

(iii) Parliamentary Assistance Allowance : Rs.10,000 per month

(iv) Sitting Allowance  
(During the Session of the Assam Legislative Assembly and Committee Meetings) : Rs. 1850 per day

(v) Daily Allowance  
While on tour within the State of Assam and

halt in connection with  
official duties : Rs.1850 per day

While on tour outside  
the state of Assam and  
halt in connection with  
official duties : Rs. 2500 per day;

Provided that the Sitting Allowance shall not be admissible if any Member of Assam Legislative Assembly performs any official tour within the State of Assam or outside the State of Assam and halts during the period of the Session of the Assam Legislative Assembly.

\* Explanation:- Camp Office Allowance is provided to the Members for maintaining a separate office within the respective Constituency for better services to the people of the Constituency till the Government provides any such accommodation.

- Travel facilities 5. (1) Each Member shall be entitled to,-
- (a) while on tour for official purpose within the State of Assam as well as outside the State, to such travelling allowance as may be prescribed;
  - (b) for journeys performed in connection with medical treatment, to such travelling allowance as may be prescribed;
- (2) Each Member and ex-Member of the Assam Legislative Assembly shall be entitled to reimbursement of cost for the journeys performed anywhere in India for the purposes other than as mentioned in sub-section (1) of this section, subject to such ceiling as may be prescribed.
- Amenities 6. Members shall be entitled to,-
- (a) free furnished residence at Guwahati throughout the year which shall be maintained at public expenses;
  - (b) newspapers and magazines as may be prescribed;
  - (c) medical facilities and reimbursement of medical expenses as may be prescribed;
  - (d) financial advance for purchase of land, residential house, car as may be prescribed;
  - (e) telephone facilities as may be prescribed;
  - (f) Conveyance allowance as may be prescribed;
  - (g) contingency allowance including expenses for engaging a computer trained person for the camp office, as may be prescribed;
  - (h) Any other allowance or facilities or amenities as may be prescribed.
- Pension and family pension 7. (1) Every ex-Member of the Assam Legislative Assembly, who has served for a full term or less than a full term, or more than one term, shall be

paid a pension equivalent to the fifty percent of last salary drawn by him from the date succeeding the date on which he ceased to be a Member.

- (2) Every ex-Member who has served for more than five years, shall be paid an additional pension amounting to rupees one thousand for every one year exceeding the first five years as a Member.
- (3) Every ex-MLA shall be paid a medical allowance at the rate of rupees twenty thousand per month provided that no such medical allowance shall be paid to him for the period during which he holds any office and draws medical allowance as part of his remuneration in that office.
- (4) Widow/Widower of any ex-Member shall be paid family pension at the rate of fifty percent of the pension amount drawn by the ex-Member and shall also be paid medical allowance at the rate of rupees twenty thousand per mensem.

Power to make rules

- 8. (1) The Speaker may, by notification in the Official Gazette, constitute a Committee consisting of maximum ten Members nominated by the Speaker which may make rules in consultation with the State Government, for carrying out the provisions of this Act.
- (2) The Committee constituted under sub-section (1), shall elect its Chairman and shall have power to regulate its own procedure:

Provided that till the rules are made under this section and come into force, the procedure as they existed prior to commencement of this Act, shall be followed for the purpose of determining the other allowances, amenities and facilities which were admissible to a Member prior to commencement of this Act for which rules are required to be prescribed under this Act.

- (3) All rules made under this Act shall be laid before the Assam Legislative Assembly, as soon as may be, after they are made.

Repeal of Assam Act No.XIV of 1958

- 9. Assam Legislative Assembly Members Salaries and Allowances Act, 1958 is hereby repealed. Assam Act No. XIV of 1958

Savings

- 10. The repeal by this Act of the enactment mentioned in section 9 shall not affect the validity, invalidity, effect or consequences of anything already done or suffered under the enactments so repealed.

**Preamble**

Whereas it is expedient further to amend the Assam Legislative Assembly Members' Salaries, Allowances, Amenities and Pensions Act, 2018, hereinafter referred to as the principal Act, in the manner hereinafter appearing;

Assam Act  
No. X of 2018

It is hereby enacted in the Seventieth Year of the Republic of India as follows: -

**Short title and commencement**

1. (1) This Act may be called the Assam Legislative Assembly Members' Salaries, Allowances, Amenities and Pensions (Amendment) Act, 2019.

(2) It shall be deemed to have come into force on and with effect from the 1<sup>st</sup> day of April, 2018.

**Amendment of section 7**

2. In the principal Act, in section 7, for the existing sub-section (1), the following shall be substituted, namely: -

"(1) Every ex-Member of the Assam Legislative Assembly, who has served for a full term or less than a full term, or more than one term, shall be paid a pension of rupees forty thousand per mensem with effect from the date of commencement of this Act."

- (v) "Principal Secretary" means the Principal Secretary of the Assam Legislative Assembly;
- (vi) "Member" means the Member of the Assam Legislative Assembly;
- (vii) "Government" means the Government of Assam.
- (viii) "Attending Physician" means any registered medical Practitioner or any other Medical Officer appointed by the Government in any Government Medical College, Hospital or Dispensary etc. as the case may be under whom the Member, Ex-Member or their family seeks or avails medical treatment;
- (ix) "Family" means and includes the family of a member consisting of
  - (a) Wife or husband;
  - (b) Father and mother ordinarily residing with and wholly dependent on the member;
  - (c) Legitimate children and step children residing with and wholly dependent on the member;

Note :- (1) Father and mother of a married lady member shall not be included in her family.  
(2) Adopted children shall be considered to be legitimate children.

- (x) "Patient" means a member or a member of his or her family, or an ex-member or his or her family who requires medical attendance and treatment;
- (xi) "Medical Attendance" means attendance in a Government hospital or at the residence of the patient; and
  - (a) such Pathological, Bacteriological, Radiological or other method of examination for the purposes of diagnosis as are available in any Government hospital or Laboratory and are Considered necessary by the attending Physician; and

(ii) Provided that every Ex-Member shall be allowed to travel at any time in India alongwith his/her spouse and or any other person accompanying him/her to look after and to assist him/her by Air or Railways outside the State of Assam for which the Ex-Member shall be entitled to receive not more than Rs. 60,000/- per annum on production of Air/Railway tickets and boarding passes.

(iii) Every sitting Members and every Ex-Members of the Assam Legislative Assembly shall be entitled to free travel within the State by him/her and his/her spouse and or any other person accompanying him/her to look after and assist him/her at any time by ASTC operated under ASTC buses on productions of valid Identity Card issued by the Assam Legislative Assembly Secretariat.
