

ADVANCING CLEAR POLICY SOLUTIONS

Library lending is enshrined in the Copyright Act, and libraries provide broad access to information by lending materials without restriction. But the advent of digitization has uncovered weak points in current policy that must be addressed.

We support digital lending that uses technology to mirror the library's right to loan legally acquired books under controlled conditions while respecting copyright.



FIGHTING CORPORATE CONSOLIDATION

Consolidation among corporate publishers is affecting the quality, value, and price of the digital collections available to libraries.

To ensure a fair digital future, librarians need access to a competitive marketplace of high-quality publishing partners and distribution platforms so they can meet the growing needs of their communities.



PROMOTING A TECHNOLOGY-FORWARD FUTURE

Technological innovations hold both promise and peril for libraries and public life.

Librarians can and should engage with the technologies that have the potential to shape the future – including artificial intelligence, machine learning, publishing platforms, Web 3.0, surveillance technologies, and those that will emerge in the coming years.

In 2023, Library Futures solidified its role as the vanguard in the advocacy and legal battles for digital rights and equitable library access.

These efforts include amici curiae briefs (friends of the court documents) in two landmark cases: <u>Netchoice v. Paxton</u>, before the Supreme Court, and <u>Hachette v. Internet Archive</u>, <u>before the Second Circuit Court of Appeals</u>.

Other projects included the *Hachette v. Internet Archive* <u>liveblog and discussion event</u>
with esteemed experts and multiple policy
papers, including "<u>Digital Ownership for</u>
<u>Libraries</u>."

Throughout 2023, Library Futures held 17 diverse and impactful events, spanning from keynotes and educational learning circles to innovative campaigns and discussions on issues that threaten libraries in the digital age.

We sparked new conversations with events like the <u>Athena Unbound</u> book discussion, published by MIT Press, and the "<u>March for Libraries"</u> campaign. Additionally, we promoted collaboration and technological innovation through forums such as the <u>Library Leaders Forum</u> and <u>Creative</u> <u>Commons Open Culture VOICES</u>.

In 2023, our research initiatives influenced pivotal policy discussions and informed strategic decisions at the intersection of civil liberties and information access.

From legislative measures like our <u>STOP</u>
<u>CSAM</u> letter to discussion on the preservation of video games attended by hundreds of supporters, our work made a difference. Our student fellows contributed to crucial policy discussions with pieces like "<u>Mapping the</u>
<u>Bronx: Where Digital Redlining Denies Access and How Libraries Can Help</u>."
