# Purpose of Report

The purpose of this report is to seek your approval o initiate consultation on the proposal from the Kaitaia Abundant Life Centre rust, the proprietor of Kaitaia Abundant Life School (238), to cancel the integration agreement for the school by mutual agreement with you, under clauses 11 and 14 of Schedule 6 to he Education and Training Act 2020.

Once consultation is complete, e will provide a second Education Report informing you of the outcome of this oces and seeking your final decision on the proposal.

#### Summary

- Kaita a bundant Life is a decile 2, state integrated, Christian, co-educational, Year 1-13 composite school located in Kaitaia, Tai Tokerau. The proprietor is the Kaitaia Abundant Life Centre Trust (the Trust), and the chairperson of the Trust is Mrs Ivy Tan.
- 2. Kaitaia Abundant Life School was established in 1988 and was integrated into the state system on 29 March 1996.
- 3. In 2021, the school was impacted by the mandate requiring all teachers to be vaccinated against COVID-19, as several of the staff refused to be vaccinated. As these teachers could not attend the school and teach their classes, it resulted in the roll dropping from 251 students (as of July 2021) to 174 students (as of July 2022).

- 4. In December 2022, the Kaitaia Abundant Life Trust informed the Ministry that they intended to cancel the integration agreement, listing several concerns relating to legislation and government and Ministry policy, and curriculum initiatives.
- 5. In the Trust's opinion, the new initiatives for schools meant it was no longer possible for them to offer an education determined by the beliefs, values, and lifestyle of the Trust. They state that they were likely to jeopardise their special character on account of government and Ministry legislation, policy and curriculum initiatives including but not limited to:
  - Gender neutral requirements
  - Conversion Practices Prohibition Legislation Act 2022
  - Curriculum requirements around relationship and sexuality gui elin s
- 6. Following further communication between the Ministry and the T ust t was agreed the cancellation of the integration agreement and closure of the cho I would be by mutual agreement under clauses 11(1)(c) and 14 of Schedule 6 to the Education and Training Act 2020 (the Act).
- 7. You have sole discretion to agree with the proprieto that a integration agreement can be cancelled. Your decision must follow a period of nsultation with other persons and groups as you think fit. The Ministry will carry out that consultation on your behalf.
- 8. If you agree to initiate consultation on the proposed cancellation, our next report to you will include the feedback from this process and seek your final decision on the proposal.
- 9. Given the views of the propretor, we support progressing to consultation on the proposed cancellation of the integration agreement.

#### Recommended Actions

The Ministry of Education recommends you:

- a. note that the proprietor of Kaitaia Abundant Life School (238), the Kaitaia Abundant Life Centre Trust, has proposed cancellation of the integration agreement of the school by mutual agreement under clauses 11(1)(c) and 14 of Schedule 6 to the Education and Training Act 2020 (the Act);
- b. **note** that this is in preparation to close the school as the proprietor believes it is o longer possible for them to offer an education determined by their beliefs, values and lifestyle, and comply with government legislation and Ministry policy and cu riculum initiatives; and
- agree that consultation on the proposed cancellation of the integration agreement and C. possible closure of Kaitaia Abundant Life School under clauses 11(1)() and 14 of Schedule 6 of the Act with relevant parties and groups, who might be affected by this change.

### Background

- 1. Kaitaia Abundant Life School is a decile 2, state integrated, Christian, Year 1-13 composite school located in Kaitaia, Northland.
- 2. The proprietor for Kaitaia Abundant Life School is the Kaitaia Abundant Life Centre Trust.
- 3. The school was established in 1988 and was integrated into the state system in 1996. The integration agreement notes that the special character is determined by the Christian beliefs, values and lifestyle of the Christian church as determined from time to time by the Trustees of the Kaitaia Abundant Life Centre Trust.
- 4. The July 2022 roll was 174 students and was comprised of the following thnicities: 74.7% Māori, 14.4% European, 5.7% Pasifika, 2.3% Asian and 2.9% stude ts from other cultures.
- 5. The proprietor's representative is the Chairperson of the K itaia Abund nt Life Centre Trust, (Mrs) Ivy Tan. Mrs Tan communicated with the Min stry n D cember 2022, indicating the Trust's intention to progress the proposed cancel tion of the integration agreement. The Trust listed several concerns relating to government legislation and Ministry policy, and curriculum initiatives.
- 6. In the Trust's opinion, these initiatives mea t it wa no longer possible for them to offer an education determined by the beliefs, valu, and lifestyle of the Trust. They state that they were likely to jeopardise their special character on account of government and Ministry legislation, policy and curriculum initiatives including but not limited to:
  - Gender neutral requirements
  - Conversion Practices Prohibition Legislation Act 2022
  - Curriculum requirements around relationship and sexuality guidelines.
- 7. The Trust has indicated that they came to this decision following consultation with its community and that a recent survey of the school community showed the overwhelming majority of parents agree "that the new demands placed on (them) by the government go gainst (their) beliefs and (they) must stand for what (they) believe in".
- 8. It is proposed that if you approve the cancellation of the integration agreement and the schoo is cl ed, it could occur at the end of Term 2, 2023 (16<sup>th</sup> July 2023).
- 9. On 6 December 2022, the Trust informed its community of their decision to progress to e possible cancellation of the school's integration agreement. Media interest was generated after the release of a letter from the proprietor to the whanau, outlining the ecision to progress possible cancellation of the integration agreement. This message was also shared in a media release from Mrs Tan on behalf of the Trust on the same date.

### Legislative requirements

- 10. Schedule 6, clause 11(1)(c) to the Education and Training Act (the Act) allows you and the proprietor to cancel an integration agreement by mutual agreement following consultation, under Schedule 6, clause 14 of the Act with other interested persons or groups as each party thinks fit. This will include the Association of Proprietors of Integrated Schools (APIS), the New Zealand Educational Institute (NZEI) and Post Primary Teachers' Association (PPTA) and iwi.
- 11. It is the Ministry's understanding that upon cancellation of the integration agreeme t, it is the proprietor's preference that the school will close rather than revert to being private school (with provisional registration).
- 12. As closure of the school is proposed, we recommend consultation with the Boa d of Kaitaia Abundant Life School and the boards of all state schools whose rols might be affected by the closure. This consultation will be undertaken by the Minis ry and a list of schools to be consulted is attached as Annex 2.

#### Request for cancellation of the integration agreement

- 13. In December 2022, the Chairperson of the Trust ga e not e of their intention to cancel the school's integration agreement. The ommu i ation from the Trust outlined its concerns regarding government legislation and Ministry policy, and curriculum initiatives. It is their opinion these initiatives have or are likely to jeopardise their special character.
- 14. Discussions between the Ministry nd he Trust have led to an agreement that consideration of the possible cancellation of the integration agreement will be by mutual agreement under claus s 1 (1)(c) and 14 of Schedule 6 to the Act.
- 15. The Trust has advised that the Kaitaia Abundant Life School Board have met and resolved that it "fully supports the proprietor in engaging with the Ministry of Education concerning breaches o the integration agreement with regard to our special character".
- 16. New Zeal d School Trustees Association (NZSTA) are aware of the decision by the propriet r and will continue to provide support to the school Board as required.

# Access to other Schools

17. The Kaitaia Abundant Life School roll was 174 in July 2022, which was a drop from the 251 of the previous year in July 2021. The requirements of the COVID-19 mandates meant some staff who opted not to be vaccinated could no longer work within the school. This impacted on the ability of the school to offer the full curriculum for students, particularly in the senior subject areas. As a result, more than 75 students (mainly senior students) enrolled at other schools.

- 18. Because of its special character, the school attracts students from a large geographical area. Should Kaitaia Abundant Life School close, primary and intermediate school age students will have several schools where they will be able to enrol. An initial analysis indicates the closure would have no or low chance of triggering property implications at the primary and secondary school level, and as Kaitaia Intermediate School is at capacity, there is low to medium chance it may need roll growth provision.
- 19. Kaitaia College is the only secondary school in the catchment and currently has available capacity to support Year 9-13 students who may wish to transition from Kaitaia Abundant Life School. The Ministry will need to monitor its roll as there is a low-medium chance it could trigger property implications.
- 20. Many schools in the Kaitaia catchment are at full capacity. If students enrol t thes schools, there is a high chance of them needing roll growth classrooms
- 21. The only other state integrated school with a religious focus in the Ka taia area is Pompallier Catholic School, a Year 1–8 full primary school with a rol of 160 students (July 2022), and a maximum roll of 174.
- 22. The proprietor of Pompallier Catholic School applied to increase s non-preference roll from 5% to 15% to help provide for the students from Kaitai Abundant Life School who may wish to enrol. This increase will then dec ease over eight years to 10%. This application has been approved by Hautū, I abel E ans.

#### **Property Implications**

- 23. The land and buildings are owned by the proprietor. Once the school has closed the proprietor will manage the site and facilities.
- 24. As we have noted, when the new en olment patterns are clear, additional roll growth classrooms may be required at K itaia Intermediate School. We will monitor their roll and work with their school Board to support this, should it eventuate.

#### **Financial Implications**

- 25. Kaitaia Abundant Life School is not considered to be a financial risk. It was stated in the December 2022 DRAFT Annual Accounts report, that there were available funds (Wo king Capital less Non-current Liabilities) of \$125,600. In December 2021 there were a ailable funds of \$67,954. The final 2022 position may change once all year end account ng entries and audit have been completed.
- 2 . A suming cancellation of the integration agreement occurs at the end of Term 2 2023, it is anticipated that approximately \$315,000 of Operational Grant funding for 2023 (annually \$630,000) will be released. Of this, \$66,000 is noted as not relating to the roll and will be a saving. The remaining roll related funding of \$249,000 is expected to be reabsorbed as the current student population enrols at other schools.
- 27. Provisional 2023 full time teacher equivalent (FTTE) entitlement total is 18.05 FTTEs based on a roll of 170 students (13.41 FTTE of this is for curriculum). The school also has an entitlement of 4.28 FTTE of additional staffing, 4 FTTE of this was provided through Special Reasons staffing COVID-19 provisional roll related.

28. The curriculum teaching FTTE is expected to be absorbed by schools in the area as the students enrol at them. The Principal, Deputy Principal and Special Reasons Staffing will be able to be released and is estimated to reduce staffing costs by approximately \$300,000 in 2023.

#### Risks

- 29. An initial analysis indicates the closure would have no or low chance of triggering property implications at primary and secondary school level, and low to medium chance at intermediate school level.
- 30. When the new enrolment patterns are clear, additional roll growth classrooms ay b required at Kaitaia Intermediate School. We will monitor their roll and work with their Board to support this, should it eventuate.

### Ministry comment

- 31. We consider it is unlikely that any further discussion with the pr prietor will result in a change to the Kaitaia Abundant Life Centre Tru t's decision to progress the cancellation of the school's integration agreement Th prop etor has also said that they are not in favour of changing the proprietor to anothe Christian organisation.
- 32. Given this view, we support the cancellation the integration agreement. Our focus must now be on ensuring process and procedu es are followed and what is best for the students and their education, is prioritised as quickly and efficiently as possible.

#### **Next Steps**

- 33. Following the consultation w will prepare a further report outlining our findings for your consideration. You will hen be able to make your final decision on the proprietor's proposal.
- 34. If you agree with the request to consult on the cancellation of the integration agreement for Kaitaia Ab ndant Life School, please sign the attached letters to the proprietor and Presiding Memb r of the Board.
- 35. Should t e fina decision be to cancel the integration agreement, we will appoint a chang manager to support the Board through the closure process. A residual agent will also e appointed to wrap up the Board's accounts and provide final audited accounts to the Office of the Auditor General.

#### Proactive release of Education Report

36. It is intended that this Education Report is proactively released. Any information which may need to be withheld will be done so in line with the provisions of the Official Information Act 1982.
