**YOUR LEGISLATORS' VOTING
RECORD ON SMALL BUSINESS
ISSUES | 2021 EDITION**

Floor votes by your state legislators on key small business issues during the past two sessions of the Virginia General Assembly are listed inside. Although this Voting Record does not reflect all elements considered by a lawmaker when voting, nor does it represent a complete profile of a legislator, it can be a guide in evaluating your legislator's attitude toward small business. Remember that many issues that affect small business are dealt with in committees and never make it to a floor vote in either the House or the Senate. Please thank those legislators who supported small business and continue to work with those whose scores have fallen short.

BOTH CHAMBERS

- 1. Wages -Increase in Minimum Wage (SB 7):** Increases Virginia's minimum wage from \$7.25/hour to \$9.50/hour on May 1, 2021; \$11/hour on January 1, 2022; \$12/hour on January 1, 2023; \$13/hour on January 1, 2024; \$14/hour on January 1, 2024; and \$15/hour on January 1, 2025. When the minimum wage reaches \$12/hour, the General Assembly will have to approve the remaining increases to \$15/hour. **A "No" vote supports the NFIB position.** Passed Senate 21-18; passed House 52-44. Signed by the governor.
- 2. Wages – Nonpayment of Wages (HB 123):** Allows an employee to sue in state court an employer who fails to pay wages. Employer could face claims of three times the wages due, interest and attorney fees. **A "No" vote supports the NFIB position.** Passed Senate 23-17; passed House 51-45-1. Signed by the governor.
- 3. Health Insurance – Association of Health Plans (SB 861):** Allows associations to sell health benefit plans to its members. Sets up a structure outlining what conditions must be met by association before offering health insurance plans to its membership. **A "Yes" vote in the House supports the NFIB position.** Passed House 57-41. **A "No" vote in the Senate supports the NFIB position.** Failed to pass Senate 7-33. Original bill vetoed by the governor.
- 4. Legal – Workplace Harassment (HB 481):** Allows an employee of an employer with 5 or more employees to sue their employer related to workplace harassment. Provides rules for determining what constitutes workplace harassment and permits a court to award compensatory or punitive damages and reasonable attorney fees and costs. **A "No" vote in the House supports the NFIB position.** Passed House 56-41. **A "Yes" vote in the Senate supports**

the NFIB position. Passed Senate 23-17. Bill failed in Senate Committee.

- 5a. Tax Conformity – Paycheck Protection Program (PPP) Loans (SB 1146) Senate Vote:** Conforms Virginia tax law to federal tax policy to ensure PPP and Rebuild Virginia total loan amounts are not included as income when calculating Virginia income tax. The Senate Floor amendment would ensure the entire loan amount would also be deductible as business expenses mirroring federal policy. **A "Yes" vote in the Senate supports the NFIB position.** Failed to pass Senate 17-22.
- 5a. Tax Conformity – Paycheck Protection Program (PPP) Loans (SB 1146) House Vote:** Conforms Virginia tax law to federal tax policy to ensure PPP and Rebuild Virginia total loan amounts are not included as income when calculating Virginia income tax. The House version would only allow up to \$25,000 in deductible business expenses rather than the full amount which mirrors federal policy. **A "No" vote in the House supports the NFIB position.** Passed House 55-44.
- 5b. Tax Conformity - Final Package (SB 1146):** Conforms Virginia tax law to federal tax policy to ensure PPP and Rebuild Virginia total loan amounts are not included as income when calculating Virginia income tax. The final compromise allows up to \$100,000 in deductible business expenses. Bill included an emergency clause to take immediate effect. **A "Yes" vote supports the NFIB position.** Passed Senate 39-0; passed House 95-2. Signed by the governor.
- 6. Tax Relief – Sales Tax Exemption for Personal Protection Equipment (PPE) Purchases (HB 2185):** Provides a sales tax exemption to businesses for their PPE purchases during the COVID-19 state of

emergency if the business is complying with state COVID-19 workplace safety regulations. **A "Yes" vote supports the NFIB position.** Senate passed 39-0; House passed 100-0. Signed by governor.

- 7. Retirement – State Sponsored Retirement Program (HB 2174):** Creates a state managed retirement fund for private sector employees not covered by an employer sponsored retirement plan. While employers are not required to contribute to an employee's fund, they must provide automatic payroll deductions for employees. The bill excluded businesses with less than 25 employees and part time employees. The Governor's amendment would have reinstated part time employees into the program. **A "No" vote supports the NFIB position.** Passed House 55-45; Failed to pass Senate 11-29; Original bill signed by the governor.
- 8. SWaM Designated Businesses - Right to Appeal Denial of Initial Certification (HB 2172):** Requires the Department of Small Business and Supplier Diversity to adopt regulations to establish a process for businesses that are denied initial certification as a small, women-owned, or minority-owned business to appeal such denial. **A "Yes" vote supports the NFIB position.** Passed Senate 39-0; Passed House 99-0. Signed by governor.

- 9. Repeal of Right to Work for Marijuana Permits (HB 2312):** Allows the Board to revoke a business' marijuana permit if it's determined the business did not remain neutral during any union organizing efforts by employees, including card check recognition and union access to employees such as employees' personal contact information; does not pay employees prevailing wages as determined by the U.S. Department of Labor; or classifies more than 10 percent of its workers as independent contractors. **A "No" vote supports the NFIB position.** Passed House 53-44-2. Failed to pass Senate 20-20. Lieutenant Governor voted yes. Signed by governor.

HOUSE ONLY

- 10. Paid Quarantine Leave (HB 5116):** Requires employers to immediately provide paid quarantine leave to employees for an employee's illness or exposure to COVID-19 as well as for care of a family member. Prohibits employers from taking certain retaliatory actions against an employee if they are ineligible for or has exhausted their paid quarantine leave and is absent from work without compensation. Provides an employee may sue an employer for violations. Exempts employers with less than 25 unless there is federal program to cover employers' costs. **A "No" vote supports the NFIB position.** Passed House 54-44. Failed to pass Senate committee.
