MOTION

The community of Valley Glen is seeking to install a monument sign to indicate its community name in the median triangle, at the Northeast corner on Burbank Blvd at Coldwater Canyon Ave. Currently, the Bureau of Engineering, a division of the Department of Public Works, is requiring a revocable permit for the community to install the signage.

All the costs for this community project are provided from neighborhood council funding and the signage represents a public benefit to the community of Valley Glen and the City of Los Angeles. Since the Valley Glen community does not have a Business Improvement District that would ordinarily be responsible for the revocable permit, it is appropriate that the Department of Public Works instead require a Bureau of Engineering Construction Permit.

The Greater Valley Glen Neighborhood Council has adopted a motion stating: "...in order to allow the City Council and Councilmember Krekorian to exempt the monument sign proposed by the Greater VALLEY GLEN COUNCIL for the intersection of Burbank Blvd and Coldwater Canyon from the required revocable permit and liability insurance in perpetuity, that the Greater VALLEY GLEN COUNCIL Board hereby agrees that once the monument sign located in the median island at the northeast corner of Burbank Boulevard and Coldwater Canyon (approved by the Greater VALLEY GLEN COUNCIL Board at the Special Meeting of April 9, 2012) is erected the Greater VALLEY GLEN COUNCIL will assume full liability for maintenance and upkeep of said monument sign in perpetuity; further, the Greater VALLEY GLEN COUNCIL agrees that it will not hold the City of Los Angeles liable for maintenance and upkeep of said monument sign in perpetuity."

I THEREFORE MOVE that City Engineer and any other involved City Department be authorized and directed to issue the permit(s) necessary for the installation of the Valley Glen monument sign to indicate its community name in the median strip on Burbank Blvd at Coldwater Canyon Ave., and to require a Bureau of Engineering Construction Permit rather than a revocable permit.
