# Motion for a Climate Emergency Review of the Young Fabians

#### The Young Fabians Believe:

- We are living in a time of climate crisis. Our planet has already warmed 1oC and unless radical action is taken globally in the next 11 years, we will push our planet beyond the 1.5oC tipping point. The world's scientists are clear. If this happens, it will be irreversible and will bring with it extreme weather events, food shortages and force hundreds of millions into climate related poverty.
- 2. The Young Fabians have already been at the forefront of calling for action on climate change. We have the ability and therefore the responsibility to be a strong voice for young people in the Labour movement to prevent climate catastrophe, and we need to be a training ground for future leaders to promote this message further.
- 3. To be a credible voice on the climate, we need to get our own house in order and reduce our environmental footprint as an organization.

#### The Young Fabians Resolves:

- 1. To undertake a Climate Emergency review. This is to urgently assess how we can reduce the carbon impact of our own activities.
- 2. The first step should be divesting the Young Fabians bank account from fossil fuel. Our money is currently helping to support the more than £66bn big banks have lent to companies around the world engaged in oil and gas extraction. We need to divest as a matter of priority.
- 3. That the Young Fabian Executive request The Fabian Society to conduct its own climate impact review, including switching to a bank account divested of fossil fuels, and exploring the feasibility of switching to a green energy provider for its headquarters at 61 Petty France

## **Liberation Groups Amendment**

The Young Fabians resolves to add the following article to the Society's constitution.

#### 9. Liberation Groups

#### 9.1 Definition

Liberation Groups are sub-sections of the group devoted to and responsible for advocating on behalf of members with specific protected characteristic(s) (as defined in the 2010 Equalities Act), both in terms of policy making and access to the organisation. The creation of or winding up of a Liberation Group must be proposed to the Annual General Meeting. Members who self-identify as possessing the relevant protected characteristic(s) then vote on the matter. If no member possessing the relevant protected characteristic(s), other than the proposer and seconder, are present the Young Fabians Executive may accept a petition signed by 10 current member possessing the relevant protected characteristic(s) after the AGM.

The proposal must include evidence that individuals with a particular protected characteristic are underrepresented or disadvantaged within the Fabian Society and set out how the formation of the Liberation Group will attempt to tackle these issues.

#### 9.2 Membership

Membership of Liberation Groups shall be open to any full member of the Young Fabians who: a) notifies the Chair and/or Secretary of the Liberation Group that they wish to be a member of the Group; & b) possesses the relevant protected characteristic(s)

Additionally the Liberation Group shall have discretion to recruit members from outside the Young Fabians who have experience of or a professional or personal interest in the area the Liberation Group is devoted to, subject to Rule 2 of the Fabian Society.

Only full members of the Young Fabians possessing the relevant protected characteristic(s) may sit on or vote for the members of the Liberation Group's steering committee.

#### 9.3 Steering Committee

Any member of a Liberation Group who is also a full member of the Young Fabians may sit on the Group's steering committee. Each Liberation Group must hold an AGM within three months of the Young Fabian's AGM at which they will elect a Chair, Secretary and at least one other to form the network Steering Committee. The committee may decide other roles as it deems appropriate.

Members who wish to sit on the steering committee may do so after the AGM. To do so they must notify the Liberation Group's secretary in writing of their intention and attend two steering committee meetings as an ordinary member of the Group. At the second meeting an

election shall be held to approve of their accession to the steering committee by its existing members.

The steering committee must meet a minimum of once every three months and meetings shall be open to all members of the Liberation Group. Members shall have the right to speak and propose motions at all meetings, but only the steering committee proper may vote on motions.

The time and place of all meetings must be advertised a minimum of fourteen (14) days before the meeting is held.

#### 9.4 Responsibilities

Liberation Groups shall be responsible for the running of events, publications, discussions, delegations and other member-led activities within policy areas affecting the protected characteristic(s) to which they are devoted.

Liberation Groups should also take an active role in promoting inclusion and accessibility for members possessing the relevant protected characteristic(s) to which they are devoted.
