Career

Alireza Faghani started out as a player, reaching the third tier of the Iranian league before deciding to follow in the footsteps of his father Mohammed by becoming a referee. Other relatives in the same profession include his younger brother, father-in-law and brother-in-law. He handled his first Iranian top-flight game in 2007 and earned his FIFA badge the following year. During his career he has presided over three finals in Asian club competitions: the first was the AFC President's Cup in 2009, followed by the AFC Challenge Cup 2010 and the first leg of the 2014 AFC Champions League final. In 2010, he was the man in the middle for the AFC U-16 Championship final between Korea DPR and Uzbekistan. In 2013, he was called up by FIFA for the U-20 World Cup and the Club World Cup, directing two games in each event. Faghani participated in the 2014 FIFA World Cup™ as a fourth official, after having taken charge of five Asian qualifiers. In 2015, he covered the Asian Cup final between Korea Republic and Australia, followed by Barcelona-River Plate in the decider of the Club World Cup. In 2016, he was named by the AFC as the best Asian referee of the year. The same year, along with assistants Reza Sokhandan and Mohammadreza Mansouri, Faghani headed the first all-Asian refereeing team in the Olympic final in Rio between Brazil and Germany. In 2017, he took part in the FIFA Confederations Cup, controlling two matches including the semi-final between Chile and Portugal. At the end of the season, he was named the best Iranian referee for the second time (the first time was in 2013/14). In the Asian preliminary tournament for Russia 2018, he oversaw six games, including the first leg of the continental play-off between Syria and Australia.

Career

Ravshan Irmatov started playing football at the age of seven and took up refereeing after an injury forced him out of the game. He began officiating in the Uzbekistanek league in 1998 and made his international bow in 2003 with a call-up for the first of three FIFA U-17 World Cups (the other two being the 2007 and 2009) editions). Since 2007, he has been ever-present in the AFC Champions League, where he has supervised four finals (2007, 2011, 2013 and 2017). Also in 2007, he took part in the U-20 World Cup and subsequently in 2008 presided over the first of two finals in the Club World Cup, between LDU Quito and Manchester United, which was followed by the 2011 decider between Barcelona and Santos. In 2008, Irmatov was named Asian referee of the year by the AFC, an honour that he has since won four more times (in 2009, 2010, 2011 and 2014). He was appointed to his first World Cup in 2010, where he was entrusted with five games, including the opening match between South Africa and Mexico, and Netherlands- Uruguay in the semi-finals. He has been involved in three editions of the Asian Cup, covering Australia-Japan in his only continental final in 2011. In 2012, he was on the referees list for the Olympic Football Tournament in London and officiated Korea Republic-Japan in the play-off for third place. The following year, he was selected for the Confederations Cup in Brazil. In 2014, Irmatov was invited back to the World Cup and oversaw four fixtures, taking his overall tally to nine and moving him above Mexico's Benito Archundia, Uruguayan Jorge Larrionda and Frenchman Joel Quiniou in the competition's all-time appearance table. Also in 2014, he was put in charge of the Indian Super League final. Irmatov refereed games in the Asian qualifying for Russia 2018, including Australia-Syria in the return leg of the continental play-offs, which was his 22nd World Cup qualifier (the first was in 2004). He also became the first Asian referee to officiate a CONCACAF Champions League semi-final in 2018. He has been awarded three high state honours by Uzbekistan President Islam Karimov, namely the Uzbekistanekistan Iftikhori in 2010, the El-Yurt Khurmati Order in 2014 and the Buyuk Hizmatlari Uchun Order in 2015.

Career

Mohammed Abdulla Mohammed started out as a footballer but switched to refereeing after seeing a compatriot officiating in the World Cup. That person was Ali Bujsaim, who directed seven games spanning three editions of the global showpiece (in 1994, 1998 and 2002). A year before obtaining his international credentials in 2010, Mohamed gained his first overseas experience at the Toulon Tournament in 2009. After officiating numerous games in youth tournaments, regional events and continental club cups, he supervised his first AFC Champions League matches in 2013. The following year, he presided over the final of the AFC U-22 Championship. In 2015, he received his first call-up to the Asian Cup, where he directed two fixtures, and the U-17 World Cup (three games including the semi-final between Nigeria and Mexico). In 2017, Mohamed took charge of the AFC Cup final and was among the referees selected for the U-20 World Cup. On the road to Russia 2018, he covered three Asian qualifiers.

Career

Ryuji Sato played football as a youngster but was inspired to take up refereeing after seeing a conference held in 2002 by compatriot Toru Kamikawa, who refereed at the 2002 and 2006 World Cups. He turned international in 2009 and made his debut in a friendly between Korea Republic and Iraq. Sato supervised his first final in the AFC Challenge Cup 2012. That same year he became an established referee in the AFC Champions League, where he officiated the return leg of the 2016 final between Al Ain and Jeonbuk Hyundai. He was the man in the middle for the Japanese Super Cup final in 2014. In 2015, he refereed in the Asian Cup, conducting the semi-final between Korea Republic and Iraq. FIFA selected Sato for the U-20 World Cup 2015 (two games), the Olympic Football Tournament 2016 (one game) and the U-17 World Cup 2017, where he was put in charge of Spain-Mali in the semi-finals. The preliminary tournament for Russia 2018 was his second World Cup qualifying campaign, following his debut in 2011 in the continental tournament ahead of Brazil 2014.

Career

Since turning international in 2008, Nawaf Abdulla Shukralla has been used in various AFC competitions (the AFC Cup, President's Cup and Challenge Cup), becoming an established name on the referees list for the AFC Champions League from 2010 onwards. In Asia's premier club competition he has overseen one final (the return leg between Guangzhou Evergrande and FC Seoul in 2013) and no fewer than five semi-finals. He was on the referees list for the Asian Cup in 2011 and again in 2015, when he officiated the play-off for third place between Iraq and United Arab Emirates. His first call-up for a FIFA competition was the U-17 World Cup in 2011, followed by the Club World Cup 2012 and the U-20 World Cup 2013 (including France-Ghana in the semi-finals). At the 2014 World Cup in Brazil, he was tasked with two group matches. Shukralla was again nominated for the Club World Cup in 2016 where he directed the match for third place and the U-17 World Cup in 2017. In the Asian qualifying for Russia 2018, he handled five games.

Mehdi Abid Charef followed his father into refereeing, while his brother was a player. He was selected for the FIFA panel in 2011 and received his first call-up for the CAF Champions League the following season. In 2013, he handled the final of the African Youth Championship between Ghana and Egypt. In 2015, he was assigned his first game in the CAF Africa Cup of Nations and was posted to the U-17 World Cup, where he supervised two group fixtures. In 2017, Abid Charef directed the play-off for third place in the Africa Cup of Nations, three U-17 World Cup matches, including a quarter-final, and the first leg of the CAF Confederations Cup final between TP Mazembe and Supersport United. In 2018, he directed his second Algerian Cup final, after his first one in 2011.

Career

After standing in to officiate a training game that his team was involved in, Malang Diedhiou decided to enrol on a course that set him on the way to a refereeing career. His presence in Russia marks the return of a Senegalese referee to the World Cup, 16 years after Falla Ndoye participated in the 2002 edition. He has officiated internationally in Africa since 2008, when he directed a preliminary match in the CAF Champions League, and in 2015 was appointed to his first Africa Cup of Nations and also the U-17 World Cup. The following year he handled the return leg of the CAF Confederations Cup final between TP Mazembe and MO Bejaia, as well as conducting two games at the Olympic Football Tournament in Rio de Janeiro. Diedhiou was just as active in 2017, overseeing a semi-final in the Africa Cup of Nations, another return-leg final in the CAF Confederations Cup and two Club World Cup fixtures, including the play-off for third place.

Career

Bakary Papa Gassama started out playing football but switched to refereeing after realising he would not make it as a player, in contrast to his brother who plays at semi-professional level in Gambia. He began officiating in 2003 and earned his international credentials in 2008. Gassama is one of Africa's most experienced referees and already has a World Cup under his belt, having overseen Netherlands-Chile in the 2014 edition. Since 2012, he has been a regular in the CAF Champions League, where he officiated five consecutive finals from 2013 to 2017. His first call-up for a FIFA competition was for the Olympic Football Tournament in London 2012 (two opening-round fixtures). That was followed in 2013 by the U-20 World Cup and the Club World Cup, where he presided over two games including a semifinal. In 2017, he was in Russia for the Confederations Cup. He has also taken part in four Africa Cup of Nations tournaments, including the 2015 final and a semi-final in 2017. The following year he officiated the African Nations Championship final between Morocco and Nigeria. Gassama, who also has experience in the Qatari league, was named CAF Referee of the Year four times in a row from 2014 to 2017.

Career

Ghead Grisha's footballing career took him as high as the Egyptian second division before his passion for refereeing took over, although he still plays as an amateur. Grisha made his international debut in the Toulon Tournament in 2009 and supervised a semi-final in the CAF Champions League two years later, before refereeing the first leg of the 2015 final. In his last four participations in the Africa Cup of Nations he has officiated two play-offs for third place (in 2012 and 2015). In 2015, he received his first call-up to the U-20 World Cup, covering the play-off for third place, before taking charge of two fixtures in the 2017 edition. Grisha featured in the Olympic Football Tournament 2016 in Rio de Janeiro, where he was entrusted with two games including a quarter-final. In February 2017, he was the man in the middle for the CAF Super Cup final between Mamelodi Sundowns and TP Mazembe.

Inspired by his father, himself a match official, Janny Sikazwe is the first Zambian referee to be involved in the finals of a World Cup. Internationally qualified since 2007, he has been one of the most in-demand referees in African competitions since 2012. His experience includes one final (in 2014) and two semifinals in the CAF Champions League, four participations and a final (Egypt-Cameroon in 2017) in the Africa Cup of Nations, as well as the first leg of the CAF Confederations Cup final in 2015. Also in 2015, he directed three games in the U-17 World Cup, including a quarter-final. Sikazwe was allocated to handle Real Madrid-Kashima Antlers in the 2016 Club World Cup final and the following year was included in the referee pool for the U-20 World Cup.

Career

Tessema Weyesa Bamlaku is the first Ethiopian referee involved in a World Cup for 48 years, after Seyoum Tarekegn officiated at Mexico 1970. He began refereeing in 2003 and earned international status in 2009. In 2011, he presided over a preliminary-round fixture in the CAF Champions League, before going on to direct the first leg of the 2017 final. In 2013, he officiated two games in the African Youth Championship, followed by one on his Africa Cup of Nations debut in 2015, before returning to handle two matches in the 2017 edition. He supervised his first two games in a FIFA competition at the U-17 World Cup in 2017.

Career

As a youth football coach, Joel Aguilar started out by officiating training games, before being called upon to handle a competitive match, which ignited his passion for refereeing. He is the first and still the only Salvadoran referee to have featured in a World Cup. Internationally qualified since 2002, Aguilar has covered numerous finals in Salvadoran football and is also one of CONCACAF's most experienced and in-demand referees in continental and international competitions. He started with the CONCACAF Champions Cup in 2003 and progressed to supervising the 2011 first-leg final between Monterrey and Real Salt Lake. In international team events, Aguilar participated in six editions of the Gold Cup between 2007 and 2017, directing three consecutive finals between 2011 and 2015. He was also shortlisted for two editions of the Copa América in 2015 and 2016, overseeing a semi-final in the latter edition. He has an equally extensive background in FIFA competitions, having participated in one U-17 World Cup in 2007, three U-20 World Cups (2007, 2009 and 2017) and two Club World Cups, where he handled a semi-final in both 2011 and 2015, as well as overseeing two matches in the Confederations Cup 2013 and another two in the 2014 World Cup. En route to Russia 2018, he refereed a total of six qualifiers, of which no fewer than four were in the final round. In 2015, he was named CONCACAF Referee of the Year.

Career

For many years, Mark Geiger combined his job as a mathematics teacher with his passion for refereeing, which started when he was 13 years old. Shortly before devoting himself full-time to refereeing, he received the Presidential Award for Excellence in Math and Science Teaching directly from President Obama. Having covered three games at Brazil 2014, he holds the World Cup appearance record for a US referee, and is the only American to have officiated a knockout match (France-Nigeria in the round of 16). In Russia, he will equal the record for World Cup participations by a US referee, which belongs to David Socha, who featured in the 1982 and 1986 editions. Geiger has taken charge of over 150 Major League Soccer fixtures, including the decisive final of the 2014 MLS season between LA Galaxy and New England Revolution. During his tenth year on the FIFA list in 2017, he presided over his maiden CONCACAF Champions League final (the first leg between Tigres and Pachuca), nine years after making his first tournament bow in the 2008 edition. In 2011, he officiated the final of the CONCACAF U-20 Championship between Costa Rica and Mexico, before participating in three Gold Cups, in 2013, in 2015 when he refereed a semi-final, and again in 2017. His experience in FIFA competitions stretches back to 2011, when he was tasked with handling the U-20 World Cup final between Brazil and Portugal. The following year, he oversaw two games at the Olympic Football Tournament 2012 in London, followed by the Club World Cup in 2013. After taking charge of three World Cup games in Brazil in 2014, the year in which he was named CONCACAF Referee of the Year, Geiger was assigned one match in the Copa América 2016 and two in the Confederations Cup 2017. In 2016 and 2017, he was appointed as a VAR for the FIFA Club World Cups in Japan and UAE, respectively, where he was the VAR of the final in 2017. He made his bow in the Argentinian league in 2007 and went international in 2010, debuting in the Copa Libertadores where he has since been tasked with covering two finals: the first leg in 2013 between Olimpia Asunción and Atlético Mineiro and the return leg in 2016 between Atletico Nacional and Independiente del Valle. In 2011 he was rostered for the South American U-17 Championship and the following year oversaw the first of two Recopa Sudamericana finals, specifically the first leg between Universidad de Chile and Santos, which was followed by San Lorenzo-River Plate in the return leg of the 2015 decider. A footballer in his youth, Antonio Mateu Lahoz decided to become a match official after one of his brothers, who was a referee, advised him to make the switch during a period of rehabilitation following a knee injury. He began refereeing at the age of 15 and in 2008 made his debut in *La Liga* before turning international in 2011 and immediately seeing action in EURO 2012 qualifiers, the Europa League and the Champions League preliminary stage. In 2012 he was the man in the middle for the Spanish Super Cup final and made his Champions League group-stage debut, eventually officiating a semi-final in 2017 (Monaco-Juventus). In 2014 he was the match official of the *Copa del Rey* final and the following year he was shortlisted for the U-20 World Cup, where he would subsequently return in 2017 to cover Italy-England in the semi-finals. Mateu oversaw two matches at the 2016 Olympic Football Tournament in Rio de Janeiro and was tasked with Italy-Sweden in the play-offs for the 2018 World Cup.

Career

Initially, refereeing was a means for Mažić to stay in touch with football, at the suggestion of friends after he had suffered an injury as a player. He has two cousins who have been professional footballers. Mažić has been on the FIFA referees list since 2009 and has also officiated in the Egyptian, Qatari, Romanian and Saudi Arabian leagues. At home he has been allocated no fewer than five national cup finals. His first international event was the European U-17 Championship in 2009, where he was tasked with a semifinal. In 2010 he made his debut in the Europa League and the following year he officiated the play-off for third place in the European U-21 Championship. In 2012 he made his debut in the group stage of the UEFA Champions League. In 2013 Mažić handled the first of three consecutive Europa League semifinals. He was also picked for the U-20 World Cup (two games) and for Romania-Greece in the World Cup play-offs. In 2014 he refereed two group matches (Germany-Portugal and Argentina-IR Iran) at the global showpiece, after handling the first of three successive Champions League quarter-finals. In 2016 he was the man in the middle for the UEFA Super Cup meeting between Real Madrid and Sevilla. The following year, he took charge of another cup final, between Chile and Germany in the Confederations Cup. On the trail to Russia 2018 he was called on to supervise Denmark-Republic of Ireland in the play-offs. In 2018 he officiated the UEFA Champions League final.

Career

Before choosing to become a referee, Gianluca Rocchi played football as a midfielder. He took charge of his first *Serie A* match in 2004 and joined the FIFA panel in 2008, making his debut the same year in the UEFA Cup. His first postings in the UEFA Champions League came in 2009 (qualifiers) and 2010 (group stage). The following year, he headed a semi-final in the Europa League. In 2012, in addition to directing a Champions League quarter-final, Rocchi was included in the referee pool for the Olympic Football Tournament in London and officiated Mexico-Japan in the semi-finals. The following year he handled another semi-final, Argentina-Mexico in the U-20 World Cup. Rocchi has also been called on to referee matches in the Qatari league, as well as the 2013 Italian Super Cup match and the final of the 2016 *Coppa Italia*. Between 2016 and 2018 he presided over another two Champions League quarter-finals and two Europa League semi-finals, as well as two games in the Confederations Cup 2017, the UEFA Super Cup between Real Madrid and Manchester United and finally Croatia-Greece in the qualification play-offs for Russia 2018.

Career

A former youth footballer who quit the game in his mid-teens, Damir Skomina is the first Slovenian referee to take part in the finals of World Cup. He made his debut in the Slovenian top flight in 2000 and was added to the FIFA referees list two years later.

In 2003 he debuted on the European scene, both in the UEFA Cup and in the continental U-17 championship, handling a semi-final in the latter tournament. In 2005 he took part in another European youth championship, this time at U-19 level, and oversaw the first of 13 World Cup qualifiers spanning four European preliminary campaigns (including the France-Ukraine play-off ahead of Brazil 2014), a tally that makes him the sixth-busiest European referee in the competition. In 2007 he was the man in the middle for the European U-21 Championship final between Serbia and the Netherlands, before being called up for the Olympic Football Tournament in Beijing the following year, where he presided over a quarter-final. During his career, which has also included assignments in Qatar, Saudi Arabia and Ukraine, Skomina has handled a total of three UEFA Champions League semi-finals, four Europa League semi-finals, four Slovenian cup finals and two Slovenian Super Cups. Between 2012 and 2013 he participated in the finals of the European Championship in Poland/Ukraine (three games including a quarter-final), oversaw Chelsea-Atlético Madrid in the final of the UEFA Super Cup and took charge of two games in the U-20 World Cup. In 2016 he participated in the EURO finals in France (handling four games including a quarter-final). In 2017 he was assigned to handle Ajax-Manchester United in the Europa League final and to the Confederations Cup, where Skomina oversaw one game, was the prelude to a call-up for his first World Cup.

Career

Clément Turpin's inclusion marks the return of a French referee to the World Cup finals, after none were picked for the Brazil edition four years ago. The son of Jacques Turpin – the former president of FC Montceau Bourgogne – he made his *Ligue 1* debut in 2008 and turned international two years later, when he also debuted in the Europa League qualifying stages. In 2011 he was selected for the first of two French Cup finals (the second was in 2016) and covered a semi-final in the continental U-19 championship. In 2012, Turpin officiated in the Champions League qualifying stages and in 2014 took charge of the French Super Cup encounter between Paris Saint-Germain and Guingamp. He presided over two games in the European U-21 Championship in 2015, followed by the same number in the senior European Championship and the Olympic Football Tournament in Rio de Janeiro the following year. Last year he was selected for the U-17 World Cup, where he covered a quarter-final, and was assigned to handle Peru-New Zealand in the return leg of the World Cup intercontinental play-off. In 2018 he officiated a UEFA Europa League semi-final.
