Along with University of California, Irvine, we are extremely proud to be cofounder of the Western Journal of Emergency Medicine (WestJEM), formerly the California

without any barriers or restrictions immediately following publication. Another unique feature is that WestJEM ascribes to the Creative Commons License, which means that authors retain their copyright and published material can be reused by its authors and others without permission, provided the author and original publication are credited, setting WestJEM apart from other EM journals where authors sign away their copyright and subsequently require permission to use their own work! WestJEM is the fastest growing journal in our specialty, and it quite literally has taken off! WestJEM is now listed in PubMed Central, within the National Library of Medicine and is searchable on PubMed. It is published both in print and electronically each quarter, which CAL/AAEM members receive as part of their membership. We look forward to database indexing in the near future and will continue to lend our steadfast support to the journal. Over the past few years, we have fostered a collaborative relationship with CAL/ACEP, even having one of our

board members serve as a CAL/AAEM liaison to CAL/ACEP and attend their board meetings. We are in the final stages of solidifying a co-sponsorship of *West*JEM with CAL/ACEP, a landmark example of how our two organizations can work together successfully. CAL/AAEM has also established a legal advisory service that can be accessed by our members for free.

In addition, CAL/AAEM, reflecting the educational mission of national AAEM, has been committed to providing high quality educational events to our members for free or nominal cost. When LLSA became mandatory, we provided online LLSA summaries exclusively to our members. We have sponsored and organized several pre-conference workshops at the national AAEM Scientific Assembly, most recently a Pediatric Emergencies workshop, with an impressive line-up of leading educators in pediatric EM, this past March. We developed a free electronic news service that keeps members abreast of current events relevant to the practice of emergency medicine in California and nationwide.

Despite these accomplishments, CAL/AAEM is still a fledgling organization, with a relatively small statewide membership and lots of room to grow! In contrast to CAL/ACEP, we have a much smaller budget, of which the majority goes toward funding the *Western Journal of Emergency Medicine*. We need your help to recruit new members, especially those who are already AAEM members. We strive toward having 100% membership among the California

emergency medicine residencies. I hope to step up our fundraising effort, increase visibility and communication with our members, and push forward the message of equitable and fair practices by targeting our resident members and recent graduates.
