Dear Supporter,



The Illinois General Assembly passed a large volume of bills out of both the State House and State Senate during this legislative session. So too, did the Illinois Environmental Council (IEC) successfully shepherd the passage of a record number of bills on our environmental legislative agenda. However, most of those bills were not on our list of priority legislation. While undoubtedly important, they are generally small steps in the right direction rather than the overarching policy change we need to protect people and the planet, especially as the impacts of climate change worsen.

Among the exciting wins were: SB58, a bill that bans styrofoam from purchase by state agencies and public universities; SB2368, legislation that enacts the first statewide building code and increases Illinois' climate resiliency; SB40, which ensures electric vehicle-ready (EV-ready) buildings statewide; and SB1701, Illinois' first law that assigns nutrient pollution reduction responsibilities to state agencies.

This year, IEC saw the Illinois State Senate hold up a disappointing number of bills. In a few cases, it was because of late-breaking stakeholder concerns or a lack of information from leading decision-makers. We chose to score these critical bills in the House and hope the Senate will cast votes on them during upcoming opportunities.

Unfortunately, the General Assembly passed several bills with negative environmental impacts this year. Perhaps most upsetting, some of our trusted environmental champions in the legislature supported them. We fiercely opposed the following bills: HJR23, which would expand I-55; SB76, legislation that removed Illinois' ban on new nuclear facilities; and HB3445, which would increase the price of renewable energy transmission. These bills carry long-term environmental impacts if enacted as passed.

Fortunately, Governor Pritzker has vetoed SB76 and HB3445 as well as HB2878, a bill related to the I-55 expansion. We will need your support to keep these vetoes in place in October and November.

We hope our Scorecard will be a useful resource and allow you to see whether your legislators have used their power in the General Assembly to protect you, plants, animals, and our environment or whether they used their power to aid big polluters and dirty fossil fuel special interests. Please use this information to build a relationship with your lawmakers, urging them to always vote in support of environmental issues.

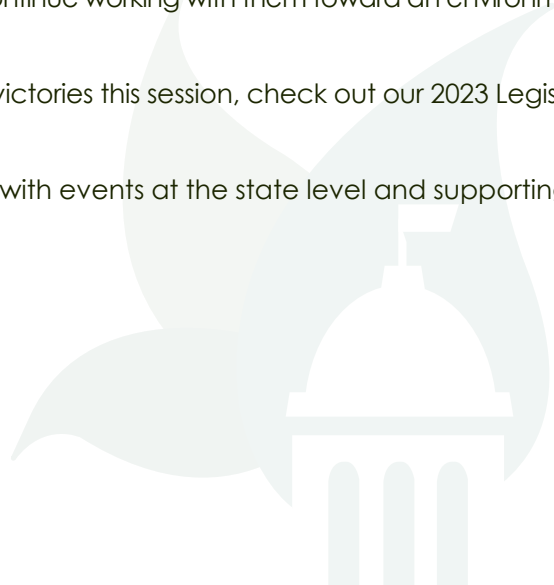

# EXPLANATION OF SCORING

For each bill, legislators are evaluated on whether they voted with the pro-environment position (“+”) on the bill or against it (“-“). For bills that the environmental community supports, a YES vote is a + and a NO vote is a -. For bills that are opposed, a NO vote is a + and a YES vote is a -. The votes are then tallied and an overall score is calculated. For instance, someone who voted pro-environment on six bills and against on four bills is given a 60% score.

The only votes not counted are those when a legislator had an excused absence (noted in the chart as “A” or “E”), which generally meant that the legislator was not in Springfield on that day due to an illness or other unexpected circumstances. Legislators who had absences were scored according to the other votes they cast.

Two other voting possibilities are included. On occasion, a legislator may vote “Present,” which is essentially an abstention. We typically have counted these votes the same as a no vote on the bill, because the impact on the bill’s potential to pass is the same as if that legislator had voted no. These are shown in the voting chart as “P” and counted the same as a “+” when it helps the pro-environment position, and shown as “p” and counted as “-” when it hurts.

Similarly, when a legislator is in Springfield but does not vote on a bill, we have counted it the same as a “no” vote on the bill. This is noted in the chart as “NV” and counted the same as a “+” when this action supports the pro-environment position. It is noted as “nv” and counted as “-” when it does not support the pro-environment position.

Legislators have many reasons for voting “Present” or for not voting at all. They may vote “Present” because of a philosophical conflict on the issue, or simply because they don’t want to commit publicly one way or the other. They may miss a vote because they were in an important meeting, were in the bathroom at the time of the vote, or were at their desk but decided not to vote. Regardless of the reason, all of these actions have significant consequences for whether or not a bill passes, and therefore we have decided that it is appropriate to hold legislators accountable for their actions, whatever they may be.

## ABOUT THE BILLS IN THE 2023 ENVIRONMENTAL SCORECARD

### **HB1190: VERIFIED GAS LEAKS - SUPPORT**

**Sponsors:** Rep. Morgan / Sen. Faraci

- Requires the owner and operator of an underground methane gas storage facility to inform the public of any verified leaks that occur.
- HB1190 passed the House by a vote of 106-0-0 and the Senate by a vote of 55-0-0.

### **HB1370: LARGE EVENT RECYCLING - SUPPORT**

**Sponsors:** Rep. Tarver / Sen. Villa

- Requires facilities with a capacity at or over 3,500 people to participate in recycling and composting.
- HB1370 passed the House by a vote of 84-23-0 and stalled in the Senate.

### **HB1440: PRETREATED SEEDS IN ETHANOL PRODUCTION - SUPPORT**

**Sponsors:** Rep. Guzzardi / Sen. Harmon

- Bans the use of pretreated seeds (i.e. coated with pesticides) in the production of ethanol.
- HB1440 passed the House by a vote of 77-36-0 and stalled in the Senate.

### **HB2086: CONSUMER-OWNED CONTAINERS - SUPPORT**

**Sponsors:** Rep. Stava-Murray / Sen. Edly-Allen

- Cuts down waste by giving restaurants and retailers health and safety standards to offer the use of personal containers for takeout.
- HB2086 passed the House by a vote of 75-38-0 and the Senate by a vote of 54-0-0.

### **HB2174: PROTECT HOME ENERGY DEVELOPMENT - SUPPORT**

**Sponsors:** Rep. Didech / Sen. Cunningham

- Restricts HOA’s and shared townhomes from enacting unfair policies which restrict renewable energy development on private property.
- HB2174 passed the House by a vote of 100-14-0 and the Senate by a vote of 54-0-1.

### **HB2317: FIRST-TIME FISHING - SUPPORT**

**Sponsors:** Rep. Rita / Sen. Morrison

- Provides that Illinois residents aged 26 years or older who have not purchased a fishing license in the previous 10 years are eligible to purchase a license for \$5. Nonresidents falling under the same criteria are eligible to purchase a license for \$10.
- HB2317 passed the House by a vote of 112-0-0 and the Senate by a vote of 56-0-0.

### **HB2376: FOAM BAN - SUPPORT**

**Sponsors:** Rep. Gong-Gershowitz / Sen. Fine

- Bans polystyrene foam foodware at restaurants and retailers throughout the state.
- HB2376 passed the House by a vote of 67-43-0 but stalled in the Senate; passed as SB58.



## **HB2487: JUSTICE40 OVERSIGHT COMMITTEE - SUPPORT**

**Sponsors:** Rep. Lilly / Sen. Belt

- Creates a committee dedicated to environmental justice and reports its findings to the General Assembly.
- HB2487 passed the House by a vote of 72-39-0 and the Senate by a vote of 43-13-0.

## **HB2520: ENVIRONMENTAL JUSTICE - SUPPORT**

**Sponsors:** Rep. Harper / Sen. Villanueva

- Legislation written and supported by environmental justice organizations that requires reviewing the cumulative impact of air pollution sources and denying unhealthy air pollution permits for impacted communities.
- HB2520 stalled in the House with a vote of 57-48-0.

## **HB2569: COMPOST PROCUREMENT - SUPPORT**

**Sponsors:** Rep. Ness / Sen. Ventura

- Requires the use of compost in land maintenance activities performed by the State when applicable; passed as part of HB 2878.
- HB2569 passed the House by a vote of 108-0-0 but stalled in the Senate.

## **HB2776: LEAD SERVICE LINE NOTICE - SUPPORT**

**Sponsors:** Rep. Huynh / Sen. Simmons

- Updates notice and posting requirements for lead service lines-related work.
- HB2776 passed the House by a vote of 114-0-0 and the Senate by a vote of 56-0-0.

## **HB2879: FARM TO FOOD BANK - SUPPORT**

**Sponsors:** Rep. Harper / Sen. Holmes

- Establishes the Illinois Farm to Food Bank Program within the Department of Human Services to help expand the availability of nutritious, locally grown, raised, or processed foods for Illinois' emergency food system.
- HB2879 passed the House by a vote of 113-0-0 and the Senate by a vote of 56-0-0.

## **HB3158: NATURAL ORGANIC REDUCTION - SUPPORT**

**Sponsors:** Rep. Cassidy / Sen. Simmons

- Provides an environmentally friendly alternative burial option.
- HB3158 passed the House by a vote of 63-38-0 but stalled in the Senate.

## **HB3277: INCIDENTAL SALES OF COMPOST - SUPPORT**

**Sponsors:** Rep. Frese / Sen. Bennett

- Clarifies that farmers are allowed to sell small amounts of compost from farm composting operations.
- HB3277 passed the House by a vote of 108-0-0 and the Senate by a vote of 56-0-0.

## **HB3445: RIGHT OF FIRST REFUSAL - OPPOSE**

**Sponsors:** Rep. Walsh / Sen. Stadelman

- Includes a provision allowing Ameren the right of first refusal for transmission projects in the Midcontinent Independent System Operator (MISO) territory, effectively eliminating the normal bid process. These types of processes have been shown to increase project costs, which will ultimately be paid for by ratepayers. IEC only opposes the portion of the bill related to the right of first refusal.
- HB3445 passed the House by a vote of 63-32-2 and the Senate by a vote of 41-9-1.

## **HB3508: PFAS FOAM TAKE-BACK - SUPPORT**

**Sponsors:** Rep. Moeller / Sen. Fine

- Creates a take-back program for firefighting foam.
- HB3508 passed the House by a vote of 109-0-0 and the Senate by a vote of 55-0-0.

## **HB3556: BLACK FARMER RESTORATION ACT - SUPPORT**

**Sponsors:** Rep. Harper / Sen. Turner

- Creates the Black Farmer Restoration Program within the Illinois Department of Agriculture to support and encourage the growth of Black farmers into the field of agriculture.
- HB3556 passed the House by a vote of 70-37-0 but stalled in the Senate.

## **HB3642: TOWNSHIP OPEN SPACE - SUPPORT**

**Sponsors:** Rep. Faver Dias / Sen. Edly-Allen

- Requires that any land acquired by a township under the open space ballot provision must go back to the ballot for approval if the land is to be sold or used for purposes other than agreed to originally by voters.
- HB3642 passed the House by a vote of 71-34-0 but stalled in the Senate.



## **HJR23: I-55 MANAGED LANES - OPPOSE**

**Sponsors:** Rep. Stava-Murray / Sen. Cunningham

- Begins the first stages of a proposed project to increase the number of lanes on I-55 in the Chicago region, much of which lies immediately adjacent to environmental justice communities. This will negatively impact air quality in areas already seeing the highest rates of air pollution in Illinois.
- HJR23 passed the House by a vote of 88-3-0 and the Senate by a vote of 39-11-1.

## **SB40: ELECTRIC VEHICLE CHARGING - SUPPORT**

**Sponsors:** Sen. Feigenholtz / Rep. Gabel

- Requires a conduit for EV-capable parking spaces for new single-family homes and newly constructed or renovated multi-unit residential buildings
- SB40 passed the Senate by a vote of 39-16-1 and the House by a vote of 69-38-1.

## **SB58: SINGLE-USE PLASTICS - SUPPORT**

**Sponsors:** Sen. Fine / Rep. Gong-Gershowitz

- Bans the purchase of polystyrene foam foodware by state agencies and public universities by 2025 and by vendors to the state in 2026. This is a major step towards plastic reduction in the state.
- SB58 passed the Senate by a vote of 36-20-0 and the House by a vote of 71-43-0.

## **SB76: END NUCLEAR MORATORIUM - OPPOSE**

**Sponsors:** Sen. Rezin / Rep. Yednock

- Removes the ban on the new construction of nuclear power plants without updating rules from decades ago.
- SB76 passed the Senate by a vote of 36-14-0 and the House by a vote of 84-22-3. At the time of publication, Gov. Pritzker has vetoed this bill.

## **SB203: INCREASE PESTICIDE VIOLATIONS - SUPPORT**

**Sponsors:** Sen. Villa / Rep. Avelar

- Expands the penalties for improper pesticide applications by making each instance of inadvertent human exposure a separate violation under the Illinois Pesticide Act; increases fine amounts and lowers the threshold for triggering violations under certain circumstances.
- SB203 passed the Senate by a vote of 51-2-0 and the House by a vote of 80-24-0.

## **SB1701: HEALTHY SOILS AND WATER INITIATIVE - SUPPORT**

**Sponsors:** Sen. Villivalam / Rep. Kelly

- Creates the Illinois Healthy Soils and Watersheds Initiative to improve the health of soils and the function of watersheds. This is the first bill Illinois has passed to outline the responsibility of Illinois' state agencies for nutrient pollution reduction and is a major step forward in decreasing Illinois' top water pollution issue.
- SB1701 passed the Senate by a vote of 109-6-0 and the House by a vote of 57-0-0.

## **SB1715: WATER FOUNTAIN - SUPPORT**

**Sponsors:** Sen. Glowiak Hilton / Rep. Ladisch Douglass

- Requires bottle filling stations for the construction of buildings with 5,000 square feet of gross public area or with occupancies of 100 or more.
- SB1715 passed the Senate by a vote of 54-0-0 and the House by a vote of 85-23-0.

## **SB1772: RESTRICT PESTICIDES AROUND SCHOOLS - SUPPORT**

**Sponsors:** Sen. Morrison / Rep. Hirschauer

- Prohibits the application of pesticides in or around kindergarten through eighth-grade schools.
- SB 1772 passed the Senate by a vote of 57-0-0 and the House by a vote of 106-3-0.

## **SB2368: BUILDING CODES - SUPPORT**

**Sponsors:** Sen. Koehler / Rep. Johnson

- Modernizes building code standards to better align the state with requirements through FEMA for funding access, along with generally improving public safety for new constructions. This legislation is a major step in our state's investment toward climate resilience and public safety.
- SB2368 passed the Senate by a vote of 34-18-1 and the House by a vote of 85-19-0.

## **SB1769: GOVERNMENT ZERO EMISSION VEHICLES - SUPPORT**

**Sponsors:** Sen. Ventura / Rep. Hoffman

- Requires that all passenger vehicles purchased by government units must be zero-emission vehicles after January 1, 2030, except law enforcement and paratransit vehicles.
- SB1769 passed the Senate by a vote of 33-20-0 and the House by a vote of 69-35-0.
