

Michael Bazzell helps celebrities, billionaires, and everyday citizens disappear completely from public view. He is now known in Hollywood as the guy that "fixes" things. His previous books about privacy were mostly REACTIVE and he focused on ways to hide information, clean up an online presence, and sanitize public records to avoid unwanted exposure. This **590 page book** is PROACTIVE. It is about starting over. It is the complete guide that he would give to any new client in an extreme situation. It leaves nothing out, and provides explicit details of every step he takes to make someone completely disappear, including document templates and a chronological order of events. The information shared in this book is based on real experiences with his actual clients, and is unlike any content ever released in his other books. The stories are all true, with the exception of changed names, locations, and minor details in order to protect the privacy of those described.

PERSONAL DATA REMOVAL

The removal process of your information is usually easy, with a few exceptions. Most services will offer you a website to request they remove your details. These direct links are often hidden within fine print or rarely visited pages. My goal in this workbook is to take the research out of the removal process and simply tell you where to start. Instead of explaining each step of the process for every service, I decided to compress this information throughout this workbook. Each removal summary will display several pieces of information about each service that I have identified. The following structure outlines the data that is displayed throughout this chapter. The final line will have blank forms for you to document your work and successful removals.

Service: The name of the service **Website**: The website of the service

Removal Link: The direct link for online removal, if available

Privacy Policy: Page containing detailed instructions

Contact: Any email addresses that will reach an employee responsible for removal **Requirements**: Any special requirements, such as a copy of an ID or written request

Notes: Any special instructions

Date: (date of request) Response: (response received) Verified: (confirm removal)

The "Date" field should list the date that you submitted the removal request. The "Response" should include any details received from the service after your submission. The "Verified" option should be used to "check-off" that service after you have confirmed that your details have been removed. All resources are listed in alphabetical order for easy reference.

The data supplied in the email address field could be used for unsuccessful removal attempts. If the official removal process for that service does not meet your needs, I recommend sending an email to the company. I have tried to locate email addresses of employees that appear to be responsible for removal requests. I suggest the following message be sent from the anonymous email address that you created earlier.

I have been unsuccessful in removing my personal information from your website. Per the information provided from your legal privacy policy, please remove the following details from your service.

Full Name (As appears on their service)
Physical Address (As appears on their service)
Telephone Number (ONLY if it appears on their service)
Email Address (ONLY if it appears on their service)

THE "MOST BANG FOR YOUR BUCK" REMOVALS:

Spokeo, Radaris, Whitepages, Intelius, BeenVerified, Acxiom, Infotracer, Lexis Nexis, TruePeopleSearch

These will trickle down to many of the smaller sites mentioned on the following pages. I recommend that people start with these first, wait about one week, and then start to tackle the remaining sites. If a site asks for a photo ID, just upload something random from thispersondoesnotexist.com, they usually don't look at the picture.

There are now dozens of companies using this workbook as a guide to remove your online data for a fee. They will never remove everything. At best, they will tackle the easy options and move on to the next customer offering money for a false sense of security. At worst, they will push missed websites with your personal details to the first page of Google results. I never recommend paying anyone to remove your online data, including myself. It's not as hard as it may seem. Some companies sell the information included here for free as their own. Please make people aware that this data is free on my site, and don't let them get swindled.
