**DESCRIPTION**

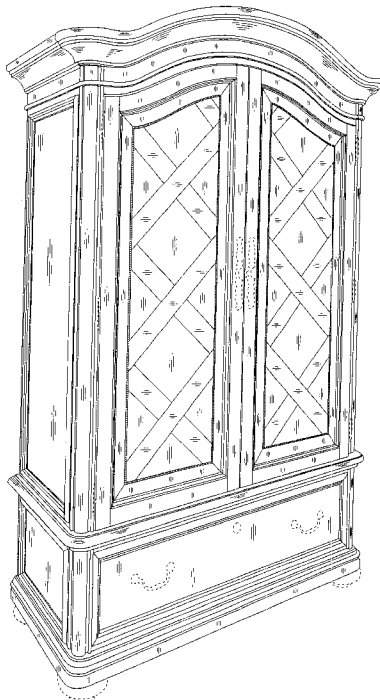
FIG. 1 is a left front perspective view of an armoire showing my new design;

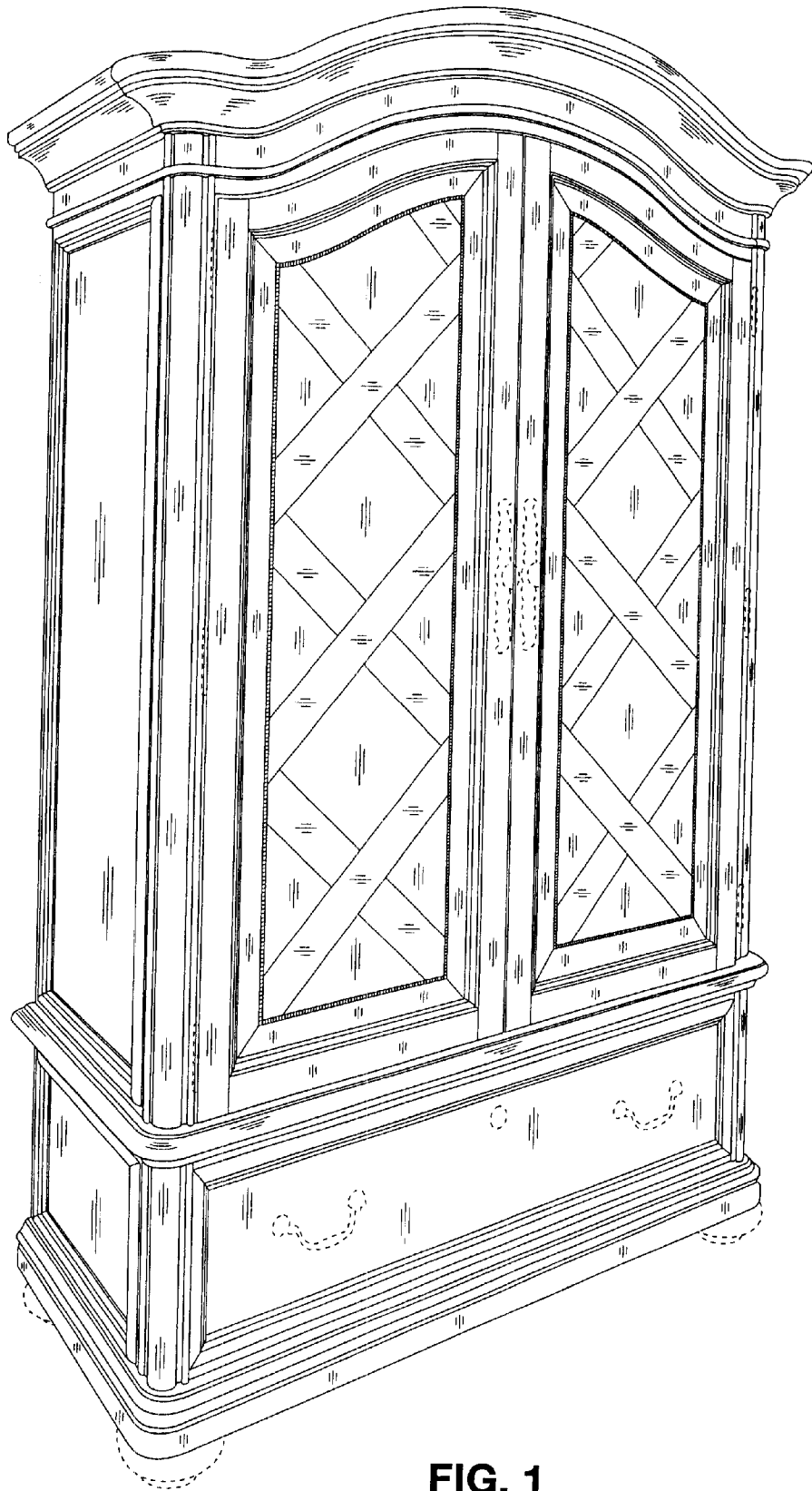

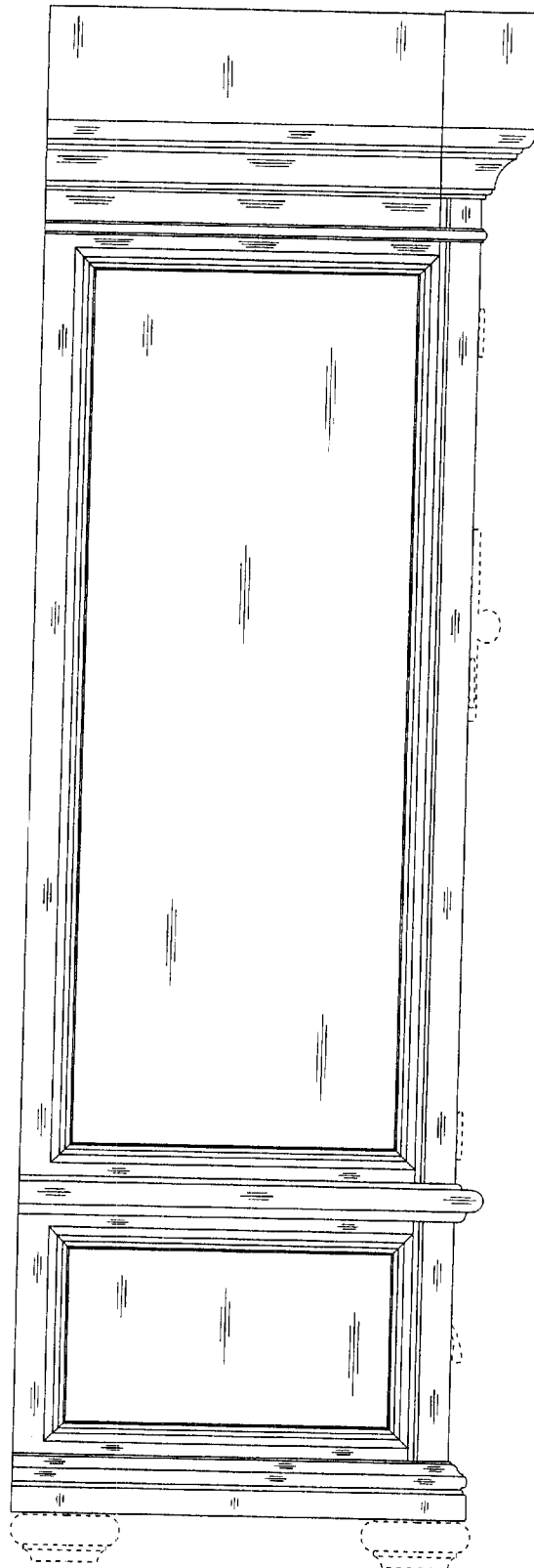

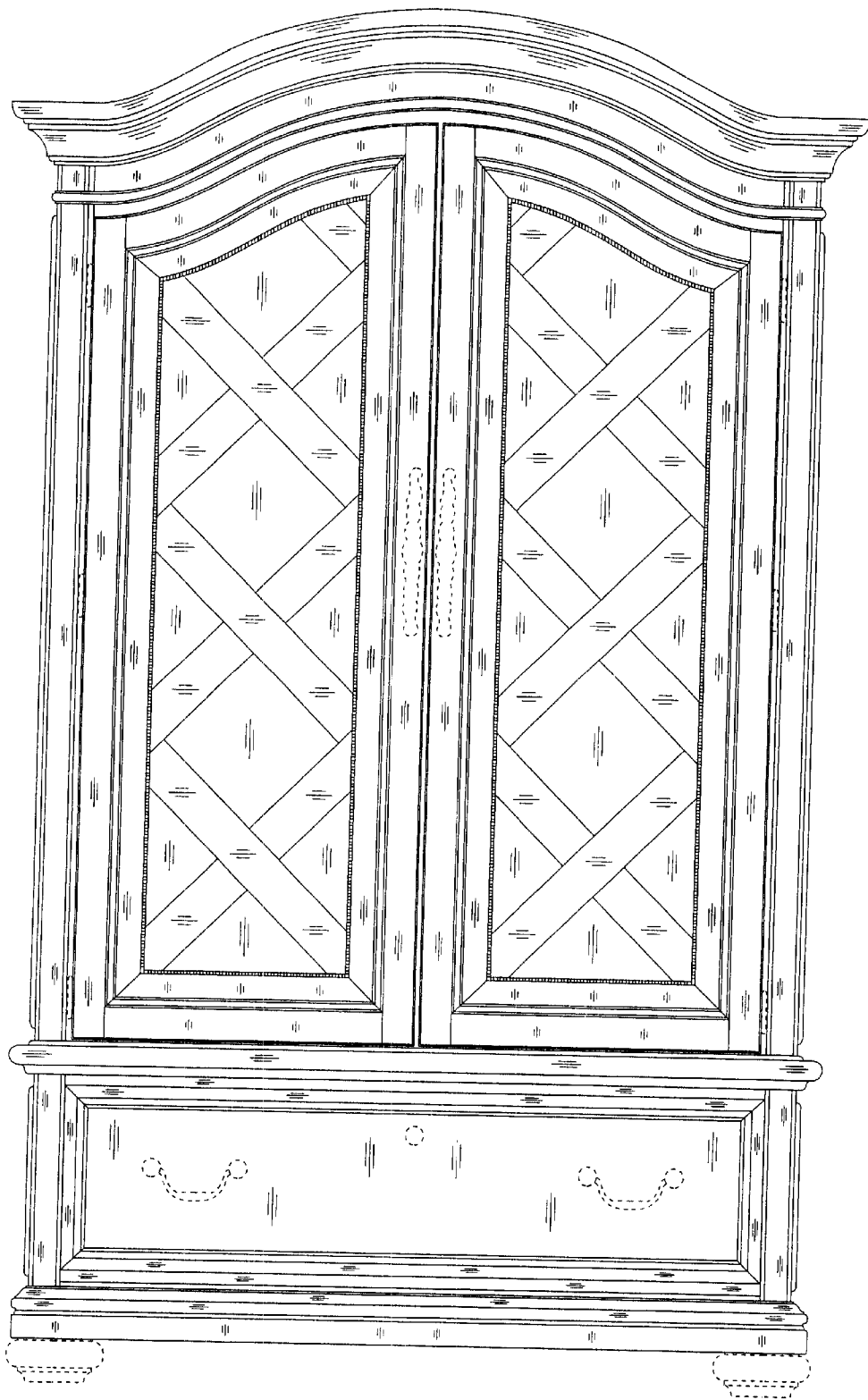
