FIG. 4 is a front view of the set top box of FIG. 1;

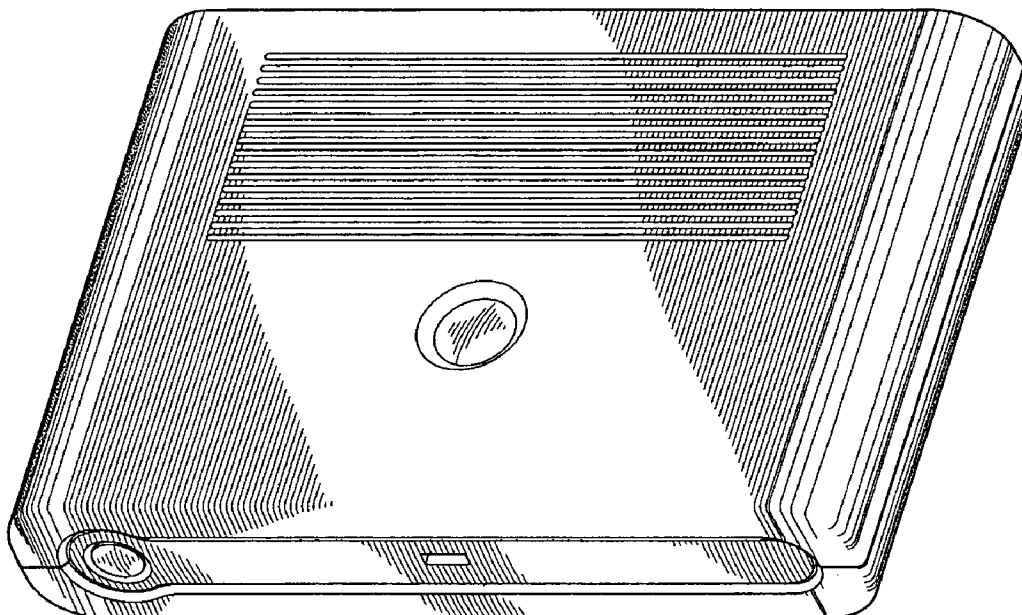
FIG. 5 is a rear view of the set top box of FIG. 1;

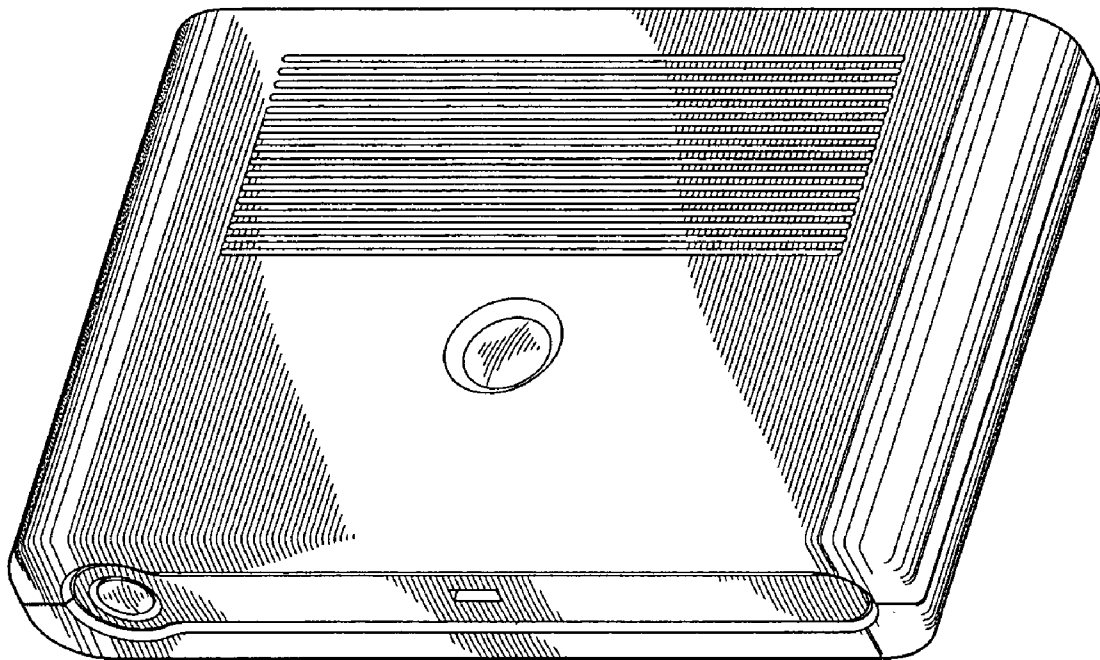
FIG. 6 is a side view of the set top box of FIG. 1; and,

FIG. 7 is a side view of the set top box of FIG. 1.

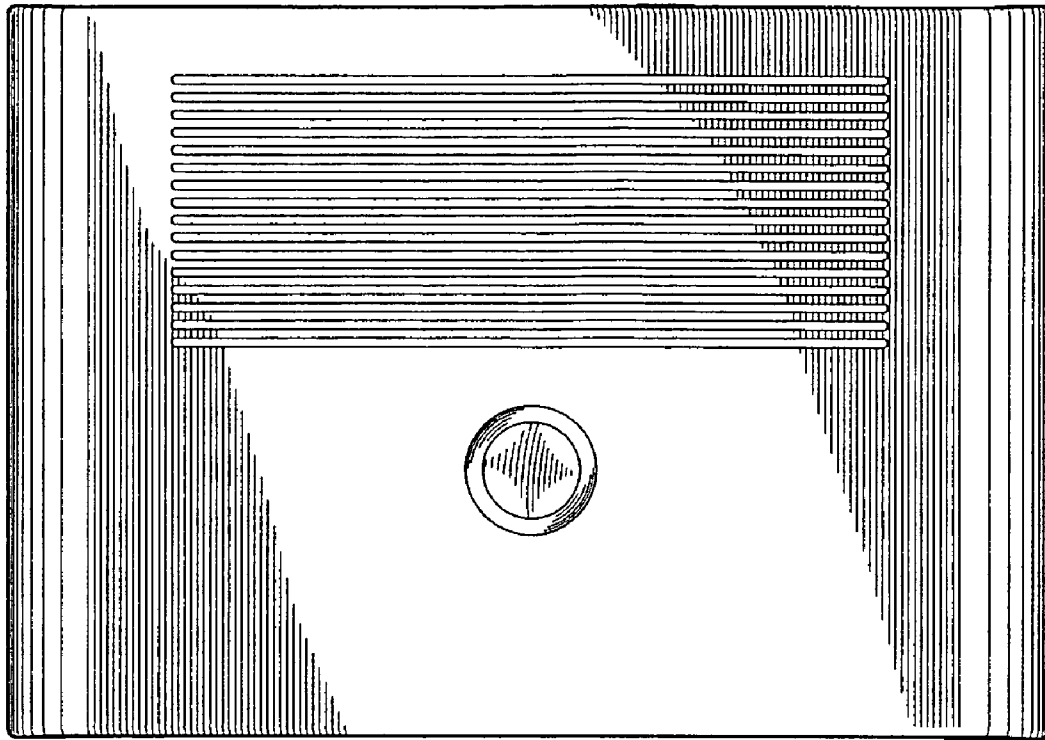

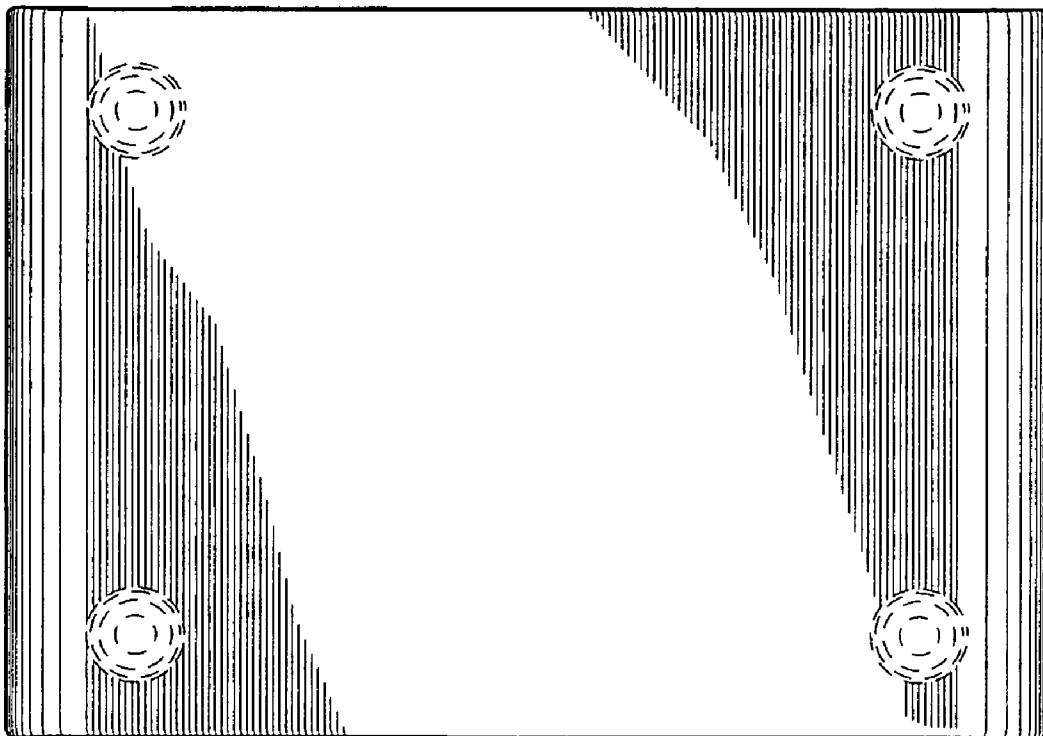

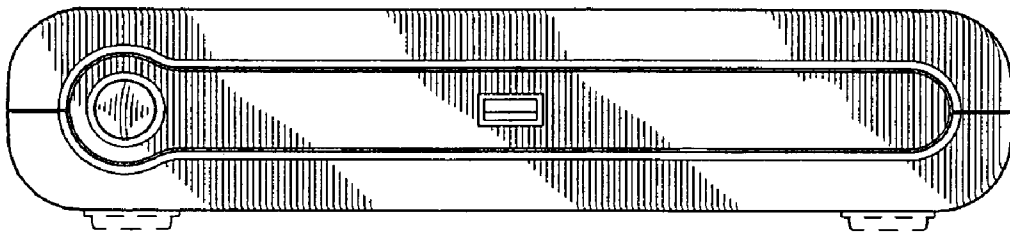

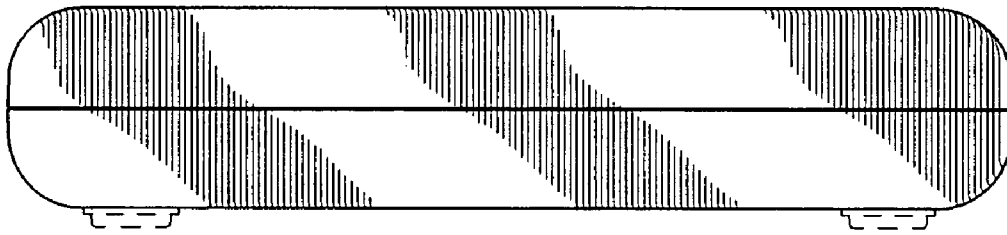

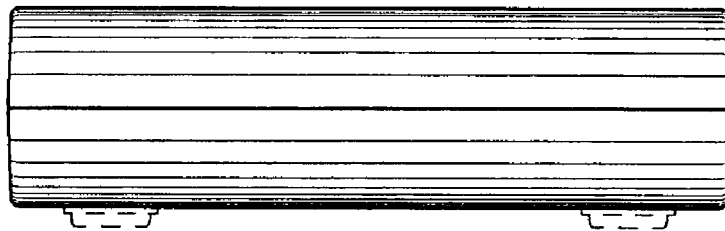

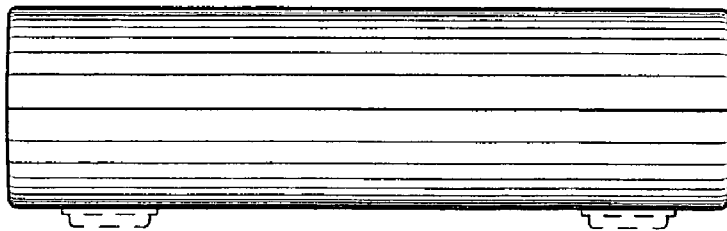
