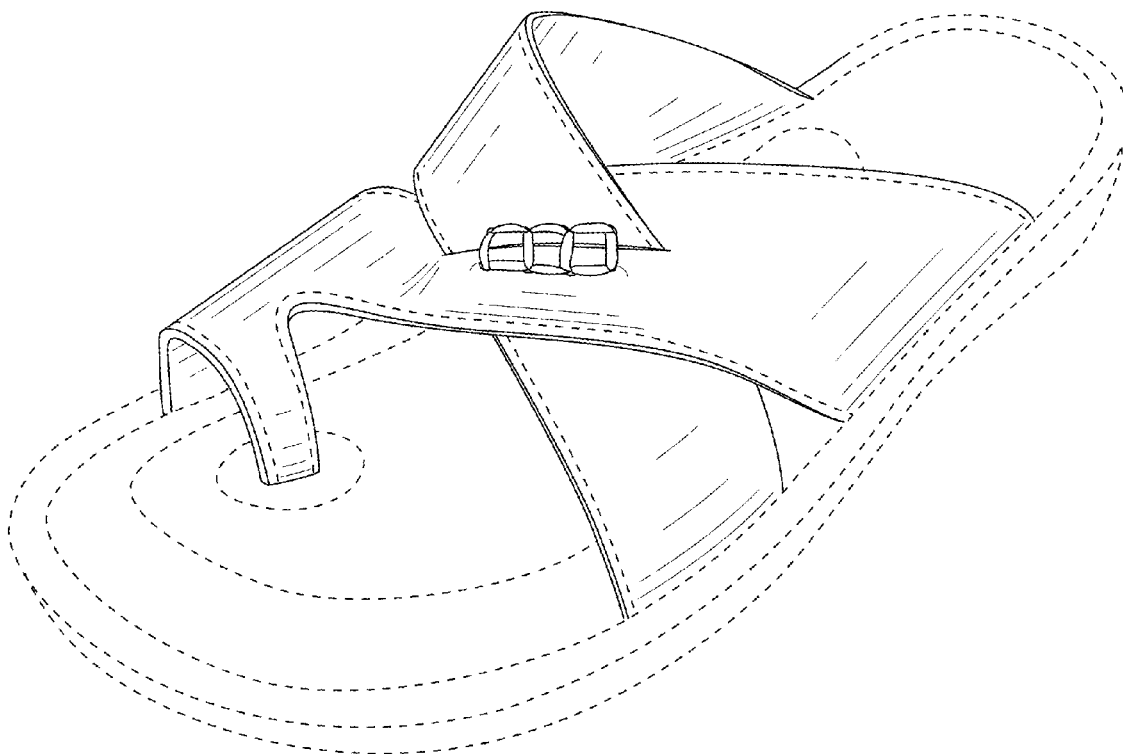
The ornamental design for an upper for a shoe, as shown and described.

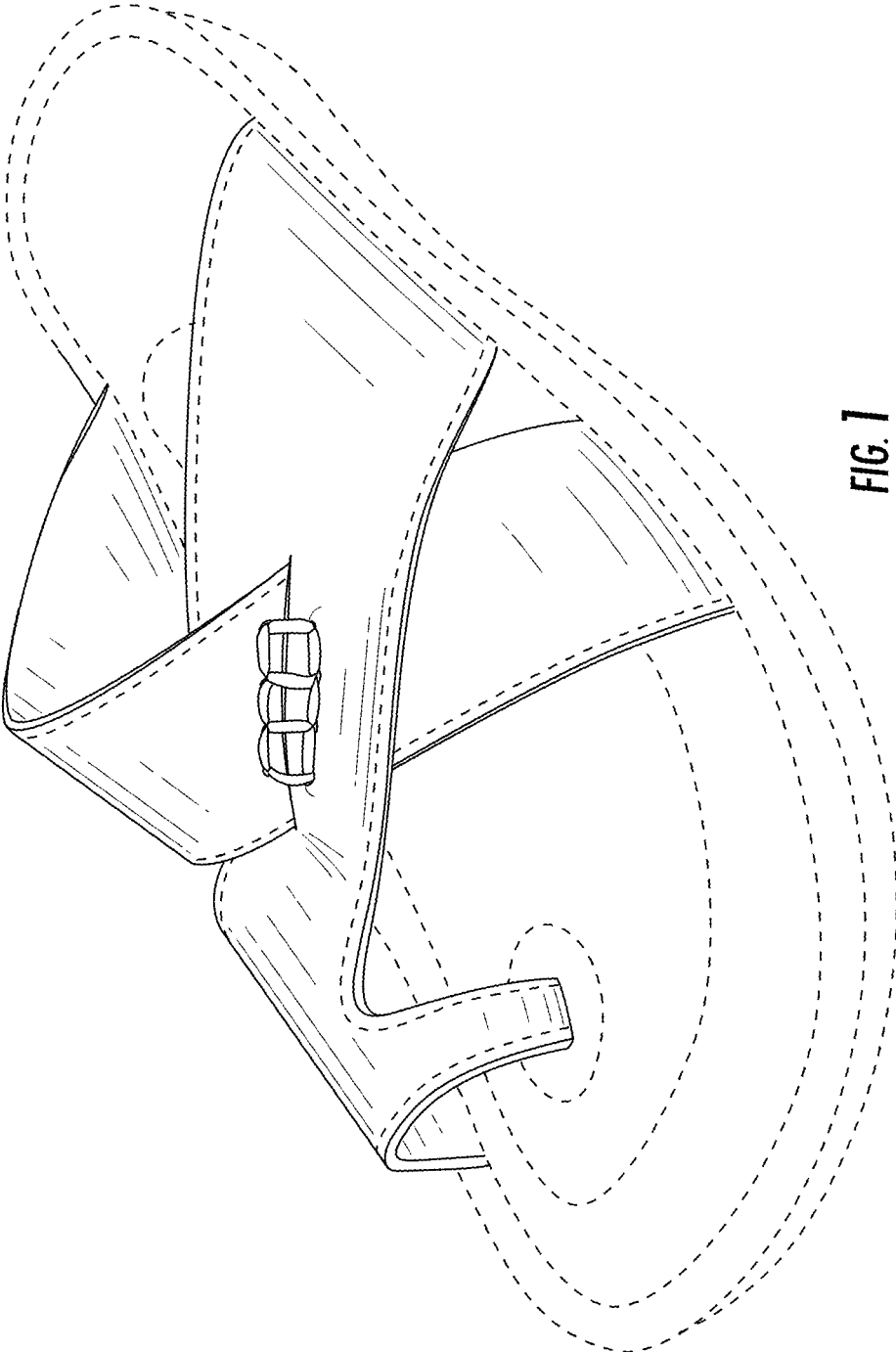

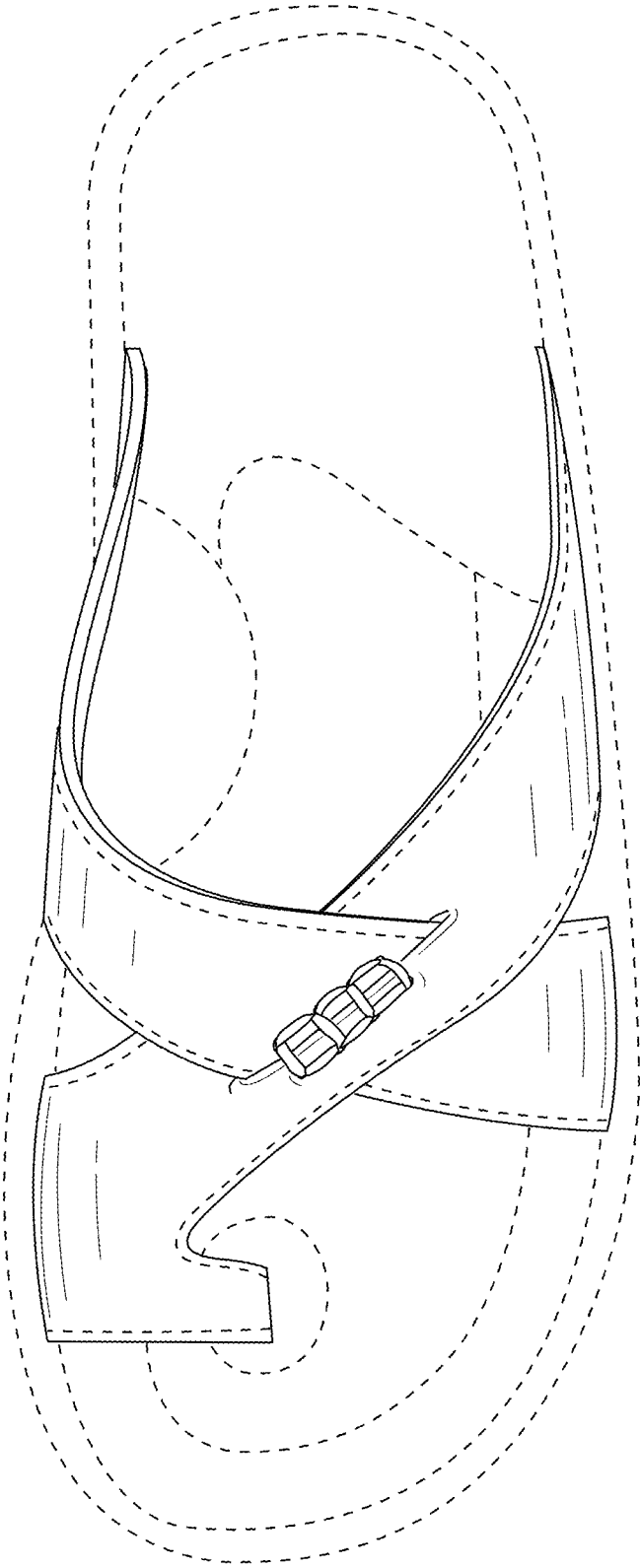

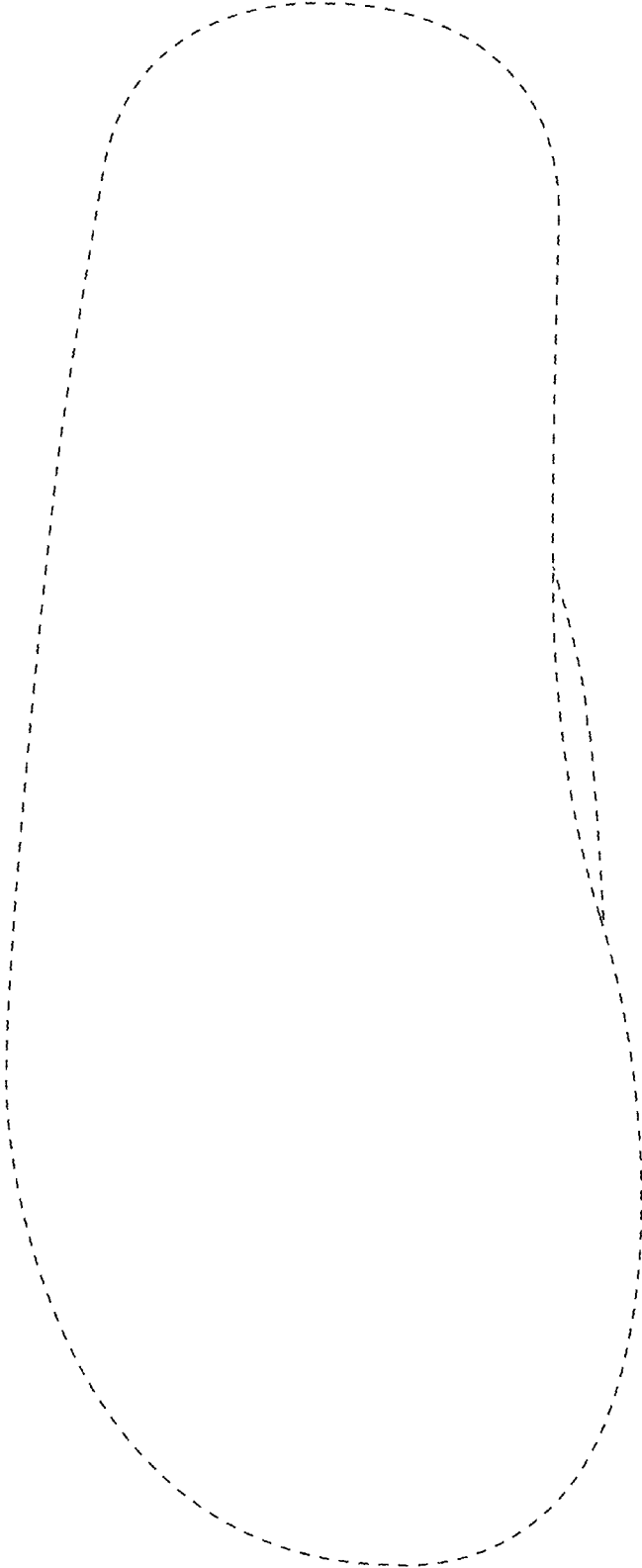

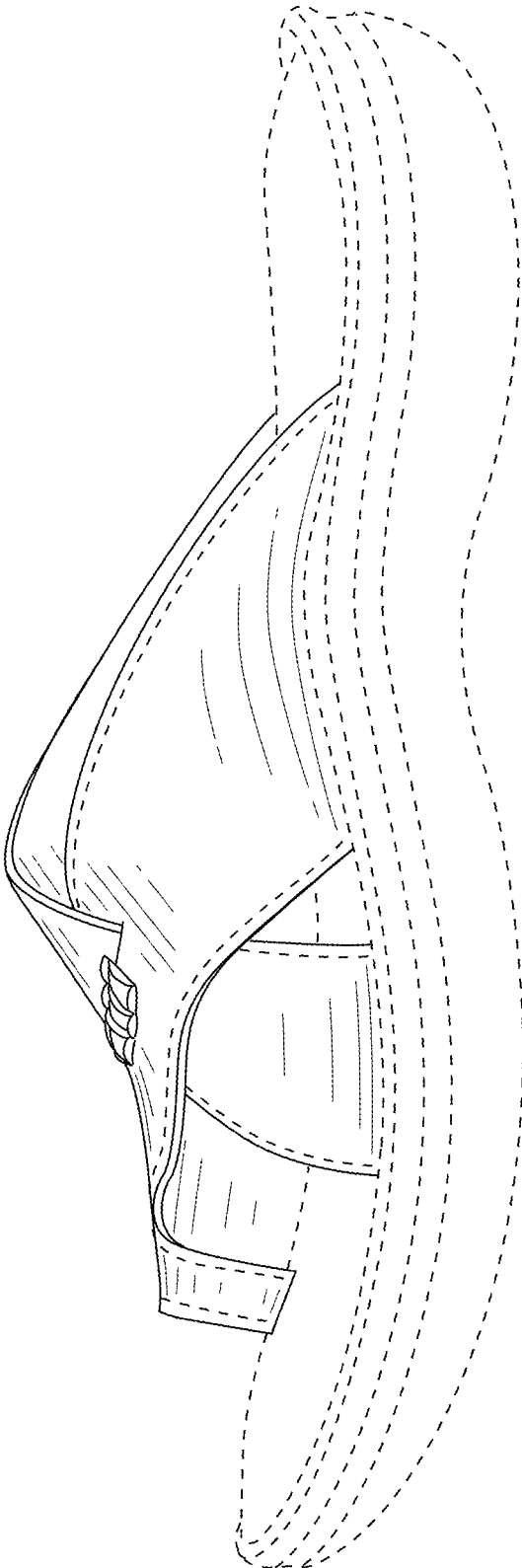

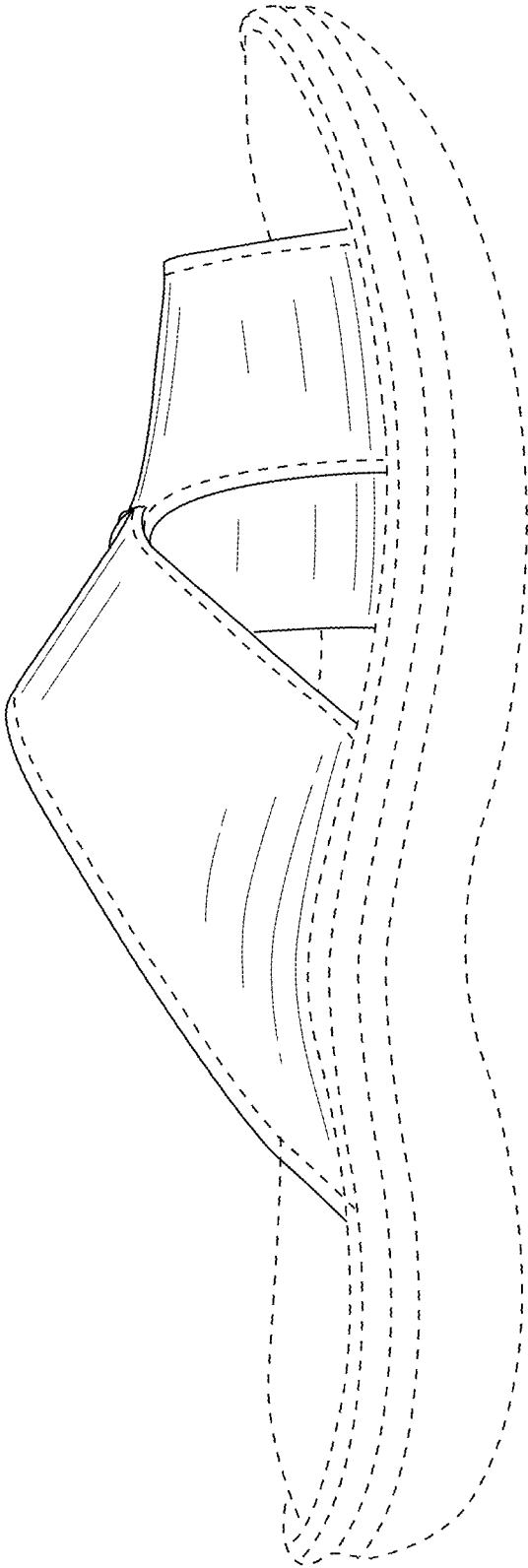

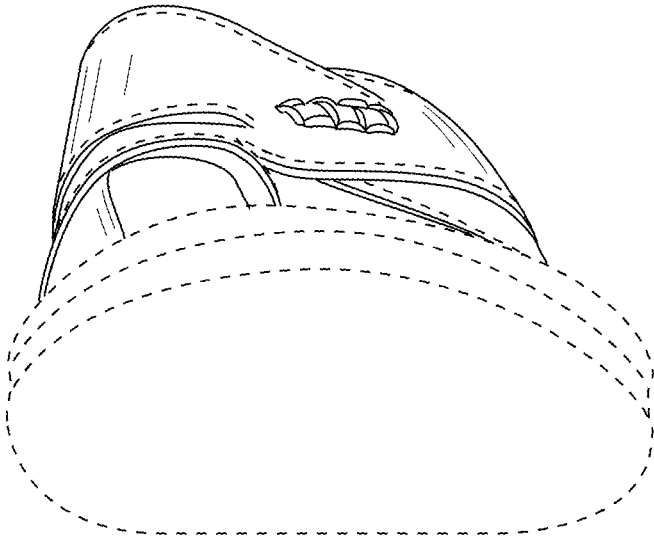

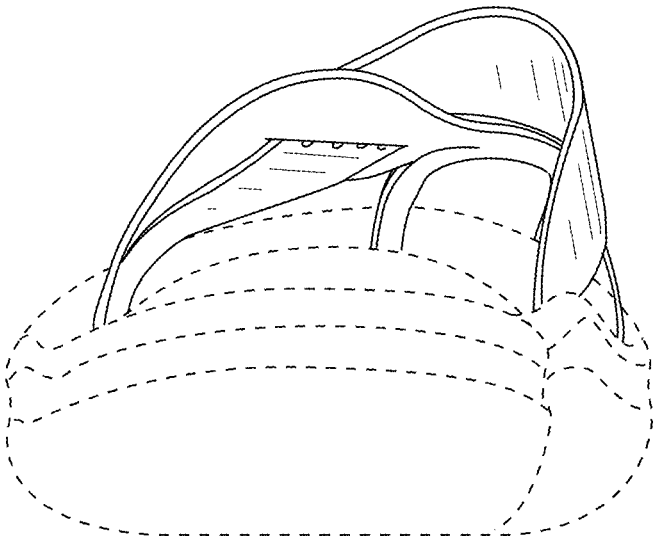
