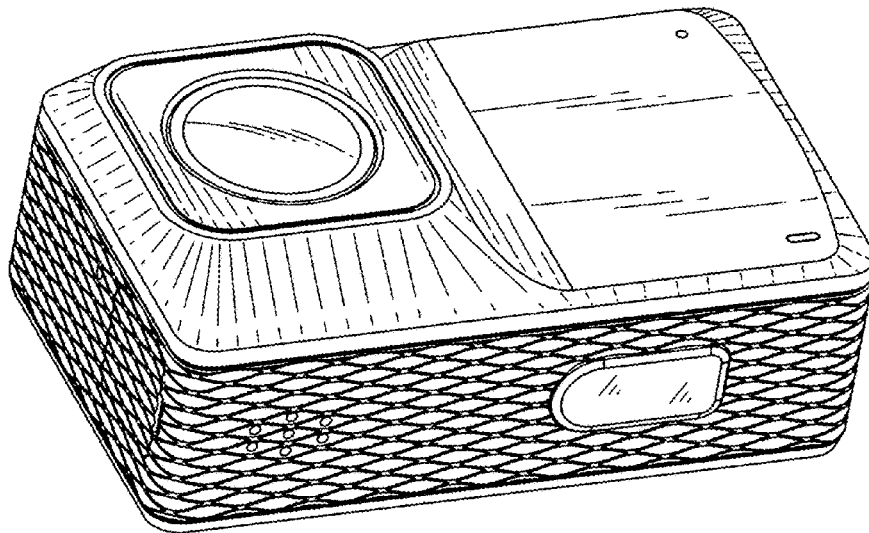
(57) **CLAIM**

The ornamental design for a sports camera, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a sports camera showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is an enlarged scale left side elevational view thereof;
FIG. 4 is an enlarged scale right side elevational view thereof;
FIG. 5 is an enlarged scale top plan view thereof;
FIG. 6 is an enlarged scale bottom plan view thereof; and,
FIG. 7 is a perspective view thereof.

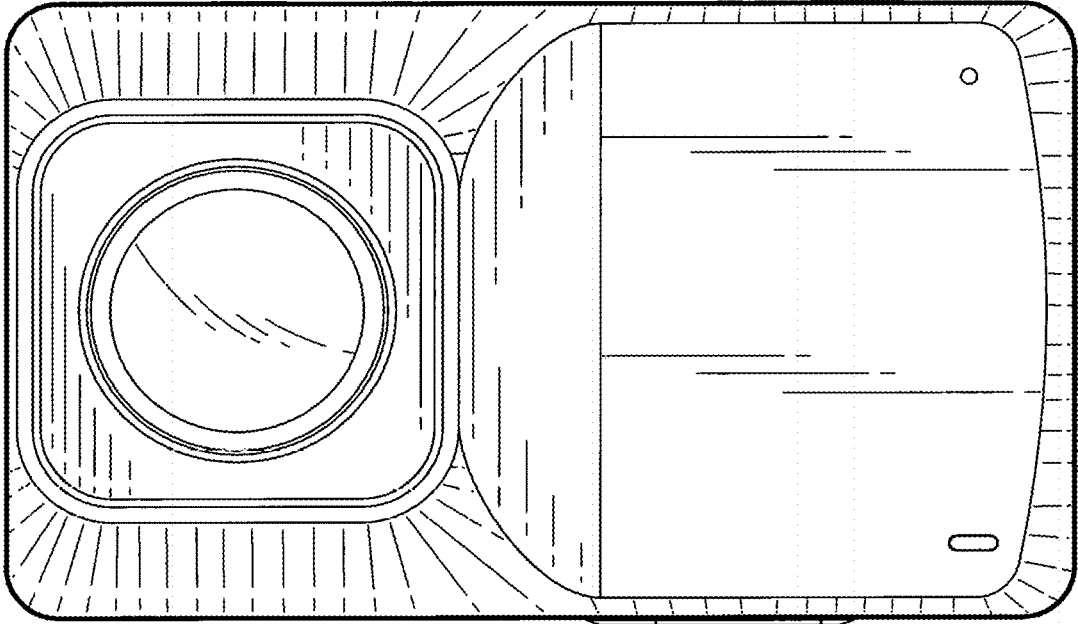

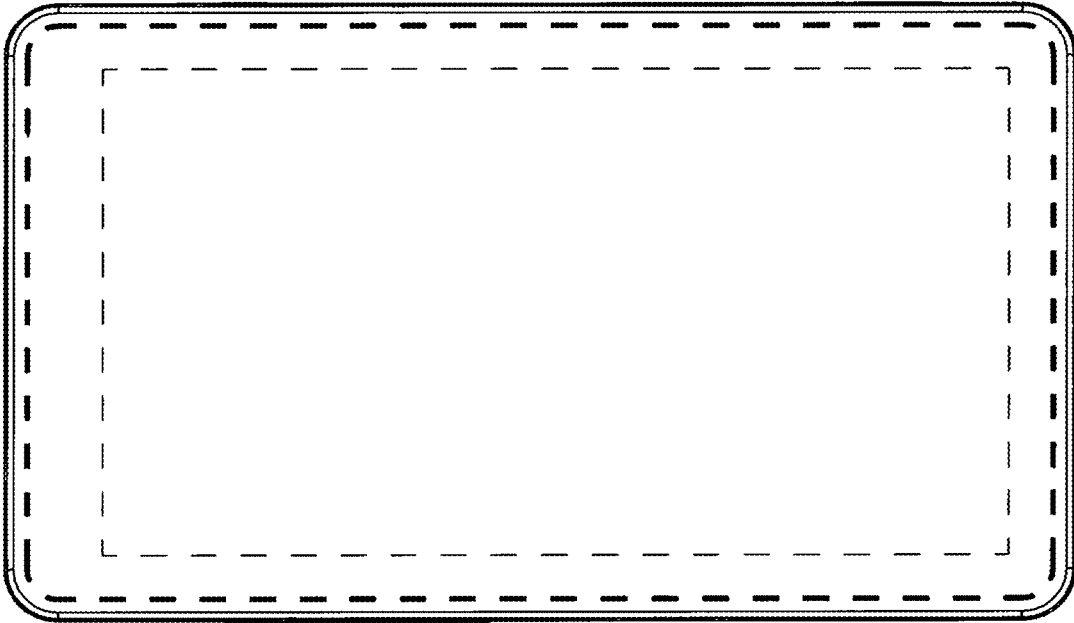

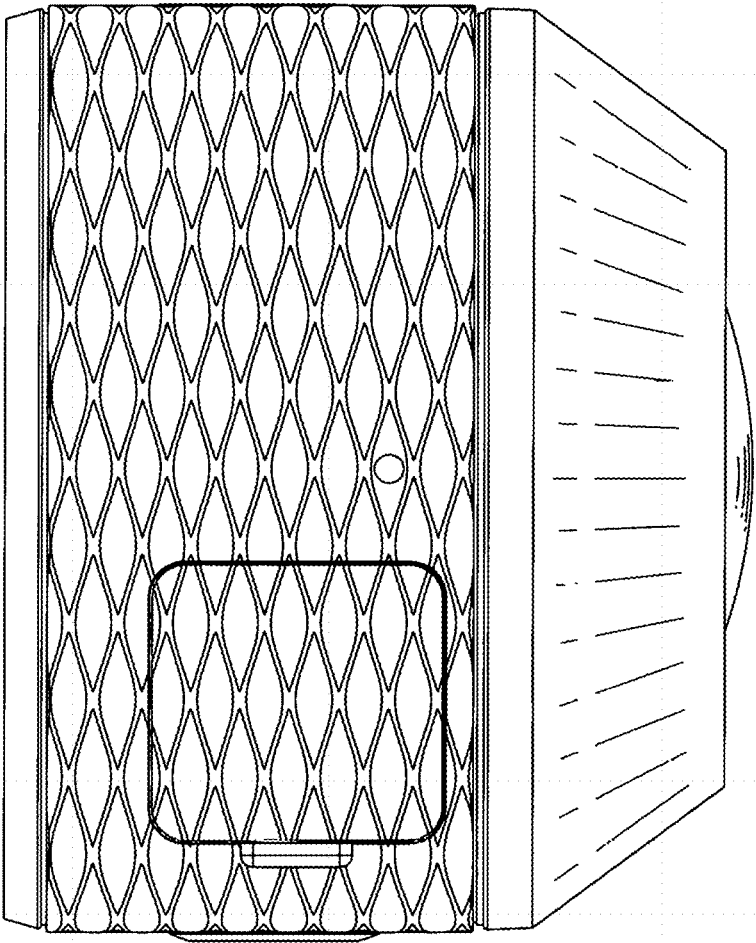

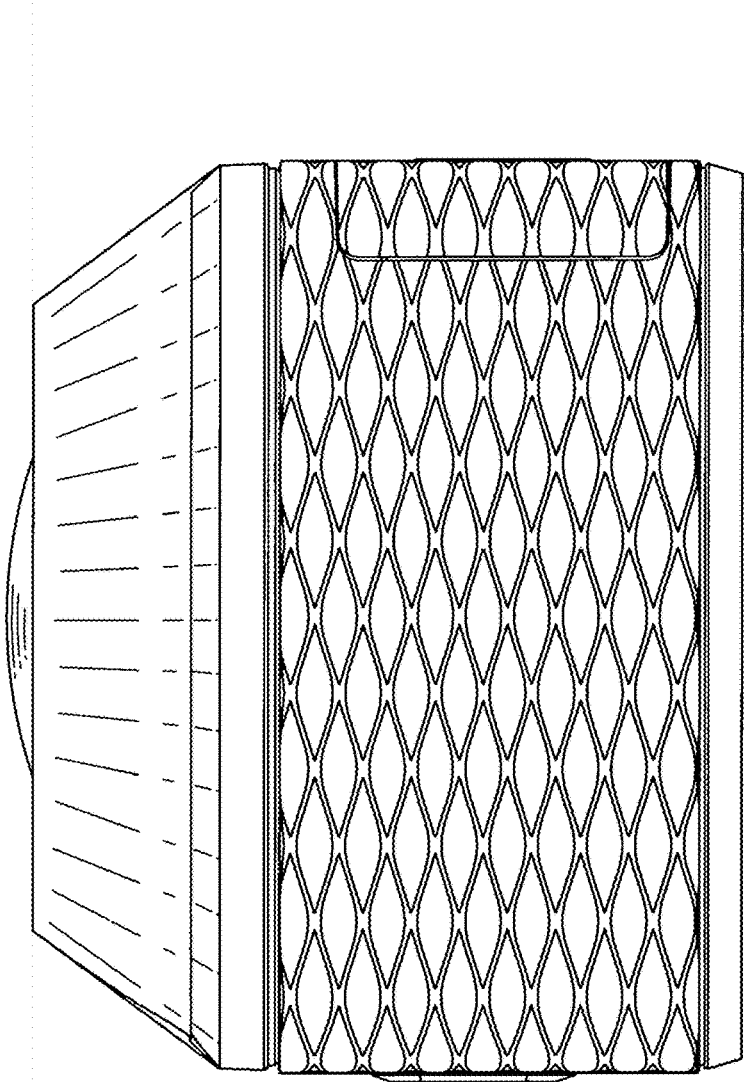

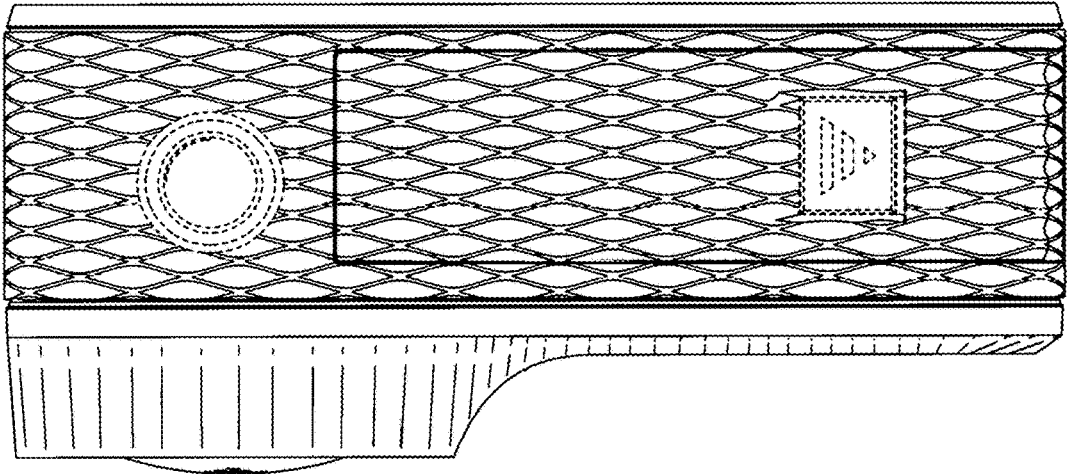

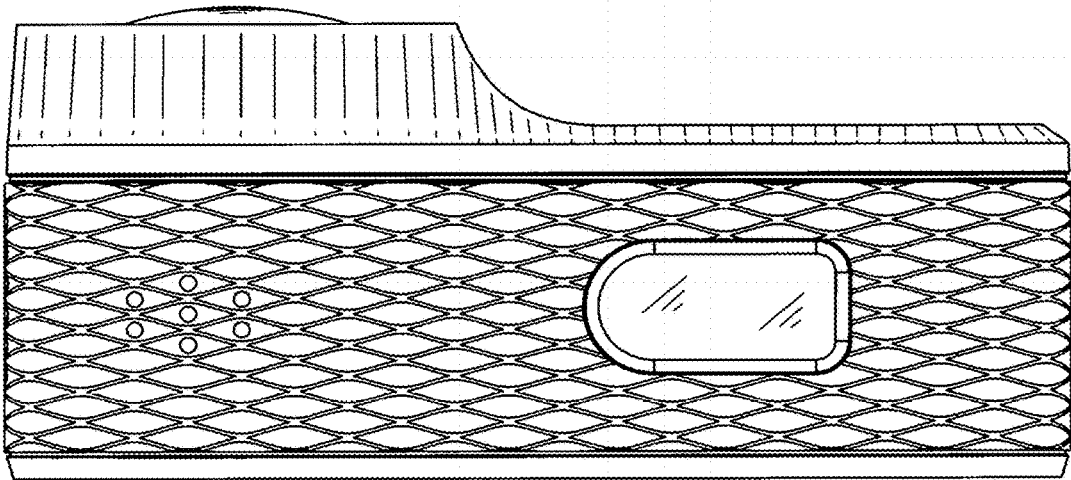

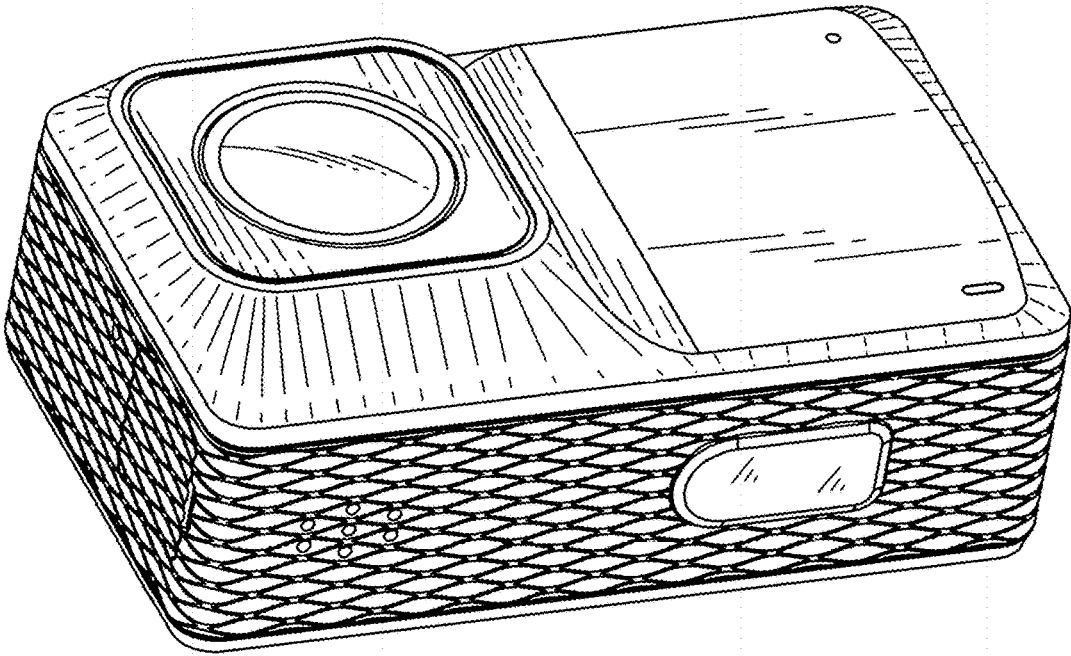
