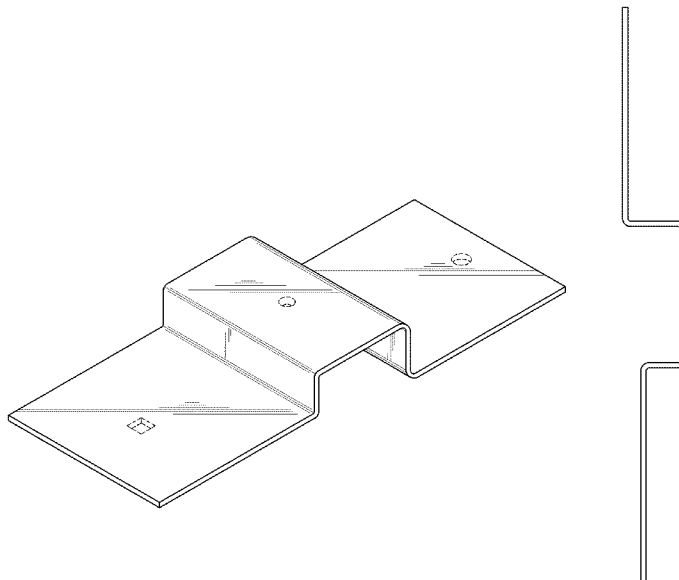
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a side, top perspective view of a bracket showing my new design;

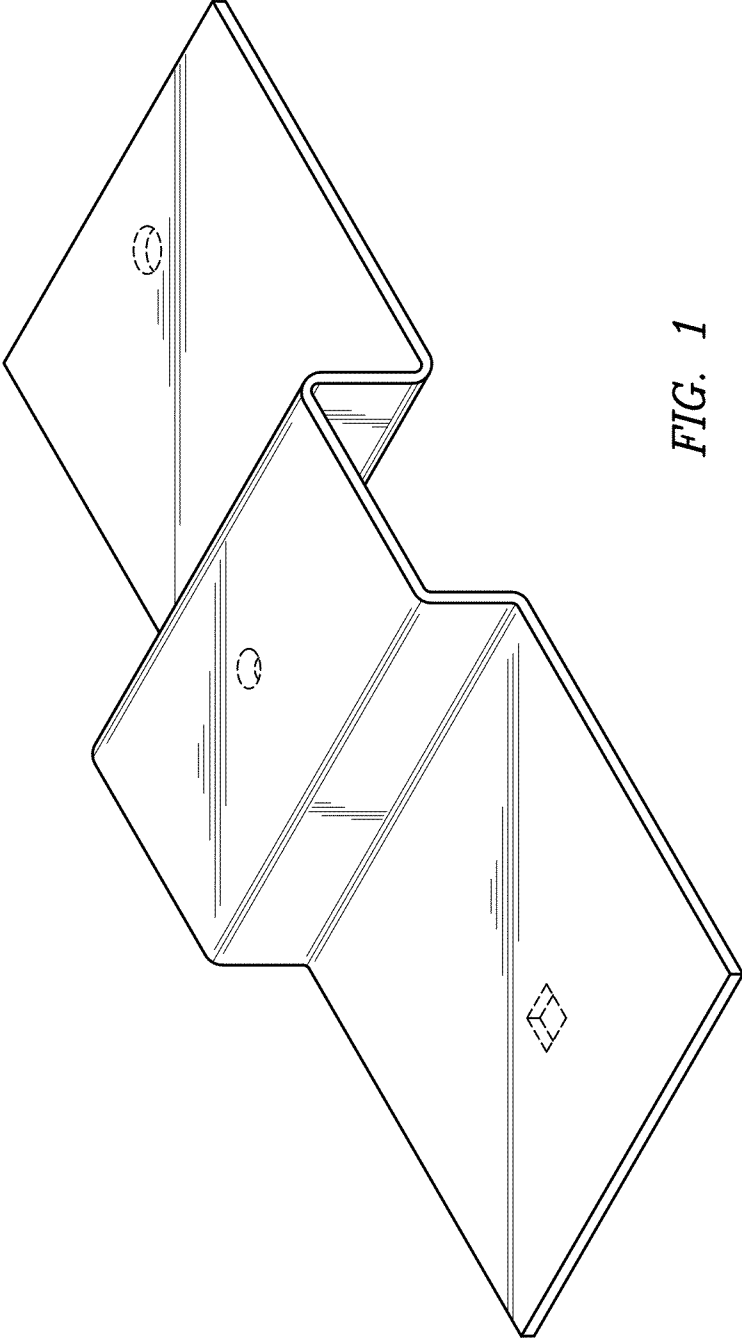

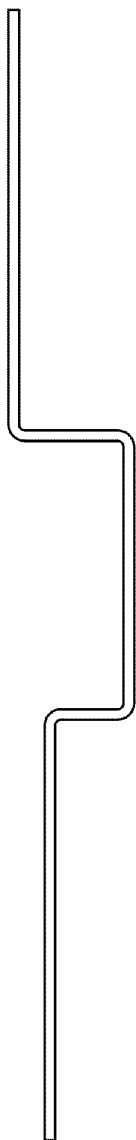

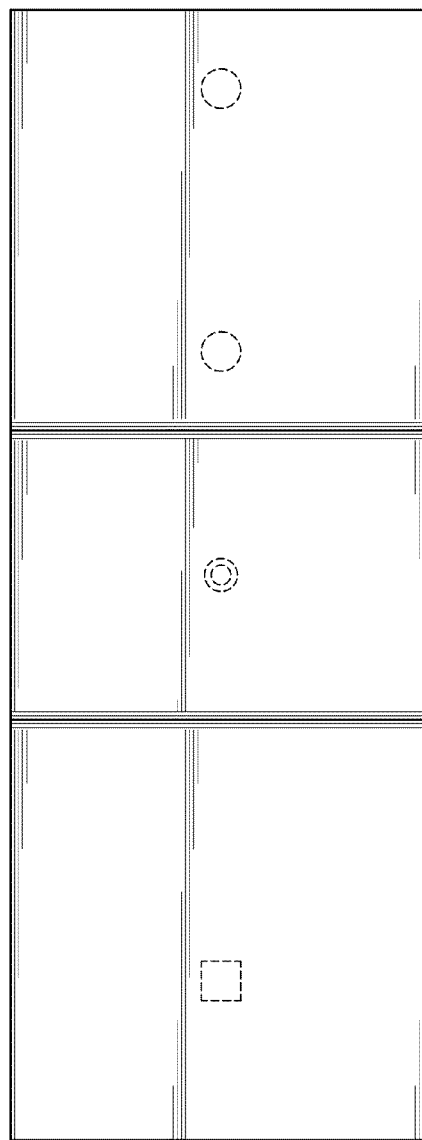

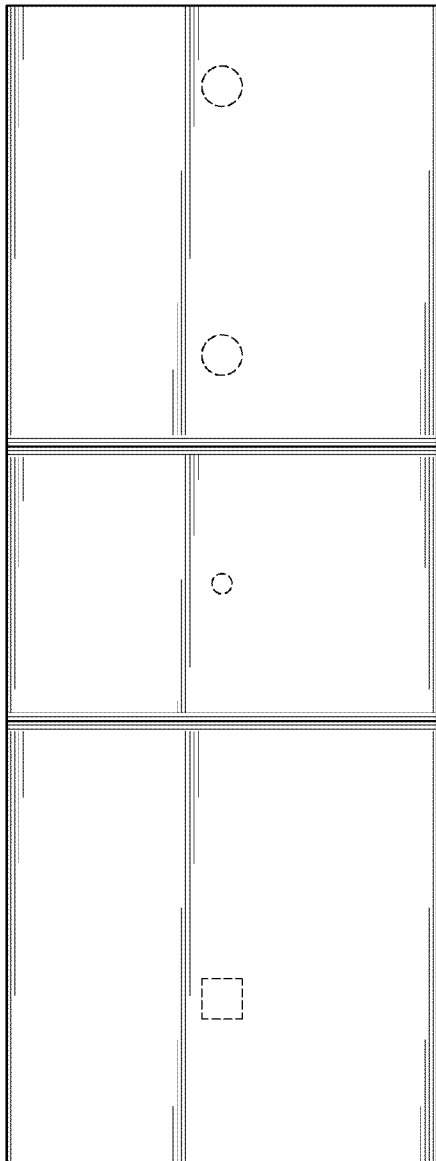
