[57] CLAIM

The ornamental design for a weight lifting glove, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a weight lifting glove showing my new design, the broken line showing of the human form and weight bar is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is an elevational view of a right side thereof;

FIG. 5 is an elevational view of a left side thereof;

FIG. 6 is an elevational view of one end thereof;

FIG. 7 is an elevational view of an opposite end thereof;

FIG. 8 is a front perspective view of a second embodiment of a weight lifting glove showing my new design, the broken line showing of the human form and weight bar is for illustrative purposes only and forms no part of the claimed design;

FIG. 9 is a rear elevational view thereof;

FIG. 10 is a front elevational view thereof;

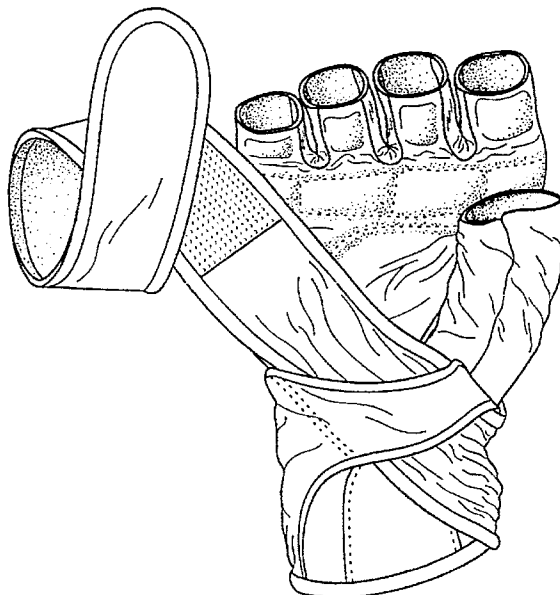
FIG. 11 is an elevational view of a right side thereof;

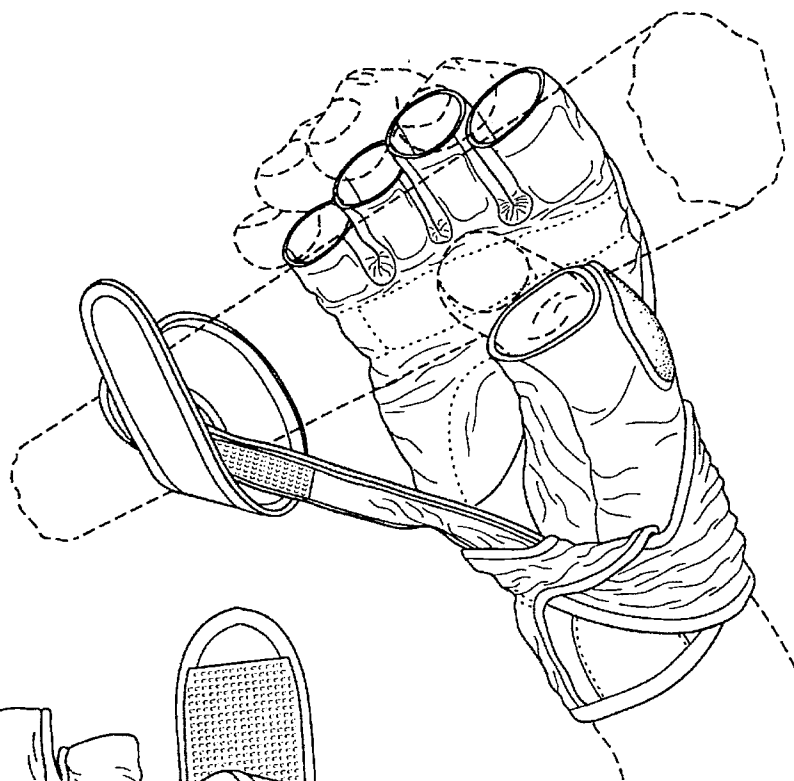

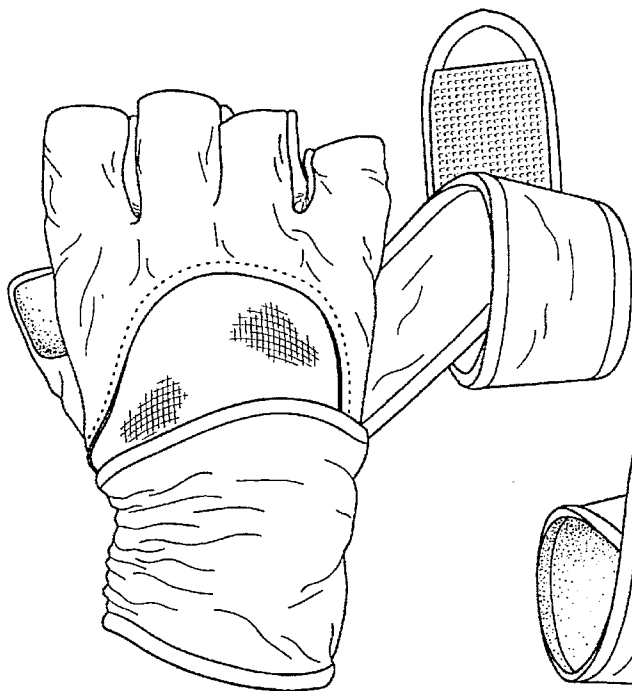

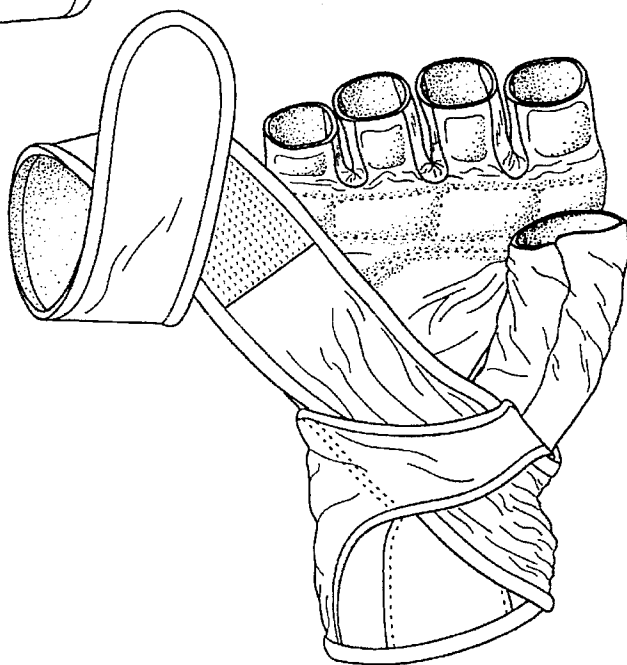

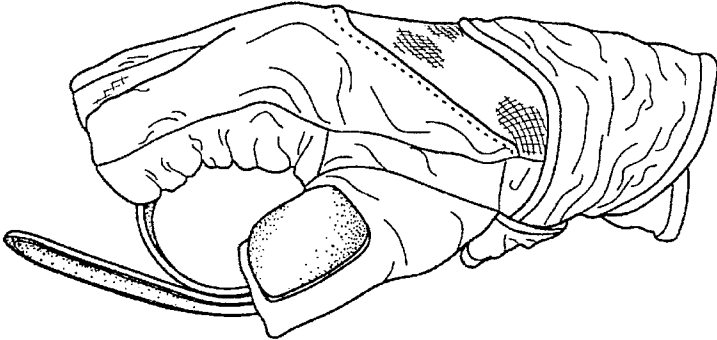

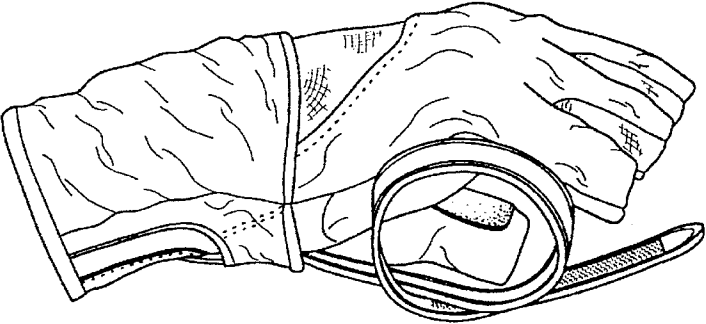

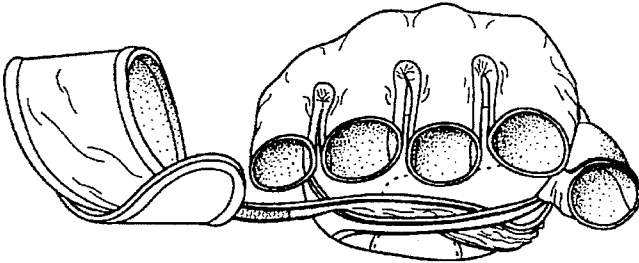

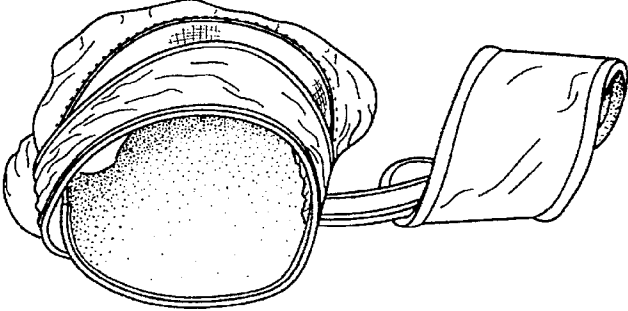

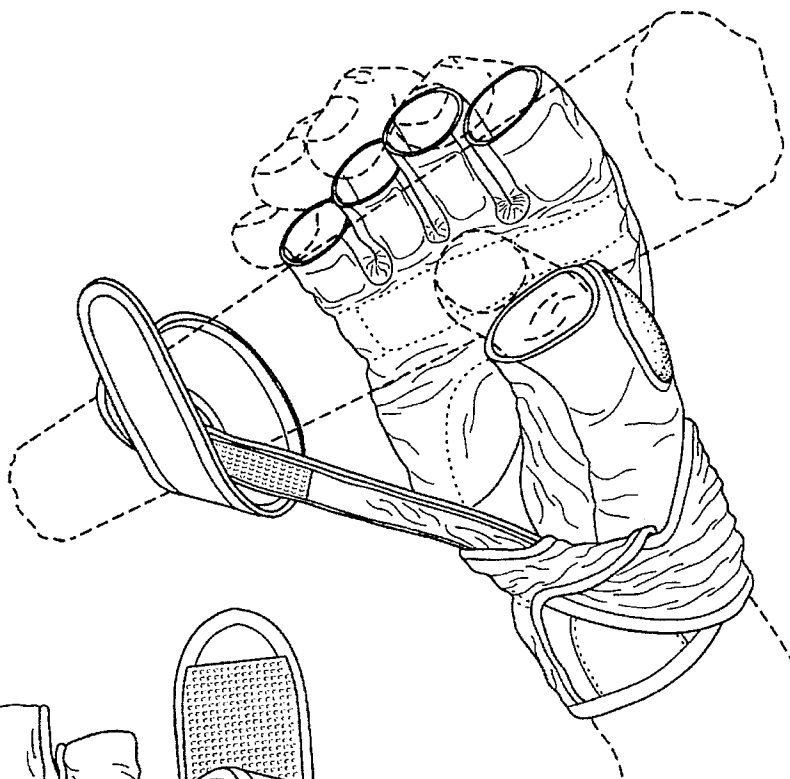

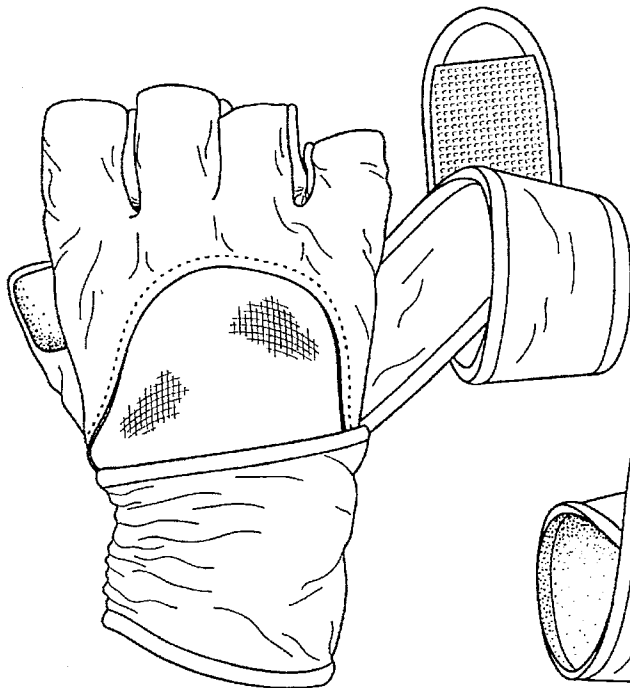

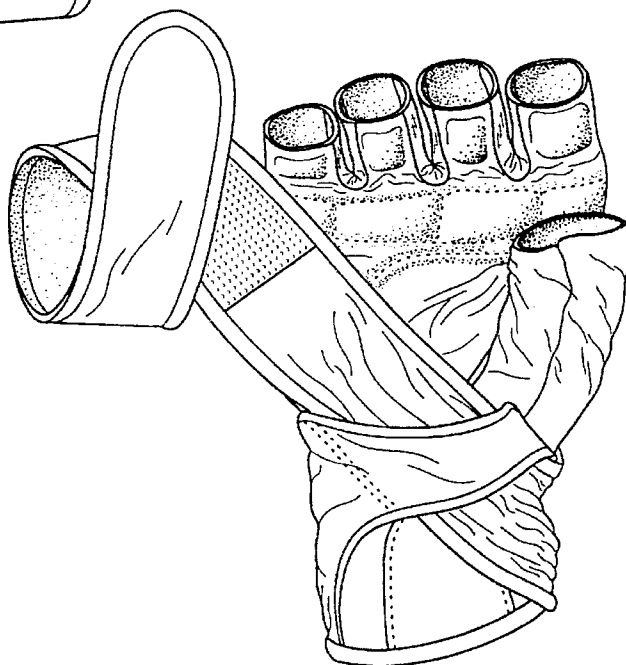

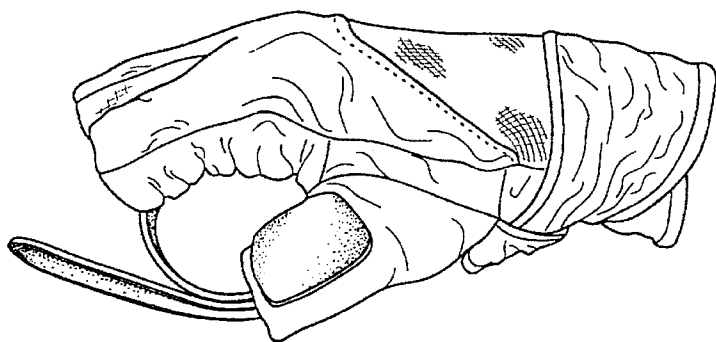

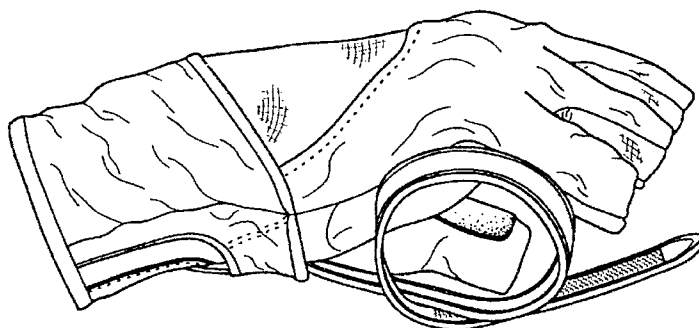

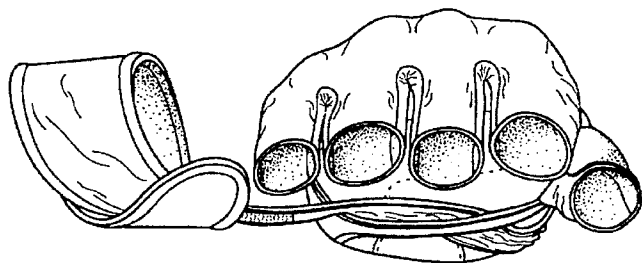

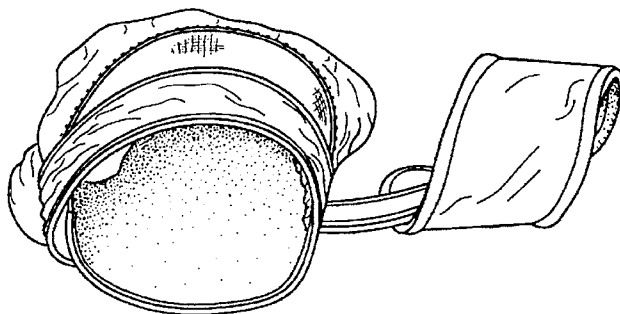
