I claim the ornamental design for the vent, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the vent embodying my design;

FIG. 2 is a bottom perspective view thereof;

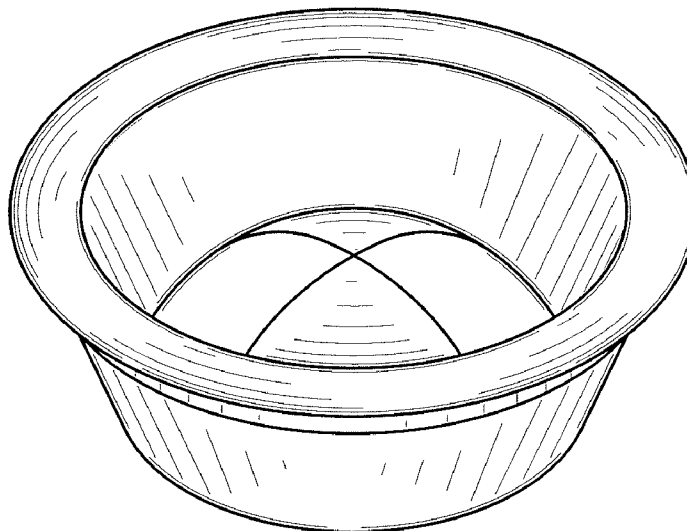
FIG. 3 is a top plan view thereof;

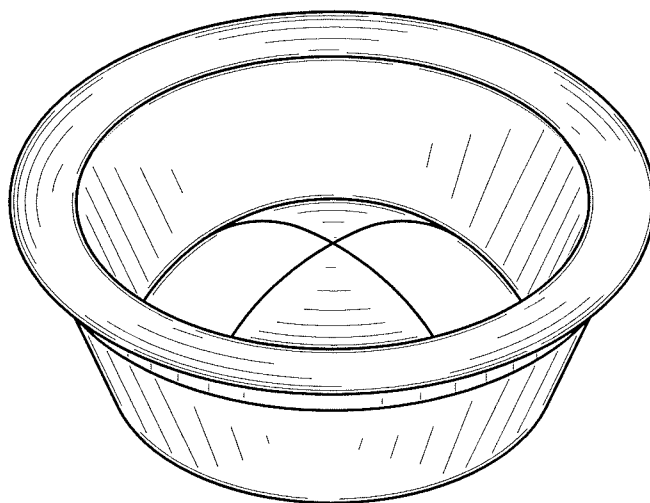

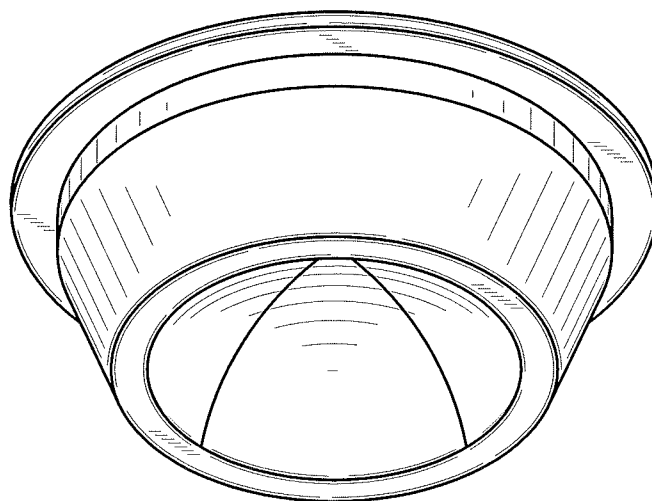

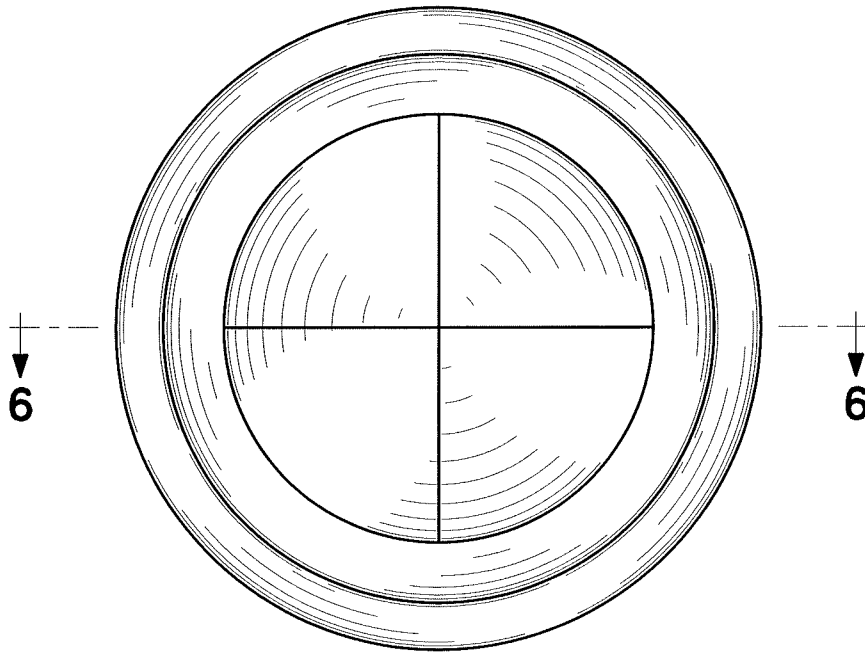

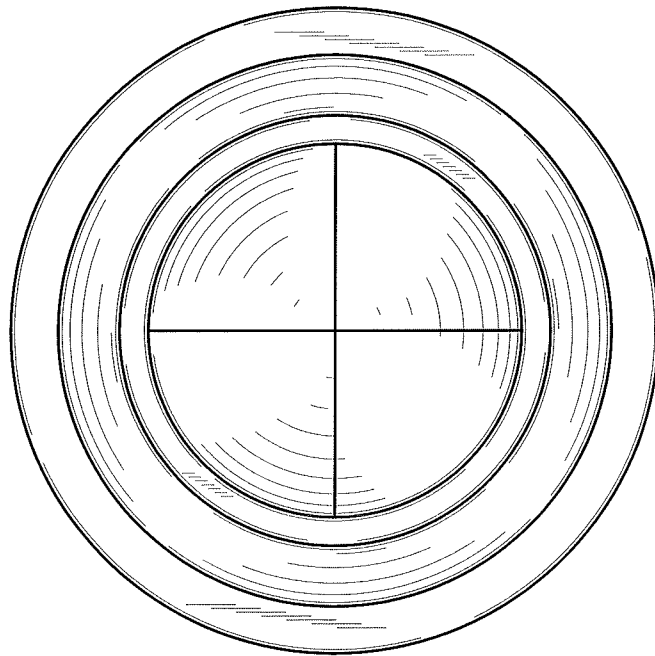

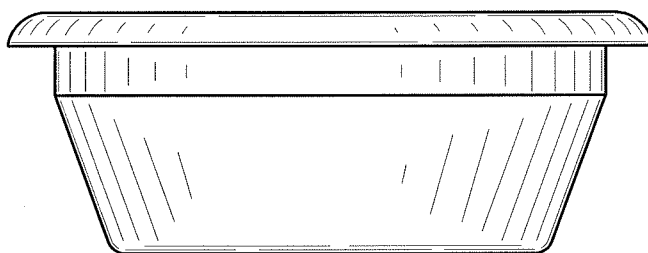

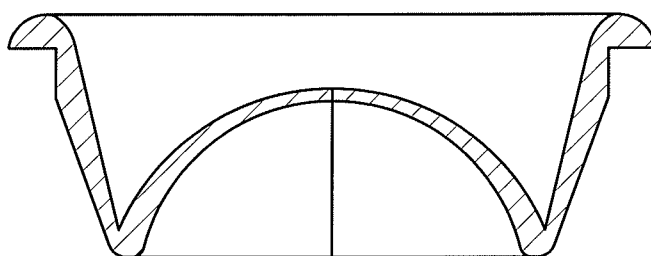
