CLAIM

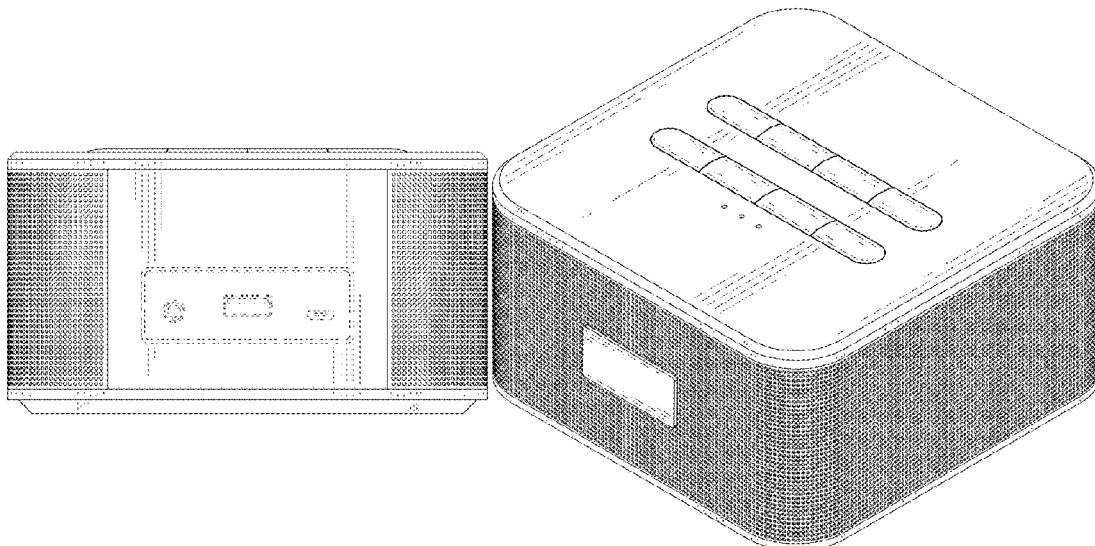
The ornamental design for a sound machine, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of an embodiment of a sound machine showing the claimed new design;
FIG. 2 is a rear elevation view of the sound machine;
FIG. 3 is a left side elevation view the sound machine;
FIG. 4 is a right side elevation view the sound machine;
FIG. 5 is a top plan view the sound machine;
FIG. 6 is a bottom plan view the sound machine;
FIG. 7 is a first perspective view the sound machine;
FIG. 8 is a second perspective view the sound machine; and,
FIG. 9 is an enlarged view of design features comprised within a circle IX in FIG. 8.

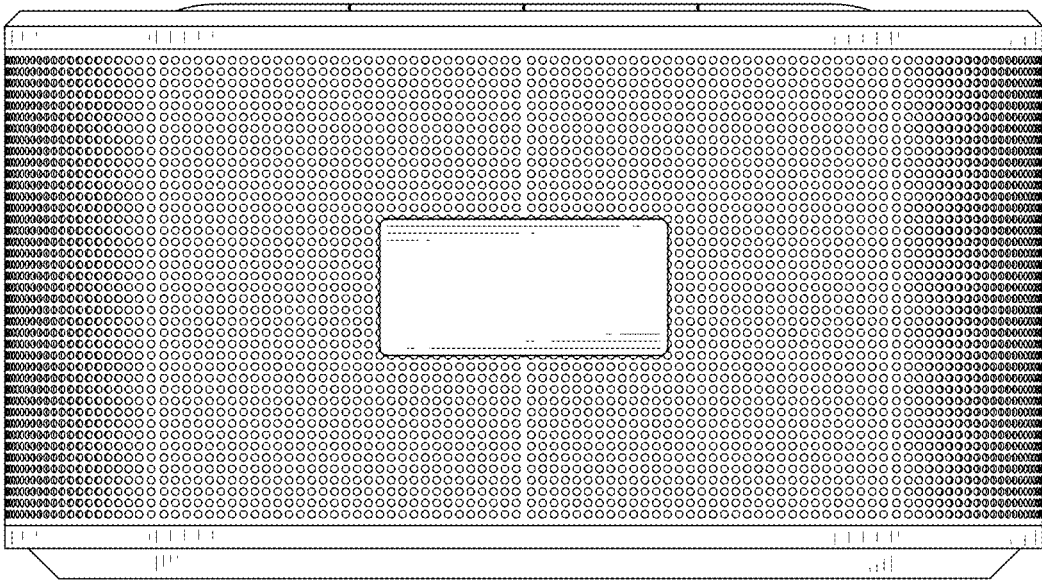

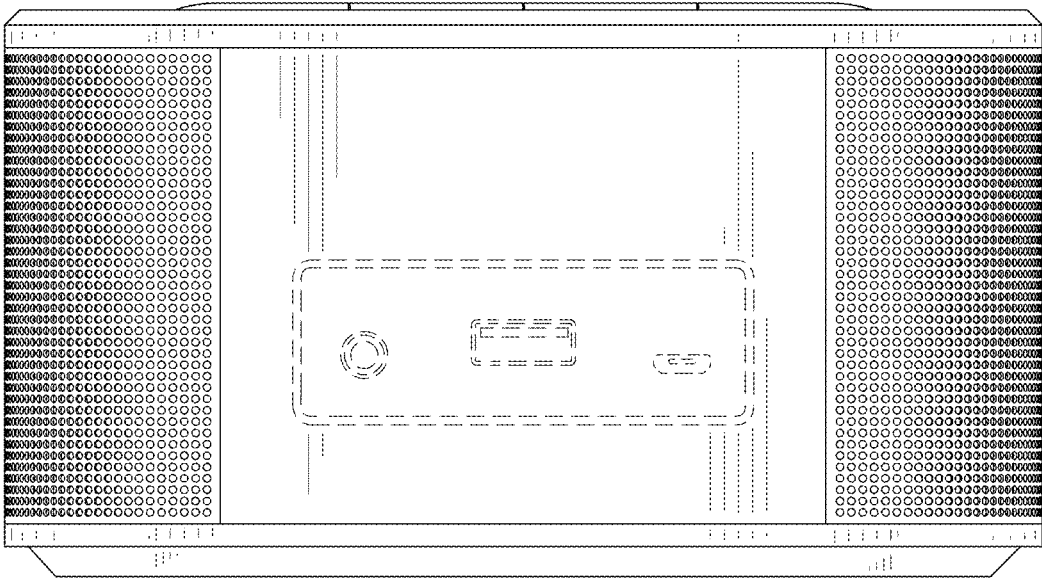

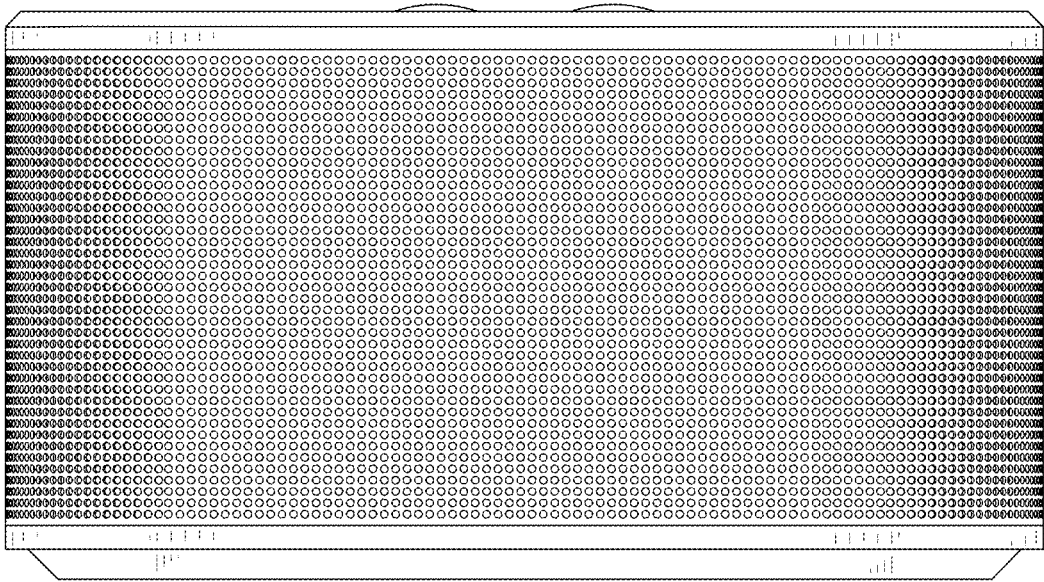

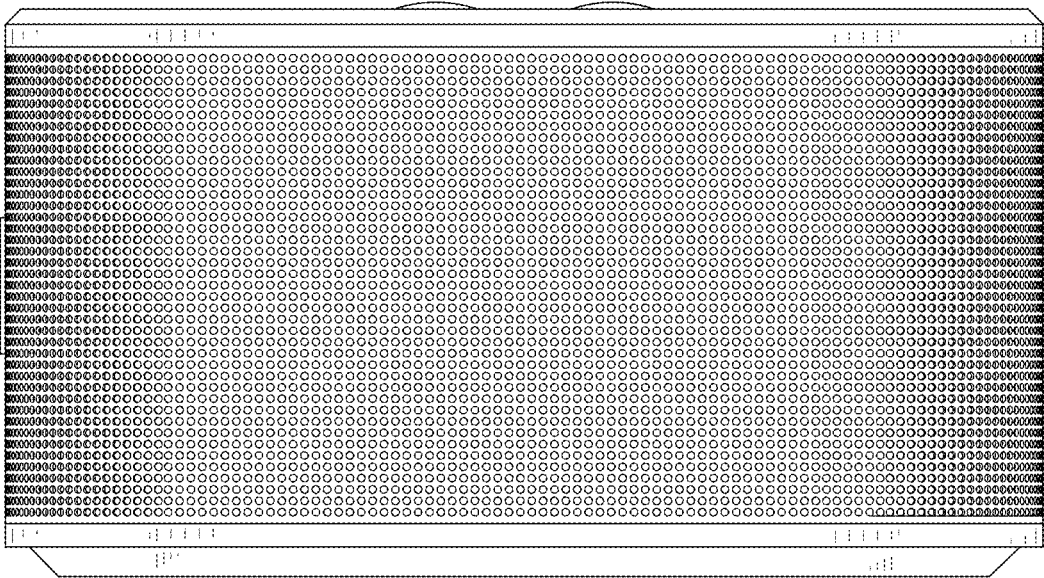

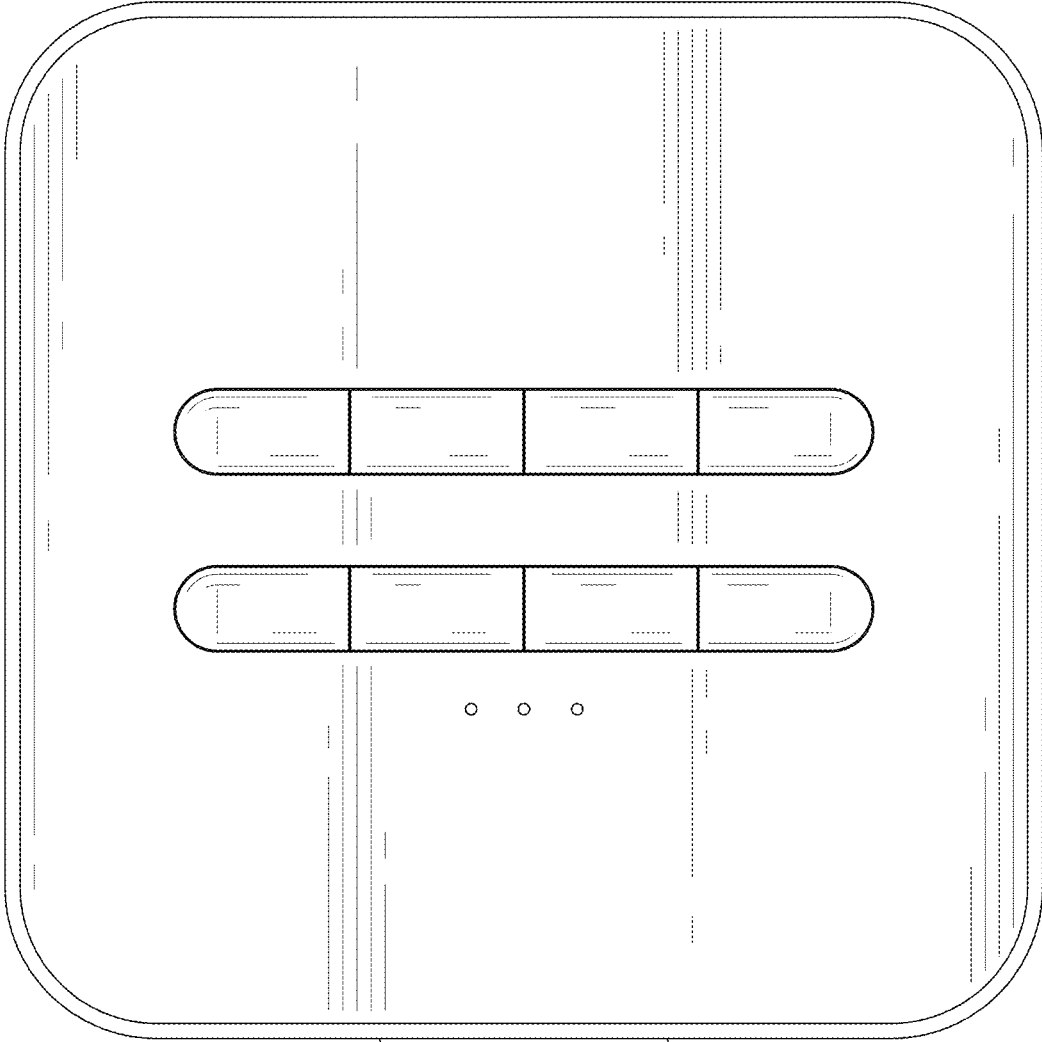

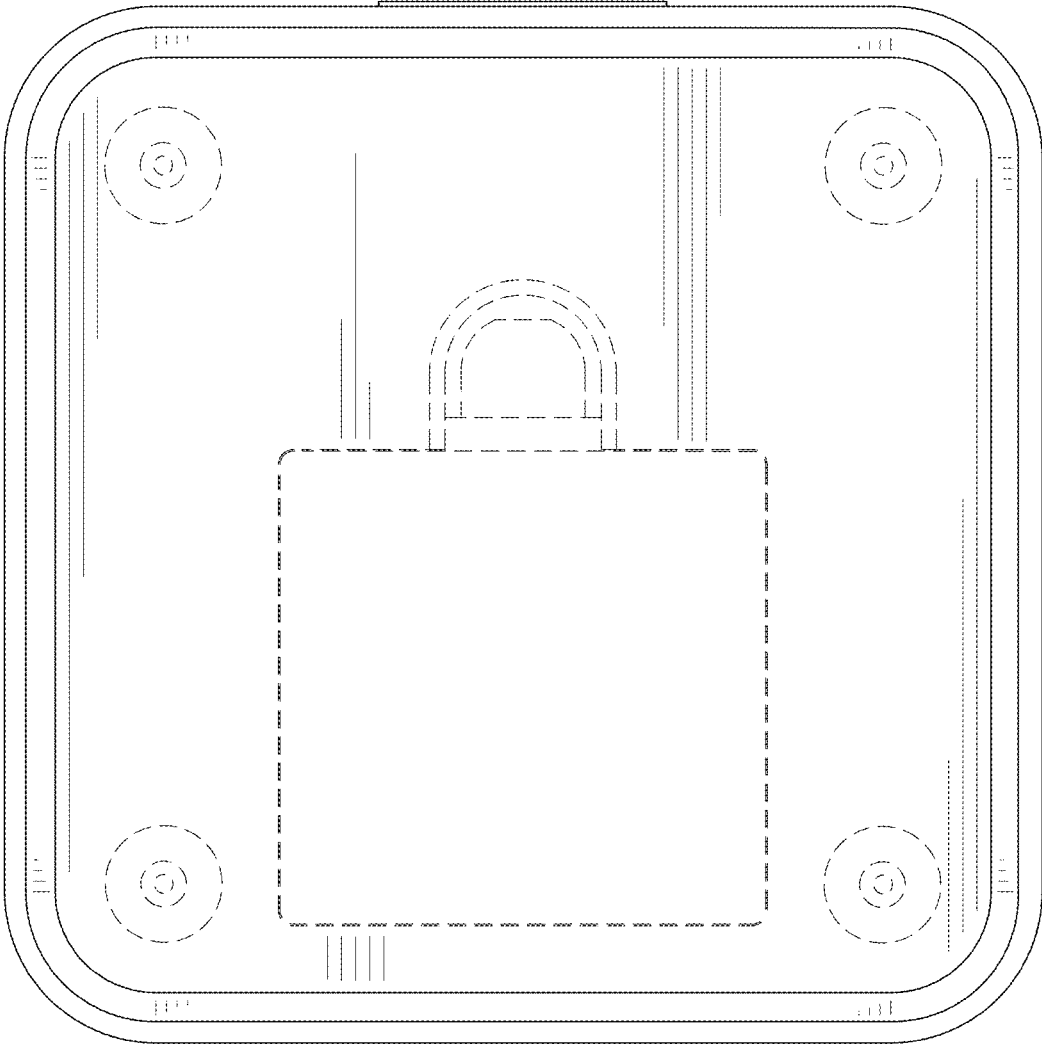

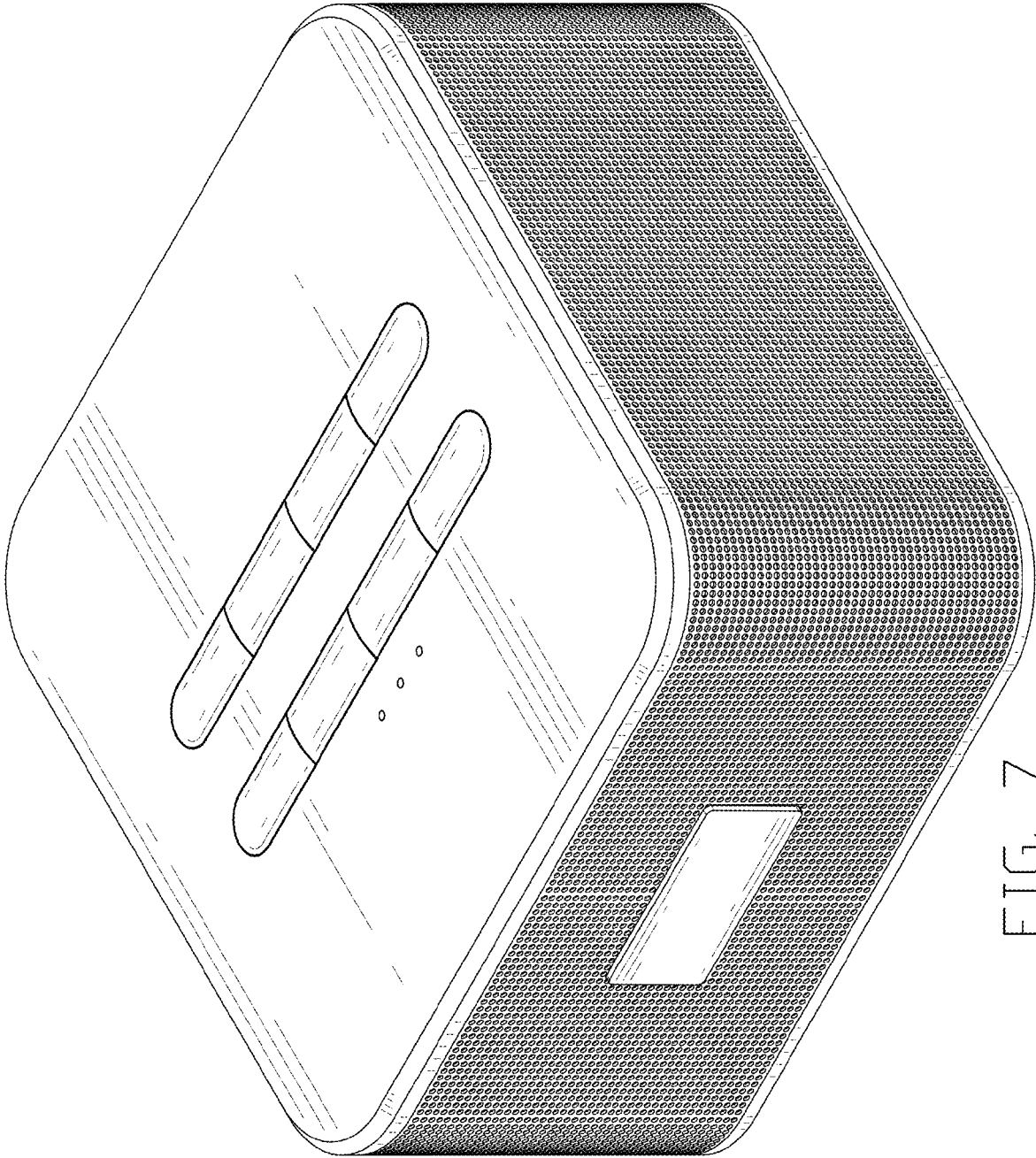

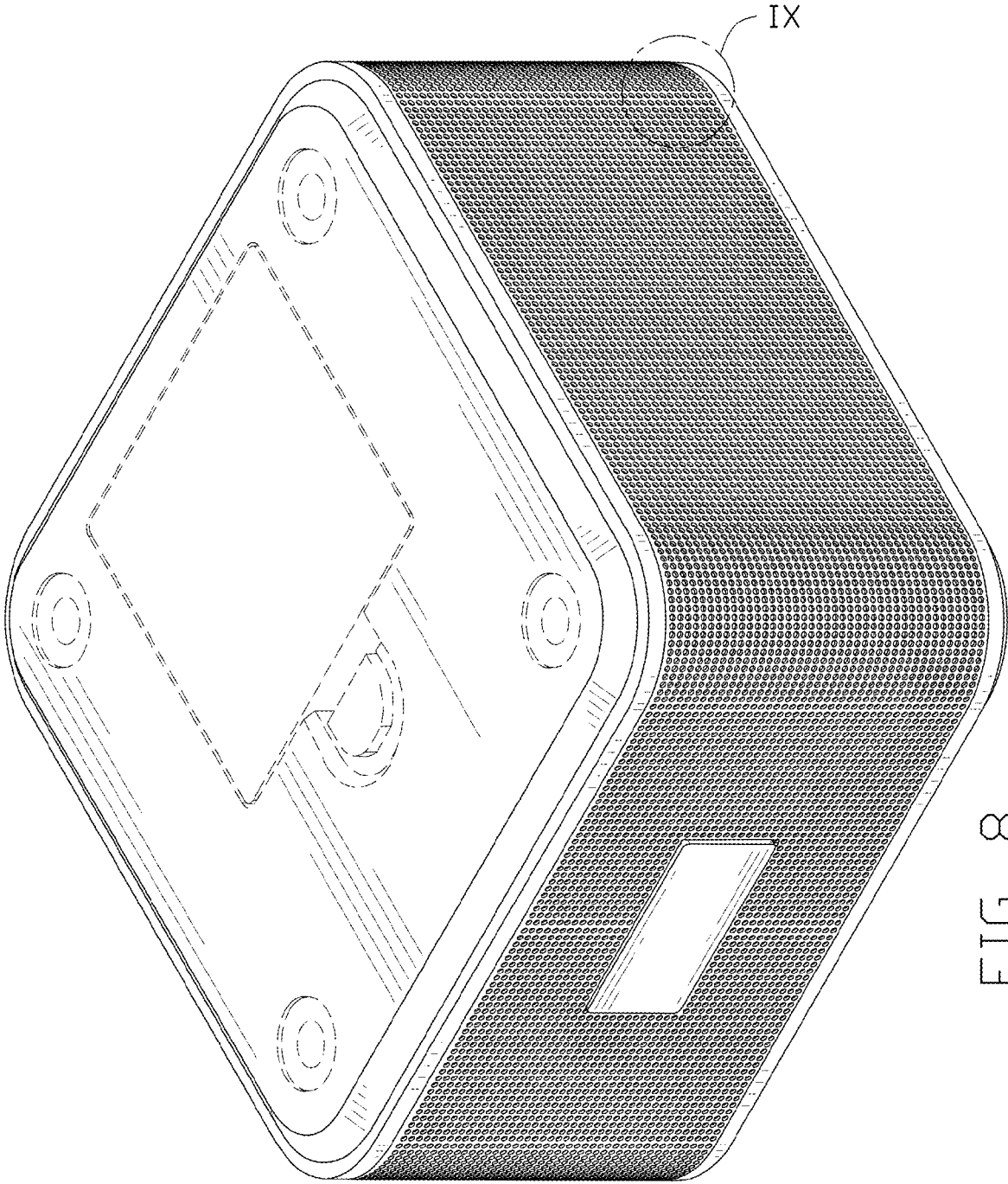

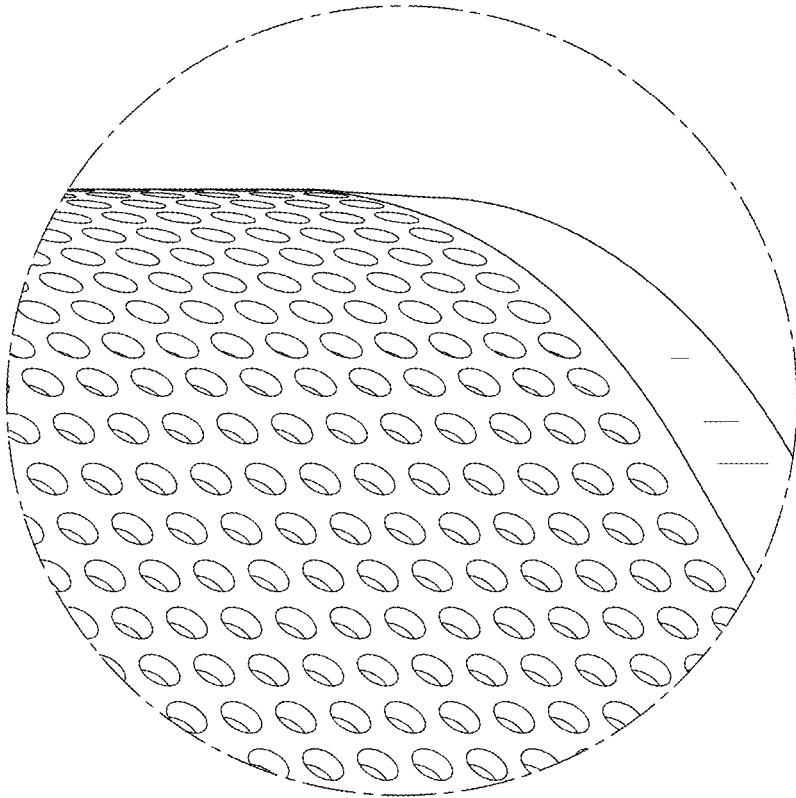
