(57) **CLAIM**

The ornamental design for a tamper-evident overcap for drum closures, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top facing of the tamper-evident overcap for drum closures according to a first embodiment;

FIG. 2 is a perspective view of the bottom facing shown in FIG. 1;

FIG. 3 is a top plan view shown in FIG. 1;

FIG. 4 is a cross sectional side view shown in FIG. 1 taken along line 4-4;

FIG. 5 is a front plan view, including the protruding structure visible in FIGS. 1-3, shown in FIG. 1;

FIG. 6 is a rear plan view shown in FIG. 1; and,

FIG. 7 is a bottom plan view shown in FIG. 1.

FIG. 8 is a perspective view of the top facing of the tamper-evident overcap for drum closures according to a second embodiment;

FIG. 9 is a perspective view of the bottom facing shown in FIG. 8;

FIG. 10 is a top plan view shown in FIG. 8;

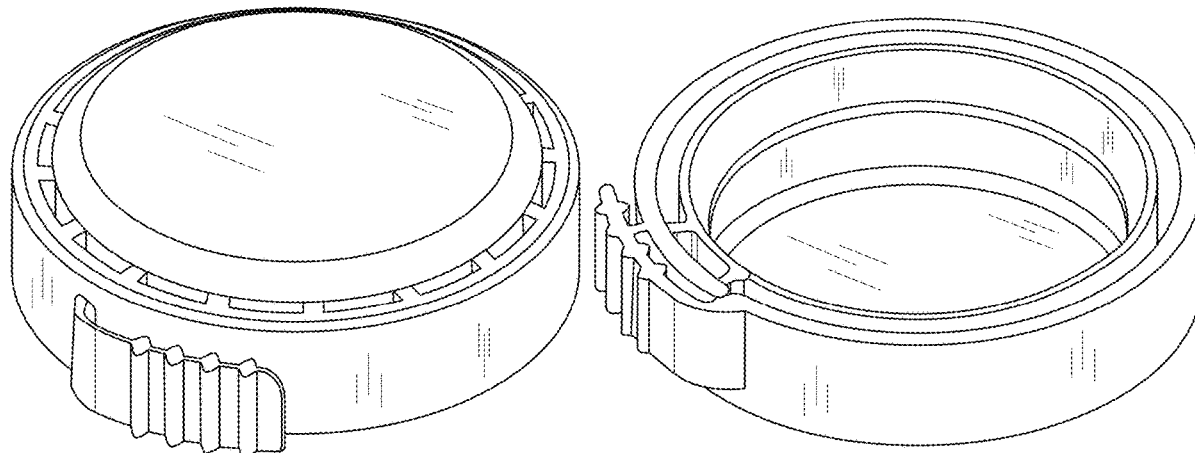
FIG. 11 is a cross sectional side view shown in FIG. 8 taken along line 11-11;

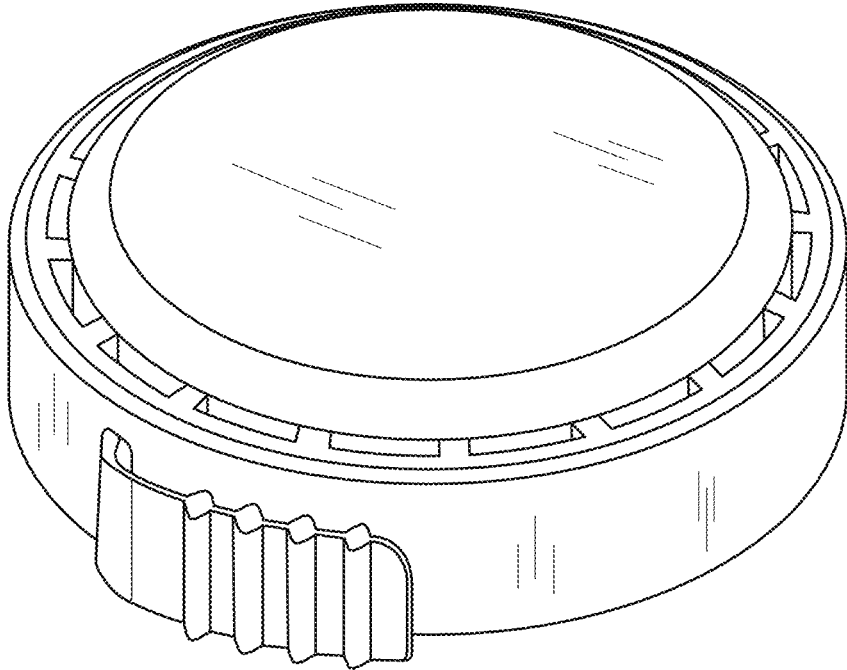

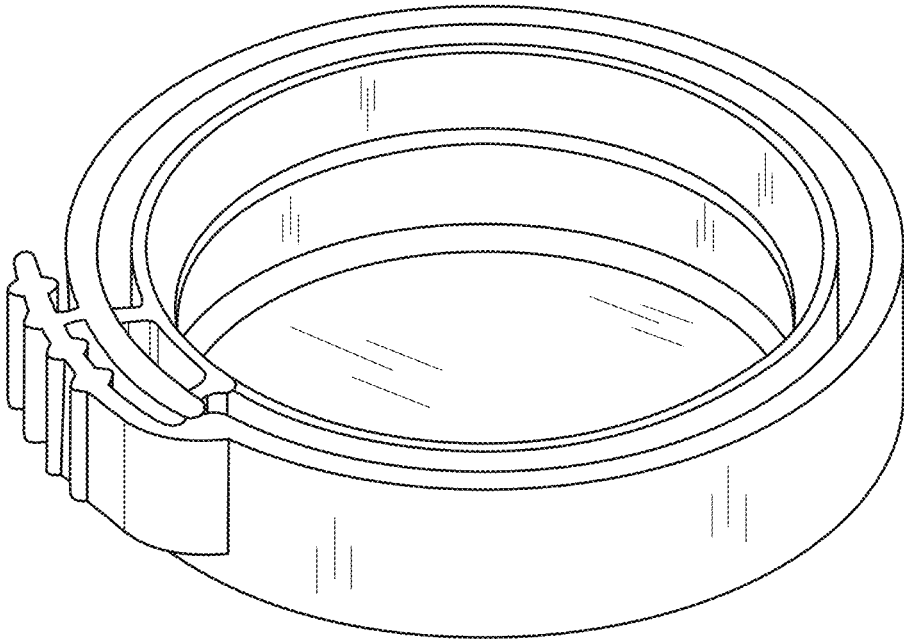

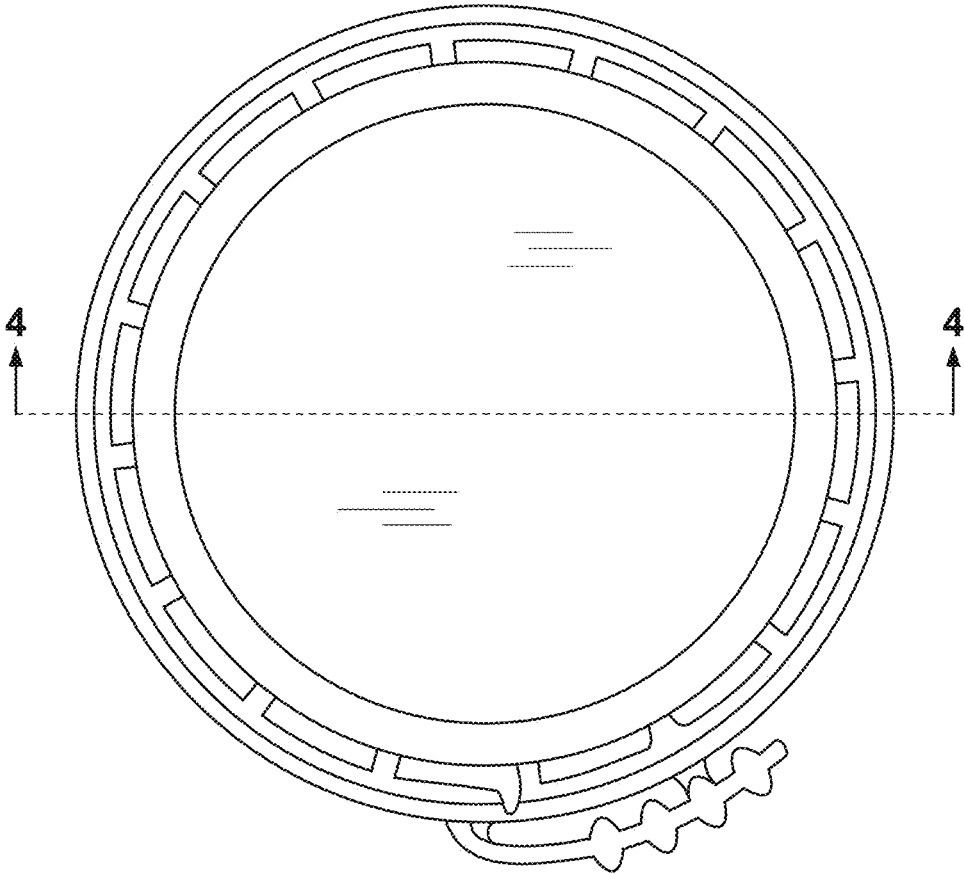

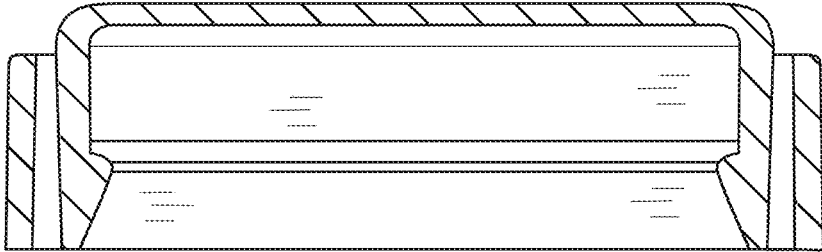

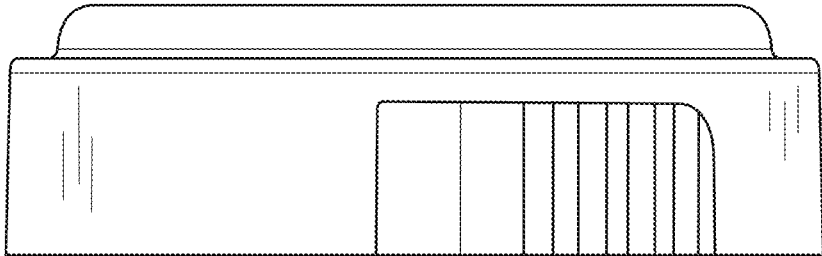

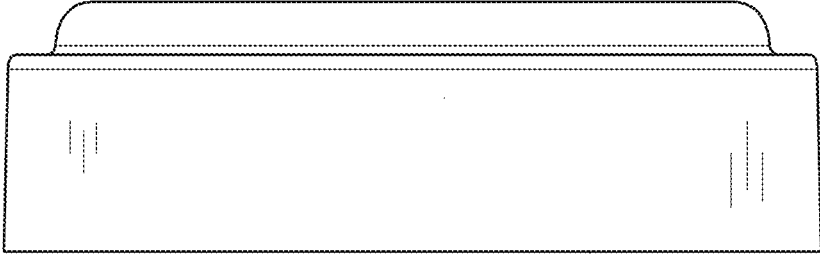

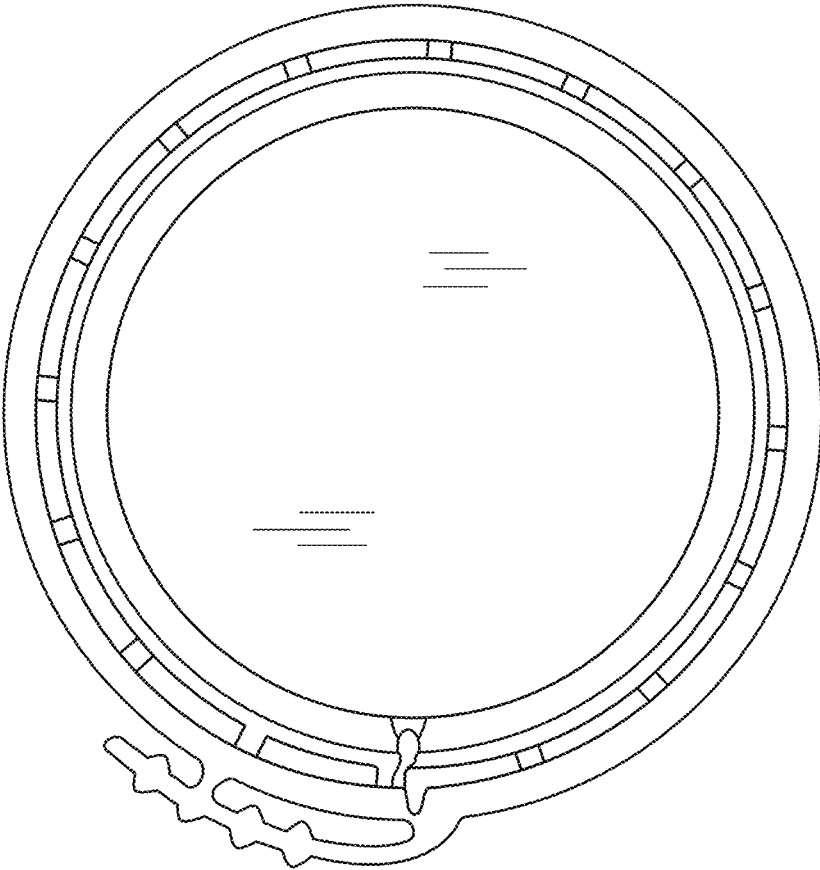

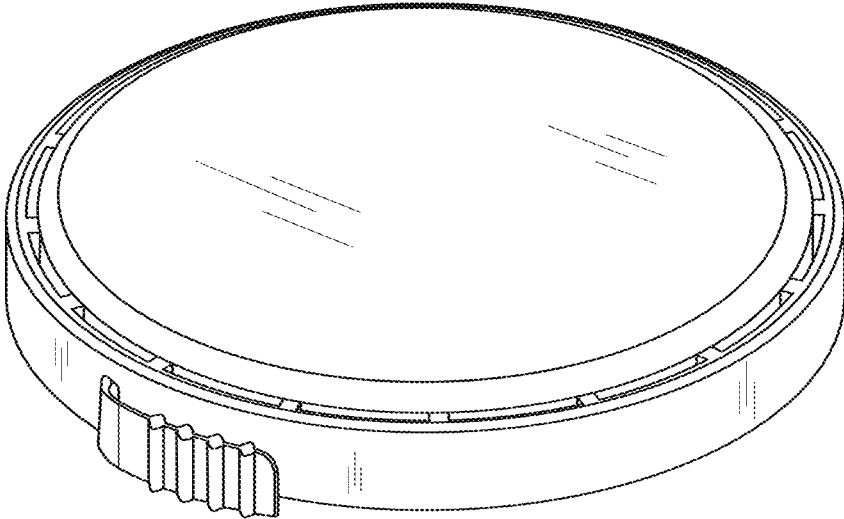

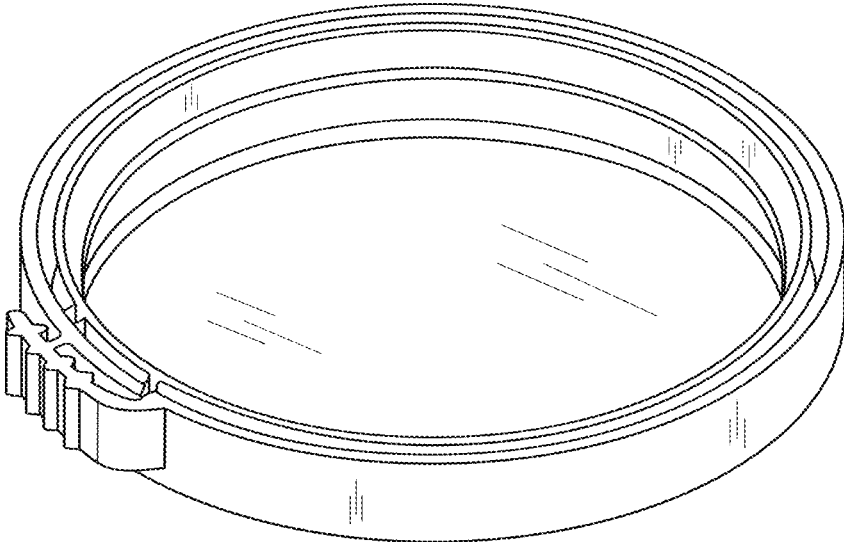

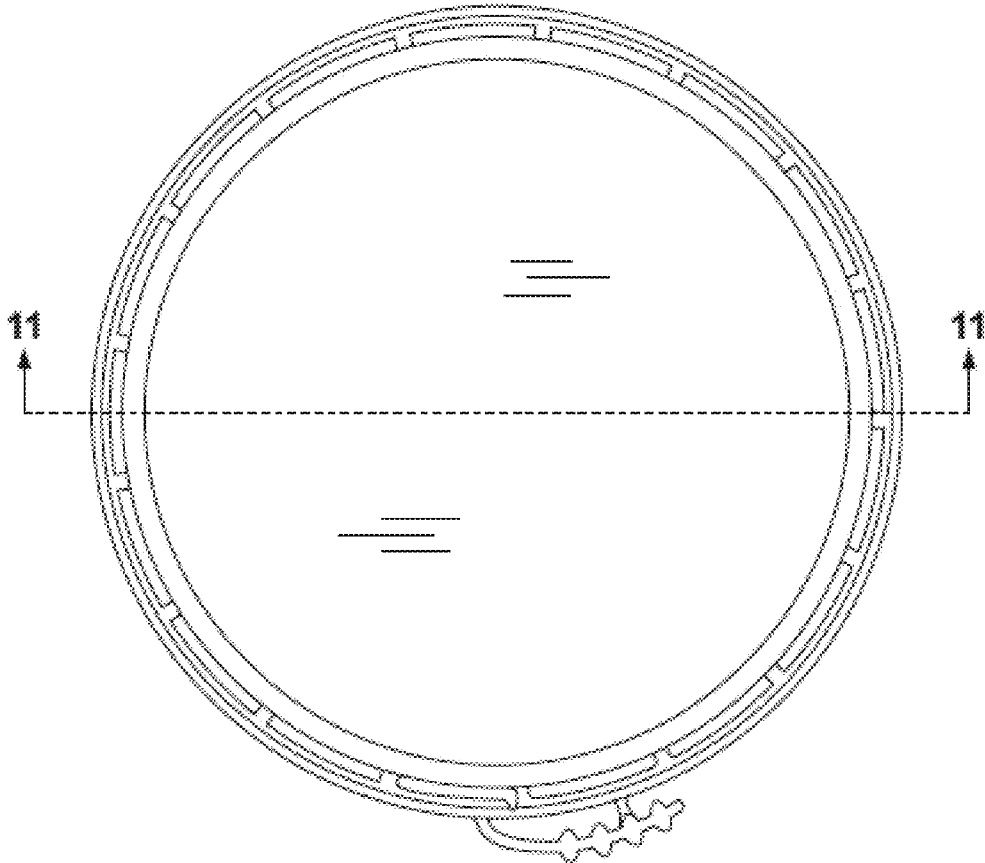

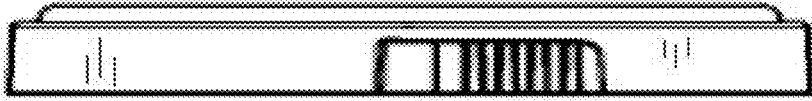

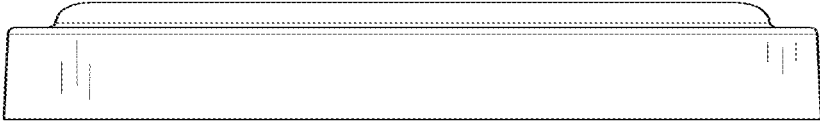

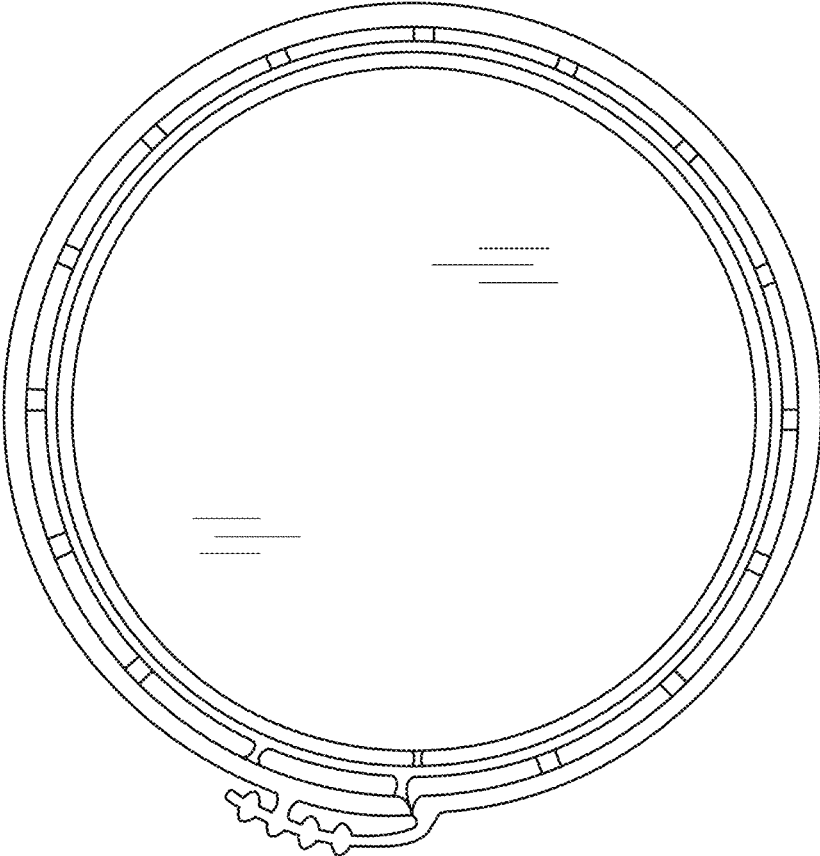
