The ornamental design for a portable intercom with a TV monitor, as shown and described.

DESCRIPTION

FIG. 1 is front perspective view of a portable intercom with a TV monitor illustrating our new design;

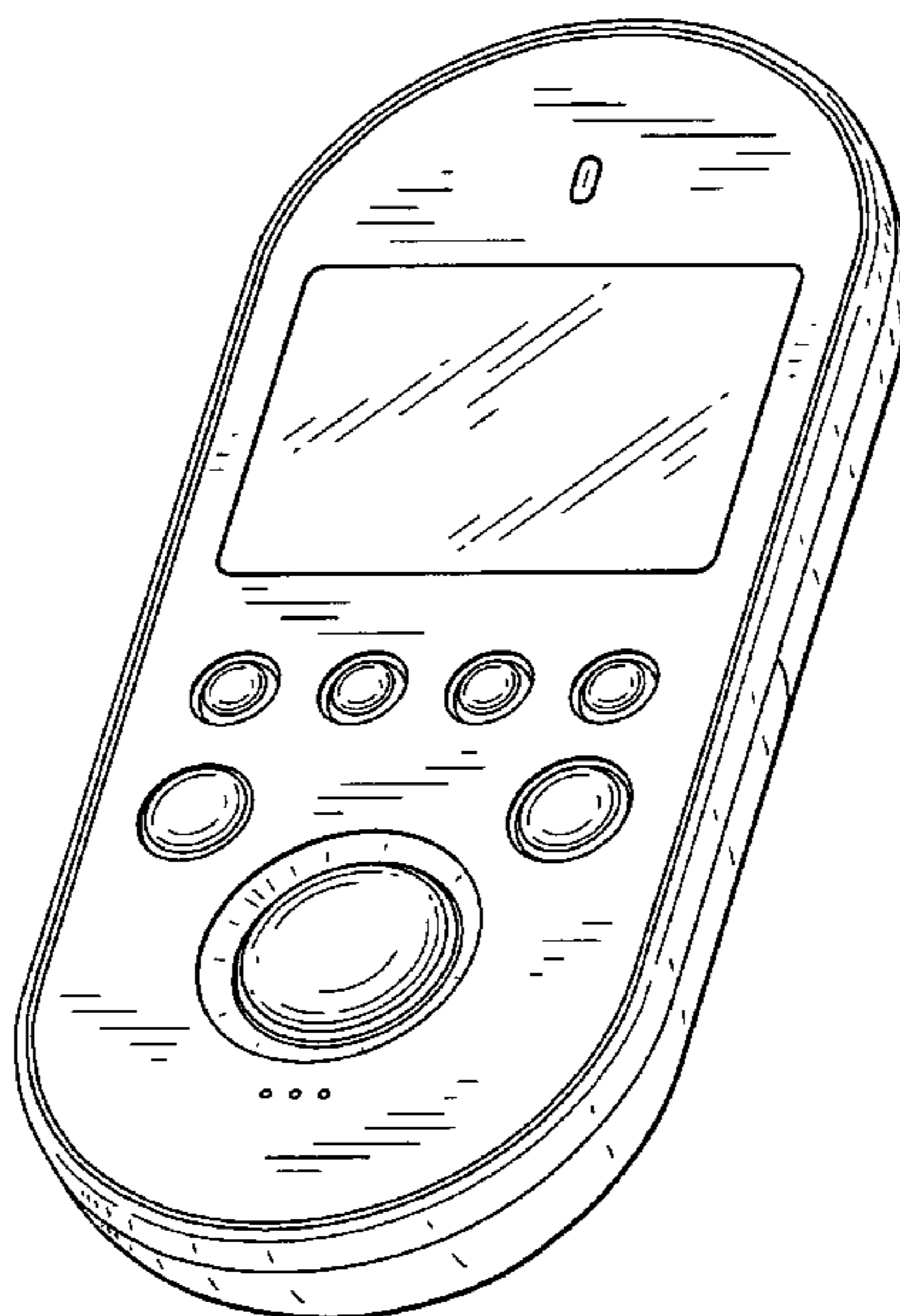

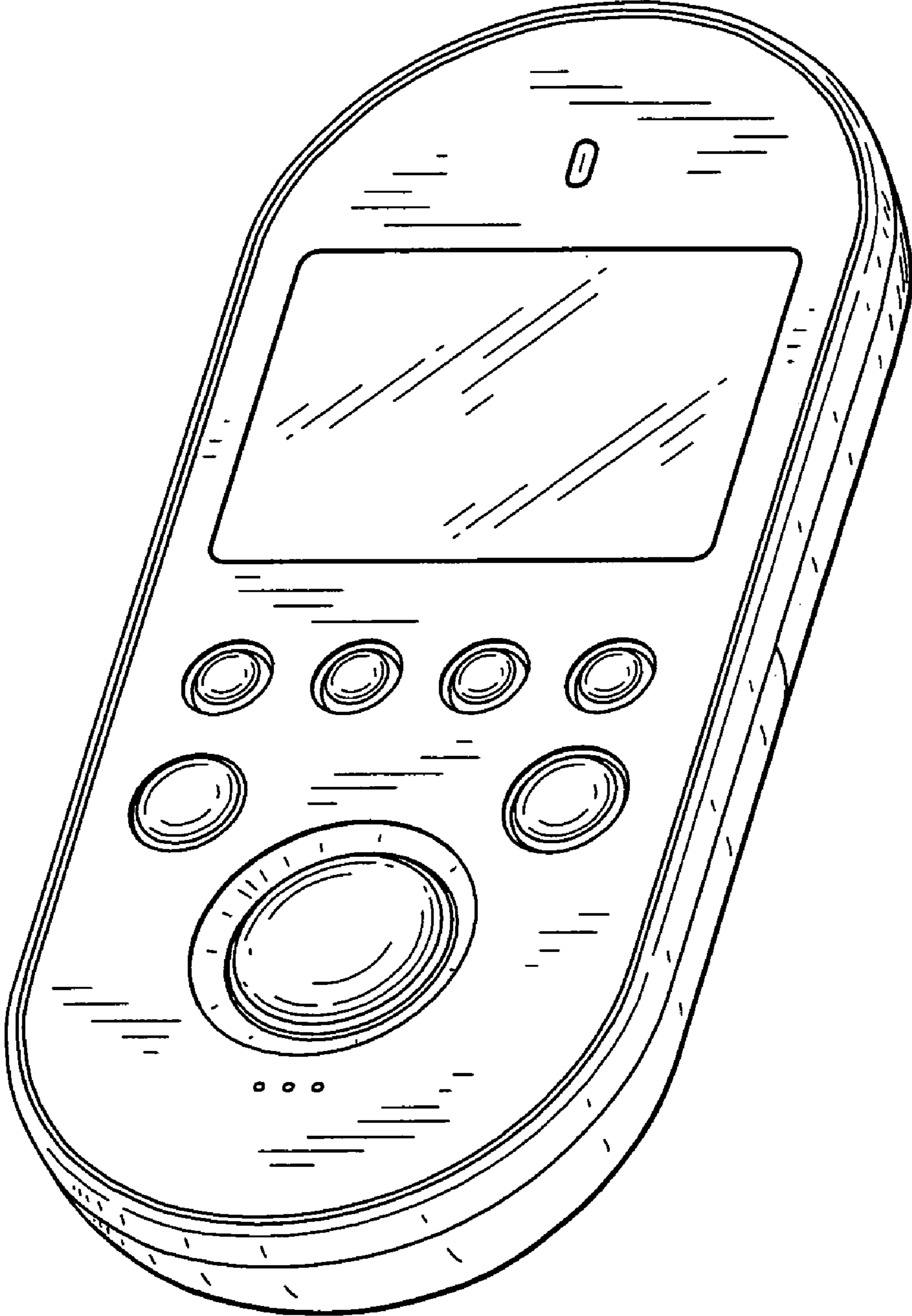

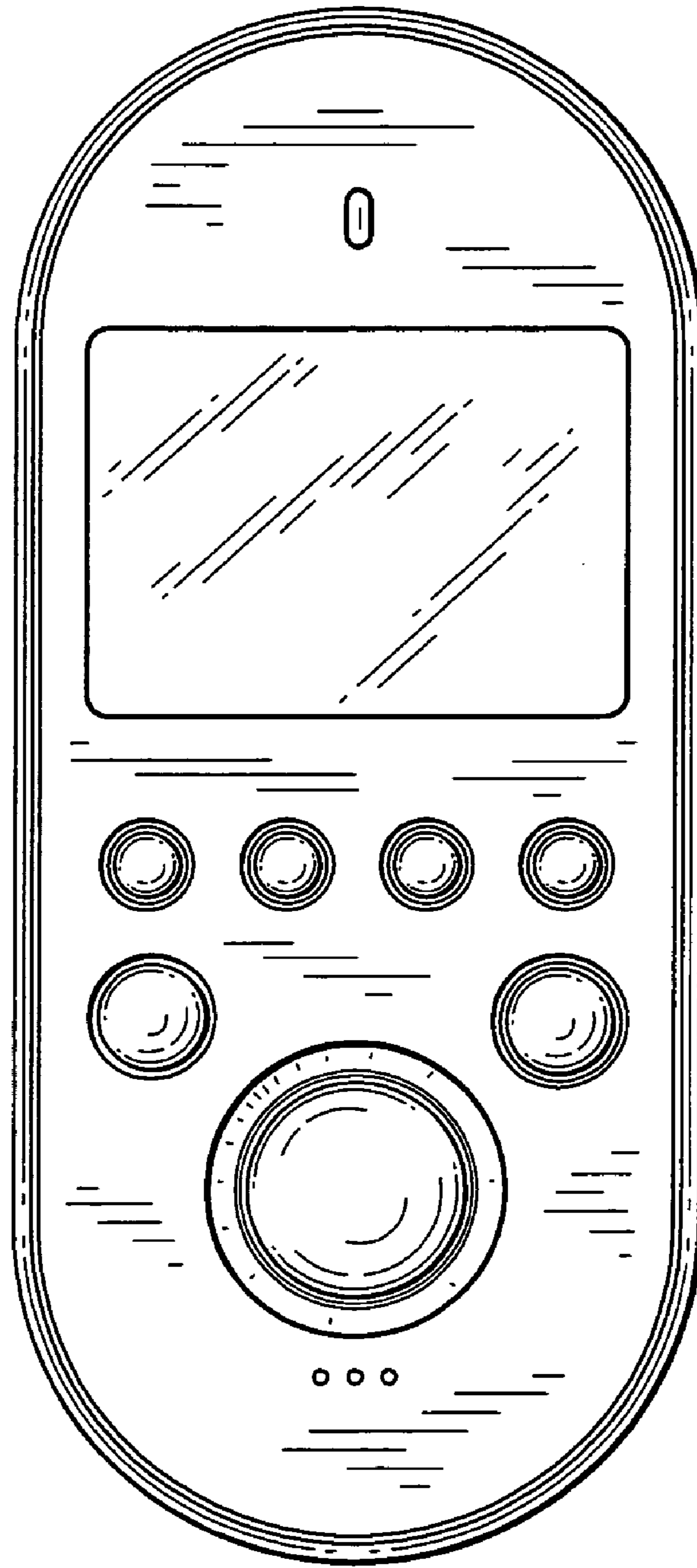

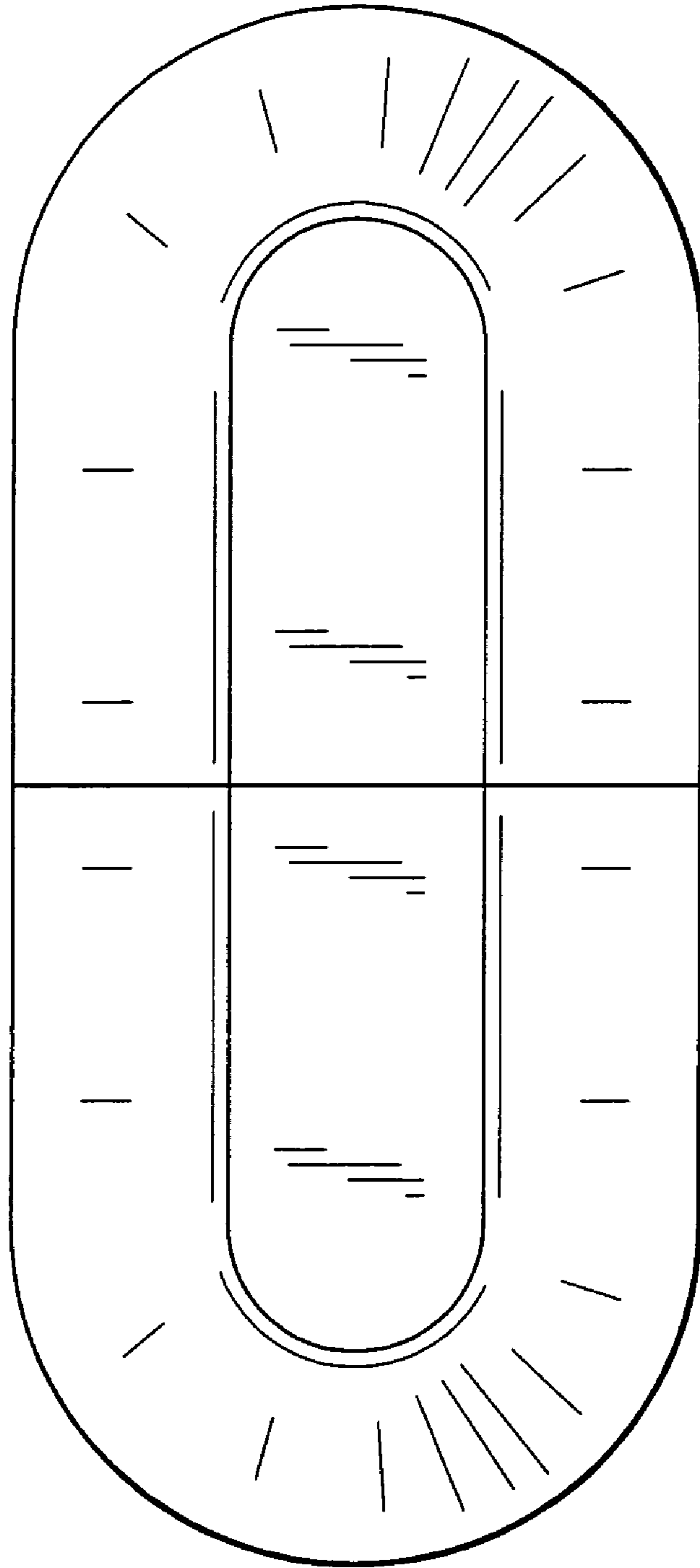

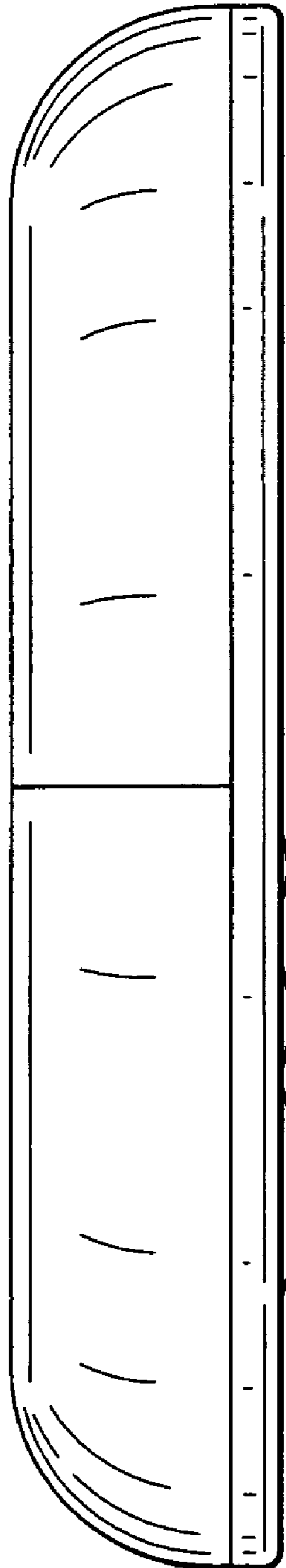

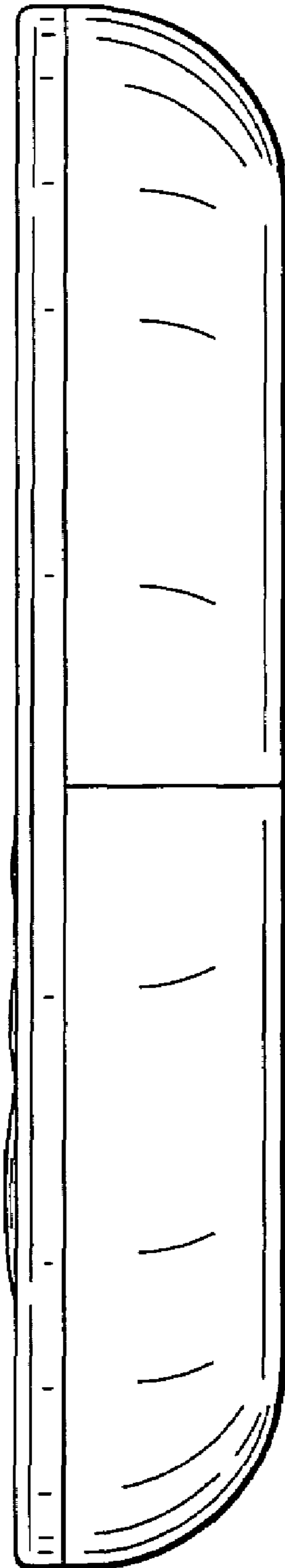

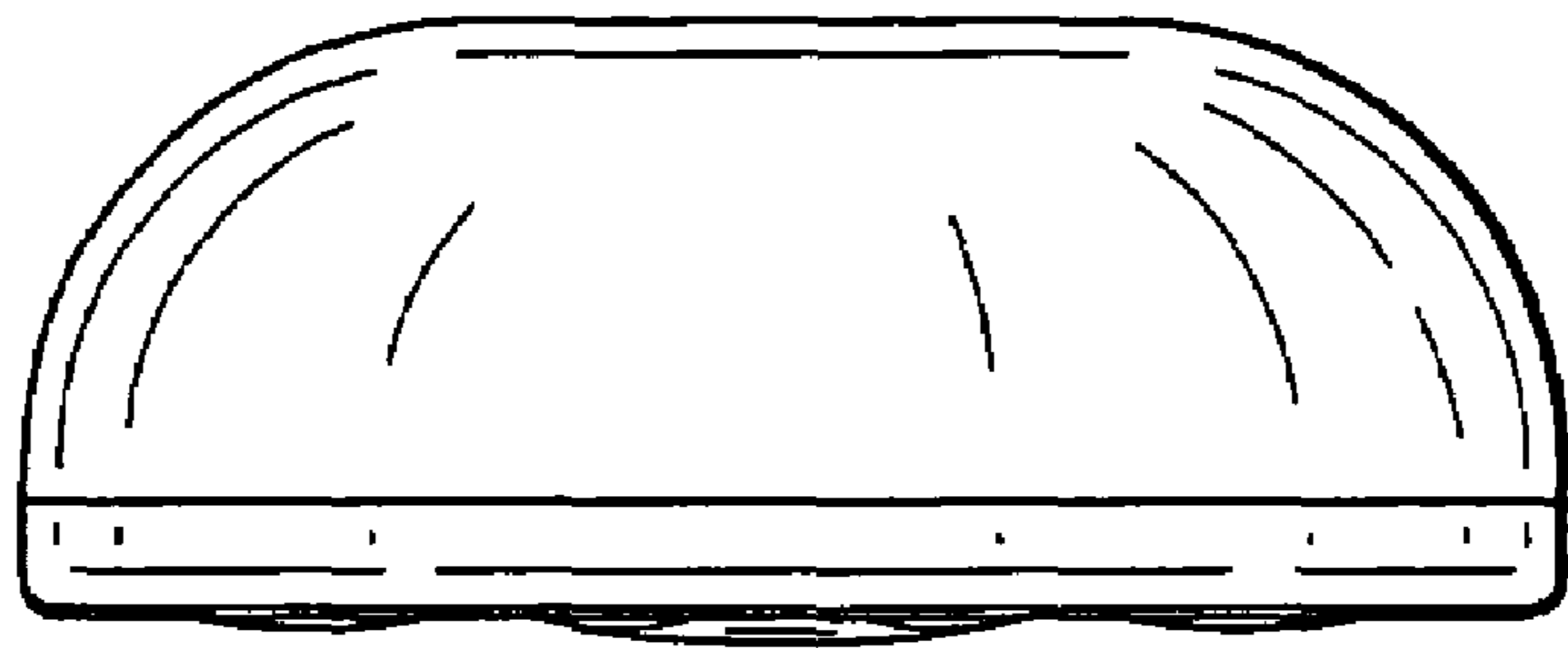
