(54) Title: VITAMIN B12 PRODUCING LACTOBACILLUS REUTERI STRAINS

(57) Abstract: The present invention relates to a composition comprising at least one probiotic bacterial strain belonging to the species *Lactobacillus reuteri* as a vitamin B12 producer. In particular, the present invention relates to selected bacterial strains belonging to the species *Lactobacillus reuteri* as vitamin B12 producers. Finally, the present invention relates to a food composition or supplement or pharmaceutical composition comprising a bacterial strain belonging to the species *Lactobacillus reuteri*.
