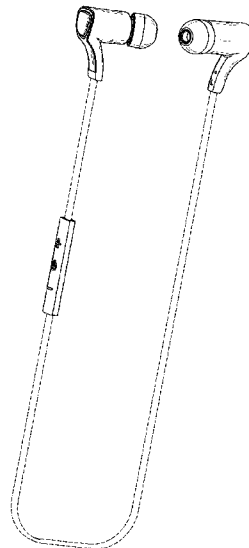
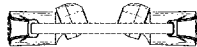

DESCRIPTION

FIG. 1 is a front elevational view of a wireless stereo headset showing my new design;

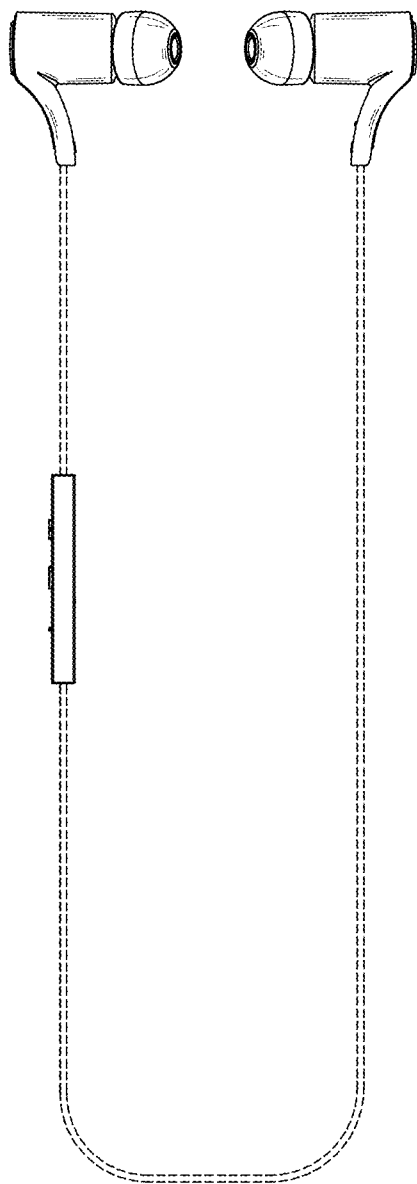

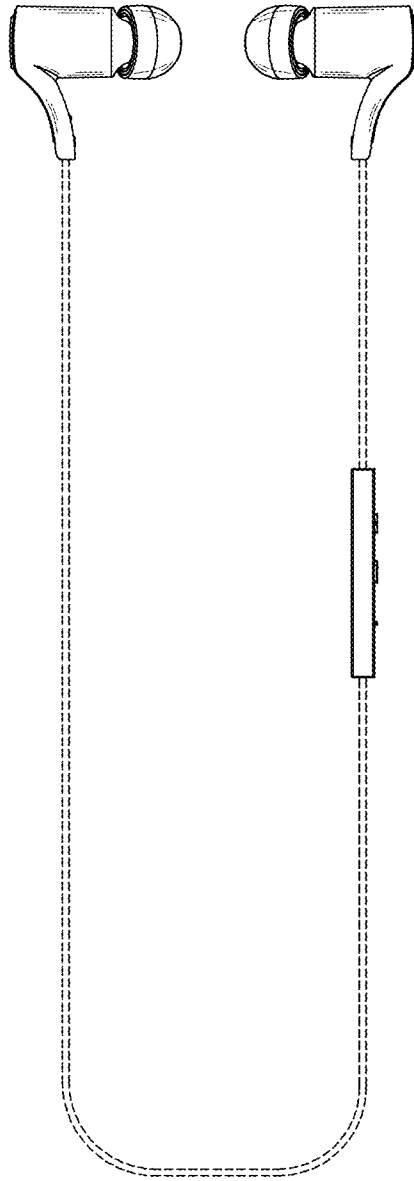

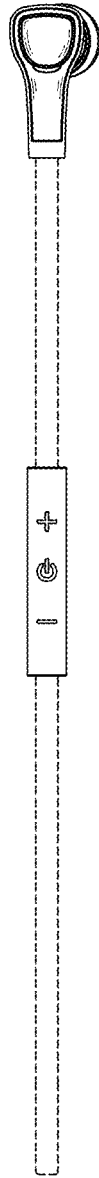

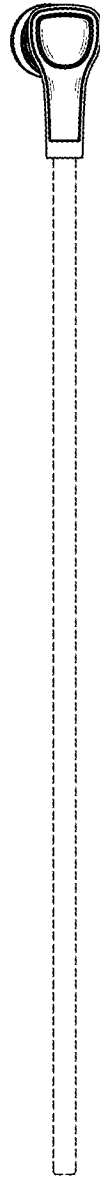

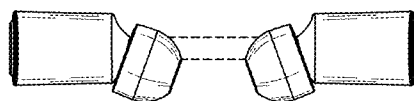

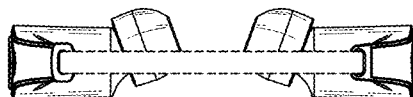

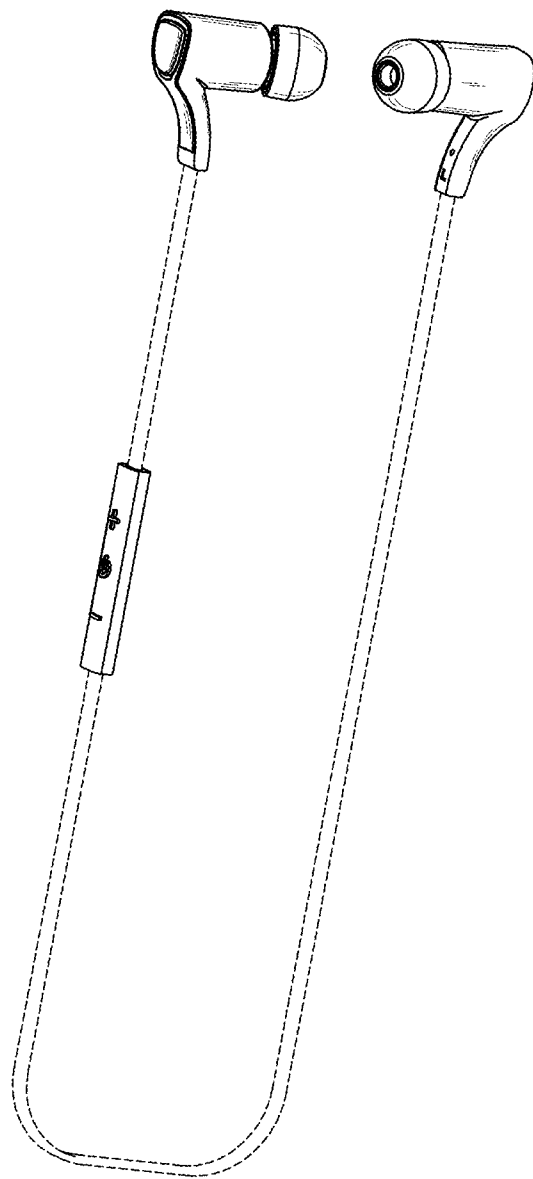
