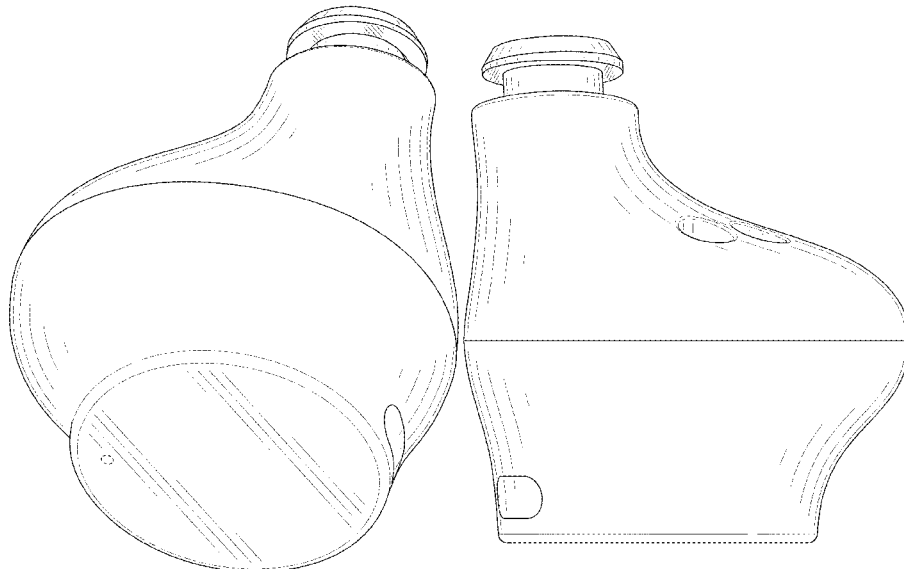
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of an earphone showing our design.  
FIG. 2 is a bottom rear perspective view of the earphone.  
FIG. 3 is a front elevation view thereof.  
FIG. 4 is a rear elevation view thereof.  
FIG. 5 is a left side elevation view thereof.  
FIG. 6 is a right side elevation view thereof.  
FIG. 7 is a top plan view thereof; and,  
FIG. 8 is a bottom plan view thereof.

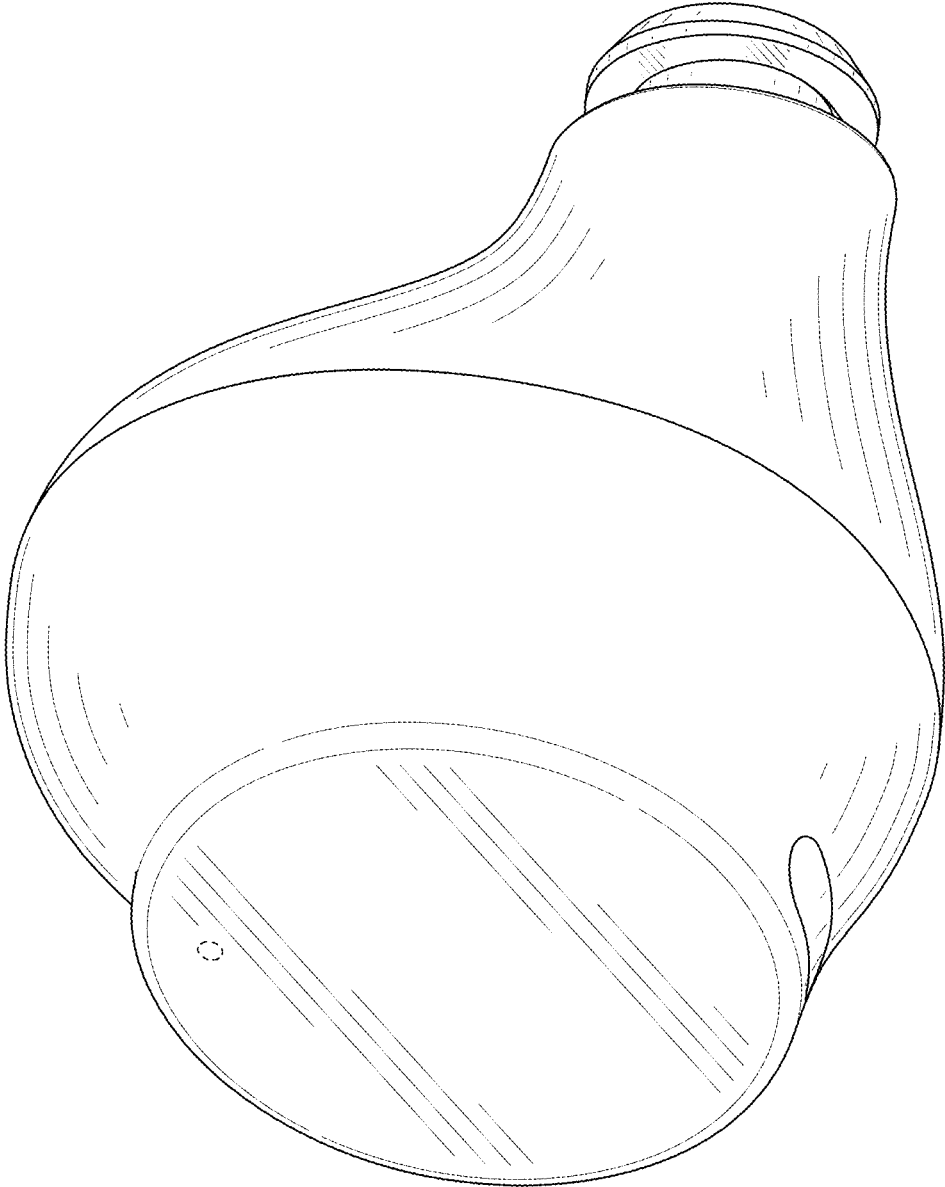

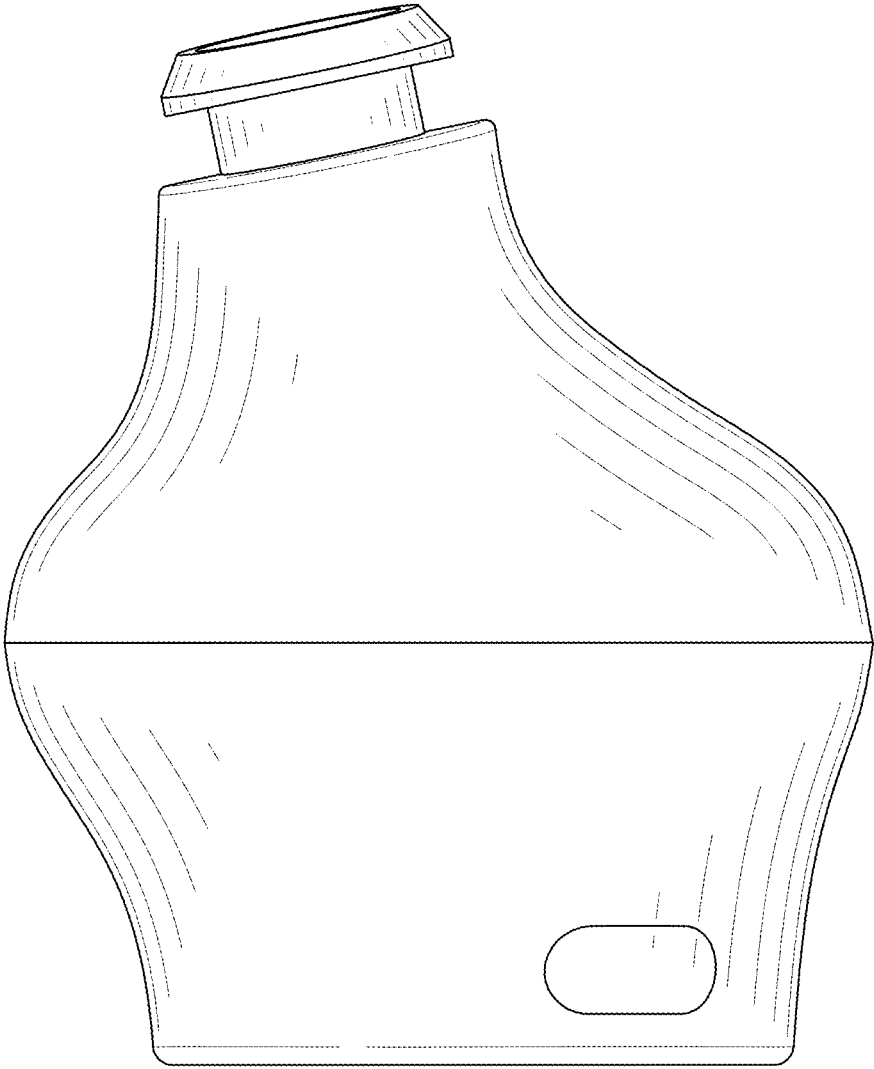

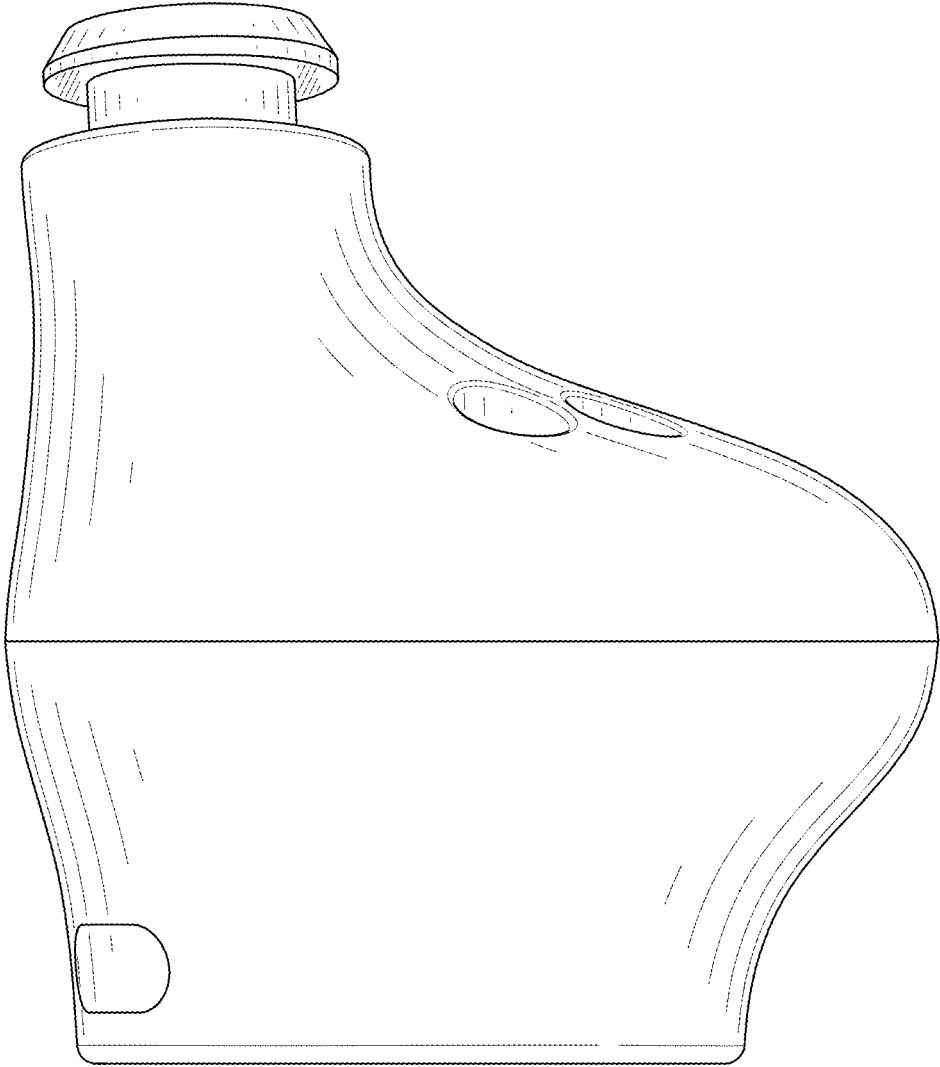

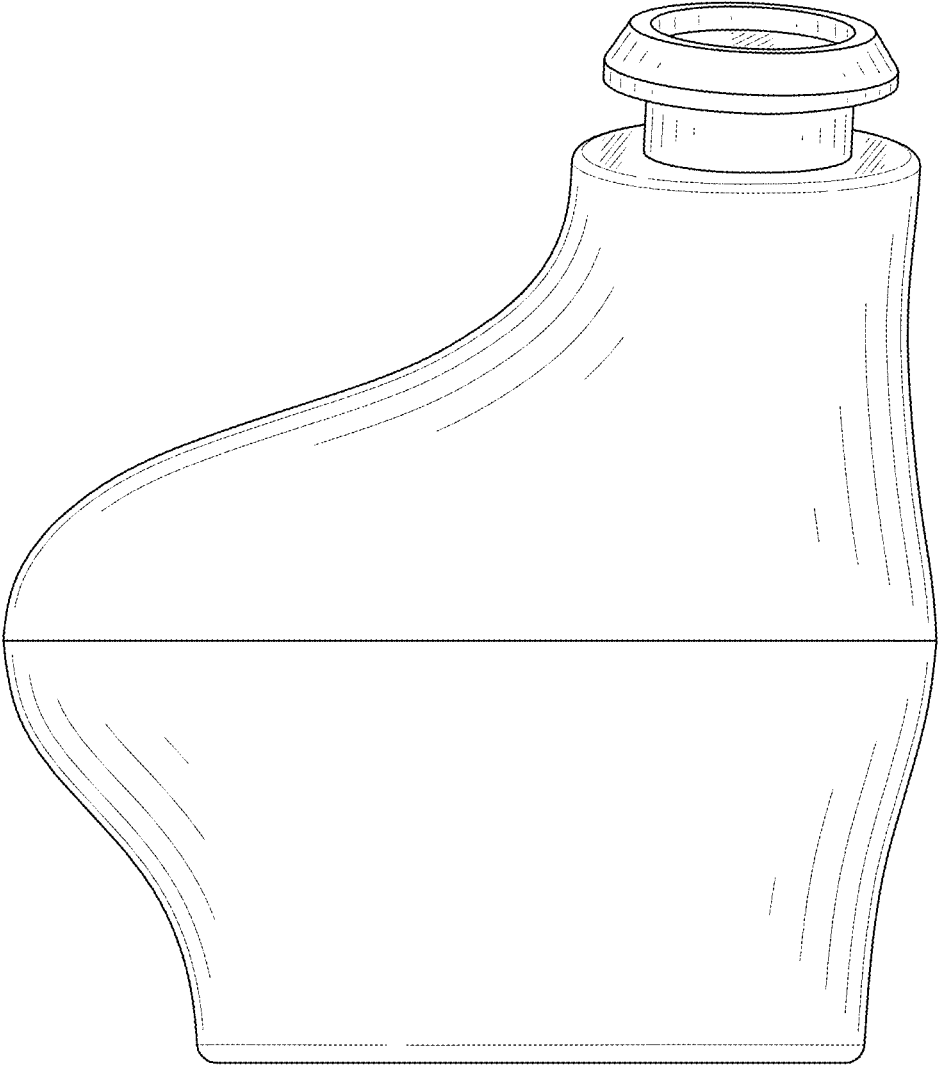

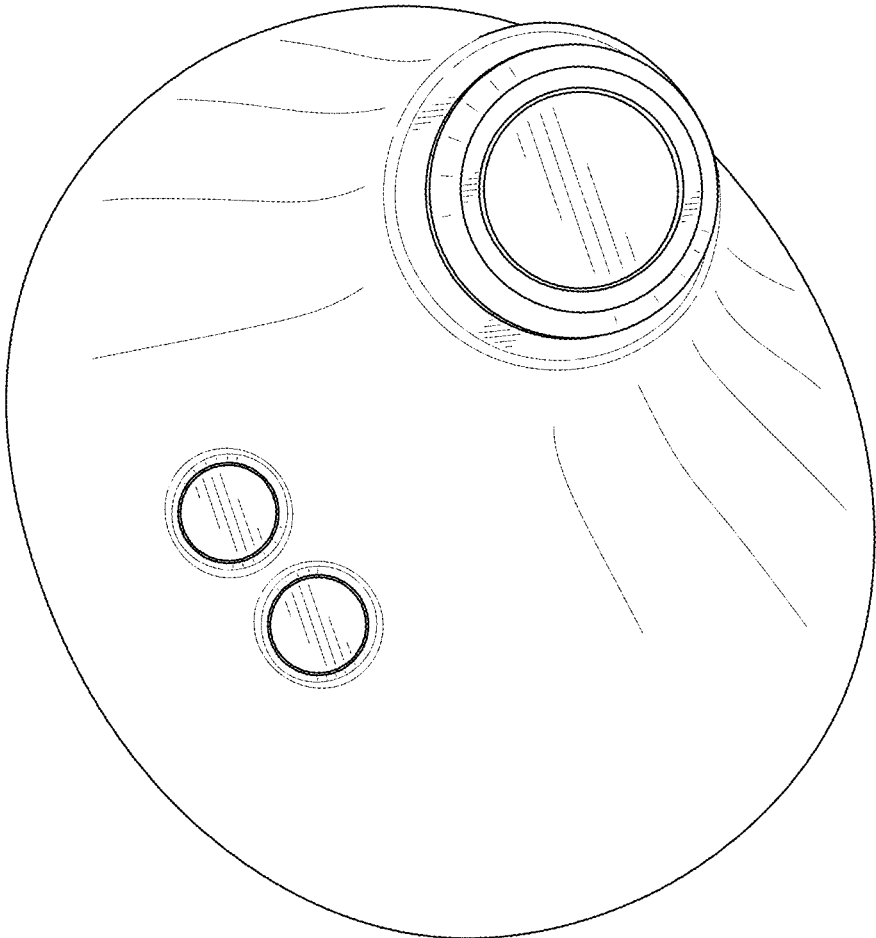

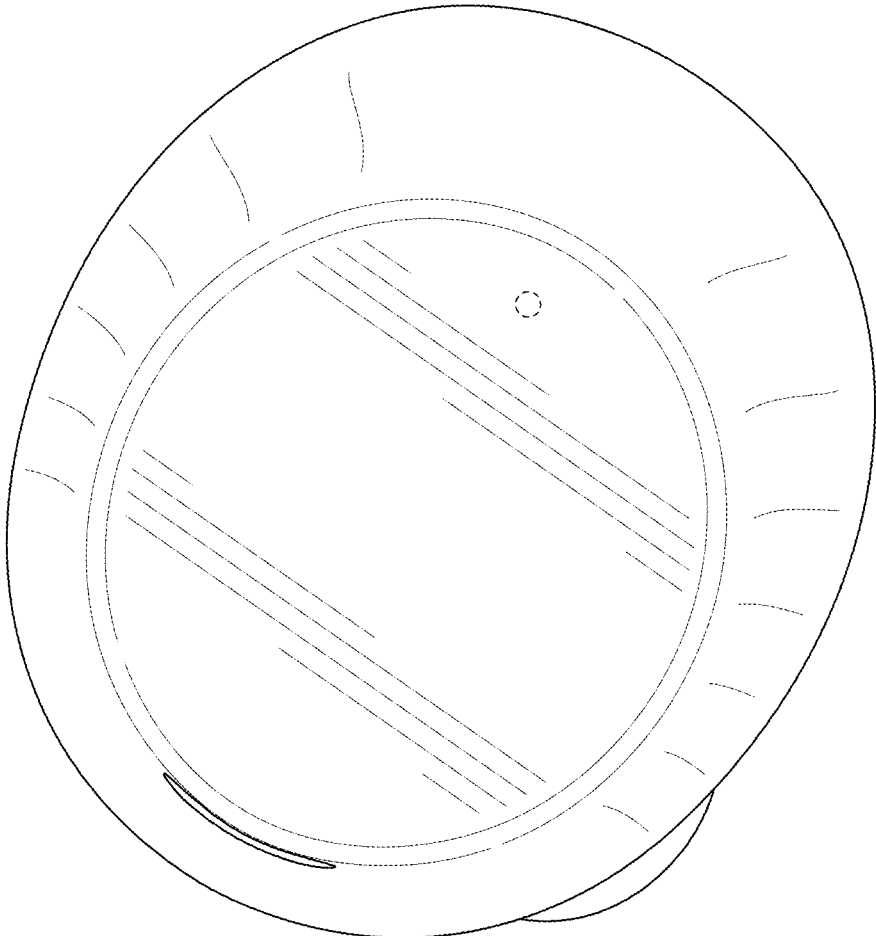
