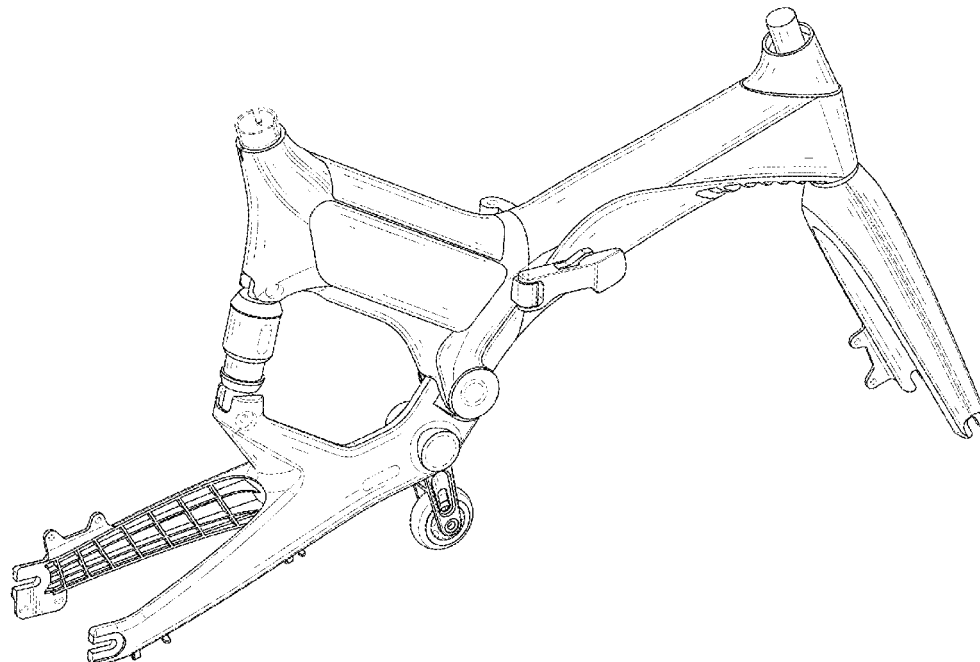
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a rear and right side perspective view of a bicycle frame showing our new design;

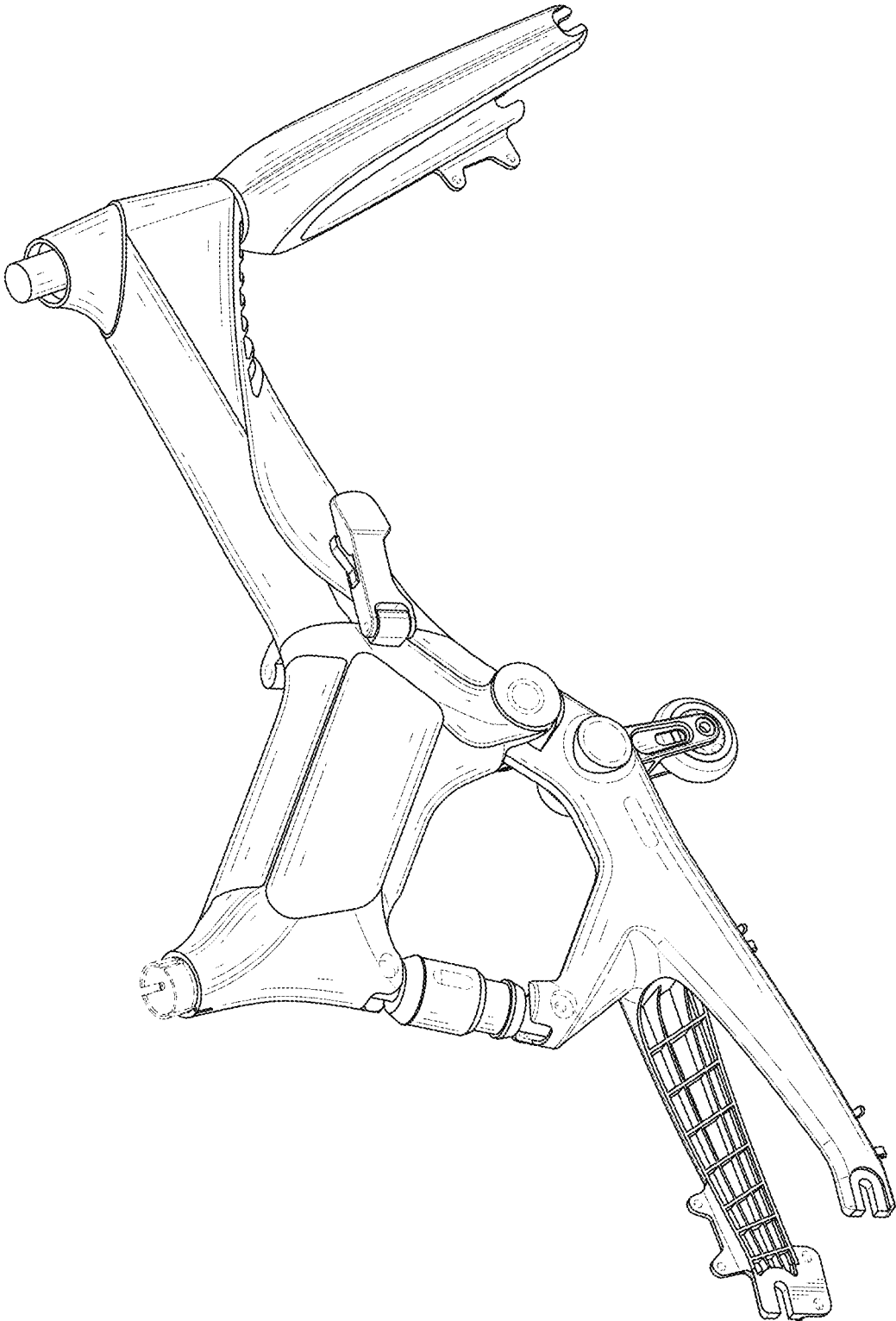

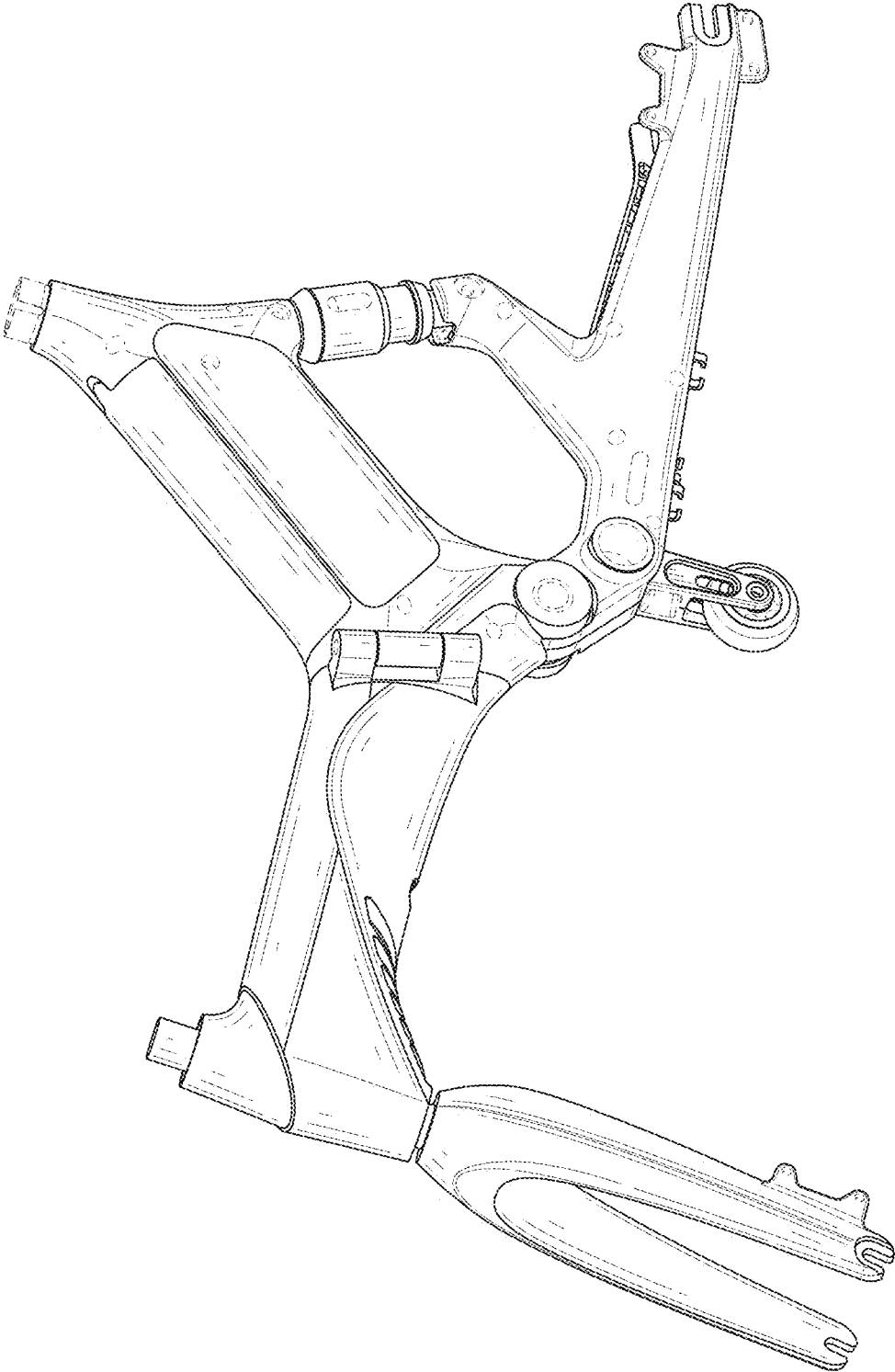

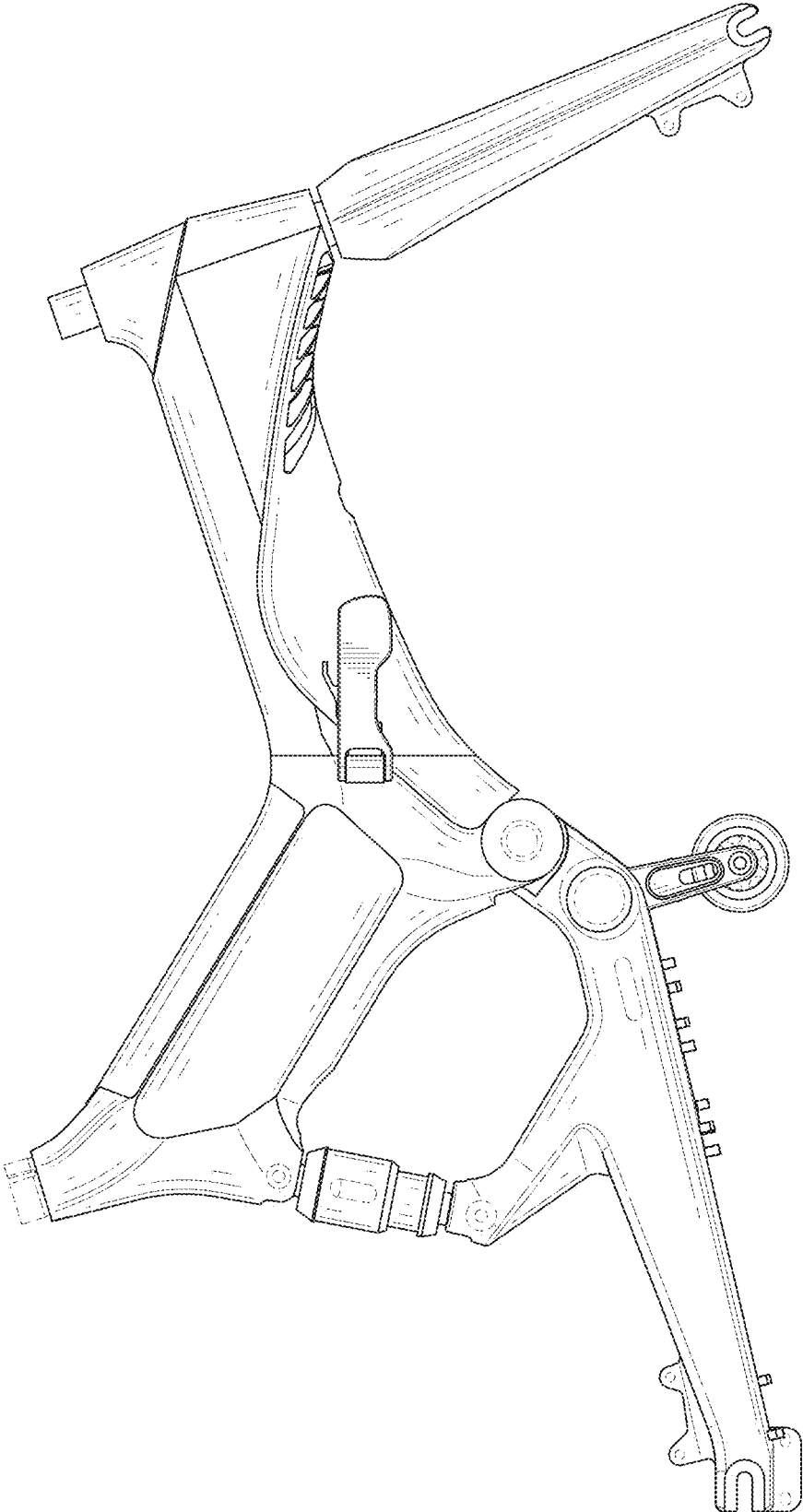

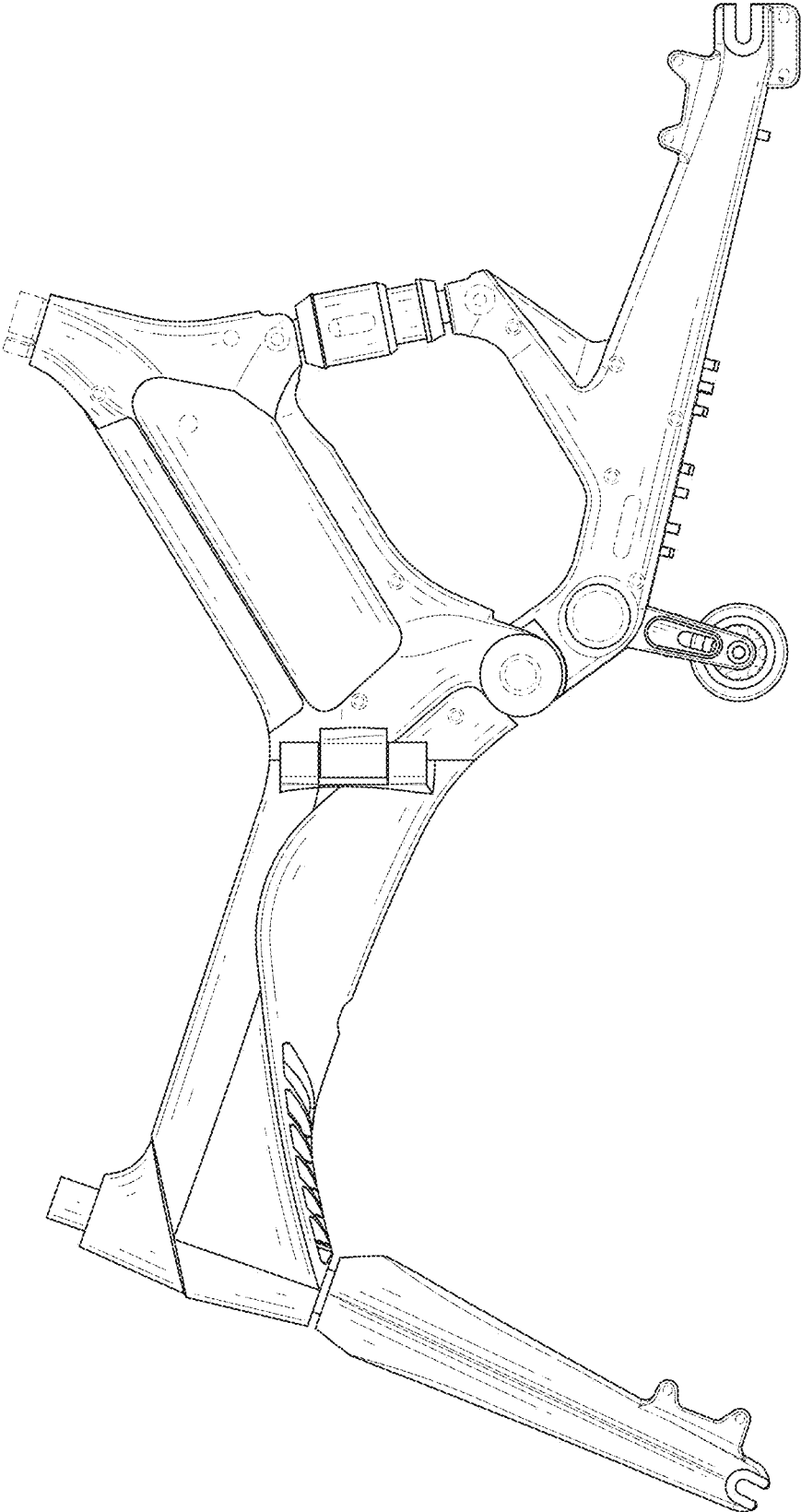

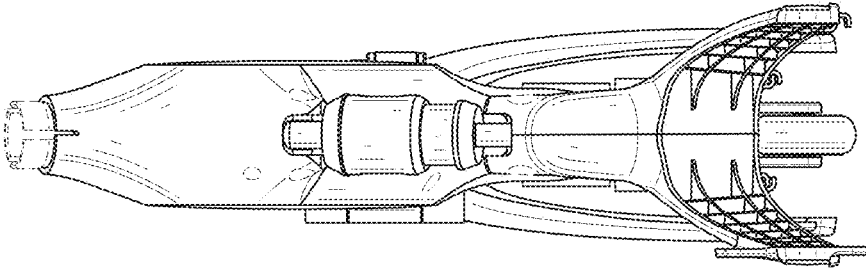

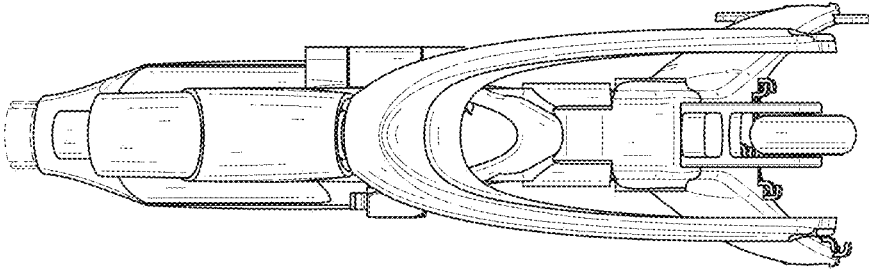

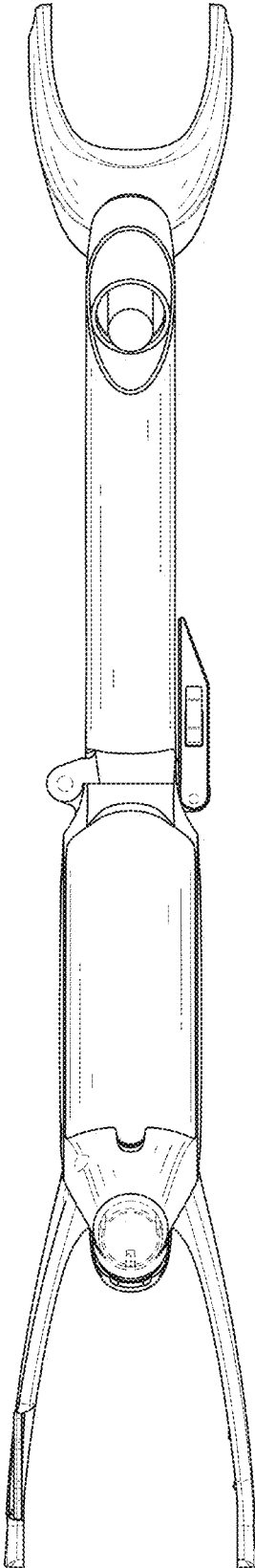

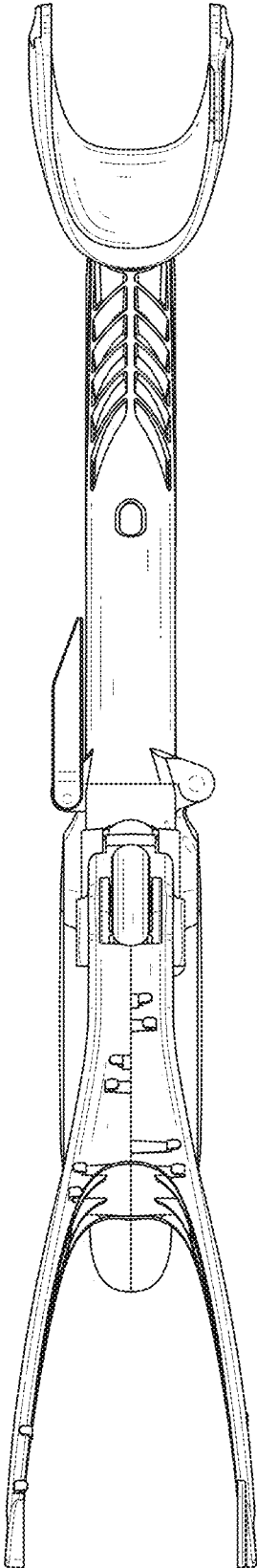
