(57) **CLAIM**

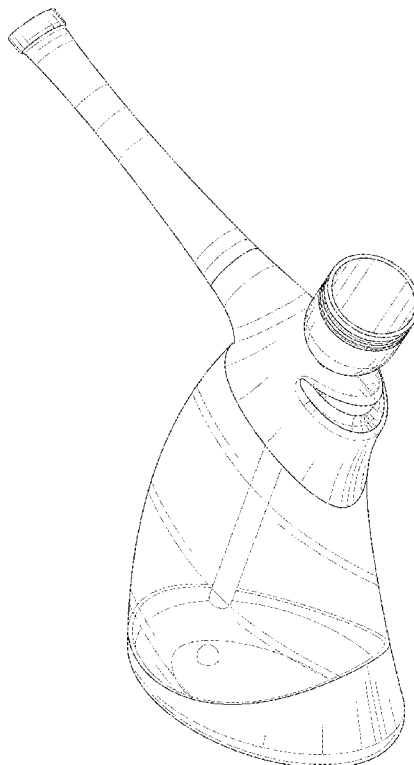
The ornamental design for a hookah, as shown and described.

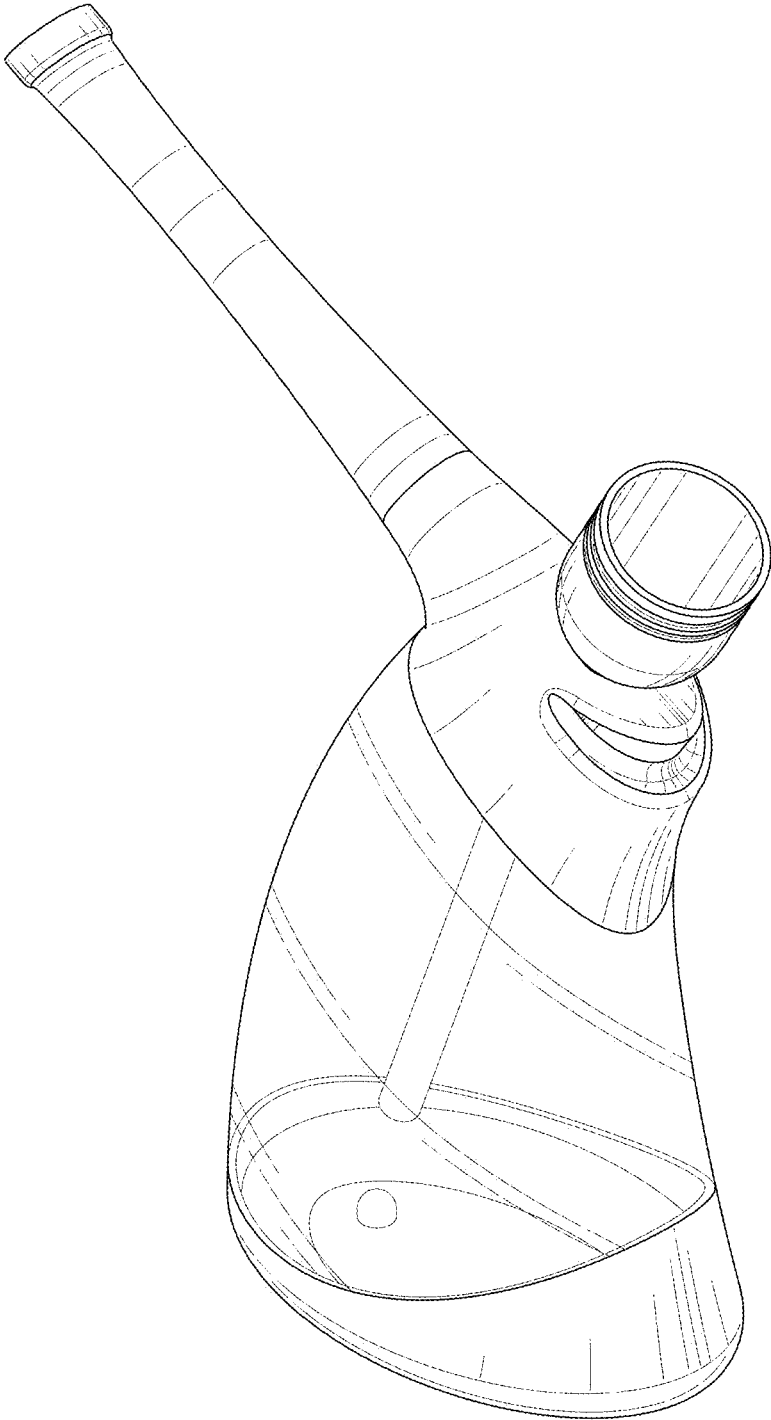

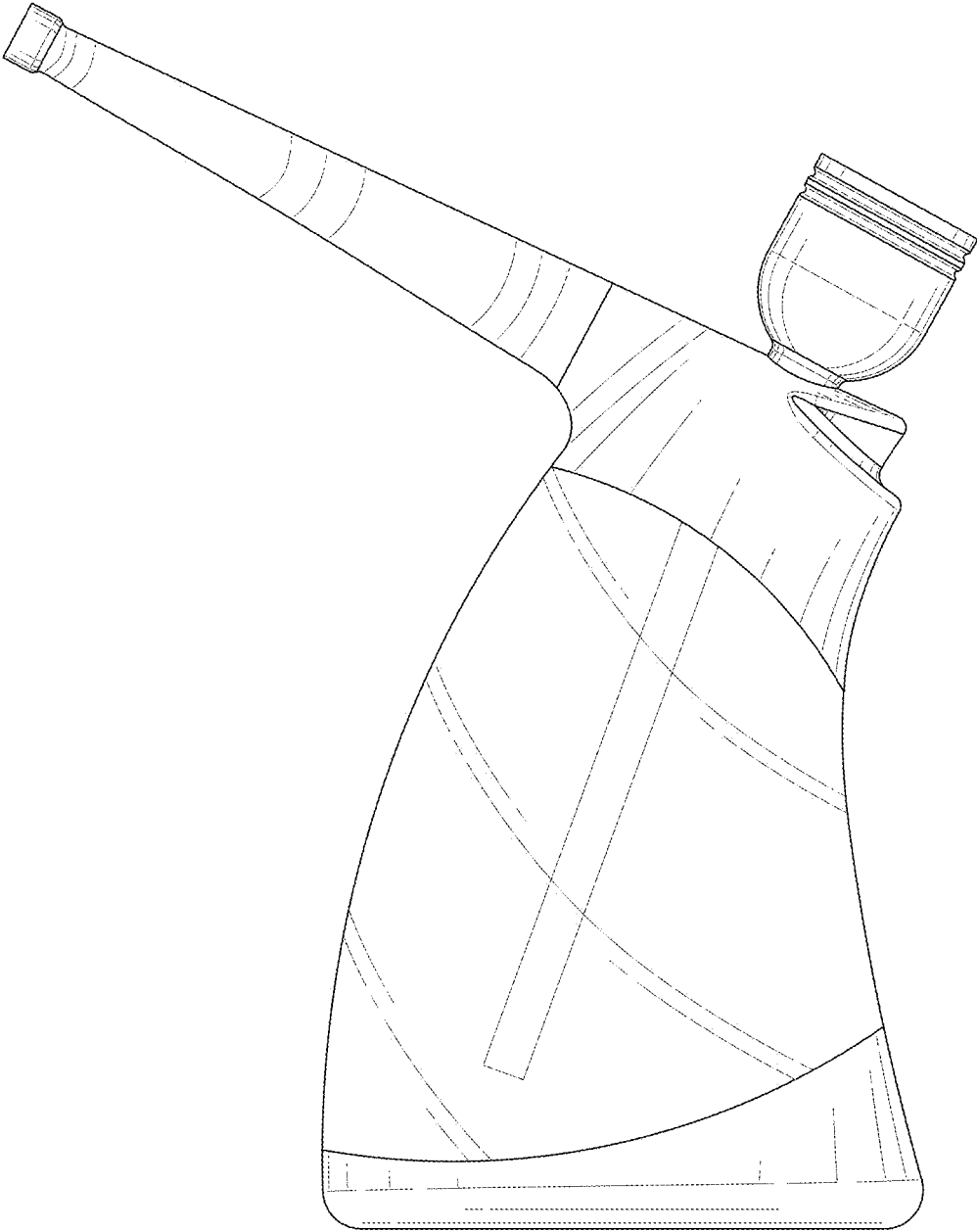

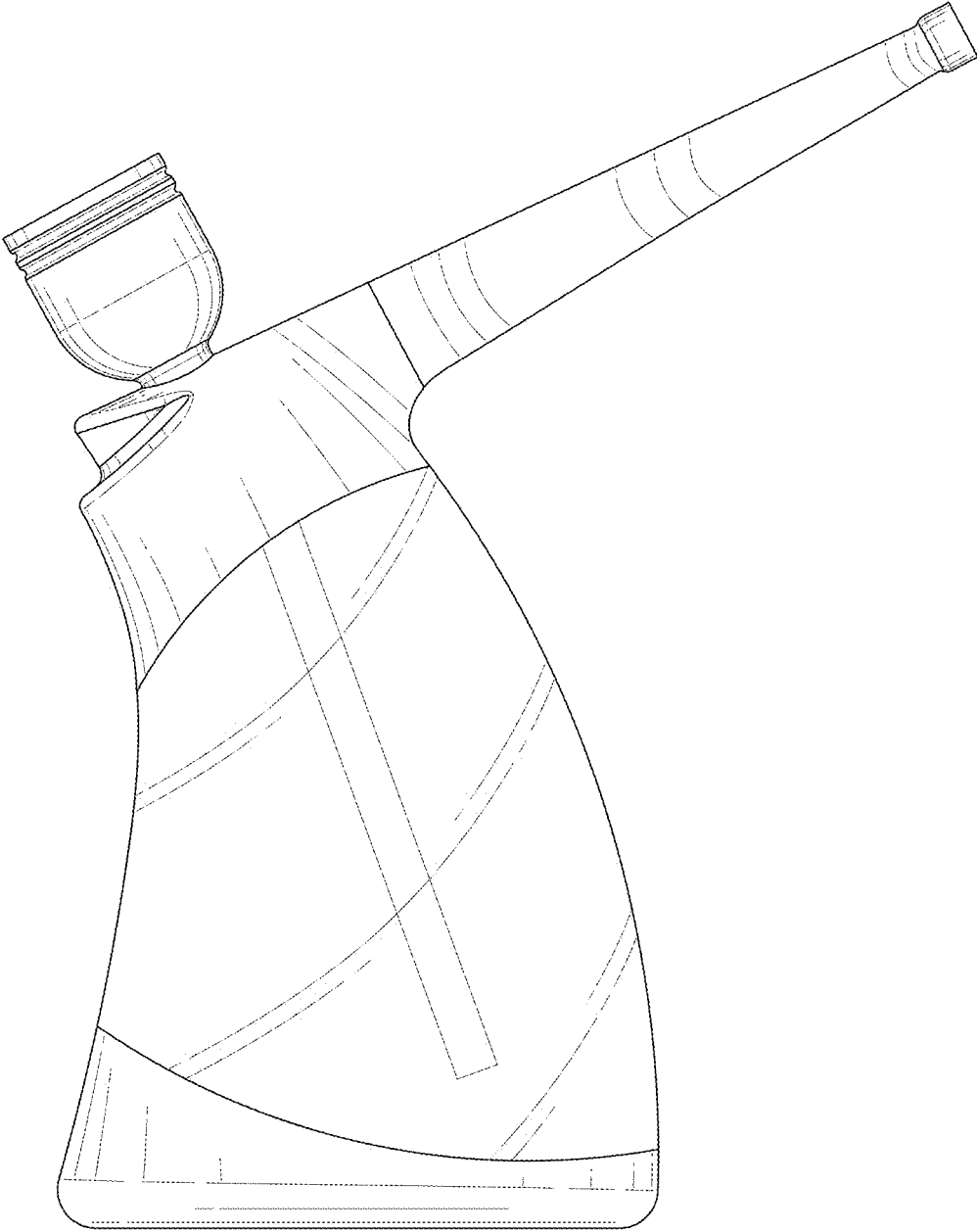

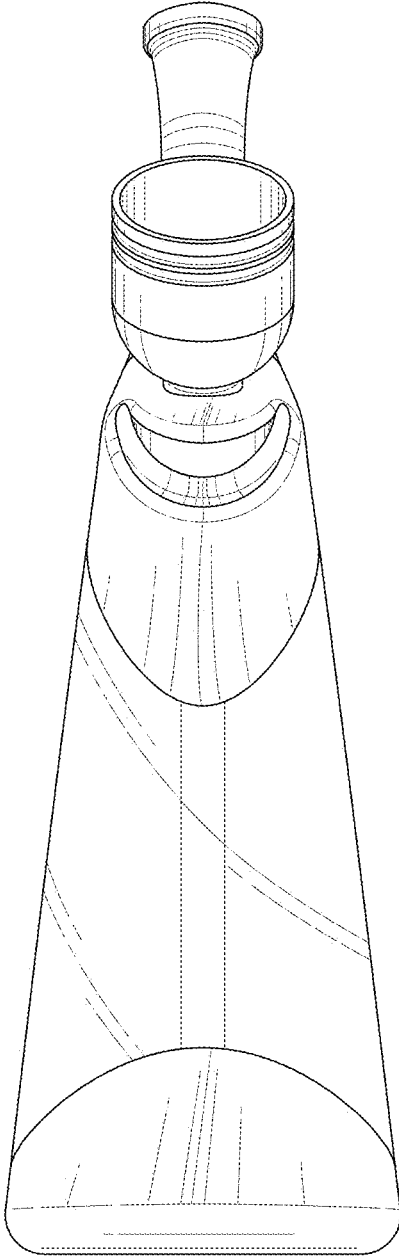

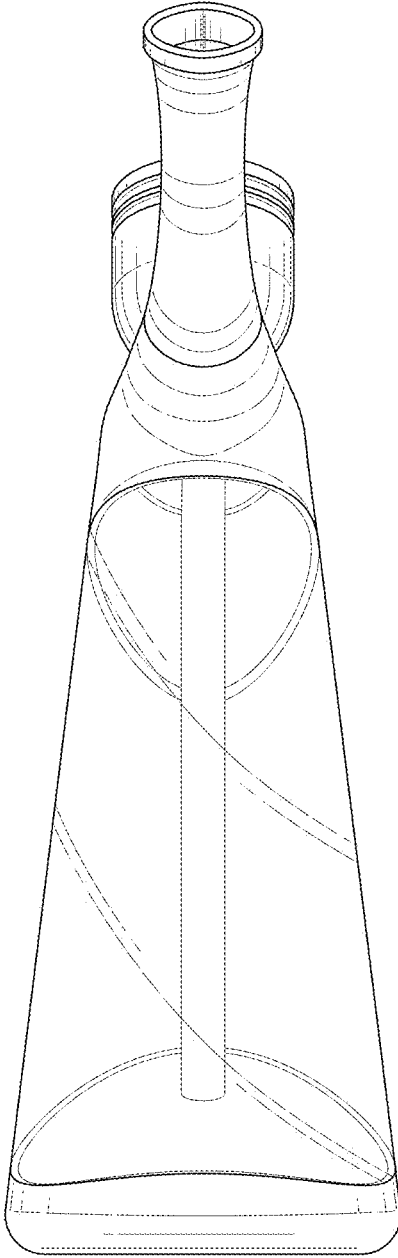

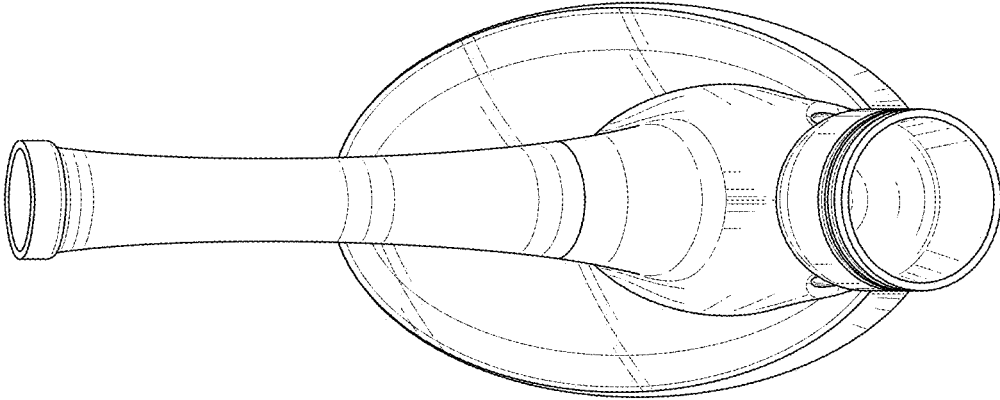

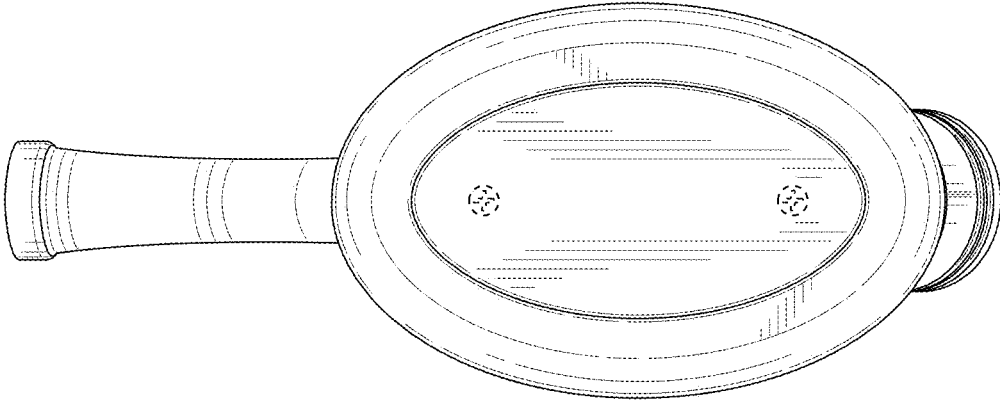
