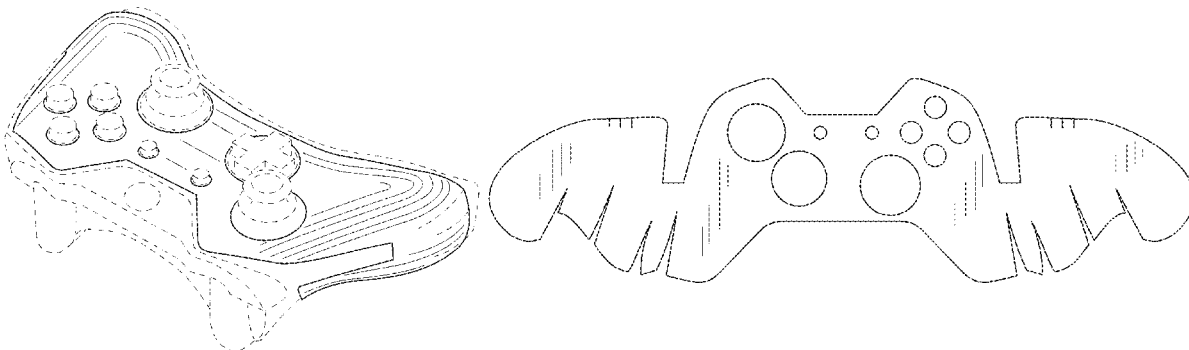
(57) **CLAIM**

The ornamental design for the wraparound grip for a gaming controller, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a wraparound grip for a gaming controller showing the new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right elevation view thereof; FIG. 5 is a left elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a front elevation view that shows the wraparound grip for a gaming controller in an unwrapped position. The broken lines in the drawings illustrate portions of the wraparound grip for a gaming controller which form no part of the claimed design.

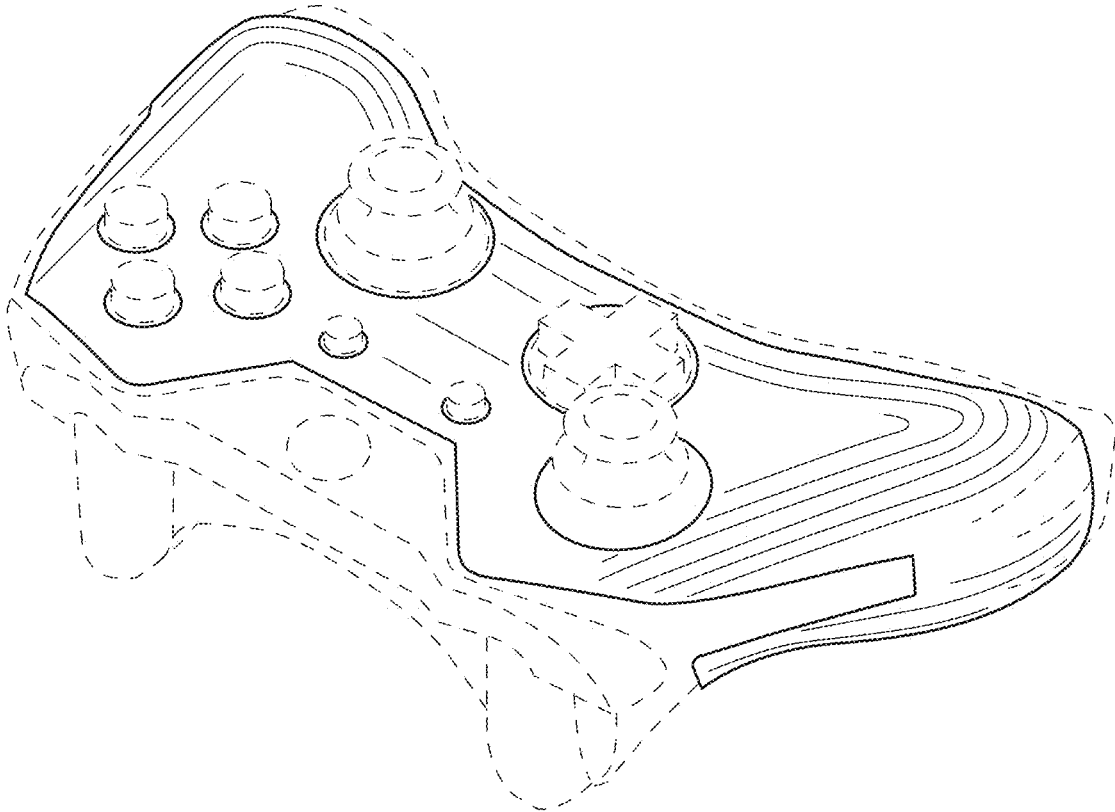

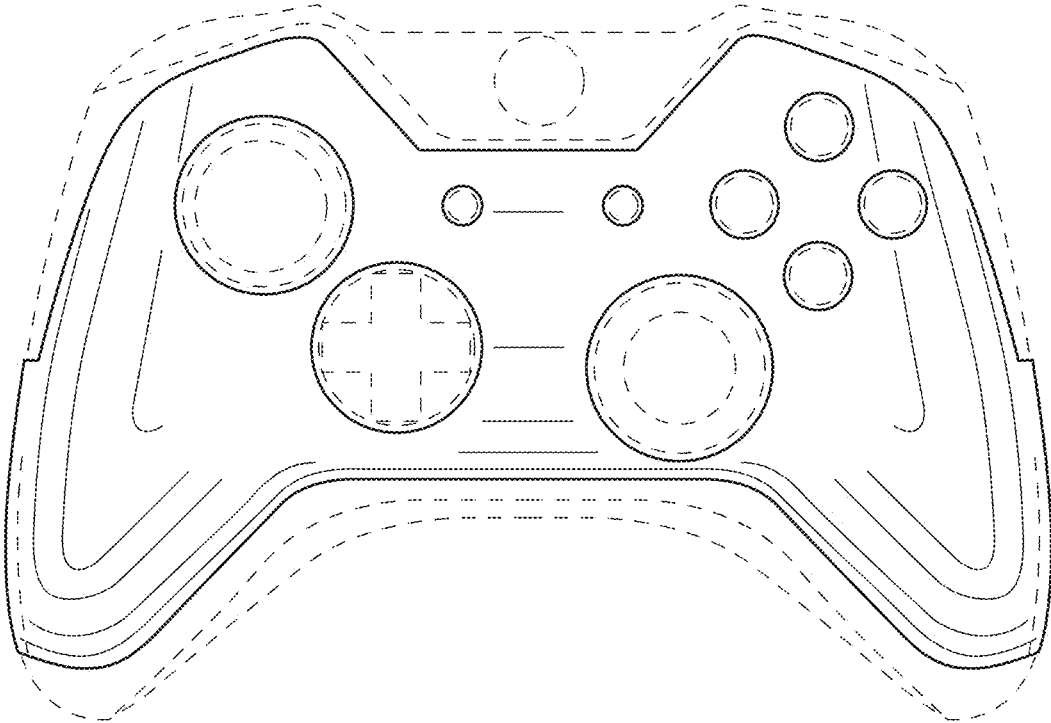

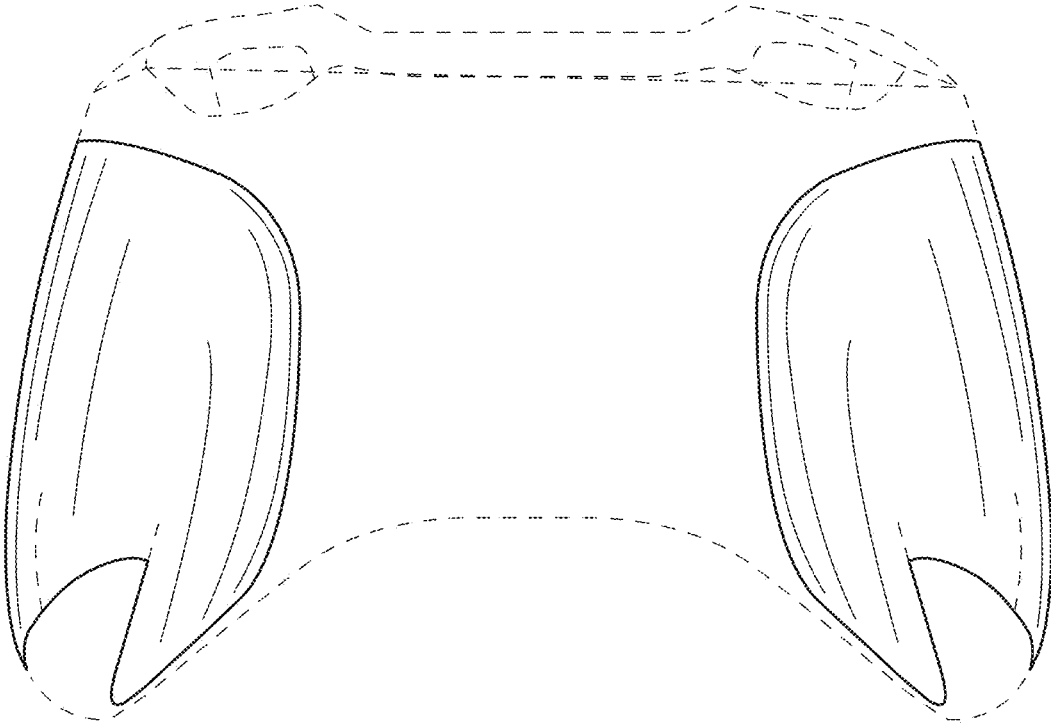

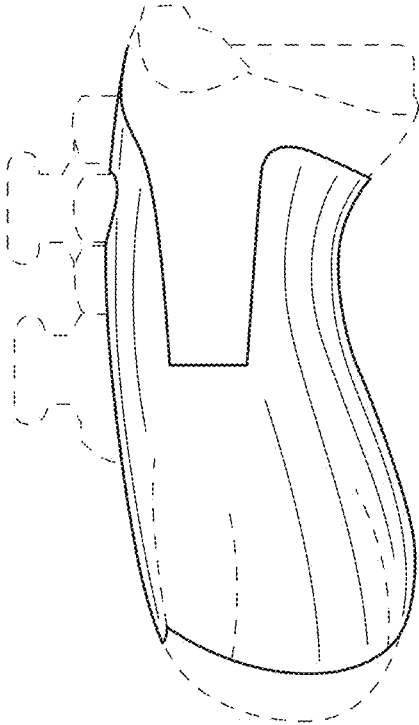

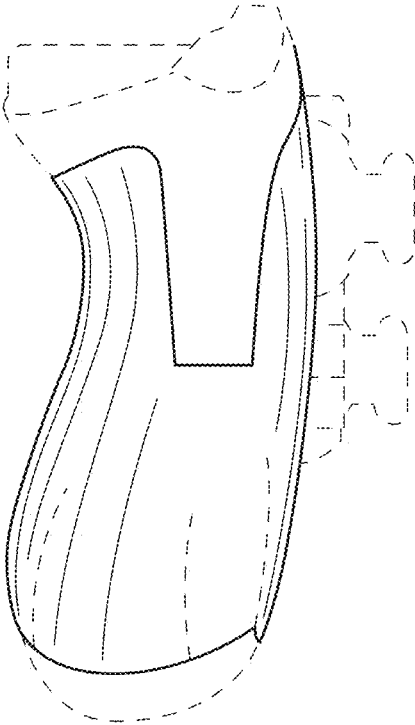

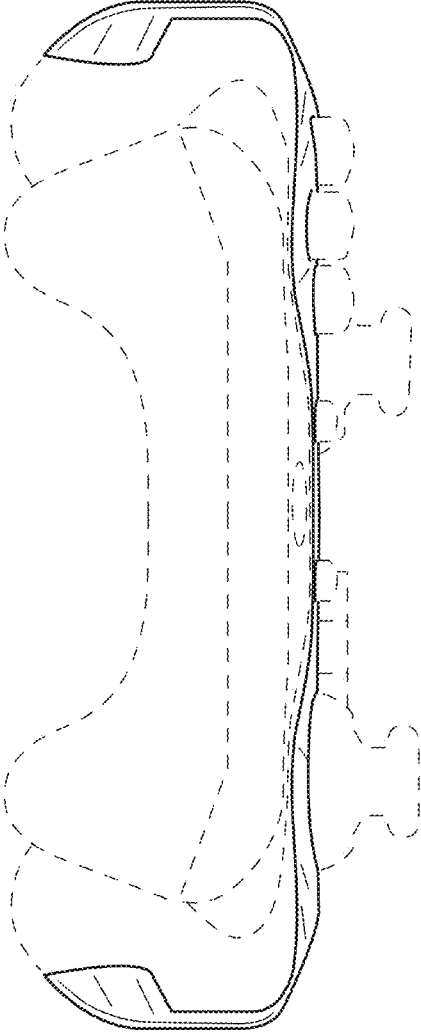

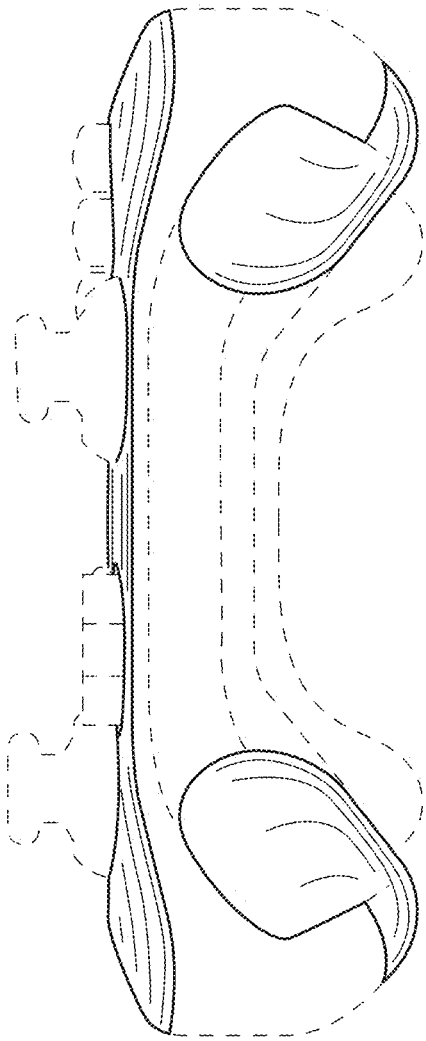

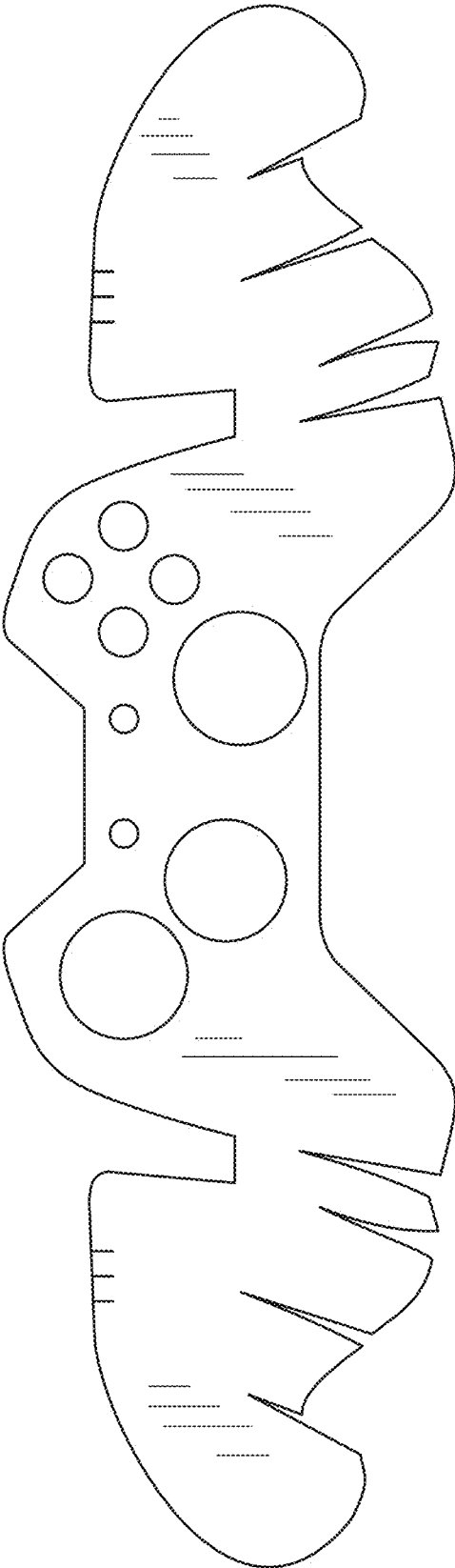
