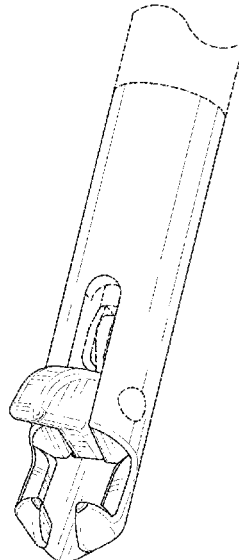
FIG. 1 is a front perspective view of a needle holder for endoscopic surgery showing our new design in an opened state;

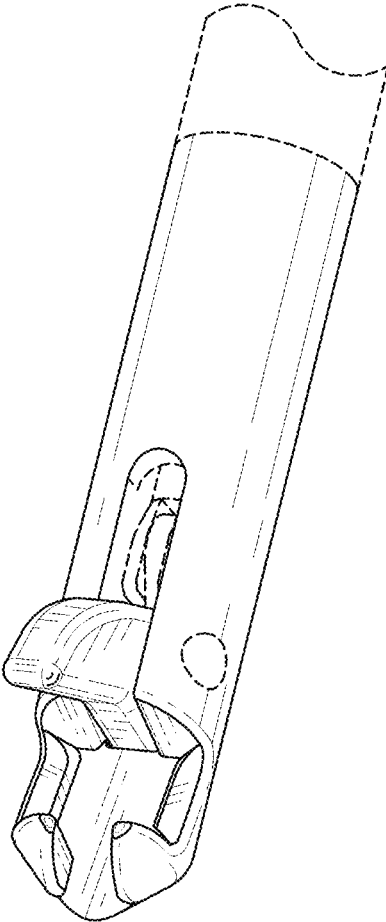

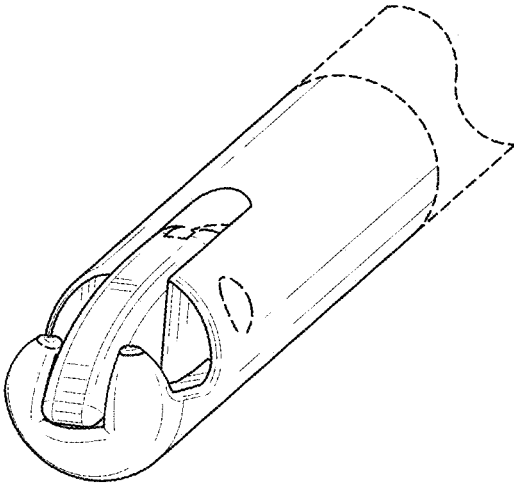

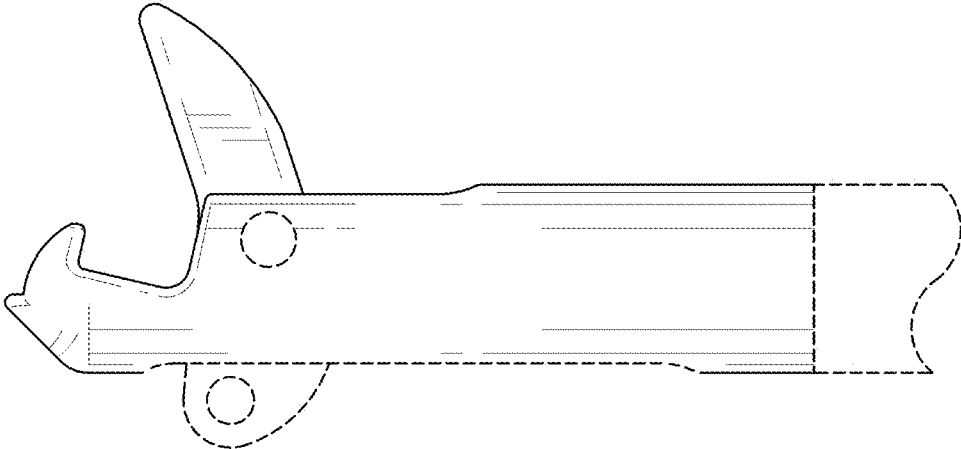

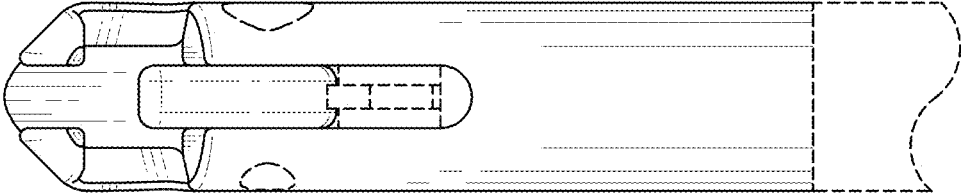

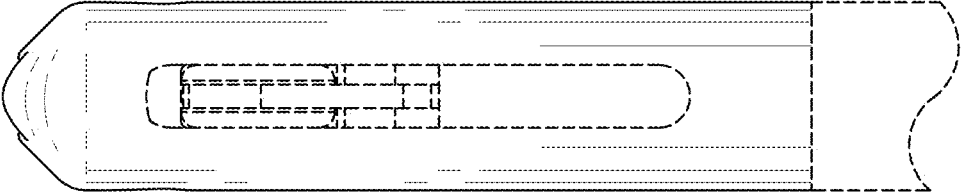

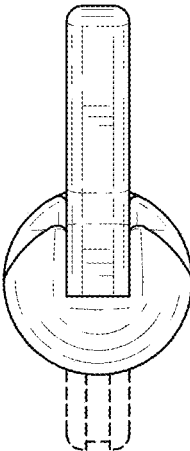

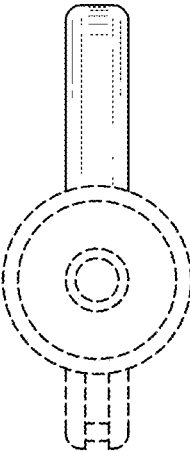
