



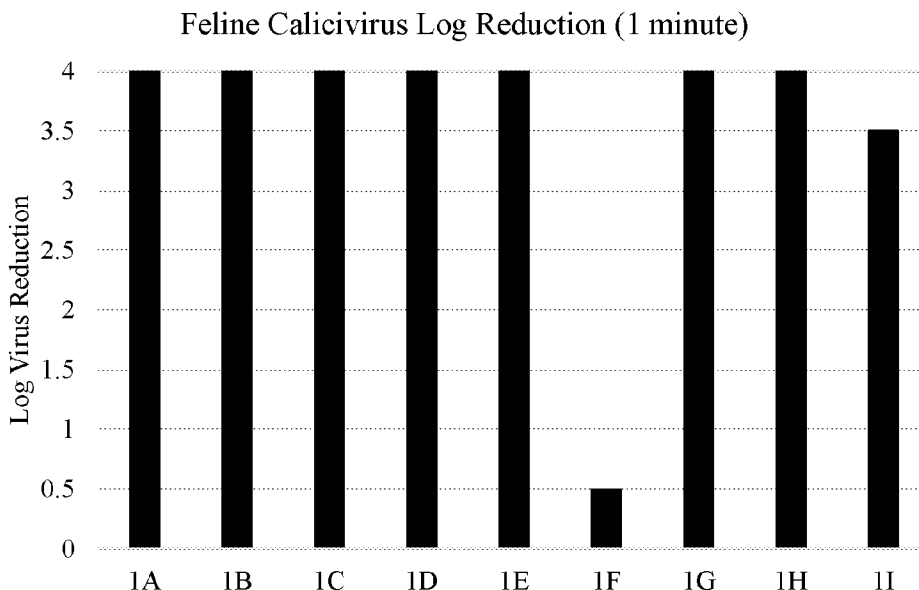

(57) **Abrégé/Abstract:**

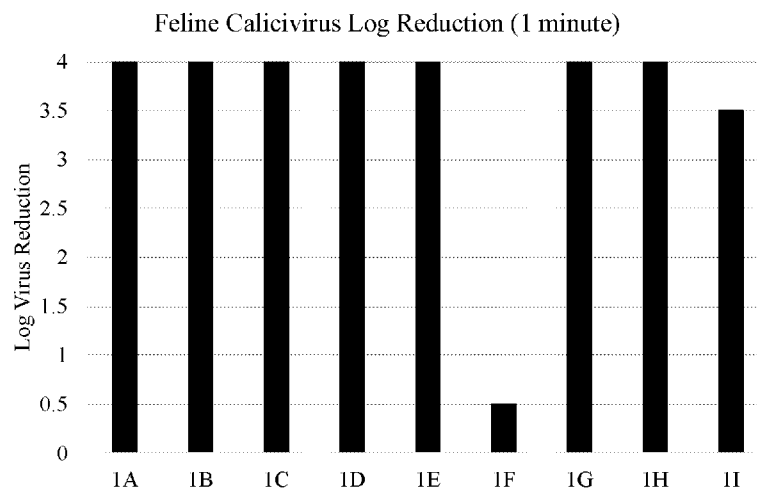

## HARD SURFACE CLEANING SOLUTION WITH RAPID VIRICIDAL ACTIVITY

### CROSS-REFERENCE

5           This application is related to and claims priority under 35 U.S.C. § 119 to U.S. Provisional Application Ser. No. 62/833,274 filed on April 12, 2019 and entitled “HARD SURFACE CLEANING SOLUTION WITH RAPID VIRICIDAL ACTIVITY”; the entire contents of this patent application are hereby expressly incorporated herein by reference.

### TECHNICAL FIELD

10           The disclosure relates to fast-acting viricidal compositions capable of removing soil, as well as inactivating a wide variety of viral pathogens, including poliovirus and norovirus. The compositions are especially effective on hard surfaces.

### BACKGROUND

15           Microbial and viral pathogens are an increasing public health concern. Pathogenic viruses present a significant health concern as they are able to persist on surfaces for longer periods of time and require complete and reliable inactivation in order to stop disease transmission. Such pathogens may often be present on many common objects and surfaces; the transmission of microbial and viral pathogens via contact with these objects and surfaces can cause illness or other health problems in humans and/or animals. As a result, disinfectant  
20           compositions are important for the prevention of bacterial and viral transmission of disease. However, the development of broad antiviral spectrum disinfectants with activity against both enveloped and non-enveloped viruses is limited due to the small number of compositions which can inactivate viruses.

25           The prevalence of microbial and viral pathogens is problematic especially for the healthcare industry, where microbial and viral pathogens can be transmitted by contact with healthcare surfaces contaminated with spillages or dispersion of body fluids from individuals carrying a bacteria, disease, infection, or virus. Surfaces in public and/or private facilities, such as counter tops, floors, bathroom furniture, etc. as well as food processing surfaces must often be treated with viricidal compositions to kill and remove pathogens.

30           In general, viruses can be identified according to a hierarchy that correspondences with the level of resistance to being inactivated. The three viral subgroups include small non-enveloped, large non-enveloped, and enveloped viruses. A viricidal product that is able to inactivate a small, non-enveloped virus is also able to inactivate any large, non-enveloped

virus or any enveloped virus. Similarly, a viricidal product that can inactivate a large, non-enveloped virus is also able to inactivate any enveloped virus.

Poliovirus is an exemplary small, non-enveloped virus wherein there is a need to develop additional compositions for surface treatment. More specifically, poliovirus is a non-enveloped enteric RNA virus belonging to the *Picornaviridae* family and composed of 60  
5 copies each of 4 repeating proteins (VP1, VP2, VP3, and VP4). Poliovirus can replicate in many cell types; in some cases, poliovirus can invade and replicate within the central nervous system (CNS), causing permanent motor neuron damage leading to paralysis. In addition, poliovirus can cause fever, headache, nausea and vomiting.

10 Polioviruses may be spread through feces and saliva, both by individuals infected with the disease, and also through the shedding of “live” oral polio vaccine. Although significant progress has been made towards global eradication of polio, there are still several countries globally where the wild poliovirus remains endemic. Additionally, there are several documented cases of polio due to circulating vaccine-derived poliovirus (cVDPV). As a  
15 result, there is still a risk of polio infection in those without vaccination or having a comprised immune system. Even though the risk of polio infection has been reduced, the ability of a composition to inactivate polio virions is significant because polioviruses are largely employed as model non-enveloped viruses. The poliovirus virion is acid resistant, making it resistant to many common disinfectants; thus the poliovirus is used as a model non-  
20 enveloped virus because inactivation of the poliovirus indicates broad spectrum antiviral effect both for other non-enveloped viruses but also across the viral hierarchy.

In addition to poliovirus, norovirus is another small, non-enveloped virus in need of additional viricidal compositions for surface treatment. The non-enveloped Norovirus (NoV), also known previously as “Norwalk-Like Virus” (NLV) or small round structured virus, is the  
25 most important viral pathogen of epidemic acute gastroenteritis that occurs in both developed and developing countries. NoV belongs to the *Caliciviridae* family and are icosahedral, single stranded, positive-sense RNA viruses whose capsids are composed of 180 copies of a single major structural protein. Noroviruses are estimated to cause 23 million cases of acute gastroenteritis in the United States per year, and are the leading cause of gastroenteritis in the  
30 United States. Of viruses, only the common cold is reported more often than viral gastroenteritis (norovirus). Norovirus causes nausea, vomiting (sometimes accompanied by diarrhea), and stomach cramps. This infection typically is spread from person to person by direct contact.

Noroviruses are very highly contagious and can spread easily from person to person. People can become infected with the norovirus in several ways, including, eating food or drinking liquids that are contaminated with norovirus; touching surfaces or objects contaminated with norovirus, and then placing their hands in their mouths; or having direct  
5 contact with another person who is infected and showing symptoms (for example, when caring for someone who is ill, or sharing foods or eating utensils with someone who is ill). During outbreaks of norovirus gastroenteritis, several modes of transmission have been documented, for example, initial foodborne transmission in a restaurant, followed by secondary person-to-person transmission to household contacts.

10 Accordingly there is a need to identify and develop viricidal compositions that can inactivate small, non-enveloped viruses, specifically poliovirus and norovirus, to then be able to have corresponding viricidal efficacy across the viral hierarchy.

Product distribution and dispersion poses another problem in the development of viricidal compositions. Even when an effective viricidal composition is developed, that  
15 composition must also be stable, fast-acting, and easy to quickly apply.

Many viricidal compositions rely on active agents which lack ideal shelf stability. For example, several viricidal compositions utilize chlorine-based compounds, such as sodium hypochlorite, as the active viricidal agent. However, chlorine is highly susceptible to degradation in response to changes in pH, temperature, and light, among others. Quaternary  
20 ammonium compounds are another potential viricidal active. However, quaternary ammonium compound-based formulations are often less effective against non-enveloped viruses, and there are growing concerns that quaternary ammonium compounds released into the environment can lead to bacterial resistance. Peroxide compositions represent another type of viricidal composition, however much like chlorine-based compounds, peroxides also  
25 have poor shelf stability and can be costly to manufacture. As a result, there is a need to develop stable viricidal compositions.

Further, as many viruses demonstrate viricidal resistance and can sometimes survive for long periods of time outside of the human body, the viricidal compositions must be fast-acting, *i.e.* must be able to quickly inactivate viruses and reduce the chance of the spread of  
30 infection. As a result, there is a need to develop compositions and methods to provide viricidal and disinfectant compositions against small, non-enveloped viruses (and also large, non-enveloped viruses and enveloped viruses), in a short contact time, preferably 10 minutes or less, more preferably 5 minutes or less, and most preferred 1 minute or less.

Finally, to facilitate the quick inactivation of pathogens and to reduce the risk of transmission, viricidal compositions should be easy to use and/or apply to a surface. For example, in some applications, such as hospitals, a powdered viricidal composition is applied to a surface to absorb liquids potentially contaminated with pathogens. However, it is  
5 difficult to measure the correct quantity of powder to apply, and this method requires the removal of additional solid materials from the surface. As a result, there is a need to develop effective viricidal compositions which may be easily applied to a surface, for example by spraying, flooding, and/or as wipe or pad pre-saturated with the composition.

Other objects, advantages and features of the present invention will become apparent  
10 from the following specification taken in conjunction with the accompanying figures.

### **BRIEF SUMMARY**

An advantage of the viricidal compositions disclosed herein is that they provide improved viricidal activity against a variety of bacteria and viruses, including, in particular enveloped and non-enveloped viruses. Importantly, it was found that it provides strong kill  
15 rates against polio which is notoriously difficult to kill. Another advantage of the viricidal compositions is that they provide surprising good cleaning and soil removal.

A preferred embodiment is directed to a concentrated viricidal composition comprising between about 0.4 wt.% and about 30 wt.% of an anionic sulfonated or sulfated surfactant; between about 5 wt.% and about 95 wt.% of a solvent having less than 5%  
20 (wt./wt.) solubility in water; wherein the composition has a pH of less than about 3.5 when diluted to a use solution.

Another preferred embodiment is directed to a ready-to-use viricidal composition comprising between about 0.1 wt.% and about 10 wt.% of an anionic sulfonated or sulfated surfactant; between about 1 wt.% and about 40 wt.% of a solvent having a less than 5%  
25 (wt./wt.) solubility in water; wherein the composition has a pH of less than about 3.5.

A preferred embodiment of the composition also includes methods of cleaning a surface comprising contacting a surface with a viricidal composition. As described herein, the compositions can be applied in any suitable method, including, but not limited to, pouring, spraying, wiping, mopping, or a combination thereof. In an aspect of the disclosure, the  
30 compositions can be saturated on a wipe, including, both pre-saturated or saturated at the time of use. Preferably, the compositions disclosed herein provides at least about 3 log reduction in polio in about 1 minute or less.

While multiple embodiments are disclosed, still other embodiments will become apparent to those skilled in the art from the following detailed description, which shows and

describes illustrative embodiments of the invention. Accordingly, the figures and detailed description are to be regarded as illustrative in nature and not restrictive.

#### **BRIEF DESCRIPTION OF THE FIGURES**

FIG. 1A shows the log virus reduction of feline calicivirus after being contacted with  
5 nine different exemplary viricidal compositions for one minute.

FIG. 1B shows the log virus reduction of feline calicivirus after being contacted with seven additional exemplary viricidal compositions for one minute.

FIG. 2A shows the log virus reduction of feline calicivirus after being contacted with nine different exemplary viricidal compositions for one minute when the surfactants in each  
10 of the exemplary compositions was varied to assess surfactant impact of cidal activity.

FIG. 2B shows the log virus reduction of feline calicivirus after being contacted with seven additional exemplary viricidal compositions for one minute when the surfactants in each of the exemplary compositions was varied to assess surfactant impact of cidal activity.

Various embodiments of the viricidal compositions and their methods of manufacture  
15 and use will be described in detail with reference to the figures. Reference to various embodiments does not limit the scope of the inventions. Figures represented herein are not limitations to the various embodiments according to the invention and are presented for exemplary illustration of the invention.

#### **DETAILED DESCRIPTION OF THE PREFERRED EMBODIMENT**

20 The present disclosure relates to stable, rapid-acting viricidal compositions, methods of making, and uses thereof. It is further to be understood that all terminology used herein is for the purpose of describing particular embodiments only, and is not intended to be limiting in any manner or scope. For example, as used in this specification and the appended claims, the singular forms “a,” “an” and “the” can include plural referents unless the content clearly  
25 indicates otherwise. Further, all units, prefixes, and symbols may be denoted in its SI accepted form.

Numeric ranges recited within the specification are inclusive of the numbers defining the range and include each integer within the defined range. Throughout this disclosure, various aspects of this invention are presented in a range format. It should be understood that the  
30 description in range format is merely for convenience and brevity and should not be construed as an inflexible limitation on the scope of the invention. Accordingly, the description of a range should be considered to have specifically disclosed all the possible sub-ranges, fractions, and individual numerical values within that range. For example, description of a range such as from 1 to 6 should be considered to have specifically disclosed sub-ranges such as from 1 to 3,



from 1 to 4, from 1 to 5, from 2 to 4, from 2 to 6, from 3 to 6 etc., as well as individual numbers within that range, for example, 1, 2, 3, 4, 5, and 6, and decimals and fractions, for example, 1.2, 3.8, 1½, and 4¾. This applies regardless of the breadth of the range.

### **Definitions**

5           So that the present invention may be more readily understood, certain terms are first defined. Unless defined otherwise, all technical and scientific terms used herein have the same meaning as commonly understood by one of ordinary skill in the art to which  
embodiments of the invention pertain. Many methods and materials similar, modified, or  
equivalent to those described herein can be used in the practice of the embodiments of the  
10 present invention without undue experimentation, the preferred materials and methods are described herein. In describing and claiming the embodiments of the present invention, the following terminology will be used in accordance with the definitions set out below.

          The term “about,” as used herein, refers to variation in the numerical quantity that can occur, for example, through typical measuring techniques and equipment, with respect to any  
15 quantifiable variable, including, but not limited to, mass, volume, time, temperature, pH, and log count of bacteria or viruses. Further, given solid and liquid handling procedures used in the real world, there is certain inadvertent error and variation that is likely through differences in the manufacture, source, or purity of the ingredients used to make the compositions or carry out the methods and the like. The term “about” also encompasses these  
20 variations. Whether or not modified by the term “about,” the claims include equivalents to the quantities.

          The methods and compositions of the present invention may comprise, consist essentially of, or consist of the components and ingredients of the present invention as well as other ingredients described herein. As used herein, “consisting essentially of” means that the  
25 methods, systems, apparatuses and compositions may include additional steps, components or ingredients, but only if the additional steps, components or ingredients do not materially alter the basic and novel characteristics of the claimed methods, systems, apparatuses, and compositions.

          The term “actives” or “percent actives” or “percent by weight actives” or “actives  
30 concentration” are used interchangeably herein and refers to the concentration of those ingredients involved in cleaning expressed as a percentage minus inert ingredients such as water or salts. It is also sometimes indicated by a percentage in parentheses, for example, “chemical (10%).”

As used herein, the term “alkyl” or “alkyl groups” refers to saturated hydrocarbons having one or more carbon atoms, including straight-chain alkyl groups (e.g., methyl, ethyl, propyl, butyl, pentyl, hexyl, heptyl, octyl, nonyl, decyl, etc.), cyclic alkyl groups (or “cycloalkyl” or “alicyclic” or “carbocyclic” groups) (e.g., cyclopropyl, cyclopentyl, 5 cyclohexyl, cycloheptyl, cyclooctyl, etc.), branched-chain alkyl groups (e.g., isopropyl, tert-butyl, sec-butyl, isobutyl, etc.), and alkyl-substituted alkyl groups (e.g., alkyl-substituted cycloalkyl groups and cycloalkyl-substituted alkyl groups).

Unless otherwise specified, the term “alkyl” includes both “unsubstituted alkyls” and “substituted alkyls.” As used herein, the term “substituted alkyls” refers to alkyl groups 10 having substituents replacing one or more hydrogens on one or more carbons of the hydrocarbon backbone. Such substituents may include, for example, alkenyl, alkynyl, halogeno, hydroxyl, alkylcarbonyloxy, arylcarbonyloxy, alkoxy carbonyloxy, aryloxy, aryloxy carbonyloxy, carboxylate, alkylcarbonyl, arylcarbonyl, alkoxy carbonyl, aminocarbonyl, alkylaminocarbonyl, dialkylaminocarbonyl, alkylthiocarbonyl, alkoxy, 15 phosphate, phosphonato, phosphinato, cyano, amino (including alkyl amino, dialkylamino, arylamino, diarylamino, and alkylarylamino), acylamino (including alkylcarbonylamino, arylcarbonylamino, carbamoyl and ureido), imino, sulfhydryl, alkylthio, arylthio, thiocarboxylate, sulfates, alkylsulfinyl, sulfonates, sulfamoyl, sulfonamido, nitro, trifluoromethyl, cyano, azido, heterocyclic, alkylaryl, or aromatic (including heteroaromatic) 20 groups.

In some embodiments, substituted alkyls can include a heterocyclic group. As used herein, the term “heterocyclic group” includes closed ring structures analogous to carbocyclic groups in which one or more of the carbon atoms in the ring is an element other than carbon, for example, nitrogen, sulfur or oxygen. Heterocyclic groups may be saturated or 25 unsaturated. Exemplary heterocyclic groups include, but are not limited to, aziridine, ethylene oxide (epoxides, oxiranes), thiirane (episulfides), dioxirane, azetidine, oxetane, thietane, dioxetane, dithietane, dithiete, azolidine, pyrrolidine, pyrroline, oxolane, dihydrofuran, and furan. As used herein, the term “soil” or “stain” refers to a non-polar oily substance which may or may not contain particulate matter such as mineral clays, sand, 30 natural mineral matter, carbon black, graphite, kaolin, environmental dust, etc.

As used herein, the term “cleaning” refers to a method used to facilitate or aid in soil removal, bleaching, microbial population reduction, and any combination thereof. As used herein, the term “microorganism” refers to any noncellular or unicellular (including colonial) organism. Microorganisms include all prokaryotes. Microorganisms include bacteria

(including cyanobacteria), spores, lichens, fungi, protozoa, virinos, viroids, viruses, phages, and some algae. As used herein, the term “microbe” is synonymous with microorganism.

As used herein, the phrase “food processing surface” refers to a surface of a tool, a machine, equipment, a structure, a building, or the like that is employed as part of a food  
5 processing, preparation, or storage activity. Examples of food processing surfaces include surfaces of food processing or preparation equipment (e.g., slicing, canning, or transport equipment, including flumes), of food processing wares (e.g., utensils, dishware, wash ware, and bar glasses), and of floors, walls, or fixtures of structures in which food processing  
10 occurs. Food processing surfaces are found and employed in food anti-spoilage air circulation systems, aseptic packaging sanitizing, food refrigeration and cooler cleaners and sanitizers, ware washing sanitizing, blancher cleaning and sanitizing, food packaging materials, cutting board additives, third-sink sanitizing, beverage chillers and warmers, meat  
15 chilling or scalding waters, autodish sanitizers, sanitizing gels, cooling towers, food processing viricidal garment sprays, and non-to-low-aqueous food preparation lubricants, oils, and rinse additives.

As used herein, the phrase “food product” includes any food substance that might require treatment with a viricidal agent or composition and that is edible with or without further preparation. Food products include meat (e.g. red meat and pork), seafood, poultry, produce (e.g., fruits and vegetables), eggs, living eggs, egg products, ready to eat food,  
20 wheat, seeds, roots, tubers, leaves, stems, corns, flowers, sprouts, seasonings, or a combination thereof. The term “produce” refers to food products such as fruits and vegetables and plants or plant-derived materials that are typically sold uncooked and, often, unpackaged, and that can sometimes be eaten raw.

The term “hard surface” refers to a solid, substantially non-flexible surface such as a  
25 counter top, tile, floor, wall, panel, window, plumbing fixture, kitchen and bathroom furniture, appliance, engine, circuit board, and dish. Hard surfaces may include for example, health care surfaces and food processing surfaces.

As used herein, the phrase “health care surface” refers to a surface of an instrument, a device, a cart, a cage, furniture, a structure, a building, or the like that is employed as part of  
30 a health care activity. Examples of health care surfaces include surfaces of medical or dental instruments, of medical or dental devices, of electronic apparatus employed for monitoring patient health, and of floors, walls, or fixtures of structures in which health care occurs. Health care surfaces are found in hospital, surgical, infirmity, birthing, mortuary, and clinical diagnosis rooms. These surfaces can be those typified as “hard surfaces” (such as walls,

5 floors, bed-pans, etc.), or fabric surfaces, e.g., knit, woven, and non-woven surfaces (such as surgical garments, draperies, bed linens, bandages, etc.), or patient-care equipment (such as respirators, diagnostic equipment, shunts, body scopes, wheel chairs, beds, etc.), or surgical and diagnostic equipment. Health care surfaces include articles and surfaces employed in animal health care.

As used herein, the term “soft surface” refers to surfaces not classified as hard surfaces, but which are solid surfaces. Soft surfaces, include, but are not limited to, textiles, fabrics, woven surfaces, and non-woven surfaces. Soft surfaces, include, but are not limited to, carpets, curtains, fabrics, hospital partitions, linens, upholstery, padded seats, cushions, pillows, or a combination thereof.

As used herein, the term “instrument” refers to the various medical or dental instruments or devices that can benefit from cleaning with a composition according to the present invention.

As used herein, the phrase “meat product” refers to all forms of animal flesh, including the carcass, muscle, fat, organs, skin, bones and body fluids and like components that form the animal. Animal flesh includes, but is not limited to, the flesh of mammals, birds, fishes, reptiles, amphibians, snails, clams, crustaceans, other edible species such as lobster, crab, etc., or other forms of seafood. The forms of animal flesh include, for example, the whole or part of animal flesh, alone or in combination with other ingredients. Typical forms include, for example, processed meats such as cured meats, sectioned and formed products, minced products, finely chopped products, ground meat and products including ground meat, whole products, and the like.

As used herein, the phrases “medical instrument,” “dental instrument,” “medical device,” “dental device,” “medical equipment,” or “dental equipment” refer to instruments, devices, tools, appliances, apparatus, and equipment used in medicine or dentistry. Such instruments, devices, and equipment can be cold sterilized, soaked or washed and then heat sterilized, or otherwise benefit from cleaning in a composition of the present invention. These various instruments, devices and equipment include, but are not limited to: diagnostic instruments, trays, pans, holders, racks, forceps, scissors, shears, saws (e.g. bone saws and their blades), hemostats, knives, chisels, rongeurs, files, nippers, drills, drill bits, rasps, burrs, spreaders, breakers, elevators, clamps, needle holders, carriers, clips, hooks, gouges, curettes, retractors, straightener, punches, extractors, scoops, keratomes, spatulas, expressers, trocars, dilators, cages, glassware, tubing, catheters, cannulas, plugs, stents, scopes (e.g., endoscopes, stethoscopes, and arthroscopes) and related equipment, and the like, or combinations thereof.

As used herein, the term “microorganism” refers to any noncellular or unicellular (including colonial) organism. Microorganisms include all prokaryotes. Microorganisms include bacteria (including cyanobacteria), spores, lichens, fungi, protozoa, virinos, viroids, viruses, phages, and some algae. As used herein, the term “microbe” is synonymous with  
5 microorganism.

As used herein, the term “substantially free” refers to compositions completely lacking the component or having such a small amount of the component that the component does not affect the performance of the composition. The component may be present as an impurity or as a contaminant and shall be less than 0.5 wt-%. In another embodiment, the  
10 amount of the component is less than 0.1 wt-% and in yet another embodiment, the amount of component is less than 0.01 wt-%.

As used herein, the term “viricidal” refers to a compound or composition that reduces and/or inactivates a virus within about 10 minutes or less. Preferably, the term virucidal refers to a composition that provides at least about a 3-log reduction of the virus in about 10  
15 minutes or less, more preferably at least about a 4-log reduction of the virus in about 10 minutes or less, most preferably about a 5-log reduction of the virus in about 10 minutes or less.

The term “virus”, as used herein refers to a type of microorganism that can include both pathogenic and non-pathogenic viruses. Pathogenic viruses can be classified into two  
20 general types with respect to the viral structure: enveloped viruses and non-enveloped viruses. Some well-known enveloped viruses include herpes virus, influenza virus, paramyxovirus, respiratory syncytial virus, corona virus, HIV, hepatitis B virus, hepatitis C virus and SARS-CoV virus. Non-enveloped viruses, sometimes referred to as “naked” viruses, include the families Picornaviridae, Reoviridae, Caliciviridae, Adenoviridae and  
25 Parvoviridae. Members of these families include rhinovirus, poliovirus, adenovirus, hepatitis A virus, norovirus, papillomavirus, and rotavirus. It is known in the art that “enveloped” viruses are relatively sensitive and, thus, can be inactivated by commonly used disinfectants. In contrast, non-enveloped viruses are substantially more resistant to conventional disinfectants and are significantly more environmentally stable than enveloped viruses.

As used herein, the term “ware” refers to items such as eating and cooking utensils, dishes, and other hard surfaces such as showers, sinks, toilets, bathtubs, countertops, windows, mirrors, transportation vehicles, and floors. As used herein, the term  
30 “warewashing” refers to washing, cleaning, or rinsing ware. Ware also refers to items made of plastic. Types of plastics that can be cleaned with the compositions according to the

invention include but are not limited to, those that include polypropylene polymers (PP), polycarbonate polymers (PC), melamine formaldehyde resins or melamine resin (melamine), acrylonitrile-butadiene-styrene polymers (ABS), and polysulfone polymers (PS). Other exemplary plastics that can be cleaned using the compounds and compositions of the invention include polyethylene terephthalate (PET) polystyrene polyamide.

The terms “water soluble” and “water dispersible” as used herein, means that the ingredient is soluble or dispersible in water in the viricidal compositions. In general, the ingredient should be soluble or dispersible at 25° C concentration of between about 0.1 wt.% and about 15 wt.% of the water, more preferably at a concentration of between about 0.1 wt.% and about 10 wt.%. Sometimes ingredients, such as the solvents, can also be referred to as “sparingly soluble”, which means the compositions are only soluble between about 0.5 wt.% and about 8 wt.% in water.

The term “weight percent,” “wt.%,” “wt-%,” “percent by weight,” “% by weight,” and variations thereof, as used herein, refer to the concentration of a substance as the weight of that substance divided by the total weight of the composition and multiplied by 100.

### **Compositions**

The compositions according to the present application may be as liquid concentrates or ready to use solutions. The desired concentration for a ready-to-use solution may be dependent on its end-use and application. Further, it should be understood that the concentrates may vary in their concentration based on the end dilution ratio and whether the concentrate is formulated as an anhydrous or aqueous formulation. Preferred concentrated compositions can be prepared according to Table 1A and preferred ready-to-use compositions can be prepared according to Table 1B. The pH of the compositions may range from about 5 to about 0, preferably between about 1 and about 3.5, and more preferably between about 2 and about 3.2, and all ranges therebetween. In an embodiment comprising a carrier, the carrier is preferably water or a water miscible solvent; however, some embodiments can be anhydrous and have less than about 5 wt.% water, more preferably less than about 1 wt.% water, most preferably less than about 0.5 wt.% water. In a preferred embodiment, the compositions contain less than about 1 wt.%, preferably less about 0.5 wt.%, more preferably less than about 0.1 wt.%, most preferably not include any added peroxide such as hydrogen peroxide. It should be understood that some chemicals prepared with peroxide, may contain residual peroxide, which is not to be considered added peroxide. Rather added peroxide refers to peroxide intentionally added to the compositions.

Surprisingly, the viricidal compositions of the present application demonstrate improved viricidal performance when the compositions are prepared with a relatively high ratio of solvent to anionic surfactant. In an embodiment, the ratio of solvent to anionic surfactant is between at least about 4:1, is at least about 5:1, is at least about 6:1, is at least about 7.5:1, is at least about 8:1, is at least about 9:1, is at least about 10:1, is at least about 15:1, is at least about 20:1, is at least about 25:1, is about 30:1, is at least about 40:1, is at least about 50:1, or is at least about 100:1.

In a preferred embodiment, the viricidal compositions provide at least about a 3-log reduction of a virus, more preferably at least about a 4-log reduction, most preferably equal to or greater than about 5-log reduction. Preferably, the viricidal compositions provide these reductions in about 10 minutes or less, more preferably about 5 minutes or less, still more preferably about 3 minutes or less, and most preferably in about 1 minute or less. In a most preferred embodiment, the viricidal compositions provide complete inactivation of a virus in less than about 10 minutes, including, but not limited to polio virus.

The viricidal compositions may include concentrate compositions which can be diluted to form use compositions or ready to use (RTU) compositions. Beneficially, the compositions overcome a limitation of the prior art in that dilutable concentrates can be provided. In general, a concentrate refers to a composition that is intended to be diluted with

water to provide a use solution that contacts an object to provide the desired cleaning, viricidal efficacy, or the like. The viricidal composition that contacts the articles can be referred to as a ready-to-use composition (or use solution) dependent upon the formulation employed in the methods described herein. It should be understood that the concentration of the anionic surfactant(s), solvents, and any additional functional ingredients, in the composition will vary depending on whether the composition is provided as a concentrate or as a use solution.

A use solution may be prepared from the concentrate by diluting the solid or liquid concentrate with water at a dilution ratio that provides a use solution having desired deterative properties. The water that is used to dilute the concentrate to form the use composition can be referred to as water of dilution or a diluent, and can vary from one location to another. In a preferred embodiment, the dilution of the concentrated compositions can be at a dilution of about 0.5 oz per gallon to about 16 oz per gallon.

The liquid compositions can be provided in various forms well appreciated by those skilled in the art. The compositions can also be manufactured to include a saturated viricidal wipe, such as a paper or cloth substrate having the liquid compositions saturated thereon.

#### Anionic Sulfonated or Sulfated Surfactants

In a preferred embodiment, the compositions of the present invention include at least one anionic surfactant. In a preferred embodiment the surfactant is an anionic sulfonated or sulfated surfactant. In a preferred embodiment, the concentrated viricidal composition comprises between about 1 wt.% and about 30 wt.%, more preferably between about 3 wt.% and about 25 wt.%, and most preferably between about 5 wt.% and about 15 wt.% of the anionic sulfonated or sulfated surfactant. In a preferred embodiment, the ready-to-use viricidal composition comprises between about 0.1 wt.% and about 10 wt.%, more preferably between about 0.2 wt.% and about 5 wt.%, and most preferably between about 0.2 wt.% and about 3 wt.% of the anionic sulfonated or sulfated surfactant.

Anionic surfactants are surface active substances which are categorized by the negative charge on the hydrophile; or surfactants in which the hydrophilic section of the molecule carries no charge unless the pH is elevated to the pKa or above (e.g. carboxylic acids). Carboxylate, sulfonate, sulfate and phosphate are the polar (hydrophilic) solubilizing groups found in anionic surfactants. Of the cations (counter ions) associated with these polar groups, sodium, lithium and potassium impart water solubility; ammonium and substituted ammonium ions provide both water and oil solubility; and, calcium, barium, and magnesium promote oil solubility.



In a preferred embodiment, the at least one surfactant is an anionic sulfonated surfactant. Anionic sulfonated surfactants suitable for use in the compositions also include alkyl sulfonates, the linear and branched primary and secondary alkyl sulfonates, and the aromatic sulfonates with or without substituents. In an aspect, sulfonates include sulfonated  
5 carboxylic acid esters. In an aspect, suitable alkyl sulfonate surfactants include C8-C22 alkylbenzene sulfonates, or C10-C22 alkyl sulfonates. In an exemplary aspect, the anionic alkyl sulfonate surfactant is linear alkyl benzene sulfonic acid (LAS). In a preferred embodiment employing LAS as the anionic surfactant, the compositions are most effective at pH 3.5 or below. In a further embodiment, the anionic sulfonate surfactant may alternatively  
10 or additionally include diphenylated sulfonates, and/or sulfonated oleic acid.

Anionic sulfated surfactants suitable for use in the compositions also include alkyl ether sulfates, alkyl sulfates, the linear and branched primary and secondary alkyl sulfates, alkyl ethoxysulfates, fatty oleyl glycerol sulfates, alkyl phenol ethylene oxide ether sulfates, the C<sub>5</sub>-C<sub>17</sub> acyl-N-(C<sub>1</sub>-C<sub>4</sub> alkyl) and -N-(C<sub>1</sub>-C<sub>2</sub> hydroxyalkyl) glucamine sulfates, and  
15 sulfates of alkylpolysaccharides such as the sulfates of alkylpolyglucoside, and the like. Also included are the alkyl sulfates, alkyl poly(ethyleneoxy) ether sulfates and aromatic poly(ethyleneoxy) sulfates such as the sulfates or condensation products of ethylene oxide and nonyl phenol (usually having 1 to 6 oxyethylene groups per molecule). In some cases, the alkylene oxide bridge can be propylene oxide rather than, or in addition to ethylene oxide.

Preferred anionic sulfonated or sulfated surfactants include, but are not limited to, C8-C22 alkylbenzene sulfonates, sulfonated oleic acid, sodium lauryl sulfate, sodium laureth sulfate, a sulfosuccinate, a secondary alkane sulfonate, or mixtures thereof.  
20

In an embodiment, the viricidal compositions of the present application may be substantially or entirely free of other surfactants including, amphoteric surfactants, cationic  
25 surfactants, nonionic surfactants, zwitterionic surfactants, or other anionic surfactants.

We have found that the sulfonated surfactants are preferable as they are stable in an acidic environment, particularly in, aqueous compositions. Moreover, while sulfated surfactants are not acid-stable and thus are difficult to incorporate into acidic compositions, without being bound to the theory, we have reason to believe found that surprisingly the  
30 stability problems can be overcome by formulating the compositions to be anhydrous. Thus, a preferred embodiment is an anhydrous composition comprising a sulfated anionic surfactant. The anhydrous compositions comprising an anionic sulfated surfactant can also comprise a sulfonated surfactant.

### Buffering Agent

In a further aspect, the compositions and methods may comprise a buffering agent. In a preferred embodiment, the composition employs a pH buffering agent with a pKa between about 2 and about 3. If a buffering agent is included in the compositions, it can be in any suitable amount to buffer the composition at a desired pH. In a preferred embodiment, the concentrated viricidal composition comprises between about 0 wt.% and about 10 wt.%, more preferably between about 0.01 wt.% and about 8 wt.%, and most preferably between about 0.01 wt.% and about 5 wt.% of a buffering agent. In a preferred embodiment, the ready-to-use viricidal composition comprises between about 0 wt.% and about 5 wt.%, more preferably between about 0.01 wt.% and about 1 wt.%, and most preferably between about 0.01 wt.% and about 0.1 wt.% of a buffering agent. In a preferred embodiment, the buffering agent is in an amount less than about 0.5 wt.%, more preferably less than about 0.1 wt.%

Preferred buffering agents include, but are not limited to, phosphonates, phosphonic acids, and/or phosphates. Exemplary buffering agents include a phosphonate salt(s) and/or a heterocyclic dicarboxylic acid, e.g., dipicolinic acid. In some embodiments, the buffering agent is a pyridine carboxylic acid-based buffers, such as picolinic acid and salts, pyridine-2,6-dicarboxylic acid and salts, and phosphonate based buffers, such as phosphoric acid and salts, pyrophosphoric acid and salts and most commonly 1-hydroxyethylidene-1,1-diphosphonic acid (HEDP) and salts. In other embodiments, the compositions and methods can comprise two or more buffering agents, e.g., HEDP and 2,6-pyridinedicarboxylic acid (DPA). Further, exemplary pH buffer agents include, but are not limited to, triethanol amine, imidazole, a carbonate salt, a phosphate salt, heterocyclic carboxylic acids, phosphonates, etc.

### pH Modifiers

The viricidal compositions of the present application may include one or more pH adjusters/modifiers/buffers. The pH modifier may be alkaline or acidic and/or render a composition more alkaline or acidic. The pH modifier/buffer may be used to modify the pH and/or keep the pH of the composition in an optimal or preferred pKa range.

If a pH modifier is included in the compositions, it can be in any suitable amount to arrive at a desired pH. In a preferred embodiment, the concentrated viricidal composition comprises between about 0 wt.% and about 10 wt.%, more preferably between about 0.01 wt.% and about 8 wt.%, and most preferably between about 0.01 wt.% and about 5 wt.% of a pH modifier. In a preferred embodiment, the ready-to-use viricidal composition comprises between about 0 wt.% and about 5 wt.%, more preferably between about 0.01 wt.% and about 1 wt.%, and most preferably between about 0.01 wt.% and about 0.2 wt.% of a pH modifier.

*Alkaline pH modifier*

The compositions may include one or more alkaline pH modifiers to adjust the compositions to a desired pH.

5            Suitable alkaline pH modifiers include, but are not limited to, one or more organic alkaline pH modifiers, one or more inorganic alkaline pH modifiers, or combinations thereof. Suitable organic alkaline pH modifiers include, but are not limited to, amines and strong nitrogen bases including, for example monoethanolamine, monopropylamine, diethanolamine, dipropylamine, triethanolamine, tripropylamine, mixed  
10 isopropylamines, and the like, or combinations thereof. Suitable inorganic alkaline pH modifiers include, but are not limited to, alkali metal hydroxides (e.g. sodium hydroxide, potassium hydroxide, or the like, or combinations thereof), alkali metal carbonates (e.g., sodium carbonate, potassium carbonate, sodium bicarbonate, potassium bicarbonate, sodium sesquicarbonate, potassium sesquicarbonate, and the like, or combinations thereof), alkali  
15 metal borates (e.g., sodium borate, potassium borate, and the like, or combinations thereof), alkali metal oxides (e.g., sodium oxide, potassium oxide, and the like, or combinations thereof), and the like, or combinations thereof. Examples of one or more alkaline pH modifiers include one or more of an alkanolamine and/or alkali metal carbonate.

A number of commercially available alkaline pH modifiers may be suitable for use in  
20 the viricidal compositions. Commercially available alkaline pH modifiers may include amino alcohols include, but are not limited to, primary amino alcohols (e.g. 2-Amino-2-methyl-1-propanol), amino alcohols (e.g. 2-Amino-2-methyl-1-propanol), commercially available alkyl alkanolamines including, but not limited to, monoethanolamine and triethanolamine.

In an aspect, the alkaline pH modifiers can include ethanolamines and/or carbonates.  
25 In a further preferred aspect, the alkaline pH modifiers include monoethanolamine, diethanolamine, triethanolamine, 2-amino-2-methyl-1-propanol, monoisopropylamine, diisopropylamine, 2-(2-Aminoethoxy)ethanol (DGA) and/or an alkali metal carbonate. In a further preferred aspect, the alkaline pH modifiers do not include caustic, including for example, any alkali metal hydroxides. In such preferred aspects, the alkaline pH modifiers  
30 monoethanolamine, caustic and/or other highly alkaline components are included at less than about 1 wt-% per component in a concentrate viricidal composition. In other aspects, such alkaline pH modifiers are excluded from the viricidal composition.

*Acidic pH Modifier*

The compositions may include an acidic pH modifier. In such an aspect, the acidic pH modifier can be a combination of a weak acid and a strong acid. Strong acids that can be used are acids which substantially dissociate an aqueous solution. "Weak" organic and  
5 inorganic acids are acids or acid components in which the first dissociation step of a proton from the acid moiety does not proceed essentially to completion when the acid is dissolved in water at ambient temperatures at a concentration within the range useful to form the present compositions.

Without wishing to be bound by theory, an acidic pH modifier are believed to affect  
10 the lipid envelope and/or capsid in the same manner. Moreover, the acidic pH modifiers disclosed herein facilitate the creation of a low pH buffer on the surface of a substrate, thereby prolonging the residual viricidal and viricidal activity of the compositions and products in which they are incorporated.

Exemplary strong acids suitable for use modifying the pH of the compositions include  
15 methane sulfonic acid, sulfuric acid, sodium hydrogen sulfate, phosphoric acid, phosphonic acid, nitric acid, sulfamic acid, hydrochloric acid, trichloroacetic acid, trifluoroacetic acid, toluene sulfonic acid, glutamic acid, and the like; alkane sulfonic acid, such as methane sulfonic acid, ethane sulfonic acid, linear alkyl benzene sulfonic acid, xylene sulfonic acid, cumene sulfonic acid and the like. In a preferred aspect, the compositions include a strong  
20 acid having a pKa less than about 2.5 to beneficially provide the acidic use compositions having a pH less than about 4, or preferably less than about 3. In an embodiment, the compositions include a strong acid in combination with the anionic surfactant, and optionally include a weak acid.

Exemplary weak acids suitable for use modifying the pH of the compositions include  
25 alpha hydroxycarboxylic acid, such as lactic acid, citric acid, tartaric acid, malic acid, gluconic acid, and the like; carboxylic acids, such as formic acid, acetic acid, propionic acid and the like; other common organic acids such as ascorbic acid, glutamic acid, levulinic acid, etc. could also be used. In a preferred aspect, the compositions include a weak acid having a pKa greater than about 2.5 to beneficially provide the acidic use compositions having a pH  
30 less than about 4, or preferably less than about 3. In an embodiment, the compositions include a weak acid in combination with the anionic surfactant, and optionally include a strong acid.

In a preferred embodiment, the compositions can contain less than 0.5 wt.%, preferably less than about 0.1 wt.%, more preferably less than about 0.01 wt.%, and most preferably free of a carboxylic acid, a strong acid, a weak acid, a peracid, or mixture thereof.

### Solvent

The viricidal compositions comprise an organic solvent. In a preferred embodiment, the concentrated viricidal composition comprises between about 5 wt.% and about 95 wt.%, more preferably between about 30 wt.% and about 95 wt.%, and most preferably between  
5 about 60 wt.% and about 95 wt.% of a solvent. In a preferred embodiment, the ready-to-use viricidal composition comprises between about 0.2 wt.% and about 10 wt.%, more preferably between about 1 wt.% and about 7 wt.%, and most preferably between about 2 wt.% and about 5 wt.% of a solvent.

In a preferred embodiment, the solvent is a hydrophobic oxygenated solvent.  
10 Exemplary solvents and solvent systems include limited water-solubility alcohols. In an aspect, a benzyl alcohol solvent and/or solvent system is employed. In a further aspect, a phenoxyethanol solvent and/or solvent system is employed. Without being limited to a particular mechanism of action, in some embodiments, the solvent provides a limited water solubility alcohol providing hydrophobicity that assists in comprising the virus. In an  
15 embodiment, the solvent has a solubility in water of preferably less than 15% water soluble, more preferably less than 8 % water soluble, and most preferable less than 5% water soluble. Additional suitable solvents and solvent systems may include one or more different solvents including aromatic alcohols, ether amines, amidines, 1,2-diols, esters, glycol ethers, and mixtures thereof. Representative glycol ether solvents may include aromatic glycol ether  
20 solvents, such as ethylene glycol phenyl ether (commercially available from Dow as Dowanol Eph) or diethylene glycol phenyl ether (commercially available as Dowanol DiEPh). Additional suitable glycol ether solvents may include, without limitation, Butyl CARBITOL™ acetate, Butyl CARBITOL™, Butyl CELLOSOLVE™ acetate, Butyl CELLOSOLVE™, Butyl DIPROPASOL™, Butyl PROPASOL™, CARBITOL™ PM-600,

Additional suitable solvents may include 1,8-Diazabicyclo[5.4.0]undec-7-ene, or also may be referred to as 2,3,4,6,7,8,9,10-Octahydropyrimidol[1,2-a]azepine (or DBU), 2,5,7,10-tetraoxaundecane (TOU), acetamidophenol, acetanilide, acetophenone, 2-acetyl-1-methylpyrrole, ethyl hexyl glycerine, benzyl acetate, benzyl alcohol, methyl benzyl alcohol,

 terpinenes, carvone, cinnamaldehyde, borneol and its esters, citrals, ionenes, jasmine oil,  
 limonene, dipentene, linalool and its esters. Representative dibasic esters include dimethyl  
 25 adipate, dimethyl succinate, dimethyl glutarate, dimethyl malonate, diethyl adipate, diethyl  
 succinate, diethyl glutarate, dibutyl succinate, dibutyl glutarate and products available under  
 the trade designations DBE, DBE-3, DBE-4, DBE-5, DBE-6, DBE-9, DBE-IB, and DBE-ME  
 from DuPont Nylon. Representative phthalate esters include dibutyl phthalate, diethylhexyl  
 phthalate and diethyl phthalate. Additional solvents include glycerin alkyl ethers such as  
 30 mono 2-ethyl hexyl glycerin ether, mono heptyl glycerin ether, di butyl glycerin ether, etc.  
 Also glycols such as 1,2 hexane diol and 1,2 octane diol.

Difficulties with the use of ester solvents in aqueous acidic solutions can potentially  
 be overcome with this invention using an anhydrous composition.

In a preferred embodiment, the solvent is one or more of benzyl alcohol and/or a solvent from the Dowanol E series and/or Dowanol P series.

### **Additional Functional Ingredients**

The components of the viricidal compositions can further be combined with various additional functional components. The functional ingredients provide desired properties and functionalities to the compositions. For the purpose of this application, the term "functional ingredient" includes a material that when dispersed or dissolved in a use and/or concentrate solution, such as an aqueous solution, provides a beneficial property in a particular use. Some particular examples of functional materials are discussed in more detail below, although the particular materials discussed are given by way of example only, and that a broad variety of other functional ingredients may be used. In certain embodiments one or more of the following additional functional ingredients may be preferred, defoamers, foaming agents, coupling agents, fragrances and/or dyes, additional surfactants, rheology modifiers or thickeners, hydrotropes, chelating/sequestering agents, and the like.

#### *15 Defoaming Agents*

Defoaming agents can also be included in the compositions. Generally, defoamers which can be used in accordance with the invention preferably include alcohol alkoxyates and EO/PO block copolymers. Defoamers can also include polyalkylene glycol condensates and propyl glycols, including polypropyl glycol. In some embodiments, the compositions can include antifoaming agents or defoamers which are of food grade quality given the application of the methods. To this end, one of the more effective antifoaming agents includes silicones. Silicones such as dimethyl silicone, glycol polysiloxane, methylphenol polysiloxane, trialkyl or tetralkyl silanes, hydrophobic silica defoamers and mixtures thereof can all be used in defoaming applications. In a preferred embodiment, the concentrated viricidal composition comprises between about 0 wt.% and about 10 wt.%, more preferably between about 0.01 wt.% and about 8 wt.%, and most preferably between about 0.01 wt.% and about 5 wt.% of a defoaming agent. In a preferred embodiment, the ready-to-use viricidal composition comprises between about 0 wt.% and about 1 wt.%, more preferably between about 0.01 wt.% and about 0.5 wt.%, and most preferably between about 0.01 wt.% and about 0.1 wt.% of a defoaming agent.

#### *Additional Surfactants*

The compositions of the present application may optionally include one or more additional surfactants. The one or more additional surfactants may comprise anionic, nonionic, amphoteric, and/or zwitterionic surfactants. In a preferred embodiment, the

concentrated viricidal composition comprises between about 0 wt.% and about 10 wt.%, more preferably between about 0.1 wt.% and about 8 wt.%, and most preferably between about 1 wt.% and about 10 wt.% of an additional surfactant. In a preferred embodiment, the ready-to-use viricidal composition comprises between about 0 wt.% and about 10 wt.%, more preferably between about 0.01 wt.% and about 1 wt.%, and most preferably between about 0.01 wt.% and about 0.5 wt.% of an additional surfactant.

#### *Nonionic Surfactants*

Suitable nonionic surfactants suitable for use with the compositions of the present invention include alkoxyated surfactants. Suitable alkoxyated surfactants include EO/PO copolymers, capped EO/PO copolymers, alcohol alkoxyates, capped alcohol alkoxyates, mixtures thereof, or the like. Suitable alkoxyated surfactants for use as solvents include EO/PO block copolymers, such as the Pluronic and reverse Pluronic surfactants; alcohol alkoxyates, such as Dehypon LS-54 (R-(EO)<sub>3</sub>(PO)<sub>4</sub>) and Dehypon LS-36 (R-(EO)<sub>3</sub>(PO)<sub>6</sub>); and capped alcohol alkoxyates, such as Plurafac LF221 and Tegoten EC11; mixtures thereof, or the like. In a preferred embodiment, the nonionic surfactant is Pluronic F127 an EO/PO block copolymer.

#### *Amphoteric Surfactants*

Amphoteric, or ampholytic, surfactants contain both a basic and an acidic hydrophilic group and an organic hydrophobic group. These ionic entities may be any of anionic or cationic groups described herein for other types of surfactants. A basic nitrogen and an acidic carboxylate group are the typical functional groups employed as the basic and acidic hydrophilic groups. In a few surfactants, sulfonate, sulfate, phosphonate or phosphate provide the negative charge. Due to the pH of the system, it was found that many amphoteric surfactants, particularly those based on a carboxylic acid, were incompatible. In particular, it was found that the protonated portion of the carboxylic acid based amphoteric surfactants will complex with the anionic surfactant causing precipitation. Thus, limited amphoteric surfactants were found to be compatible with the system. Preferred amphoteric surfactants which can be included have a sulfate or sulfonate group.

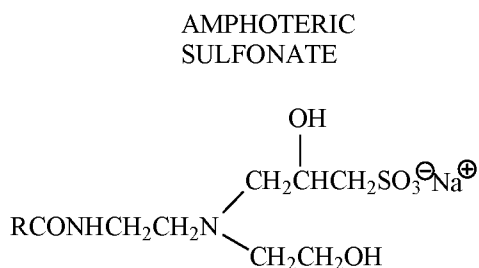
Amphoteric surfactants can be broadly described as derivatives of aliphatic secondary and tertiary amines, in which the aliphatic radical may be straight chain or branched and wherein one of the aliphatic substituents contains from about 8 to 18 carbon atoms and one contains an anionic water solubilizing group, *e.g.*, carboxy, sulfo, sulfato, phosphato, or phosphono. Amphoteric surfactants are subdivided into two major classes known to those of skill in the art and described in "Surfactant Encyclopedia" Cosmetics & Toiletries, Vol. 104



(2) 69-71 (1989), which is herein incorporated by reference in its entirety. The first class includes acyl/dialkyl ethylenediamine derivatives (*e.g.* 2-alkyl hydroxyethyl imidazoline derivatives) and their salts. The second class includes N-alkylamino acids and their salts. Some amphoteric surfactants can be envisioned as fitting into both classes.

5 Amphoteric surfactants can be synthesized by methods known to those of skill in the art. For example, 2-alkyl hydroxyethyl imidazoline is synthesized by condensation and ring closure of a long chain carboxylic acid (or a derivative) with dialkyl ethylenediamine. Commercial amphoteric surfactants are derivatized by subsequent hydrolysis and ring-  
 10 opening of the imidazoline ring by alkylation -- for example with chloroacetic acid or ethyl acetate. During alkylation, one or two carboxy-alkyl groups react to form a tertiary amine and an ether linkage with differing alkylating agents yielding different tertiary amines.

Long chain imidazole derivatives having application in the present invention generally have the general formula:



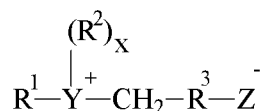
15 wherein R is an acyclic hydrophobic group containing from about 8 to 18 carbon atoms and M is a cation to neutralize the charge of the anion, generally sodium. Commercially prominent imidazoline-derived amphoteric surfactants that can be employed in the present compositions include for example: Cocoamphopropyl-sulfonate.

#### 20 *Zwitterionic Surfactants*

Zwitterionic surfactants can be thought of as a subset of the amphoteric surfactants and can include an anionic charge. Zwitterionic surfactants can be broadly described as derivatives of secondary and tertiary amines, derivatives of heterocyclic secondary and tertiary amines, or derivatives of quaternary ammonium, quaternary phosphonium or tertiary  
 25 sulfonium compounds. Typically, a zwitterionic surfactant includes a positive charged quaternary ammonium or, in some cases, a sulfonium or phosphonium ion; and an alkyl group. Zwitterionics generally contain cationic and anionic groups which ionize to a nearly equal degree in the isoelectric region of the molecule and which can develop strong<sup>77</sup> inner-

salt” attraction between positive-negative charge centers. Examples of such zwitterionic synthetic surfactants include derivatives of aliphatic quaternary ammonium, phosphonium, and sulfonium compounds, in which the aliphatic radicals can be straight chain or branched, and wherein one of the aliphatic substituents contains from 8 to 18 carbon atoms and one  
 5 contains an anionic water solubilizing group, *e.g.*, carboxy, sulfonate, sulfate, phosphate, or phosphonate.

Sultaine surfactants are exemplary zwitterionic surfactants for use herein. A general formula for these compounds is:



10 wherein R<sup>1</sup> contains an alkyl, alkenyl, or hydroxyalkyl radical of from 8 to 18 carbon atoms having from 0 to 10 ethylene oxide moieties and from 0 to 1 glyceryl moiety; Y is selected from the group consisting of nitrogen, phosphorus, and sulfur atoms; R<sup>2</sup> is an alkyl or monohydroxy alkyl group containing 1 to 3 carbon atoms; x is 1 when Y is a sulfur atom and 2 when Y is a nitrogen or phosphorus atom, R<sup>3</sup> is an alkylene or hydroxy alkylene or hydroxy  
 15 alkylene of from 1 to 4 carbon atoms and Z is a radical selected from the group consisting of sulfonate, sulfate, phosphonate, and phosphate groups.

 20 dodecoxy-2-hydroxypropyl-ammonio]-propane-1-phosphonate; 3-(N,N-dimethyl-N-hexadecylammonio)-propane-1-sulfonate; 3-(N,N-dimethyl-N-hexadecylammonio)-2-hydroxy-propane-1-sulfonate; 3-[S-ethyl-S-(3-dodecoxy-2-hydroxypropyl)sulfonio]-propane-1-phosphate; 3-[P,P-dimethyl-P-dodecylphosphonio]-propane-1-phosphonate; and S[N,N-di(3-hydroxypropyl)-N-hexadecylammonio]-2-hydroxy-pentane-1-sulfate. The alkyl groups  
 25 contained in said detergent surfactants can be straight or branched and saturated or unsaturated.

Sultaines useful in the present invention include those compounds having the formula (R(R<sup>1</sup>))<sub>2</sub> N<sup>+</sup> R<sup>2</sup>SO<sup>3-</sup>, in which R is a C<sub>6</sub>-C<sub>18</sub> hydrocarbyl group, each R<sup>1</sup> is typically independently C<sub>1</sub>-C<sub>3</sub> alkyl, *e.g.* methyl, and R<sup>2</sup> is a C<sub>1</sub>-C<sub>6</sub> hydrocarbyl group, *e.g.* a C<sub>1</sub>-C<sub>3</sub>  
 30 alkylene or hydroxyalkylene group.

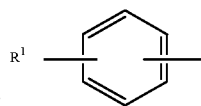
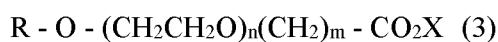

5 In an embodiment, the compositions of the present invention include a betaine. For example, the compositions can include cocoamido propyl betaine.

*Additional Anionic Surfactant*

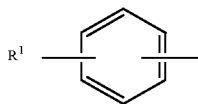
The viricidal compositions can optionally further comprise an additional anionic surfactant. Additional anionic surfactants can include anionic carboxylate surfactants, those  
 10 which have a carboxylic acid or an alpha hydroxyl acid group. Anionic carboxylate surfactants suitable for use in the present compositions include carboxylic acids (and salts), such as alkanolic acids (and alkanooates), ester carboxylic acids (*e.g.* alkyl succinates), ether carboxylic acids, and the like. Such carboxylates include alkyl ethoxy carboxylates, alkyl aryl ethoxy carboxylates, alkyl polyethoxy polycarboxylate surfactants and soaps (*e.g.* alkyl  
 15 carboxyls). Secondary carboxylates useful in the present compositions include those which contain a carboxyl unit connected to a secondary carbon. The secondary carbon can be in a ring structure, *e.g.* as in *p*-octyl benzoic acid, or as in alkyl-substituted cyclohexyl carboxylates. The secondary carboxylate surfactants typically contain no ether linkages, no ester linkages and no hydroxyl groups. Further, they typically lack nitrogen atoms in the  
 20 head-group (amphiphilic portion). Suitable secondary soap surfactants typically contain 11-13 total carbon atoms, although more carbons atoms (*e.g.*, up to 16) can be present. Suitable carboxylates also include acylamino acids (and salts), such as acylgluamates, acyl peptides, sarcosinates (*e.g.* N-acyl sarcosinates), taurates (*e.g.* N-acyl taurates and fatty acid amides of methyl tauride), and the like.



5           Such alkyl and alkylaryl ethoxy carboxylates are commercially available. These ethoxy carboxylates are typically available as the acid forms, which can be readily converted to the anionic or salt form. Commercially available carboxylates include, Neodox 23-4, a C<sub>12-13</sub> alkyl polyethoxy (4) carboxylic acid (Shell Chemical), and Emcol CNP-110, a C<sub>9</sub> alkylaryl polyethoxy (10) carboxylic acid (Witco Chemical). Carboxylates are also available  
10 from Clariant, *e.g.* the product Sandopan<sup>®</sup> DTC, a C<sub>13</sub> alkyl polyethoxy (7) carboxylic acid.

In some embodiments, the compositions can further comprise sodium xylene sulfonate, sodium cumene sulfonate, potassium naphthalene sulfonate, or a combination thereof.

In an embodiment, the compositions are optionally free of anionic carboxylate  
15 surfactants.

*Water Conditioning Agents, Builders, Chelants, and/or Sequestrants*

The compositions and methods can optionally include a water conditioning agent, builder, chelant, and/or sequestering agent, or a combination thereof. A chelating or sequestering agent is a compound capable of coordinating (*i.e.* binding) metal ions commonly  
20 found in hard or natural water to prevent the metal ions from interfering with the action of the other deterative ingredients of a viricidal composition. Similarly, builders and water conditioning agents also aid in removing metal compounds. Exemplary water conditioning agents include anti-redeposition agents, chelating agents, sequestering agents and inhibitors.

Suitable organic water conditioning agents can include both polymeric and small  
25 molecule water conditioning agents. Organic small molecule water conditioning agents are typically organocarboxylate compounds or organophosphate water conditioning agents. Polymeric inhibitors commonly comprise polyanionic compositions such as polyacrylic acid compounds. More recently the use of sodium carboxymethyl cellulose as an antiredeposition agent was discovered. This is discussed more extensively in U.S. Patent No. 8,729,006 to  
30 Miralles et al., which is incorporated herein in its entirety.

Small molecule organic water conditioning agents include, but are not limited to: sodium gluconate, sodium glucoheptonate, N-hydroxyethylenediaminetriacetic acid

(HEDTA), ethylenediaminetetraacetic acid (EDTA), nitrilotriacetic acid (NTA), diethylenetriaminepentaacetic acid (DTPA), ethylenediaminetetrapropionic acid, triethylenetetraaminehexaacetic acid (TTHA), and the respective alkali metal, ammonium and substituted ammonium salts thereof, ethylenediaminetetraacetic acid tetrasodium salt  
 5 (EDTA), nitrilotriacetic acid trisodium salt (NTA), ethanoldiglycine disodium salt (EDG), diethanolglycine sodium-salt (DEG), and 1,3-propylenediaminetetraacetic acid (PDTA), dicarboxymethyl glutamic acid tetrasodium salt (GLDA), methylglycine-N-N-diacetic acid trisodium salt (MGDA), and iminodisuccinate sodium salt (IDS). All of these are known and commercially available.

10 Suitable inorganic water conditioning agents include, but are not limited to, sodium tripolyphosphate and other higher linear and cyclic polyphosphates species. Suitable condensed phosphates include sodium and potassium orthophosphate, sodium and potassium pyrophosphate, sodium tripolyphosphate, and sodium hexametaphosphate. A condensed phosphate may also assist, to a limited extent, in solidification of the solid detergent  
 15 composition by fixing the free water present in the composition as water of hydration. Examples of phosphonates included, but are not limited to: 1-hydroxyethane-1,1-diphosphonic acid,  $\text{CH}_3\text{C}(\text{OH})[\text{PO}(\text{OH})_2]_2$ ; aminotri(methylenephosphonic acid),  $\text{N}[\text{CH}_2\text{PO}(\text{OH})_2]_3$ ; aminotri(methylenephosphonate), sodium salt (ATMP),  $\text{N}[\text{CH}_2\text{PO}(\text{ONa})_2]_3$ ; 2-hydroxyethyliminobis(methylenephosphonic acid),  
 20  $\text{HOCH}_2\text{CH}_2\text{N}[\text{CH}_2\text{PO}(\text{OH})_2]_2$ ; diethylenetriaminepenta(methylenephosphonic acid),  $(\text{HO})_2\text{POCH}_2\text{N}[\text{CH}_2\text{CH}_2\text{N}[\text{CH}_2\text{PO}(\text{OH})_2]_2]_2$ ; diethylenetriaminepenta(methylenephosphonate), sodium salt (DTPMP),  $\text{C}_9\text{H}_{28-x}\text{N}_3\text{Na}_x\text{O}_{15}\text{P}_5$  ( $x=7$ ); hexamethylenediamine(tetramethylenephosphonate), potassium salt,  $\text{C}_{10}\text{H}_{28-x}\text{N}_2\text{K}_x\text{O}_{12}\text{P}_4$  ( $x=6$ ); bis(hexamethylene)triamine(pentamethylenephosphonic acid),  
 25  $(\text{HO}_2)\text{POCH}_2\text{N}[(\text{CH}_2)_6\text{N}[\text{CH}_2\text{PO}(\text{OH})_2]_2]_2$ ; and phosphorus acid,  $\text{H}_3\text{PO}_3$ . A preferred phosphonate combination is ATMP and DTPMP. A neutralized or alkaline phosphonate, or a combination of the phosphonate with an alkali source before being added into the mixture such that there is little or no heat or gas generated by a neutralization reaction when the phosphonate is added is preferred.

30 In an embodiment, the viricidal compositions can be substantially free of phosphates and/or phosphonates.

In addition to aminocarboxylates, which contain little or no NTA, water conditioning polymers can be used as non-phosphorous containing builders. Exemplary water conditioning polymers include, but are not limited to: polycarboxylates. Exemplary polycarboxylates that

can be used as builders and/or water conditioning polymers include, but are not limited to: those having pendant carboxylate ( $\text{---CO}_2^-$ ) groups such as polyacrylic acid, maleic acid, maleic/olefin copolymer, sulfonated copolymer or terpolymer, acrylic/maleic copolymer, polymethacrylic acid, acrylic acid-methacrylic acid copolymers, hydrolyzed polyacrylamide, hydrolyzed polymethacrylamide, hydrolyzed polyamide-methacrylamide copolymers, hydrolyzed polyacrylonitrile, hydrolyzed polymethacrylonitrile, and hydrolyzed acrylonitrile-methacrylonitrile copolymers. For a further discussion of chelating agents/sequestrants, see Kirk-Othmer, Encyclopedia of Chemical Technology, Third Edition, volume 5, pages 339-366 and volume 23, pages 319-320, the disclosure of which is incorporated by reference herein. These materials may also be used at substoichiometric levels to function as crystal modifiers conditioning agents can be in an amount from about 0.05 wt.% to about 7 wt.%; preferably from about 0.1 wt.% to about 5 wt.%; and more preferably from about 0.5 wt.% to about 3 wt.%.

#### **Methods of Use**

The viricidal compositions are configured to provide viricidal efficacy when in contact with a viricidal population; the compositions are also useful in treating surfaces in need of viricidal efficacy, including for example viricidal efficacy. In further aspects, the viricidal compositions are still further well suited for treating surfaces in need of viricidal efficacy against small, non-enveloped viruses, large, non-enveloped viruses and/or any enveloped viruses. In a particular, aspect, the viricidal compositions are particularly well suited for treating surfaces in need of inactivating small, non-enveloped viruses including, but not limited to, poliovirus, feline calicivirus, and/or norovirus.

Accordingly, methods of using a viricidal are encompassed according to the present disclosure. Methods of inactivating a virus are also encompassed according to the present disclosure. Methods of inactivating a small, non-enveloped virus are also encompassed according to the present disclosure. Still further, methods of inactivating a poliovirus and/or norovirus are encompassed according to the present disclosure.  
25

The methods of use for viricidal, including antiviral, disinfection along with inactivating viruses, include a contacting step, wherein the viricidal compositions disclosed herein are applied to a surface in need of treatment. In an aspect, the contacting step involves contacting the composition with a surface contaminated with a virus, including enveloped and non-enveloped viruses, such as a caliciform virus including norovirus and/or poliovirus. Beneficially, in an aspect, complete kill of one or more viruses on a surface is achieved with  
30

a contact time of less than 10 minutes, less than 5 minutes, less than 2 minutes, less than 1 minute, or less than 30 seconds.

In an embodiment, the contacting may involve contacting the viricidal composition with a food contact and/or non-food contact hard surface. Such surfaces can further include instruments, such as medical instruments. Surfaces can also include those cleaned in third-sink sanitizing, including various wares. In still further aspects, contacting the composition can be to a CIP (clean in place) application. In still further aspects, contacting the composition may be contacting the composition with a ware wash machine, such as a ware wash application.

In still further aspects, contacting the composition may include contacting the composition with a tissue surface, including tissue treatment applications. Exemplary tissue surfaces include mammalian skin, such as animal or human skin, including for example human hands.

The various surfaces to which the compositions can be applied can include any conventional application means. Suitable applications can include, for example, by wiping, spraying, pouring, mopping, dipping, immersing, or the like. The contacting can also include providing a solid to be first dissolved in water to form a solution for the contacting. The contacting step allows the composition to contact the surface for a predetermined amount of time. The amount of time can be sufficient to allow, including from a few seconds to an hour, from about 30 seconds to about 15 minutes, or any range therebetween. The methods may comprise a single step of applying the composition onto the surface without direct physical removal, such as a rinse step. In an embodiment, the compositions can be on a wipe such that the wipe can be applied to a surface. In a preferred embodiment, the viricidal compositions can be on a pre-saturated wipe. In another preferred embodiment, a wipe can be saturated with the viricidal compositions at or before the time of use manually or by a machine or system. In an embodiment, where the composition is saturated on a wipe, the wipe is preferably comprised of a polyester, a polypropylene, a polyamide, a cellulose, a rayon, or a blend or combination thereof.

In some aspects, the methods can further include a precleaning step, such as where a viricidal compositions is applied, wiped and/or rinsed, and thereafter followed by the applying of the compositions. The compositions and methods of use thereof can include treating cleaned or soiled surfaces

### **Methods of Manufacture**

The viricidal compositions can be prepared by mixing of the ingredients in the compositions. They can be prepared as concentrated compositions or ready-to-use compositions. If prepared as concentrated compositions, the concentrated viricidal  
5 compositions can be subsequently diluted at the time of use or before use. The viricidal compositions can be prepared using in-line mixing or in bulk mixing. Further, the viricidal compositions can be prepared in batch or continuous mixing processes.

All publications and patent applications in this specification are indicative of the level of ordinary skill in the art to which this invention pertains. All publications and patent  
10 applications are herein incorporated by reference to the same extent as if each individual publication or patent application was specifically and individually indicated as incorporated by reference.

Materials used:

#### EXAMPLE 1. Viricidal Suspension Test

15 An evaluation was conducted to determine the viricidal efficacy of the compositions of the present application against a test virus in suspension. The stock virus of feline calicivirus, a norovirus surrogate, was diluted to a titer of approximately 6-log<sub>10</sub> infectious unites per 0.1 ml. In addition, the virus sample was also loaded with organic soil present at 5 wt.% of the sample. The prepared sample was then added to the test compositions, which

20 were prepared as set forth in Tables 2A and 2B at a ratio of one parts virus and 9 parts test product. Contact was allowed for one minute. After one minute, the test compositions and virus/soil samples were neutralized, placed in media, and allowed to incubate. After the close of the incubation period, the samples treated with the composition were examined and a log count of any remaining infectious viruses was quantified. The log virus reduction as

25 measured for each formulation after 1 minute is shown in Figures 1A and 1B.

As seen in Figure 1A, the majority of the formulations resulted in a log virus reduction of at least 4.0, with the exception of Formula 1F and 1I where those formulations only achieved a log reduction of 0.5 and 3.5 respectively. As seen in Figure 1B, Formula 1K, 1L, 1N, and 1O all achieved a log virus reduction of at least 4.0. The compositions of Formula 1J, 1M, and 1P did not achieve effective virus reduction outcomes with a log virus reduction of 0.0, 0.5, and 0.0 respectively. These results indicate that certain weight formulations of the exemplary composition, such as Formula 1A, are effective against feline calicivirus at 1 minute.

Furthermore, an exemplary concentrated viricidal composition was prepared according to a preferred embodiment of the compositions described herein according to Table 3 below. This exemplary concentrated viricidal composition was tested as part of a surfactant screening as set forth in Table 4A. The log virus reduction was measured for each of the formulations set forth in Tables 4A and 4B after 1 minute as shown in Figures 2A and 2B.

As seen in Figure 2A, Formula 2A encompassing the exemplary composition resulted in a log reduction of at least 5.0 after 1 minute of contact time. No other formulas achieved successful log virus reduction levels, with the exception of Formulas 2F and 2G, where both also achieved a log reduction of at least 5.0 after 1 minute of contact time. As seen in Figure 2B, only Formulas 2L and 2O achieved a log reduction greater than 4.0, with both formulas having a log reduction of at least 5.0 after 1-minute contact time.

#### EXAMPLE 2. Viricidal Tests

Multiple viricidal tests were conducted following ASTM E1053, Standard Test Method to Assess Virucidal Activity of Chemicals Intended for Disinfection of Inanimate, Nonporous Environmental Surfaces. Table 5A shows the exemplary composition tested. Table 5B shows the results of the testing against multiple viruses.

As seen in Table 5B, the exemplary viricidal composition resulted in a log reduction of greater than 3.5 logs against polio, which is notoriously difficult to kill. Moreover, the kill log provided complete inactivation of the polio virus at 1-minute contact time. Similarly, the exemplary viricidal composition was tested against a variety of other microorganisms providing complete inactivation of two types of influenza A, Hepatitis B, HIV Type 1, and feline calicivirus. This demonstrates the surprising effectiveness of the composition against a variety of microorganisms. The test against feline calicivirus was performed both as a spray and with simple wiping. As can be seen from the log reduction data, while the exemplary composition was highly effective with both spray and wipe applications, the wipe provided significantly higher log reduction than the spray did. This demonstrates the superior cidal efficacy when the composition is applied by wiping. While the wipe test did not result in complete inactivation this is because the starting count of feline calicivirus was higher for the wipe test.

#### EXAMPLE 3. Black Soil Removal Test

An exemplary industrial hydrocarbon-based oily soil (referred to as “black soil” throughout the Examples) was prepared with about 50 grams mineral spirits, about 5 grams mineral oil, about 5 grams motor oil, about 2.5 grams black pigment dispersion and about 37.5 grams bandy black clay was prepared.

Three tiles soiled with black soil were prepared. The back, grooved sides of a plurality of 3” x 3” white vinyl tiles were soiled with approximately 0.75 grams of the black test soil using a 3” foam brush. The tiles were allowed to dry at room temperature overnight. The next day, the tiles were placed into a soaking tray containing about 200 grams of a test composition for about 2 minutes for the black soil.

The soil removal test was conducted using the Gardco Washability Test Equipment Model D10V available from Paul N. Gardner Company Inc., using a synthetic sponge. The dry synthetic sponge was saturated with about 80 grams of the test compositions. The tiles were then placed into the Gardco with the grain of the tiles parallel to the direction of sponge travel. The black soil tiles were then scrubbed with about 2 pounds of pressure with the moistened synthetic sponge for 40 cycles, rotating the tiles 90 degrees every 10 cycles for a complete 360-degree rotation of the tiles. The tiles were then rinsed with city water and dried overnight at room temperature. Hunter Lab L\* reflectance of the washed tiles were measured. The average reflectance values from the three tiles are summarized in Table 6. A higher reflectance value indicates better cleaning efficacy.

Table 6 shows the black soil cleaning efficacy of an exemplary embodiment of a viricidal cleaning solution of the invention versus standard formulations for hard surface cleaning, and further compared to water as a control. The table shows that the formula of the invention provides better cleaning efficacy to the equivalent disinfectant viricidal compositions, and only minimally less effectiveness than a heavy-duty cleaner (not disinfectant). Thus, this illustrates the suitability of the formulations of the invention for providing an effective replacement for current available disinfectant viricidal compositions for removal of black soils.

What is claimed is:

1. A concentrated viricidal composition comprising:  
between about 0.4 wt.% and about 30 wt.% of an anionic sulfonated or sulfated surfactant;  
5 between about 5 wt.% and about 95 wt.% of a solvent having less than 5% (wt./wt.) solubility  
in water;  
wherein the composition has a pH of less than about 3.5 when diluted to a use solution.
2. The composition of claim 1, wherein the composition has less than about 0.1 wt.% of  
10 added peroxide.
3. The composition of any one of claims 1-2, wherein the composition has less than  
about 0.1 wt.% of an acidic pH modifier.
- 15 4. The composition of any one of claims 1-3, wherein the solvent comprises an aromatic  
alcohol, an aromatic glycol ether, an alkylene glycol ether, or a mixture thereof.
5. The composition of any one of claims 1-4, wherein the solvent comprises benzyl  
alcohol, a phenoxyethanol, a phenoxypropanol, dipropylene glycol n-butyl ether, tripropylene  
20 glycol butyl ether or a mixture thereof.
6. The composition of any one of claims 1-5, wherein the composition has a pH between  
about 2 and about 3.2 when diluted for use.
- 25 7. The composition of any one of claims 1-6, wherein the composition has between  
about 1 wt.% and about 20 wt.% of the anionic sulfonated or sulfated surfactant; and wherein  
the composition has between about 10 wt.% and about 80 wt.% of the solvent.
8. The composition of any one of claims 1-7, wherein the composition is anhydrous.  
30
9. The composition of any one of claims 1-8, wherein the anionic sulfonated or sulfated  
surfactant comprises a C8-C22 alkylbenzene sulfonic acid, sulfonated oleic acid, sodium  
lauryl sulfate, secondary alkane sulfonate, sodium laureth sulfate, a sulfosuccinate, or mixture  
thereof.



10. The composition of any one of claims 1-9, wherein the composition further comprises an additional surfactant, a pH adjusting agent, a buffering agent, a dye, a fragrance, a foaming agent, a wetting agent, a solubilizer, a coupling agent, a hydrotrope, a defoaming agent, or  
5 mixture thereof.

11. The composition of any one of claims 1-10, wherein the anionic surfactant is dodecylbenzene sulfonic acid, the solvent is benzyl alcohol, and the nonionic surfactant is an EO/PO copolymer, and wherein the composition has a pH of less than about 3.  
10

12. The composition of any one of claims 1-11, wherein the composition when diluted to a use solution provides at least about 3-log reduction in polio in about 1 minute or less.

13. A ready-to-use viricidal composition comprising:  
15 between about 0.1 wt.% and about 10 wt.% of an anionic sulfonated or sulfated surfactant;  
between about 1 wt.% and about 40 wt.% of a solvent having a less than 5% (wt./wt.)  
solubility in water;  
wherein the composition has a pH of less than about 3.5; and  
wherein the composition provides at least about 3 log reduction in polio in about 1 minute or  
20 less.

14. The viricidal composition of claim 13, wherein the composition has between about 0.2 wt.% and about 1 wt.% of the anionic sulfonated or sulfated surfactant; and wherein composition has between about 2 wt.% and about 10 wt.% of the solvent.  
25

15. The viricidal composition of any one of claims 13-14, wherein the composition further comprises an additional surfactant, a pH adjusting agent, a buffering agent, a dye, a fragrance, a foaming agent, a wetting agent, a solubilizer, a coupling agent, a hydrotrope, a defoaming agent, or mixture thereof.  
30

16. The viricidal composition of any one of claims 13-15, wherein the anionic surfactant is dodecylbenzene sulfonic acid, the solvent is benzyl alcohol, and the nonionic surfactant is an EO/PO copolymer, and wherein the composition has a pH of less than about 3.

17. The viricidal composition of claim 13-16, wherein the composition has less than about 0.1 wt.% of an acidic pH modifier and a pH of between about 2 and about 3.2.
18. The viricidal composition of any one of claims 13-17, wherein the solvent comprises  
5 an aromatic alcohol, an aromatic glycol ether, an alkylene glycol ether, or a mixture thereof.
19. The viricidal composition of any one of claims 13-18, wherein the solvent comprises  
10 benzyl alcohol, a phenoxyethanol, a phenoxypropanol, dipropylene glycol n-butyl ether,  
tripropylene glycol butyl ether, or a mixture thereof.
20. The viricidal composition of any one of claims 13-19, wherein the composition has a  
pH of less than about 3.
21. The viricidal composition of any one of claims 13-20, wherein the anionic sulfonated  
15 or sulfated surfactant comprises a C8-C22 alkylbenzene sulfonic acid, sulfonated oleic acid,  
sodium lauryl sulfate, secondary alkane sulfonate, sodium laureth sulfate, a sulfosuccinate, or  
mixture thereof.
22. The viricidal composition of any one of claims 13-21, wherein the composition  
20 further comprises between about 0.01 wt.% and about 5 wt.% of a buffering agent.
23. The viricidal composition of any one of claims 13-22, wherein the composition  
further comprises between about 0.01 wt.% and about 10 wt.% of a defoaming agent.
- 25 24. The viricidal composition of any one of claims 13-23, wherein the viricidal  
composition is saturated on a wipe.
25. The composition of any one of claims 1-24, wherein the ratio of solvent to anionic  
surfactant is at least 10:1.
- 30 26. A viricidal wipe comprising:  
a wipe saturated with a viricidal composition comprising  
between about 0.1 wt.% and about 10 wt.% of an anionic sulfonated or sulfated  
surfactant;

between about 1 wt.% and about 40 wt.% of a solvent having a less than 5% (wt./wt.) solubility in water;

wherein the composition has a pH of less than about 3.5; and

wherein the composition provides at least about 3 log reduction in polio in about 1  
5 minute or less.

27. The viricidal wipe of claim 26, wherein the viricidal composition has between about 0.2 wt.% and about 1 wt.% of the anionic sulfonated or sulfated surfactant; and wherein composition has between about 2 wt.% and about 10 wt.% of the solvent.

28. The viricidal wipe of any one of claims 26-27, wherein the composition further comprises an additional surfactant, a pH adjusting agent, a buffering agent, a dye, a fragrance, a foaming agent, a wetting agent, a solubilizer, a coupling agent, a hydrotrope, a defoaming agent, or mixture thereof.

36. The viricidal wipe of any one of claims 26-35, wherein the composition further  
comprises between about 0.01 wt.% and about 10 wt.% of a defoaming agent.

10 37. The viricidal wipe of any one of claims 26-36, wherein the composition has a ratio of  
the solvent to the anionic surfactant of at least 10:1.

38. The viricidal wipe of any one of claims 26-37, wherein the wipe comprises a

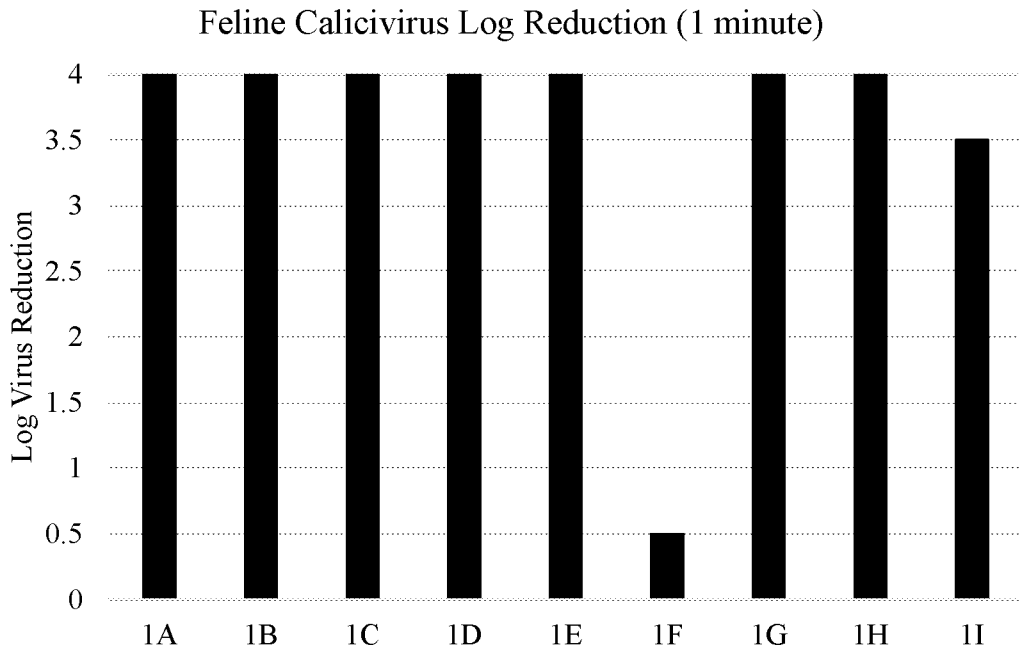

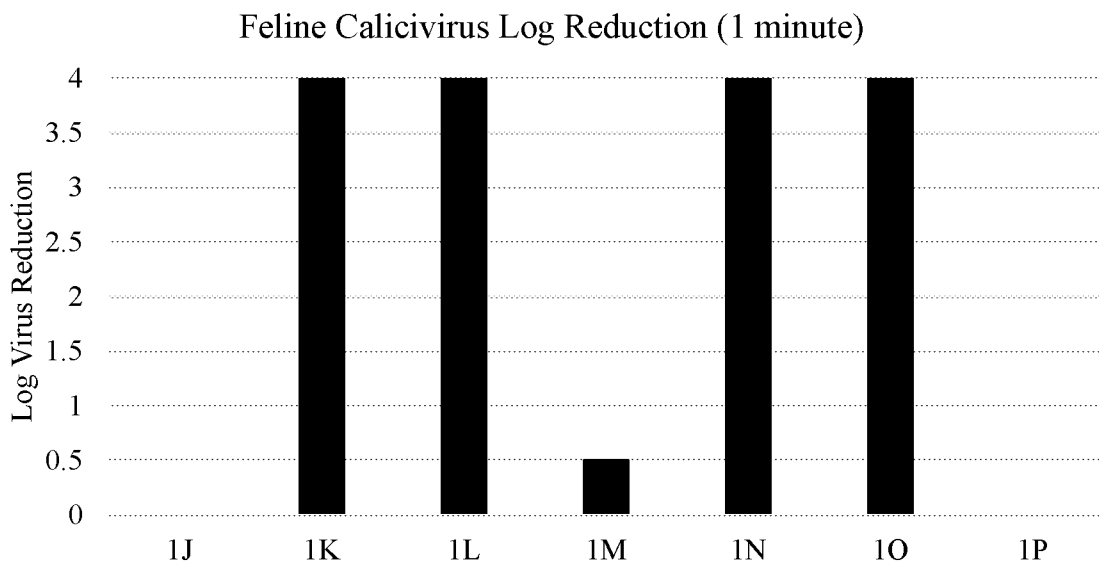

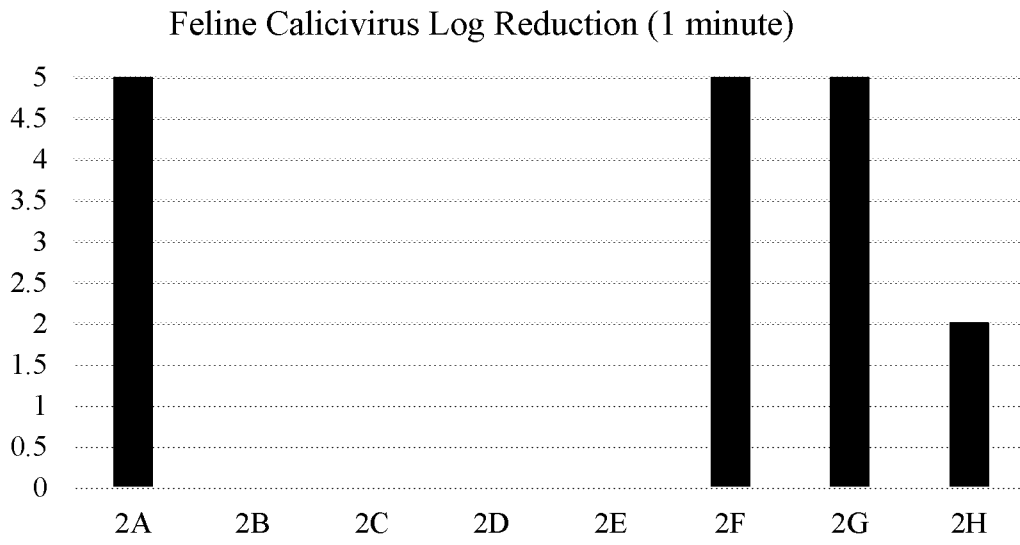

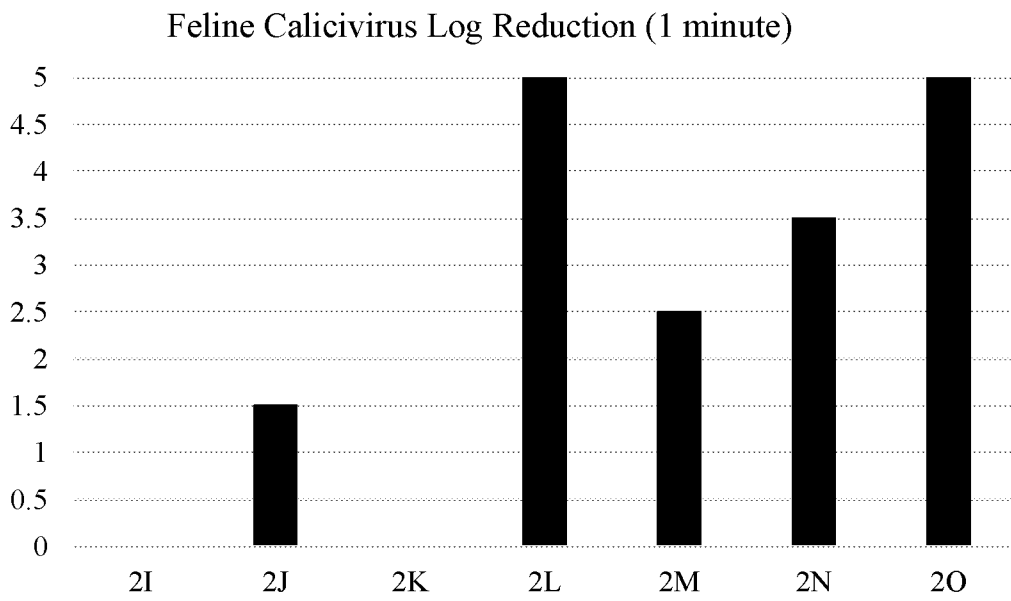

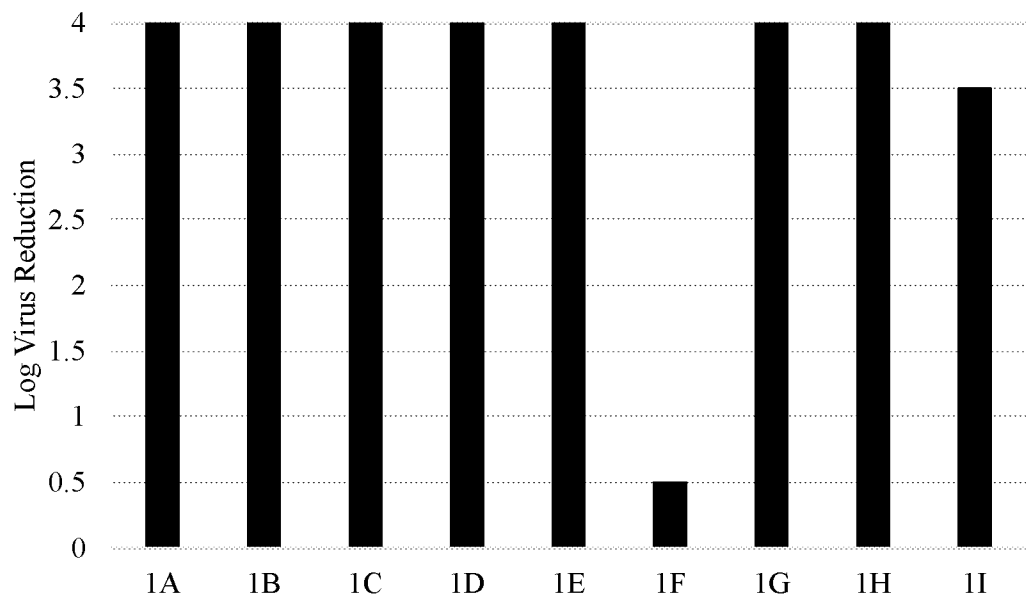
