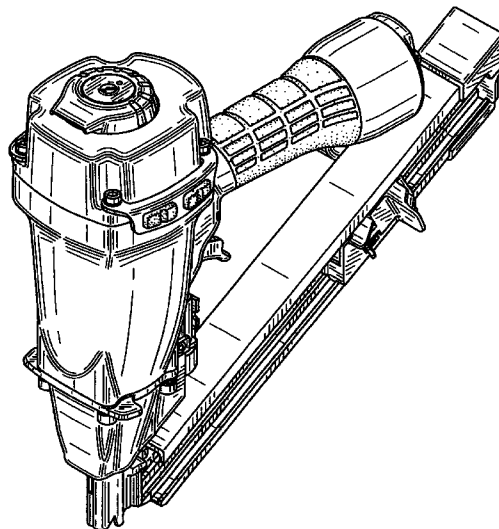
(57) **CLAIM**

The ornamental design for a fastening tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective illustration from the front and left side, of a fastening tool according to our design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. In FIGS. 1–7, broken lines showing structures are for illustrative purposes only and form no part of the claimed design.

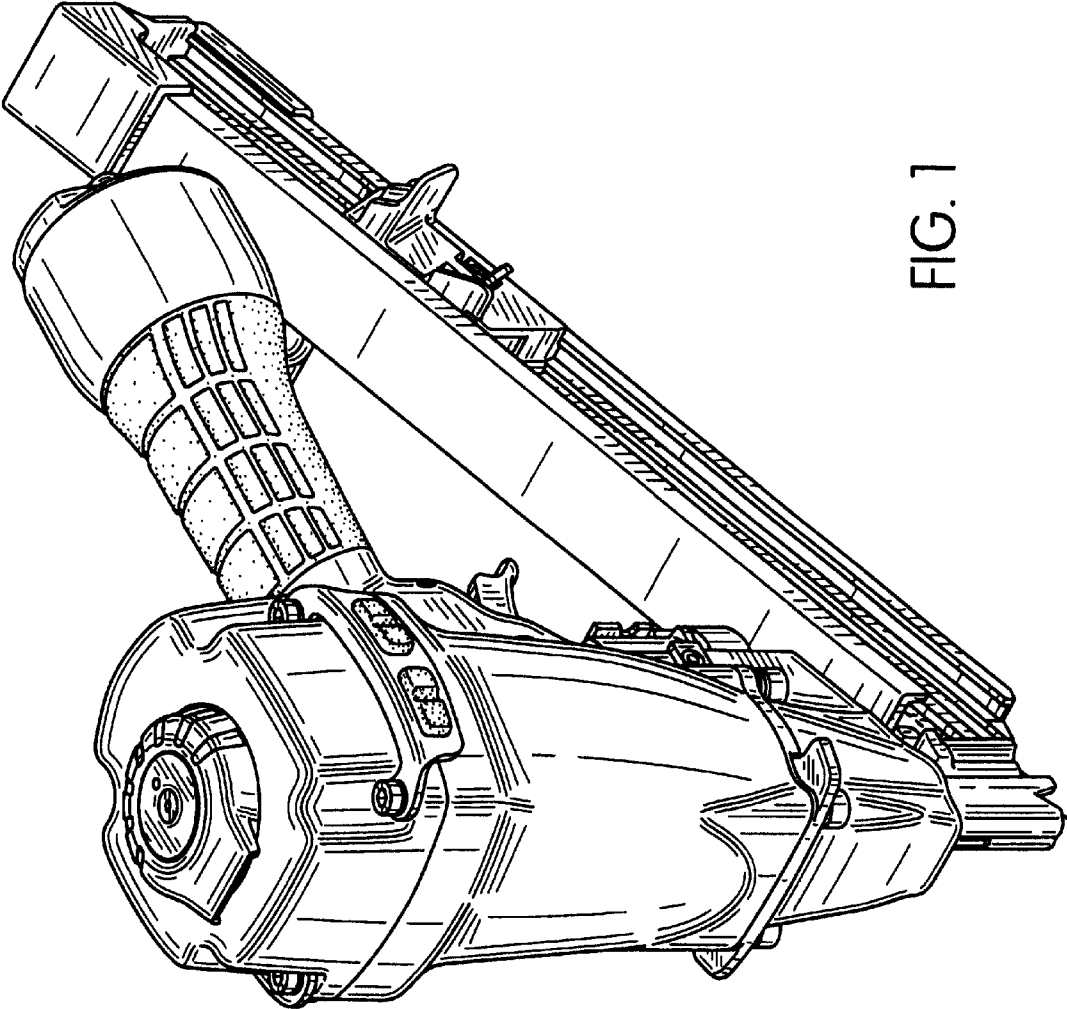

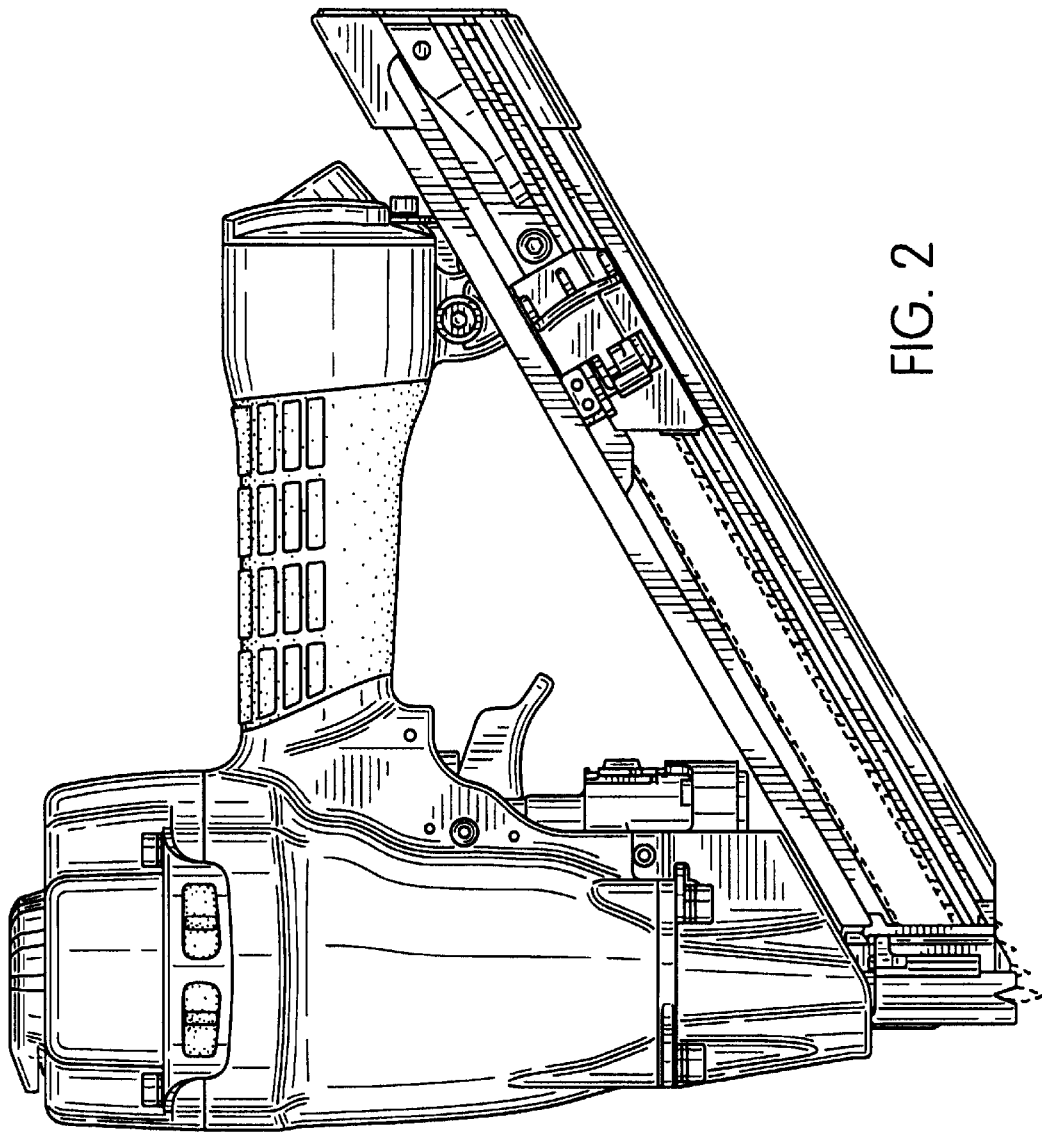

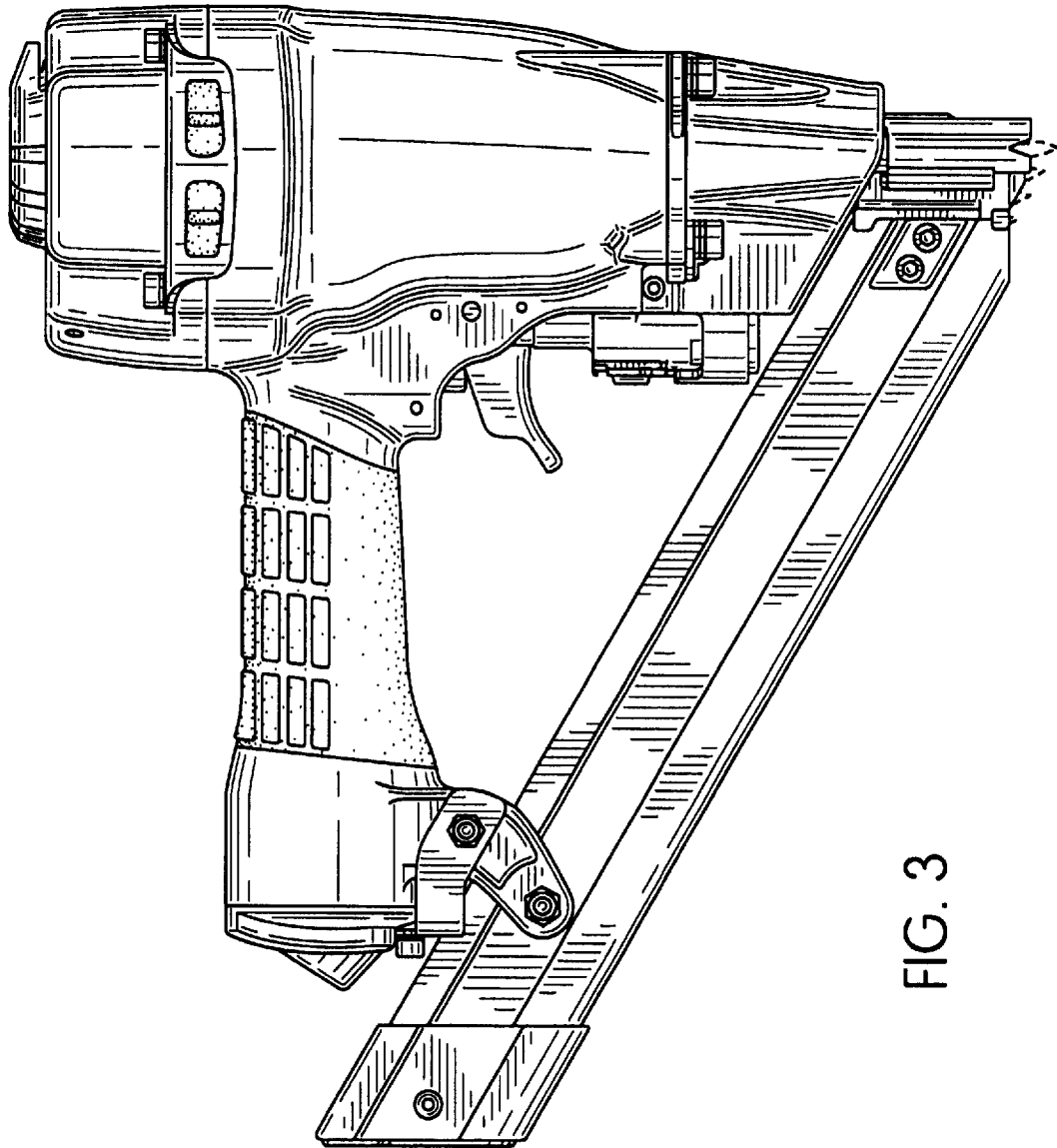

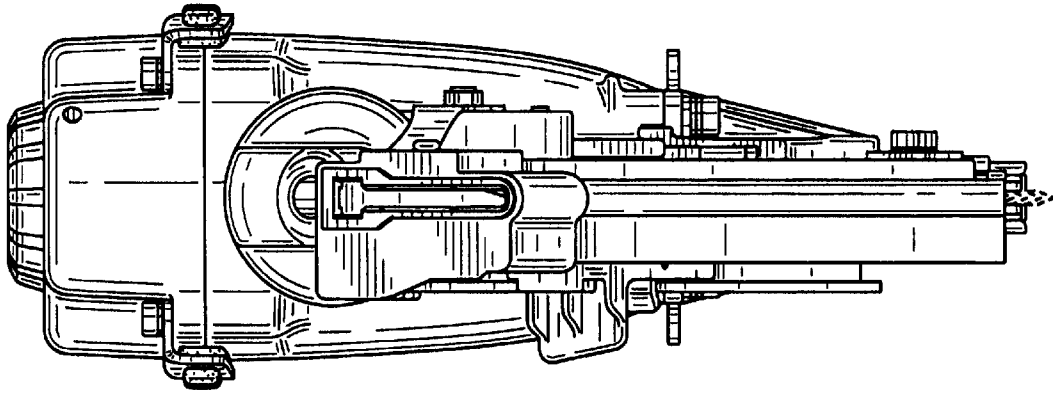

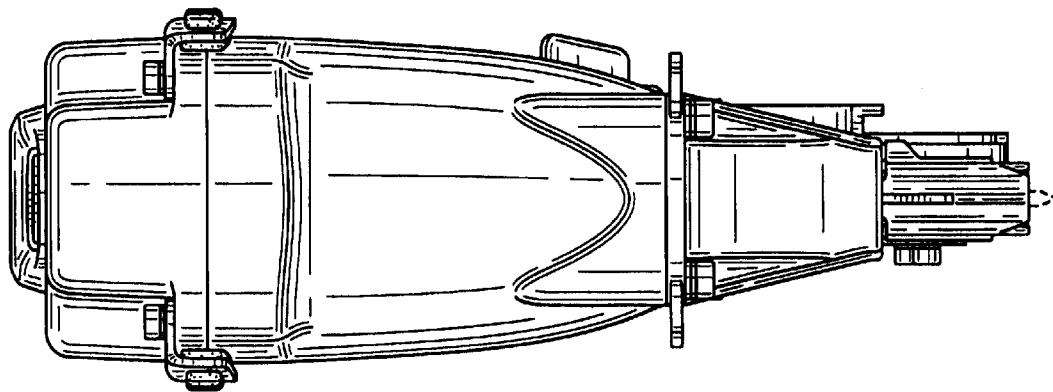

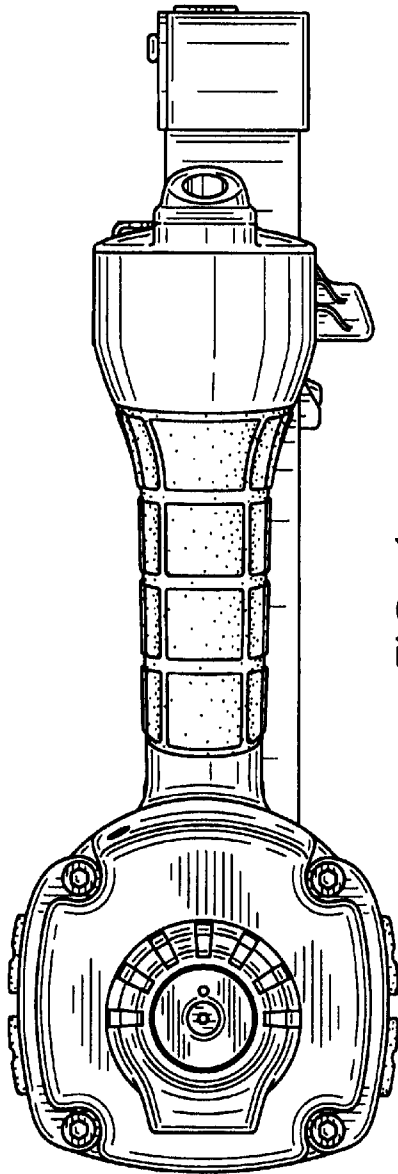

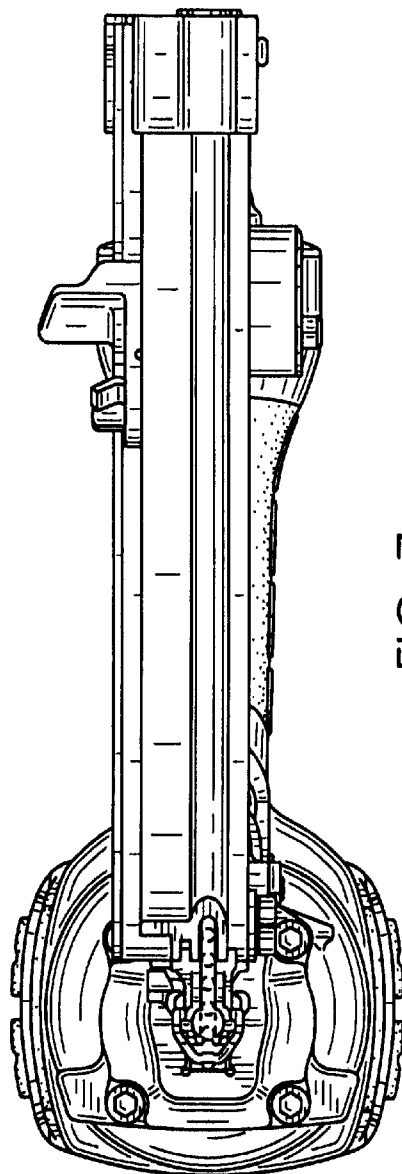
