(57) **CLAIM**

The ornamental design for a hook, as shown and described.

DESCRIPTION

FIG. 1 is an environmental, perspective view of a hook of the new design;

FIG. 2 is a right side view of the hook of FIG. 1;

FIG. 3 is a left side view of the hook of FIG. 1;

FIG. 4 is a rear view of the hook of FIG. 1;

FIG. 5 is a front view of the hook of FIG. 1;

FIG. 6 is a top view of the hook of FIG. 1;

FIG. 7 is a bottom view of the hook of FIG. 1;

FIG. 8 is a second perspective view of the hook;

FIG. 9 is a right side view of the hook of FIG. 8;

FIG. 10 is a left side view of the hook of FIG. 8;

FIG. 11 is a rear view of the hook of FIG. 8;

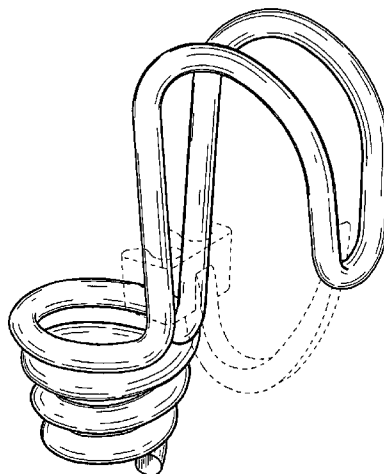
FIG. 12 is a front view of the hook of FIG. 8;

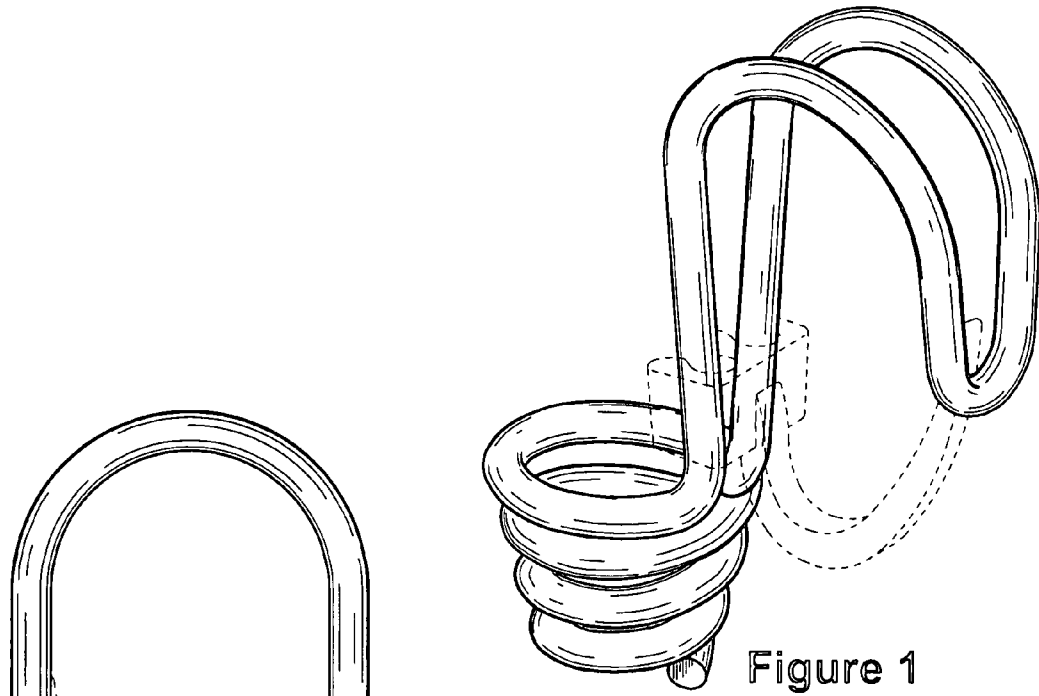

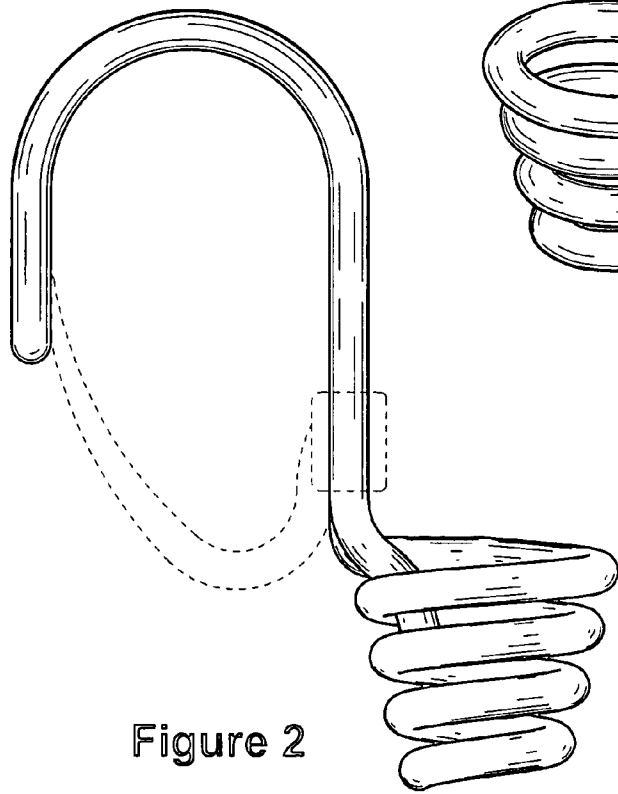

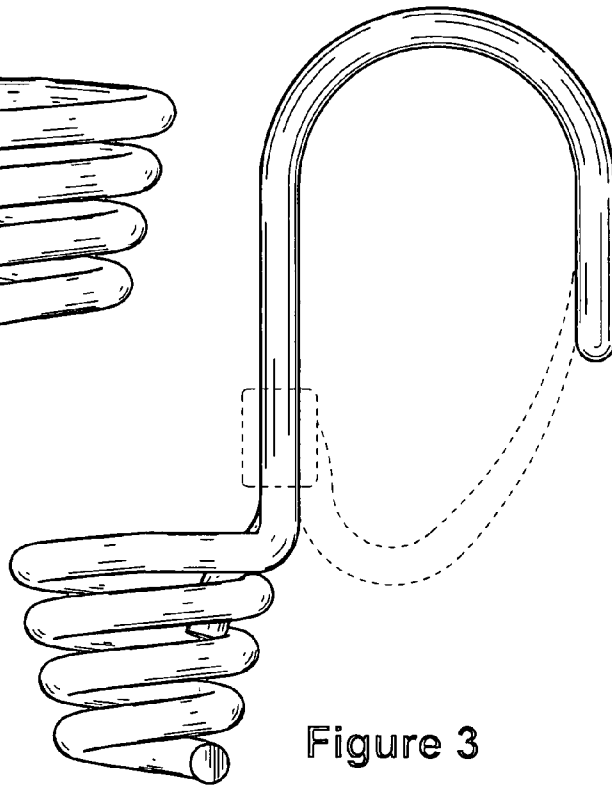

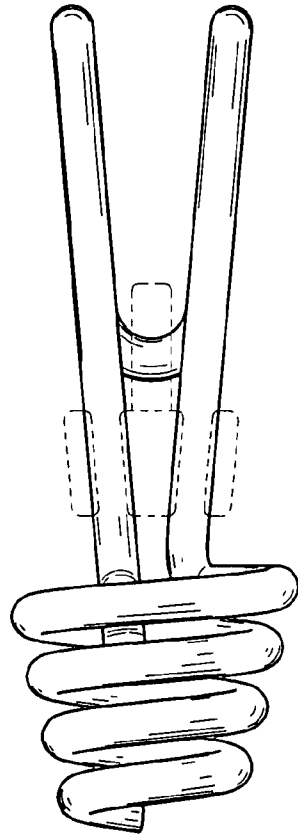

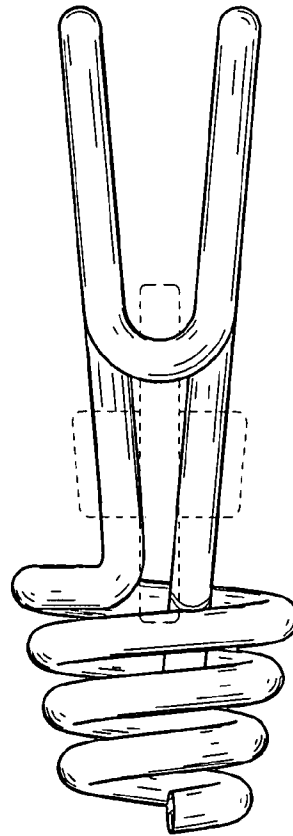

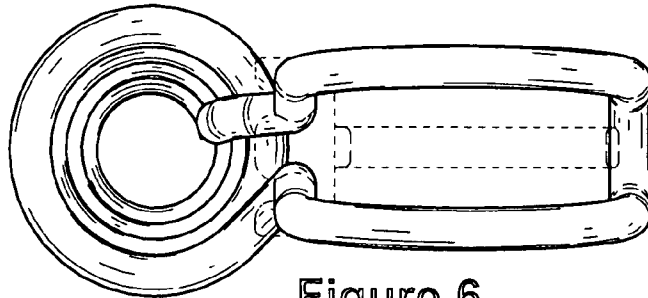

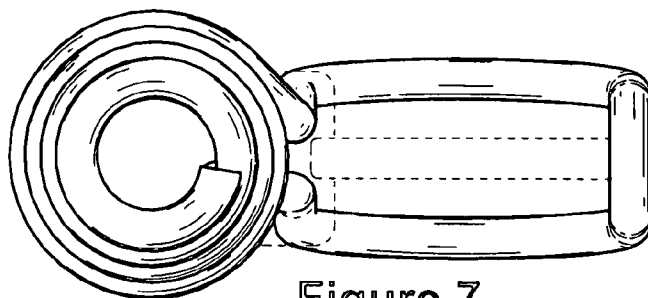

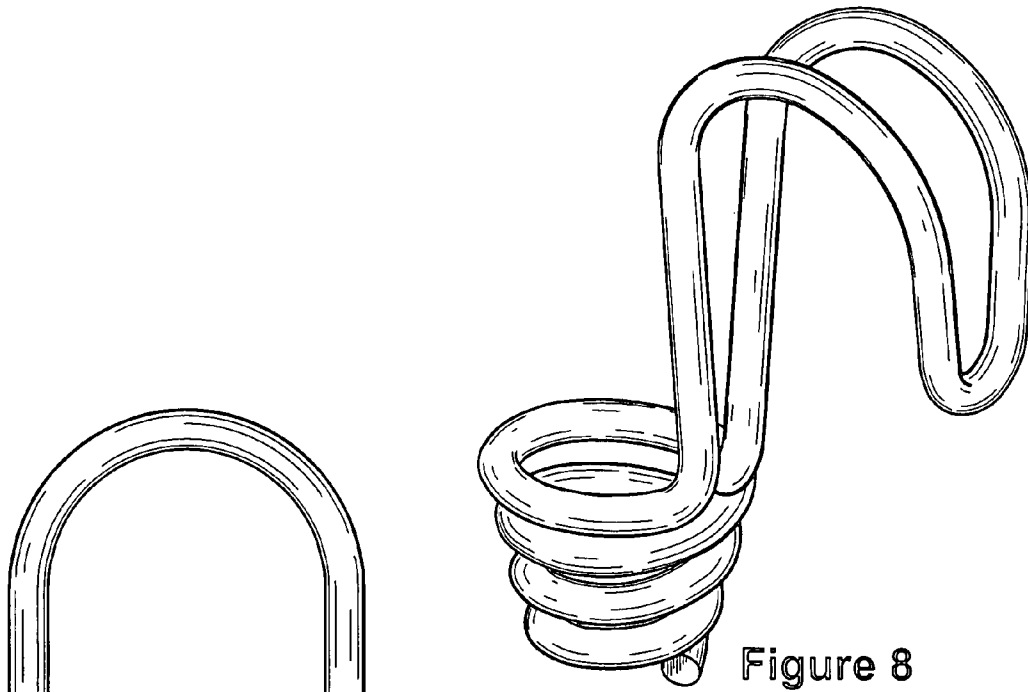

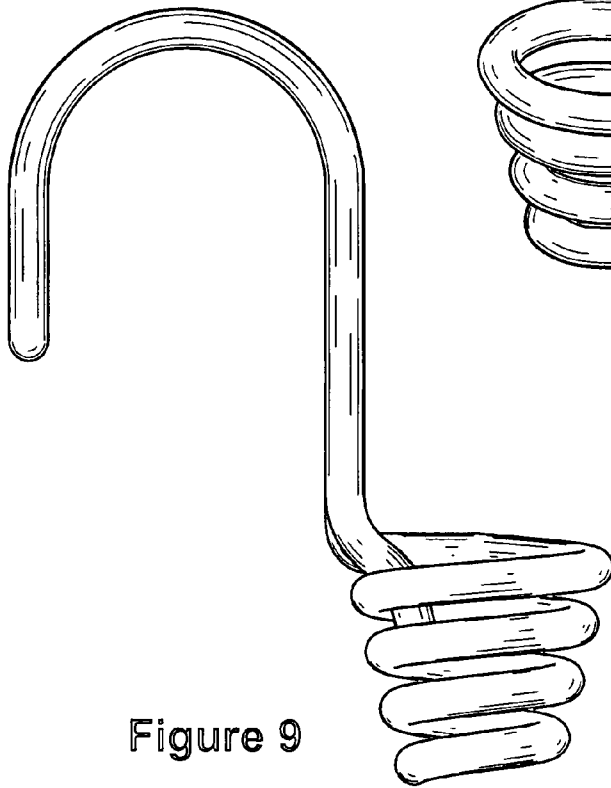

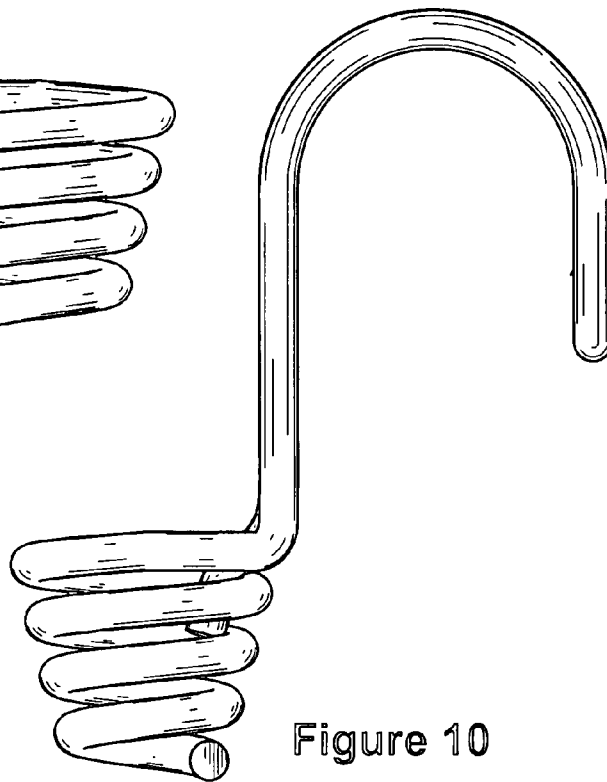

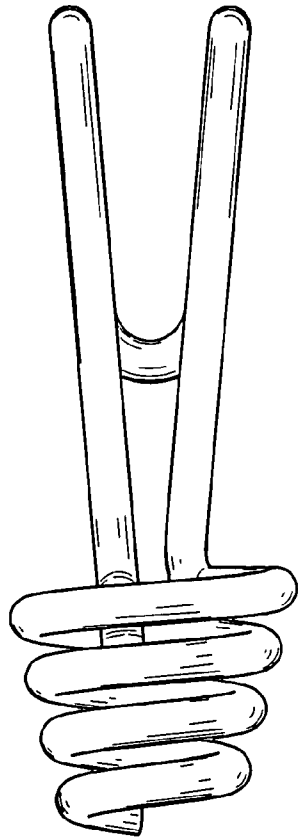

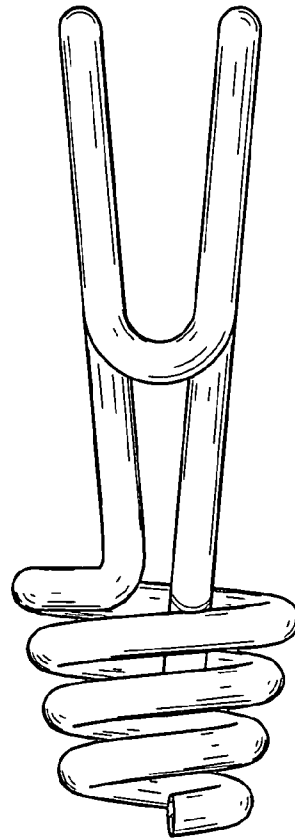

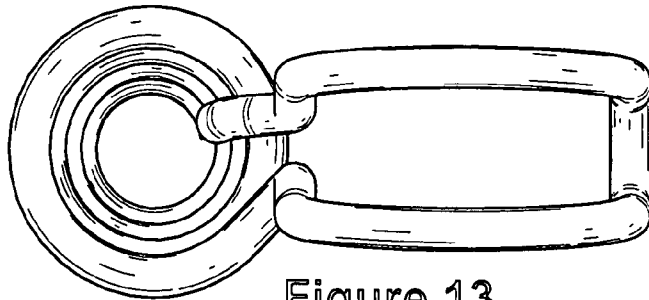

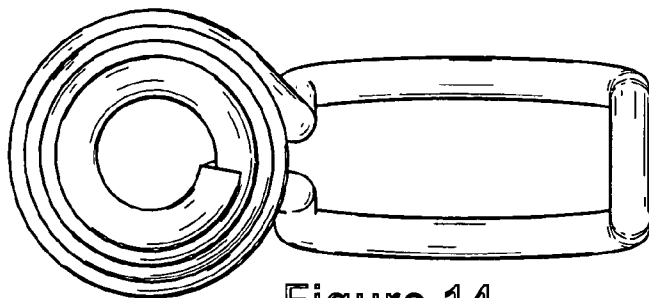
