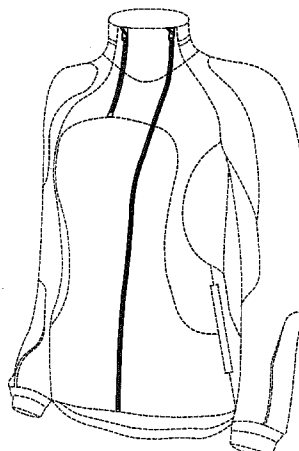
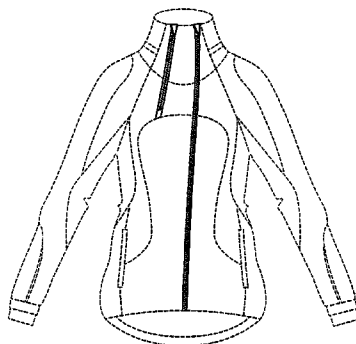
The ornamental design for a upper torso garment with zip-pers, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of an upper torso garment with zippers according to an embodiment of the design; FIG. 2 is a right side elevation view thereof; FIG. 3 is a left side elevation view thereof; and, FIG. 4 is a front perspective view thereof.

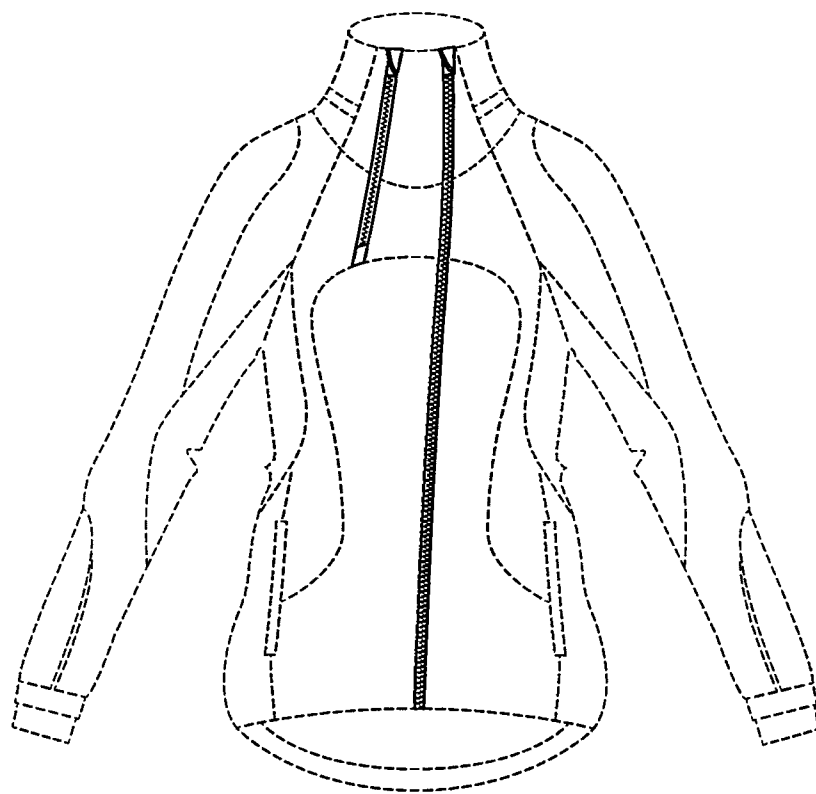

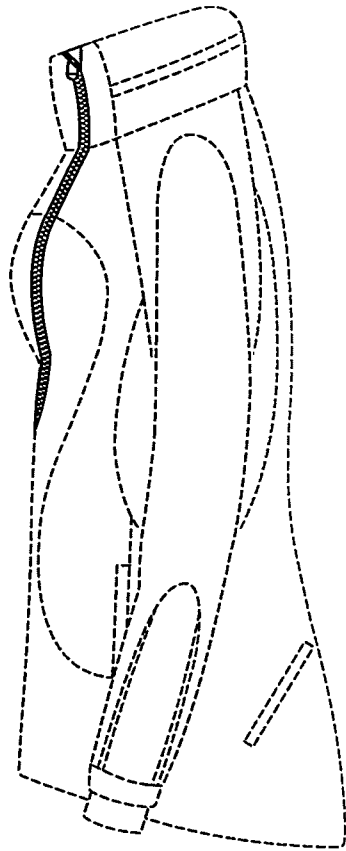

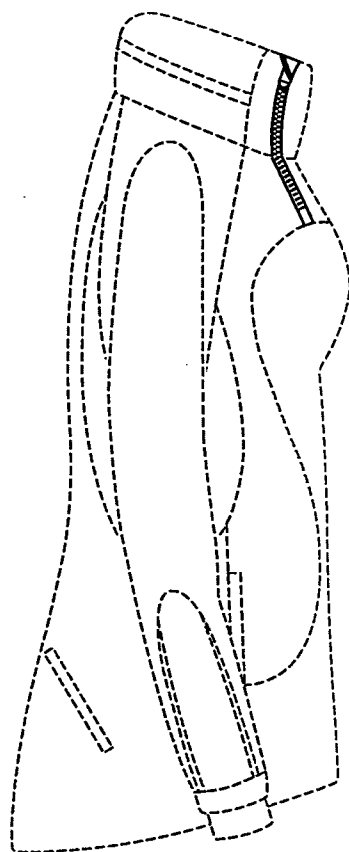

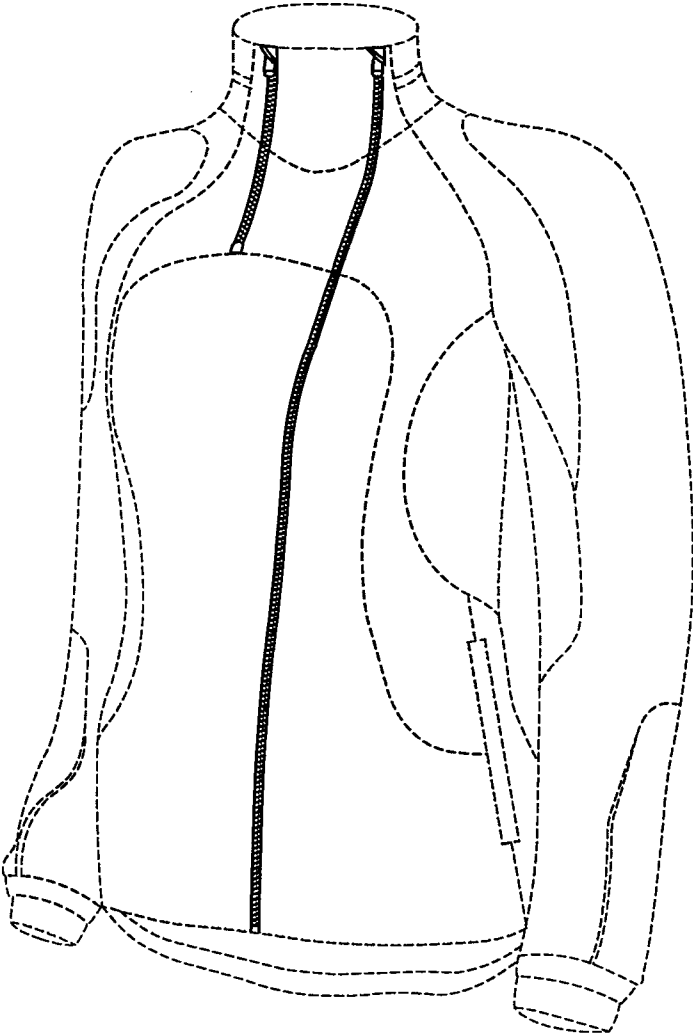
