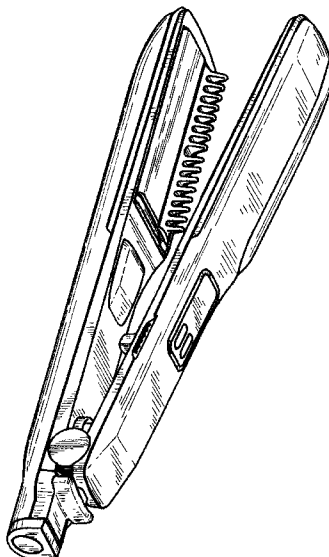
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front, bottom, and right side perspective view of a hair straightener, showing my new design;

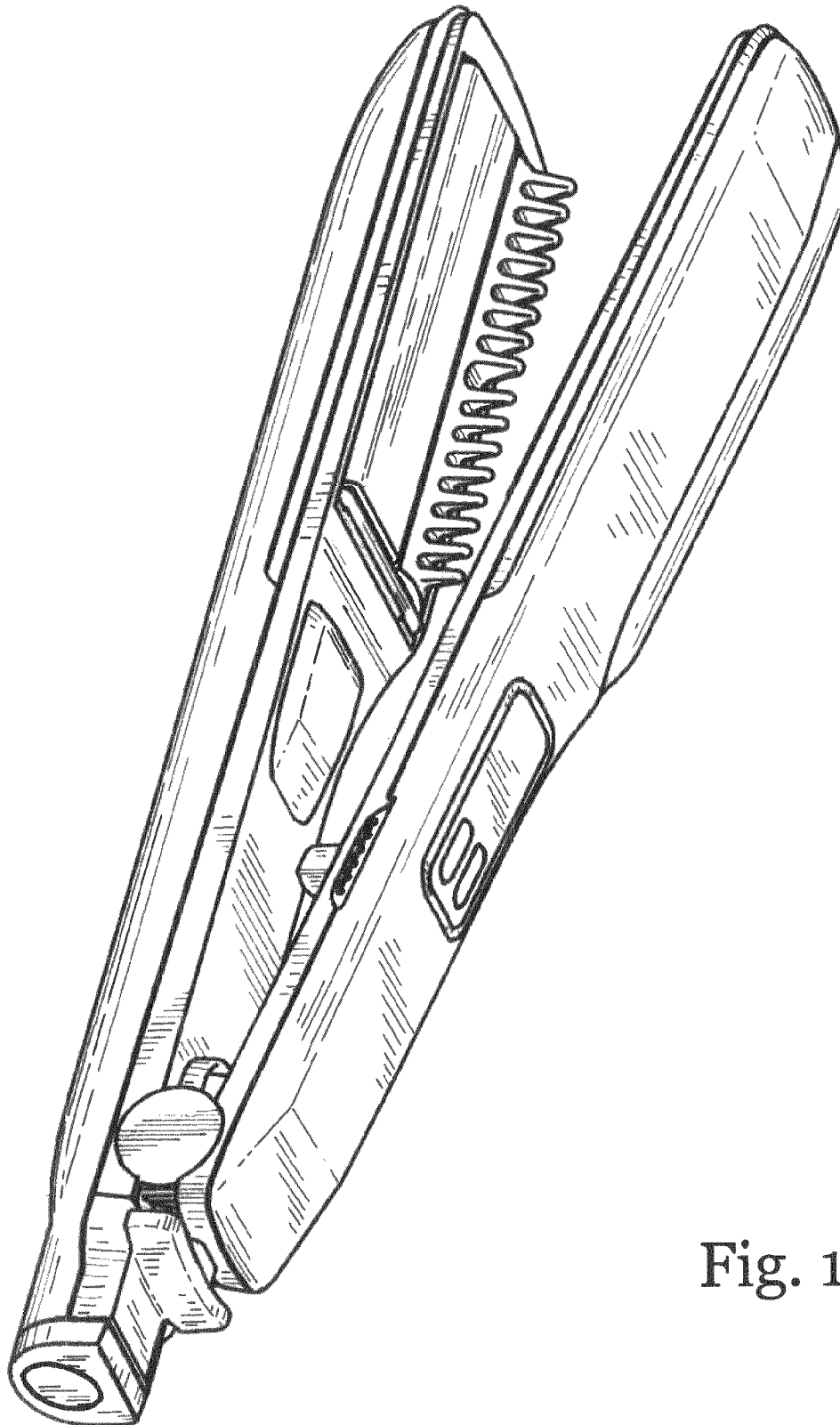

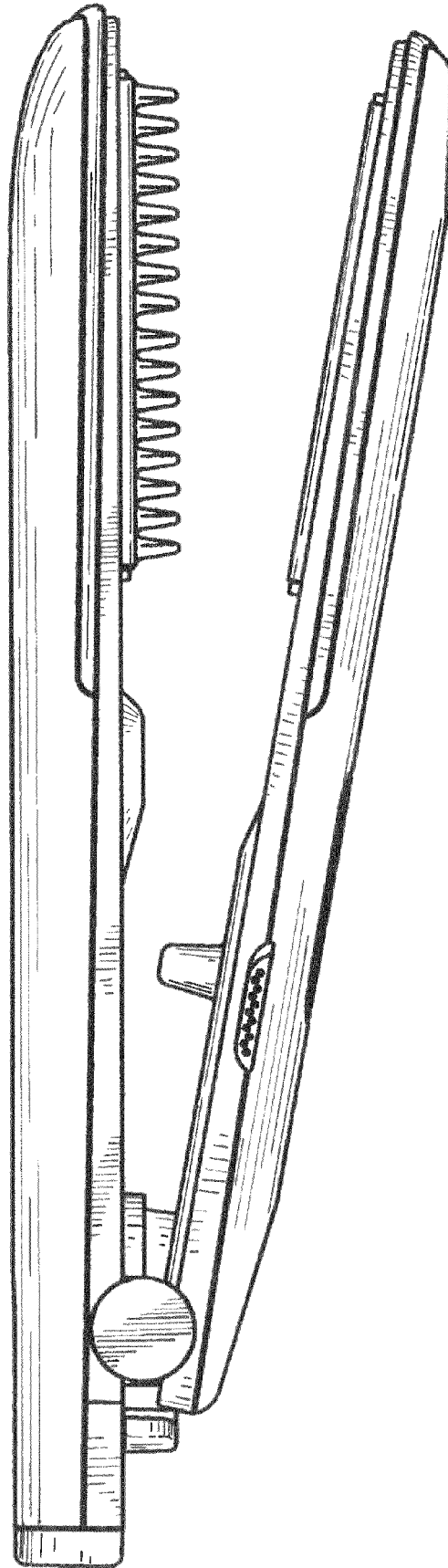

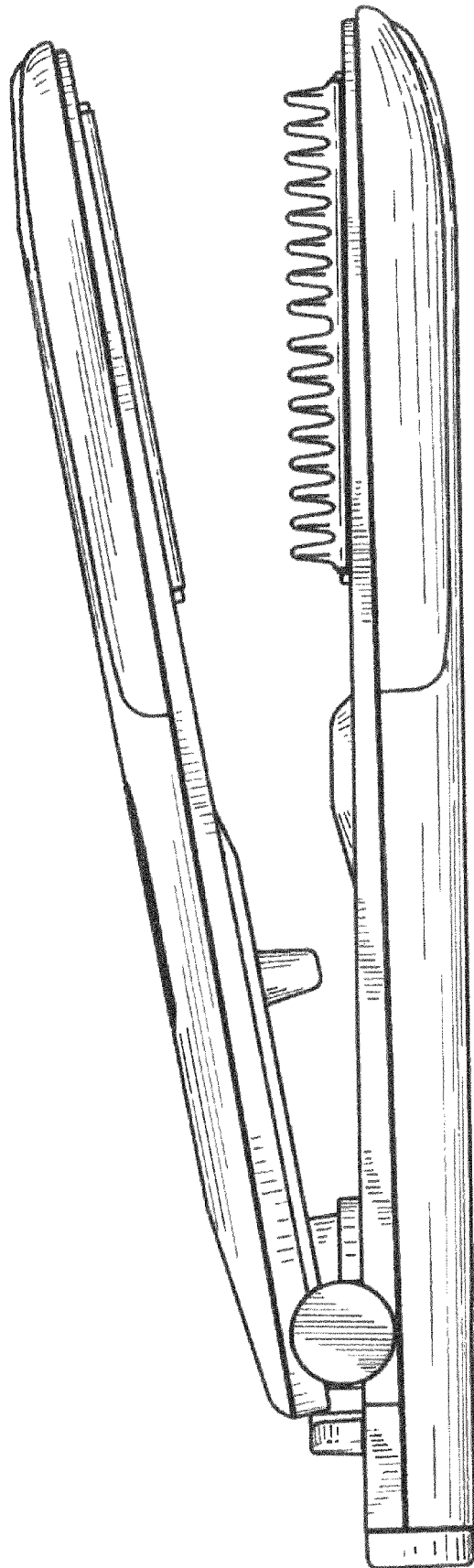

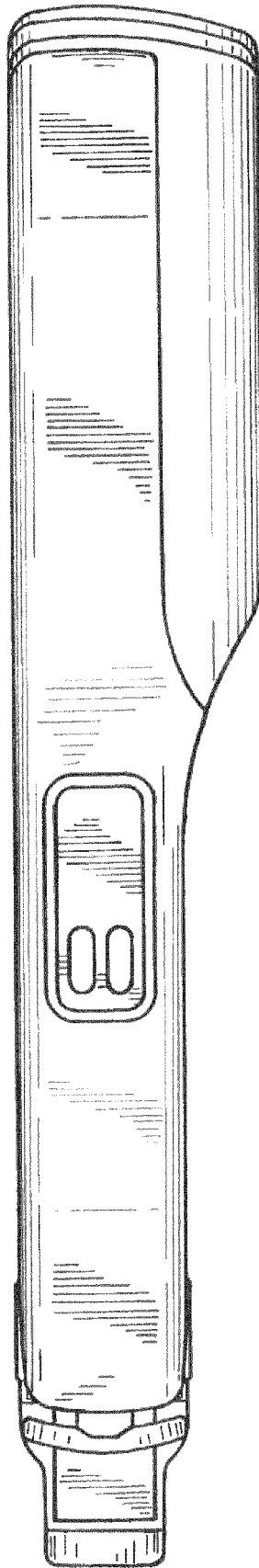

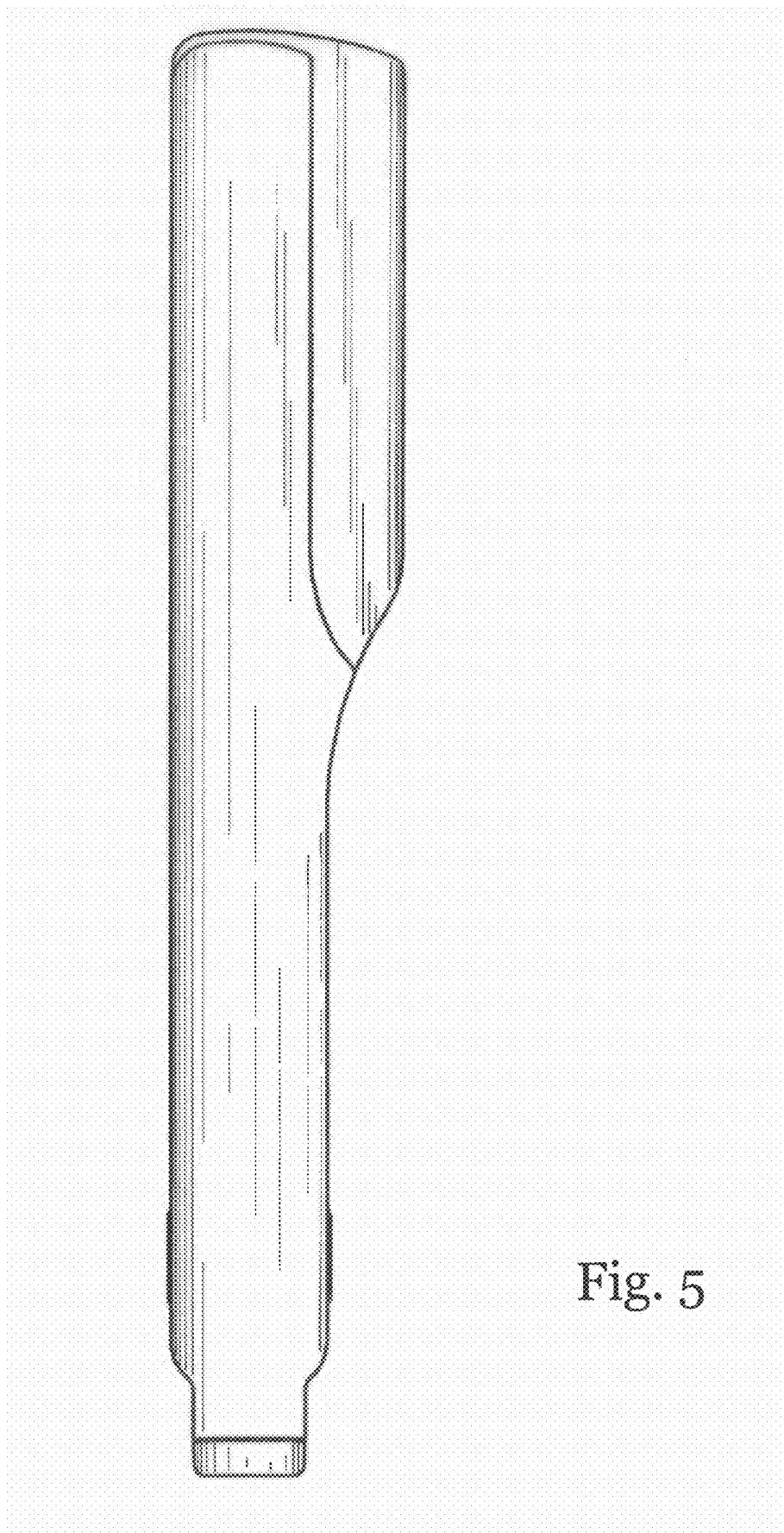

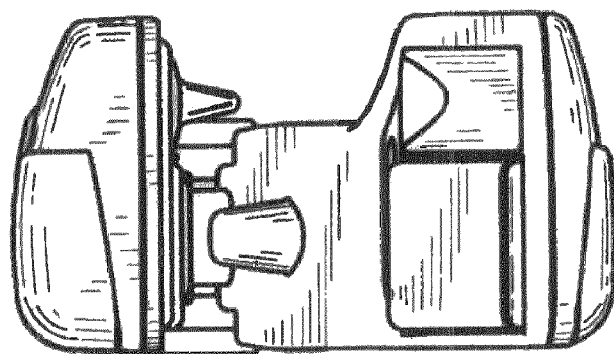

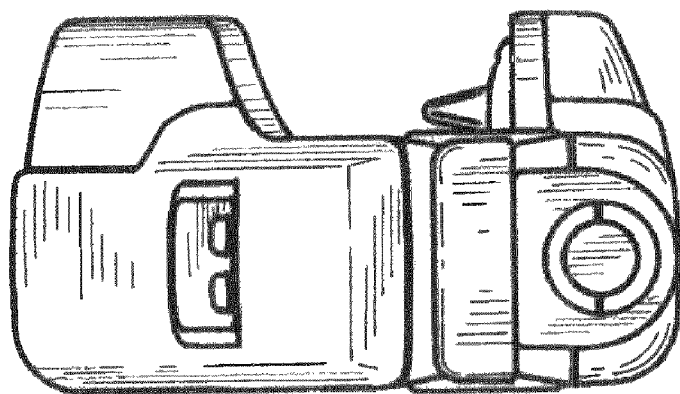
