(57) **CLAIM**

The ornamental design for a shoe upper component, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an embodiment of a shoe upper component within the environment of a shoe in accordance with my new design;

FIG. 2 is a front perspective view of the shoe upper component shown in FIG. 1 shown without the shoe environment;

FIG. 3 is a right side elevation view of the embodiment shown in FIG. 2;

FIG. 4 is a left side elevation view of the embodiment shown in FIG. 2;

FIG. 5 is a front elevation view of the embodiment shown in FIG. 2;

FIG. 6 is a rear elevation view of the embodiment shown in FIG. 2;

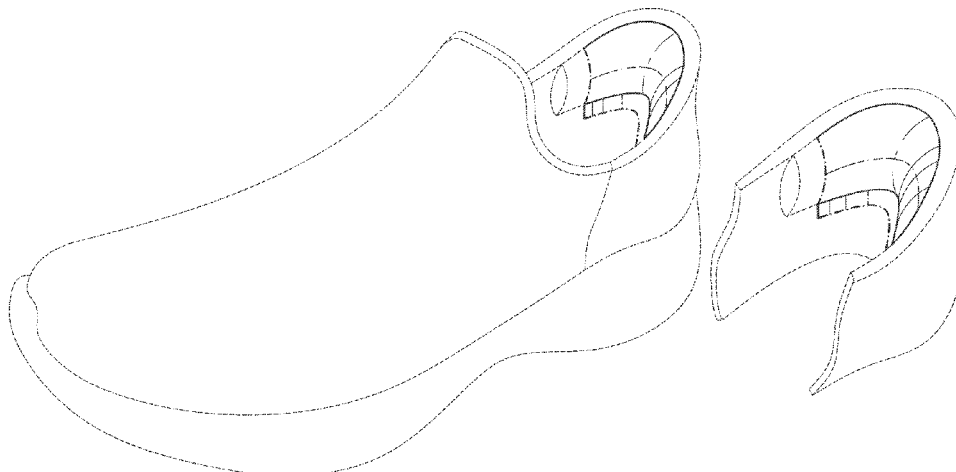
FIG. 7 is a top plan view of the embodiment shown in FIG. 2;

FIG. 8 is bottom plan view of the embodiment shown in FIG. 2; and,

FIG. 9 is a left side elevation view of the cross-section taken from line 9-9 shown in FIG. 7.

The dash-dash broken lines shown in the drawings represent portions of the shoe upper component and environmental structure that form no part of the claimed design. The dot-dash broken lines in the figures define the bounds of the claimed design and form no part of the claimed design. The surfaces devoid of shading lines form no part of the claimed design. The cross-section is provided to clarify the design.

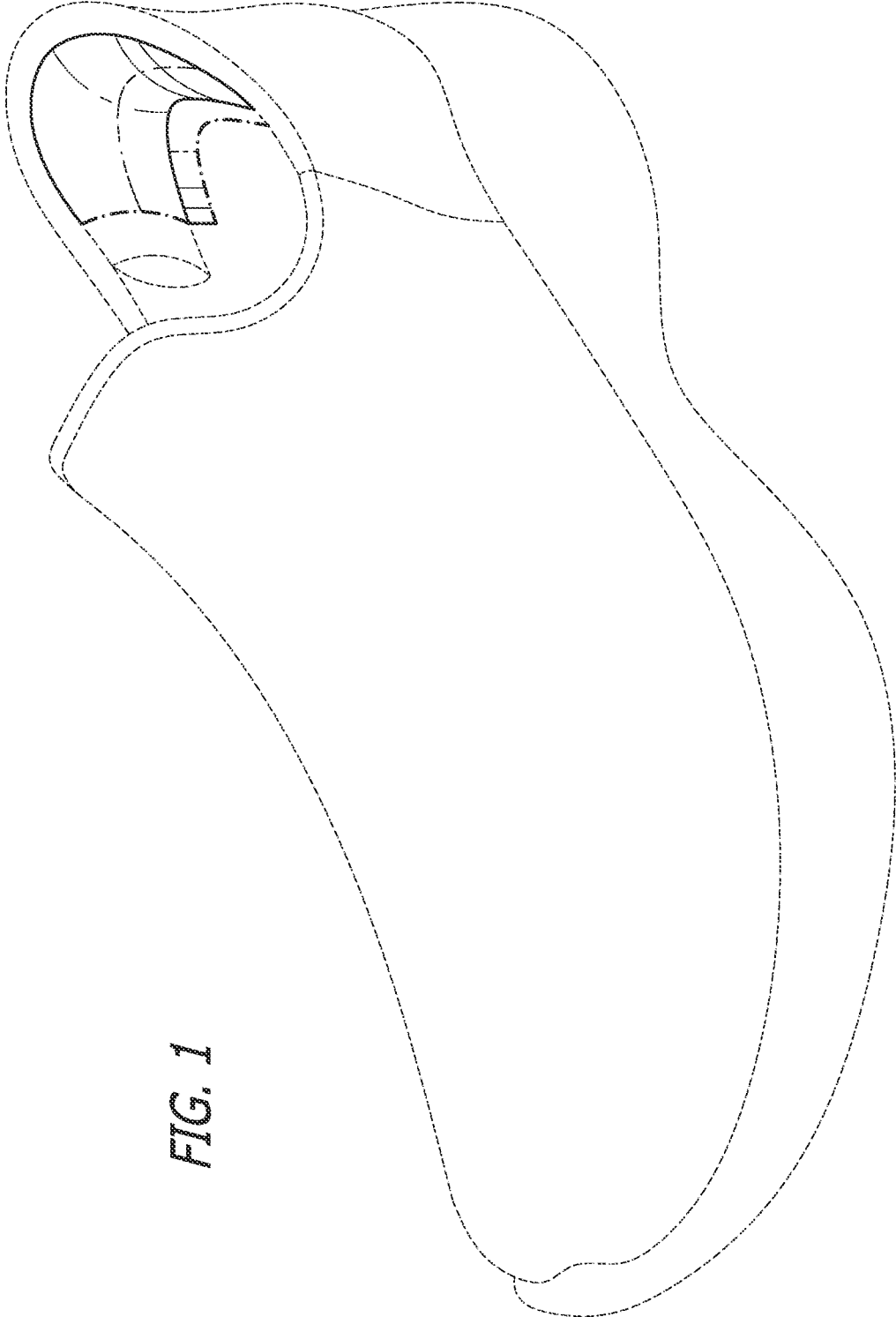

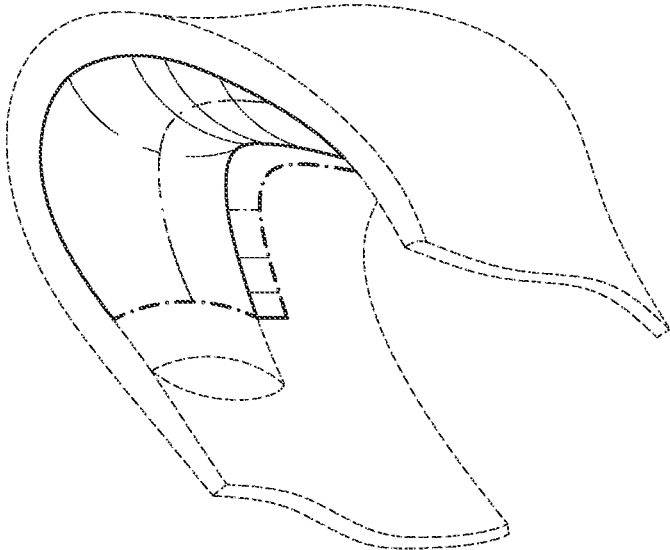

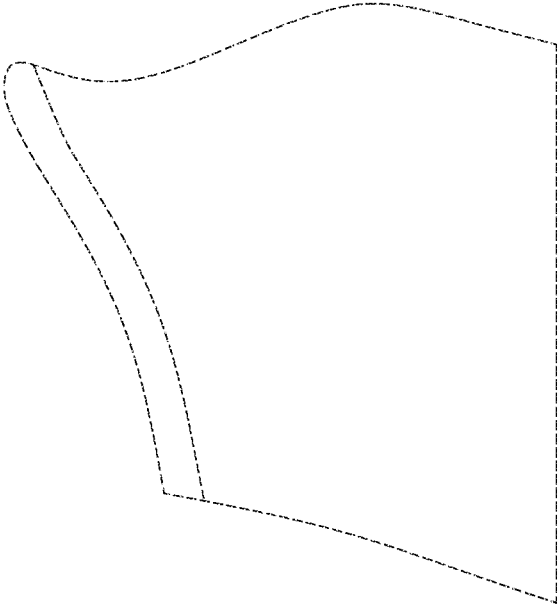

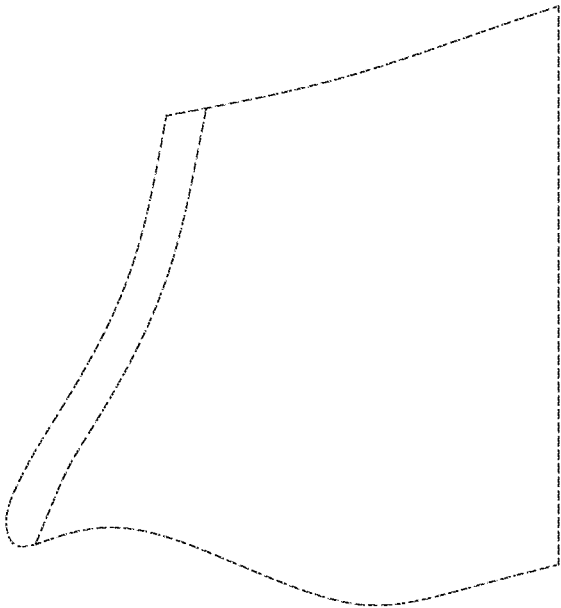

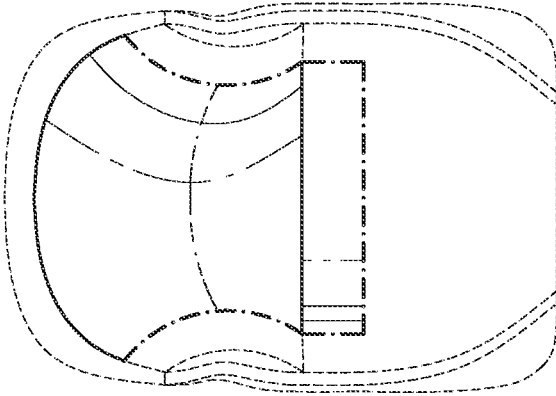

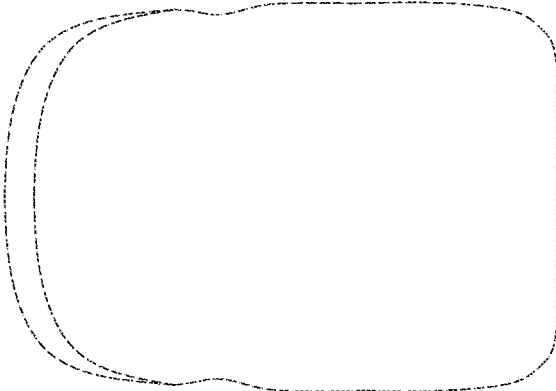

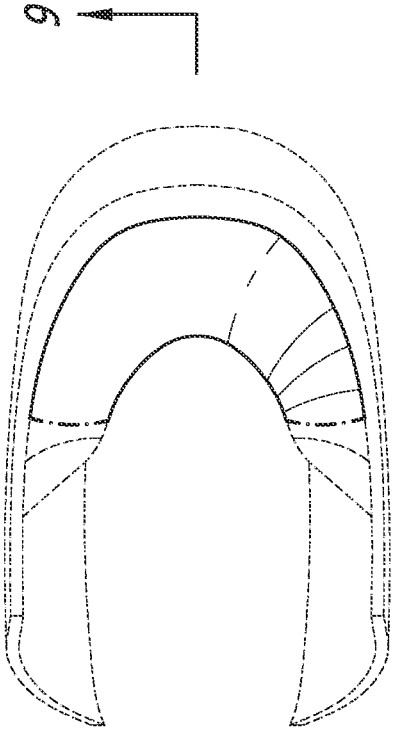

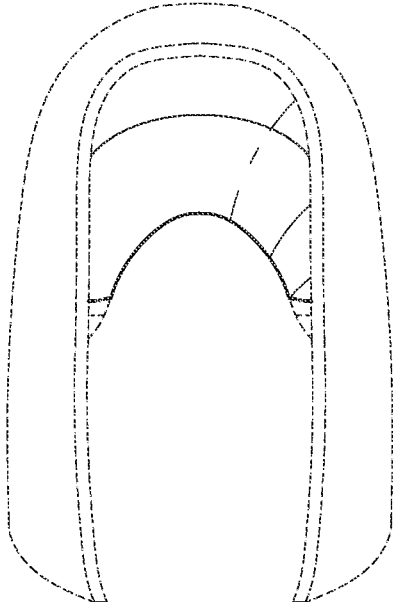

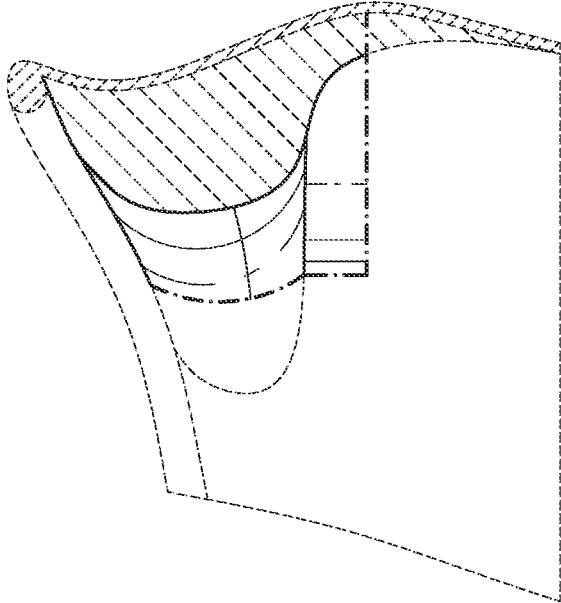
