FIG. 2 is a rear elevational view thereof.

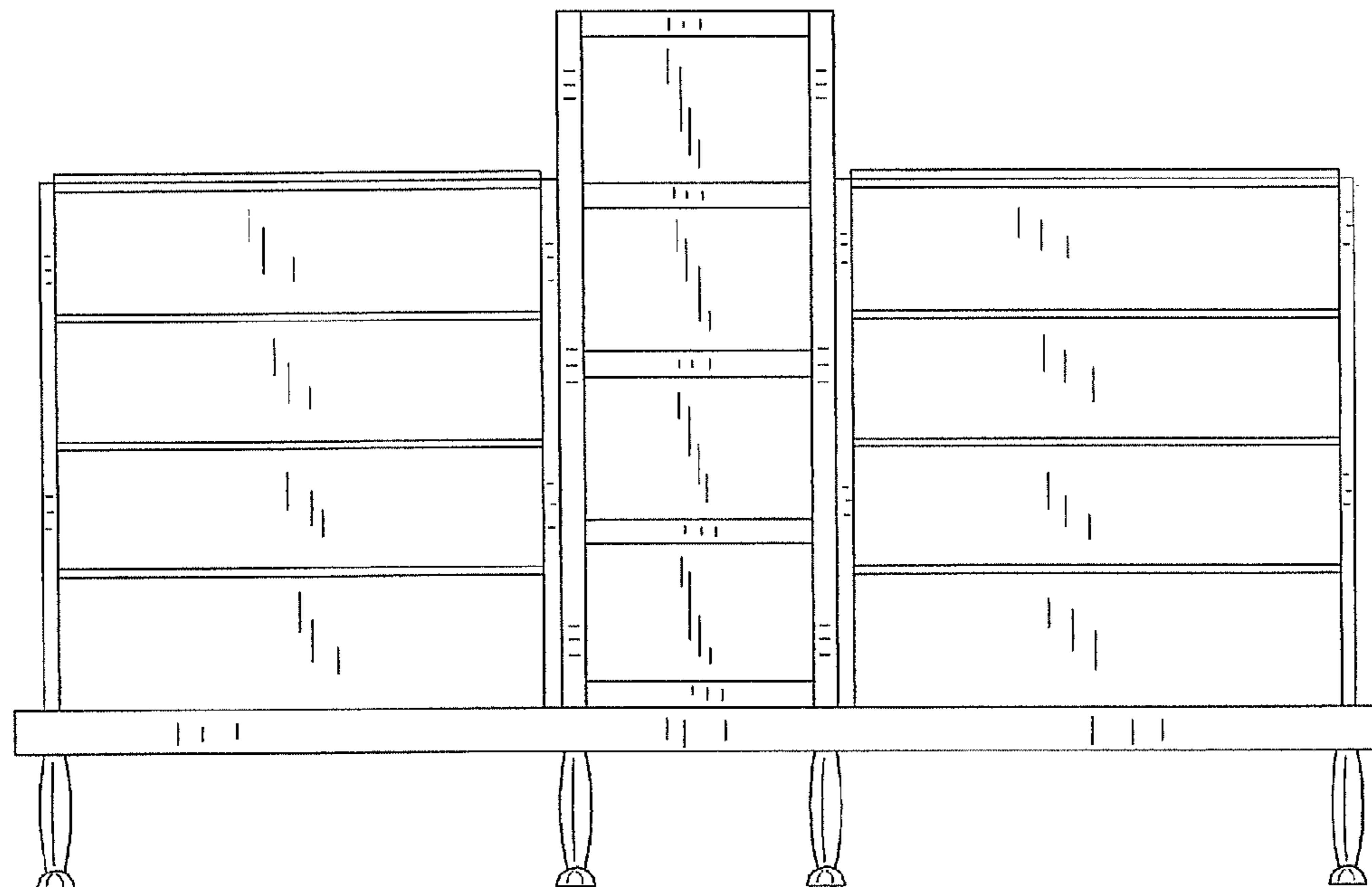
FIG. 3 is a top plan view thereof.

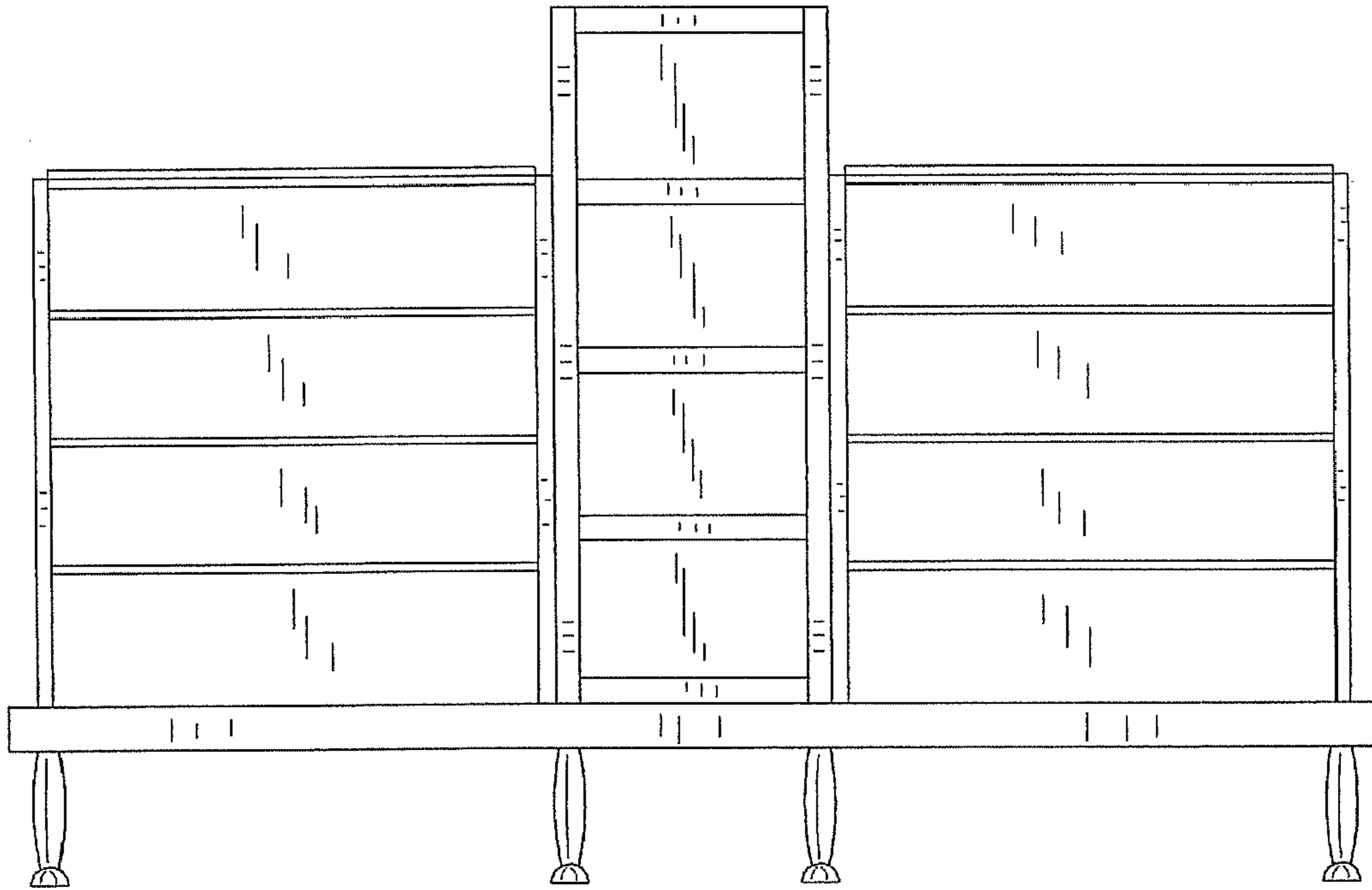

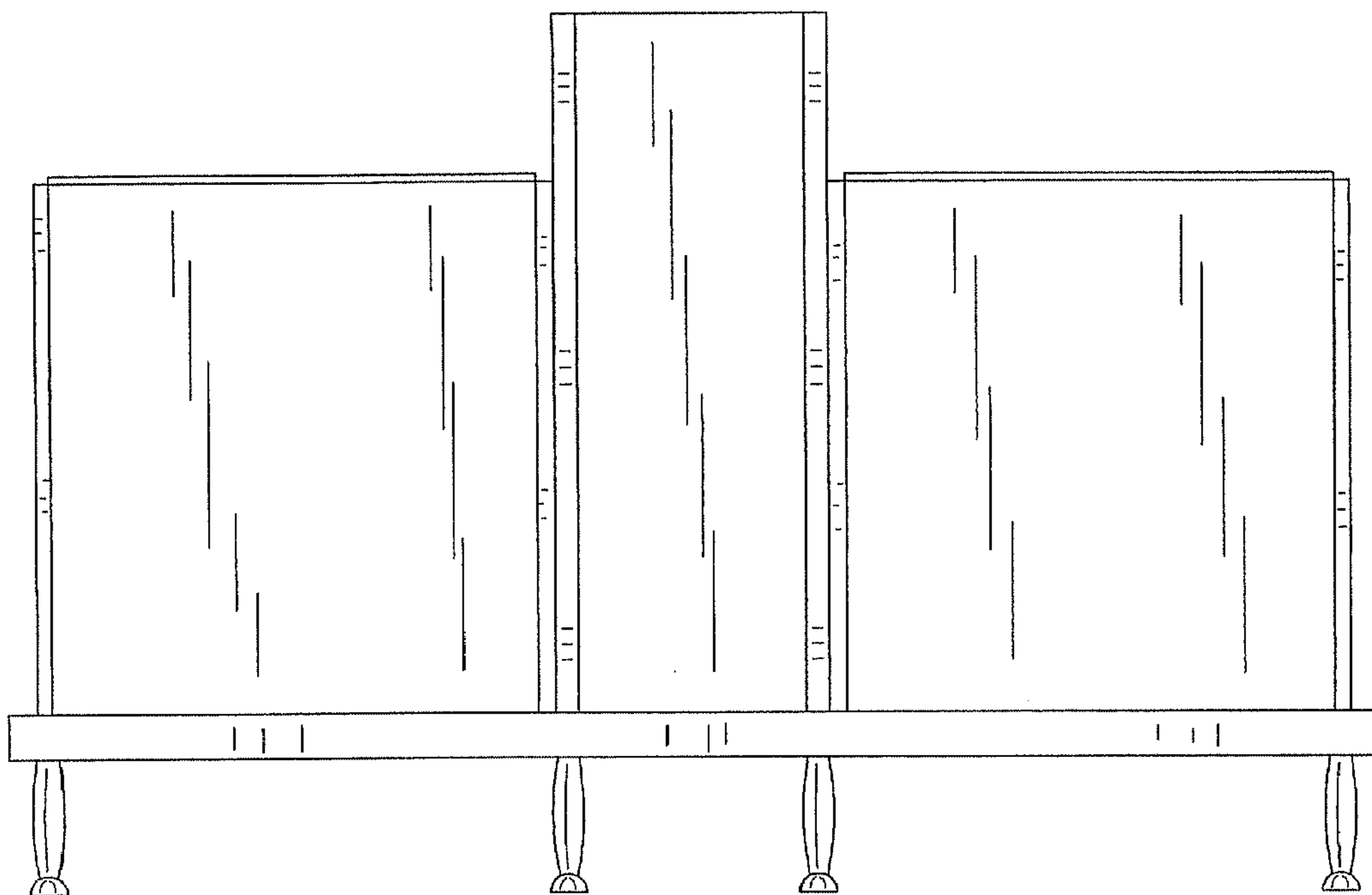

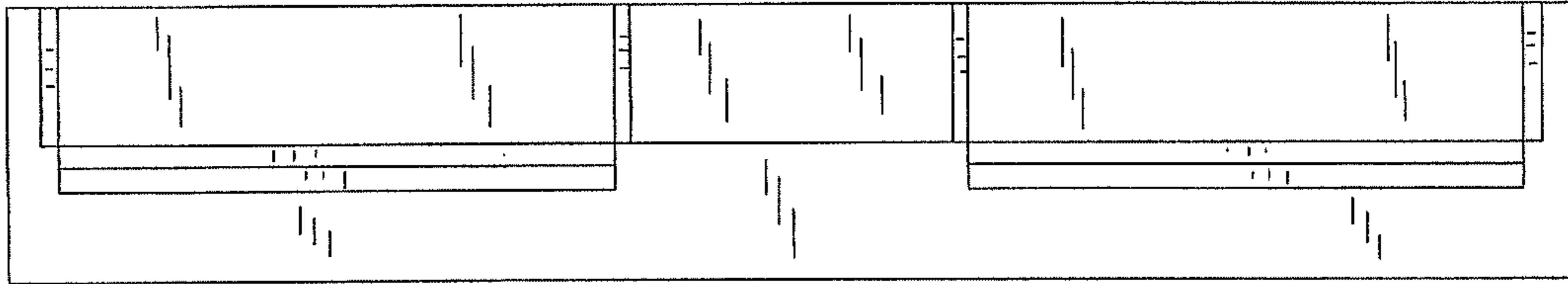

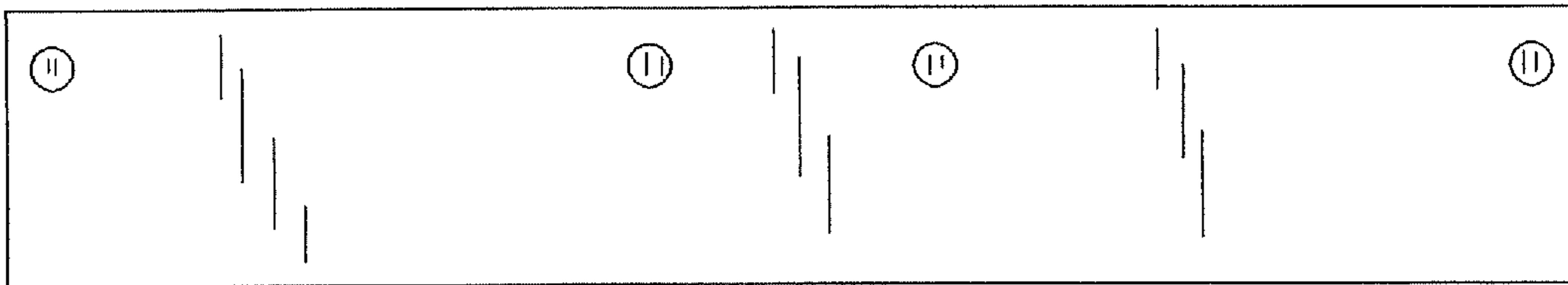

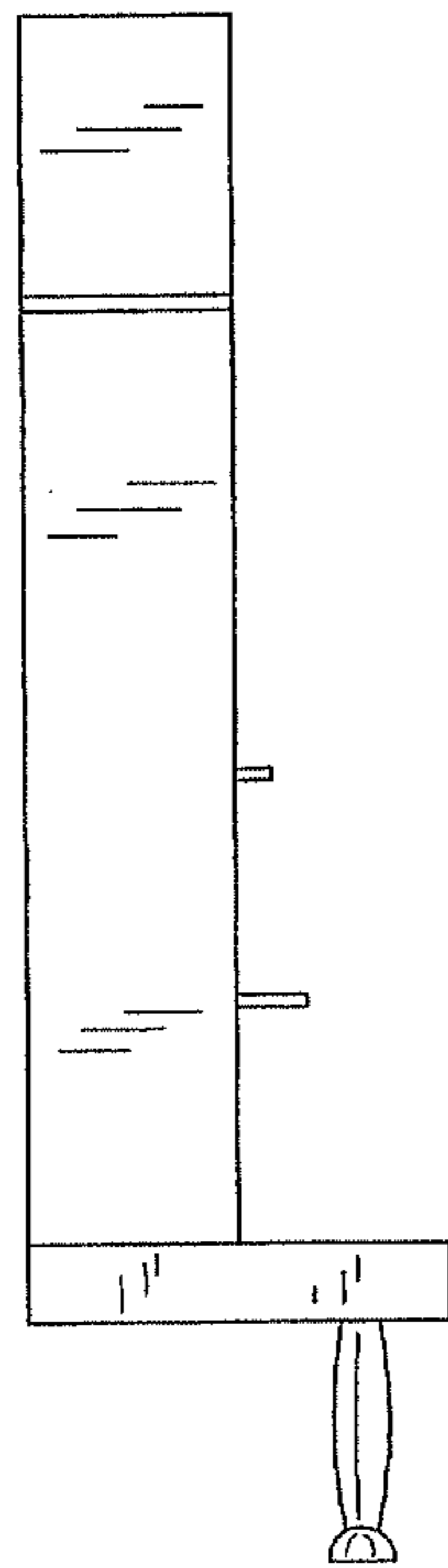

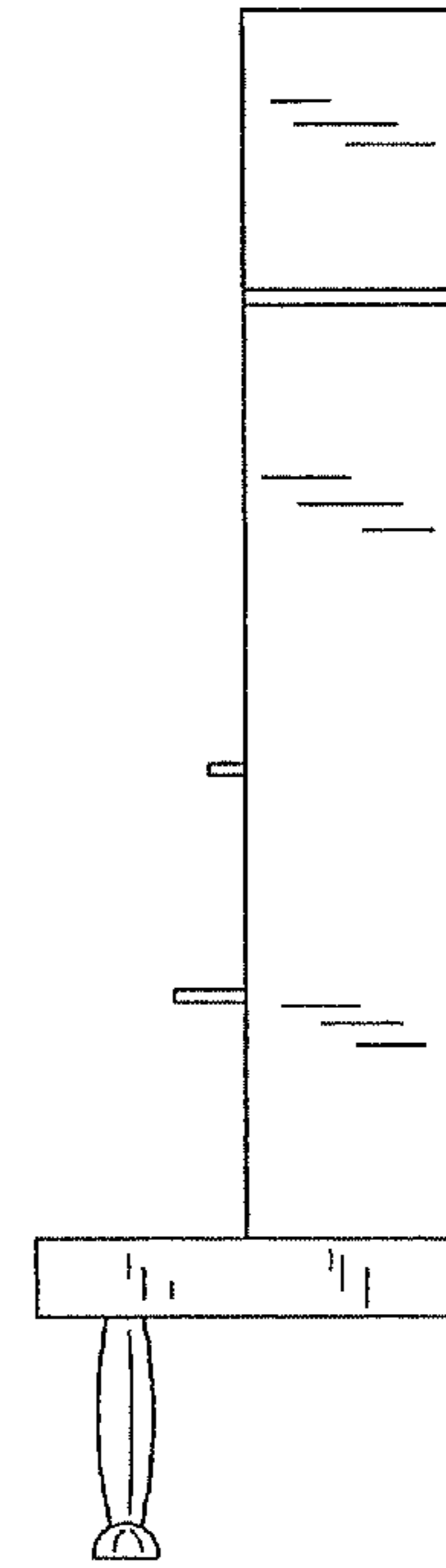
