The ornamental design for a caddy, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the new design for a caddy;

FIG. 5 is a top view thereof;


FIG. 6 is a bottom view thereof;


FIG. 7 is a cross-sectional view taken along line 7-7 of FIG. $\bf 5$; and,









