FIG. 4 is a perspective view of another embodiment thereof;

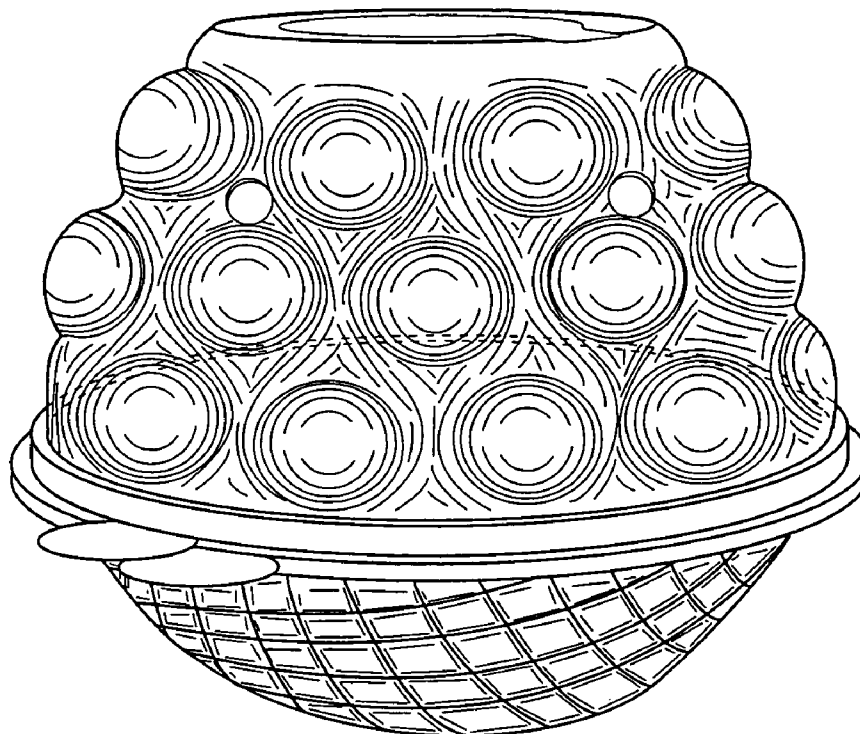
FIG. 5 is a perspective view of another embodiment thereof;

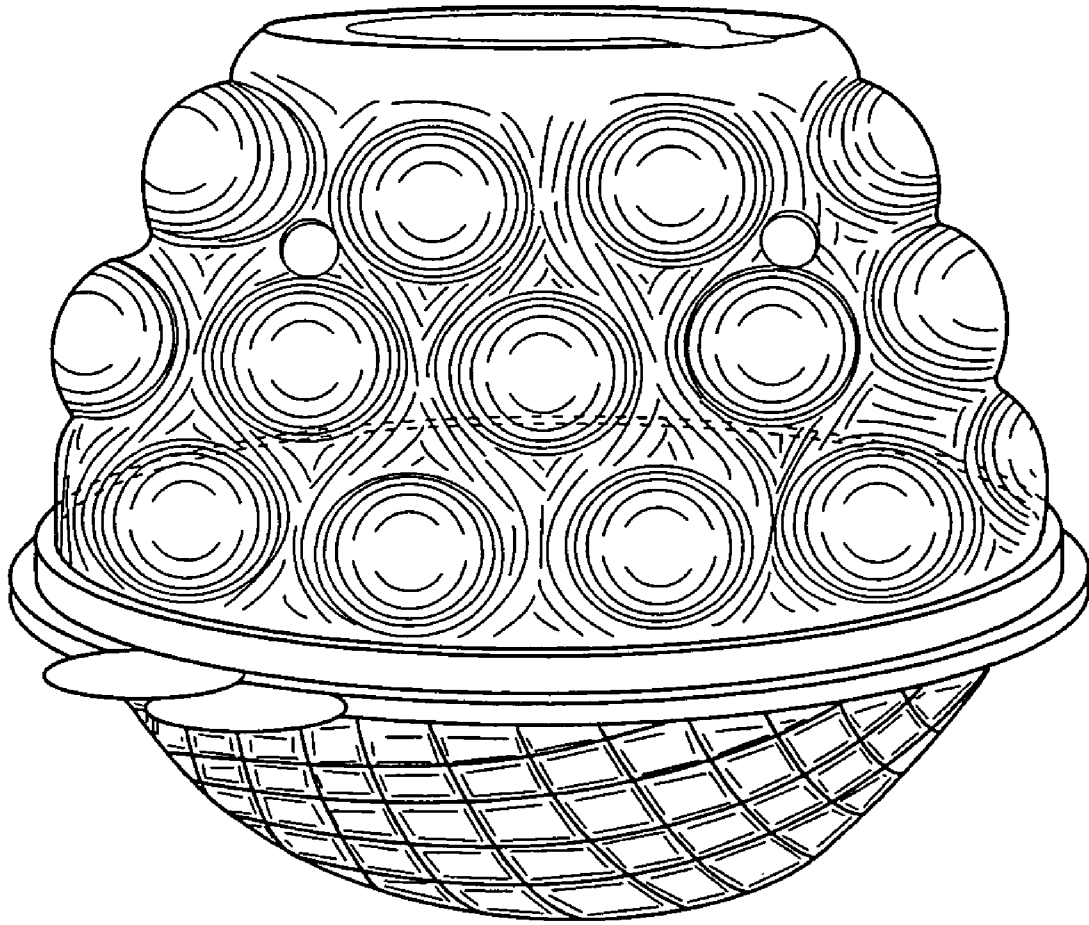
FIG. 6 is a perspective view of the bottom portion thereof, when separated from the top; and,

FIG. 7 is a perspective view of the top portion thereof, when separated from the bottom.

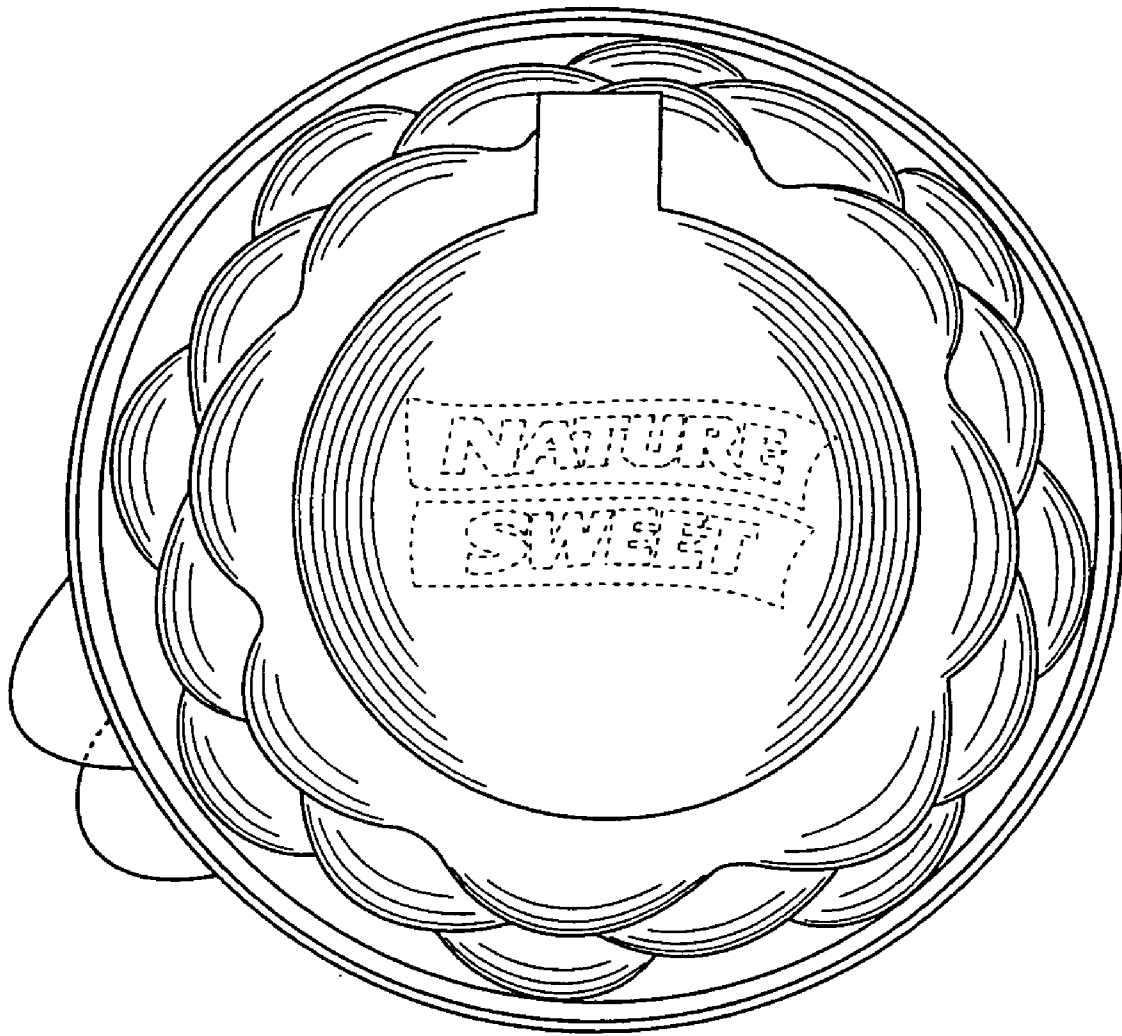

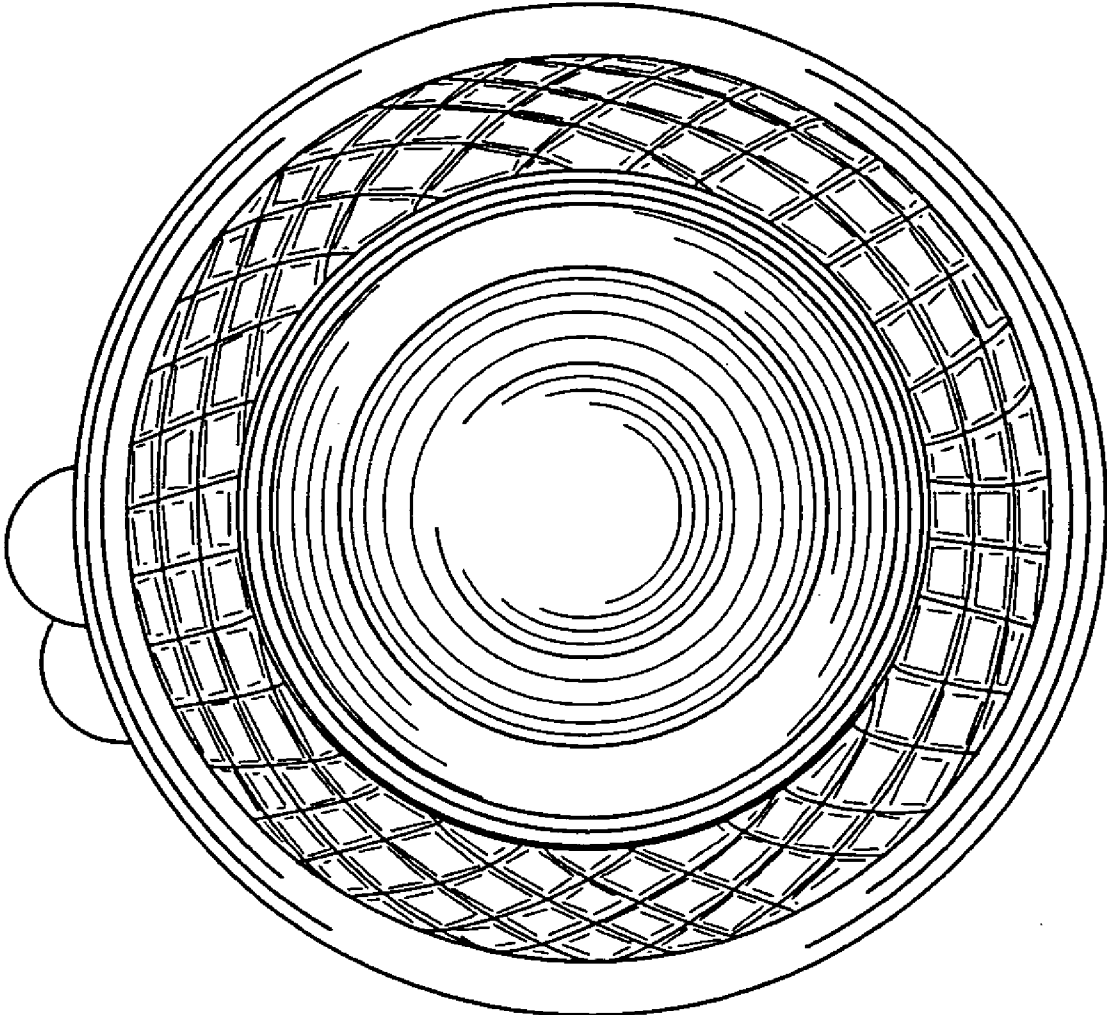




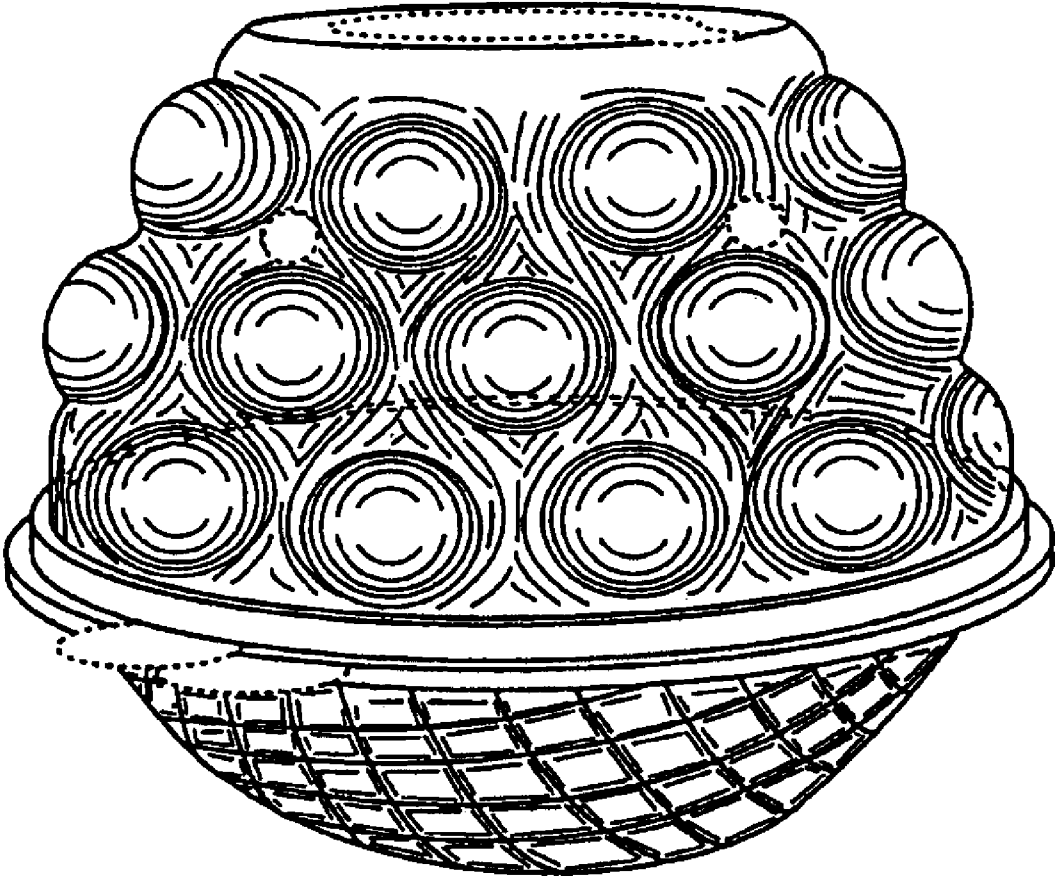

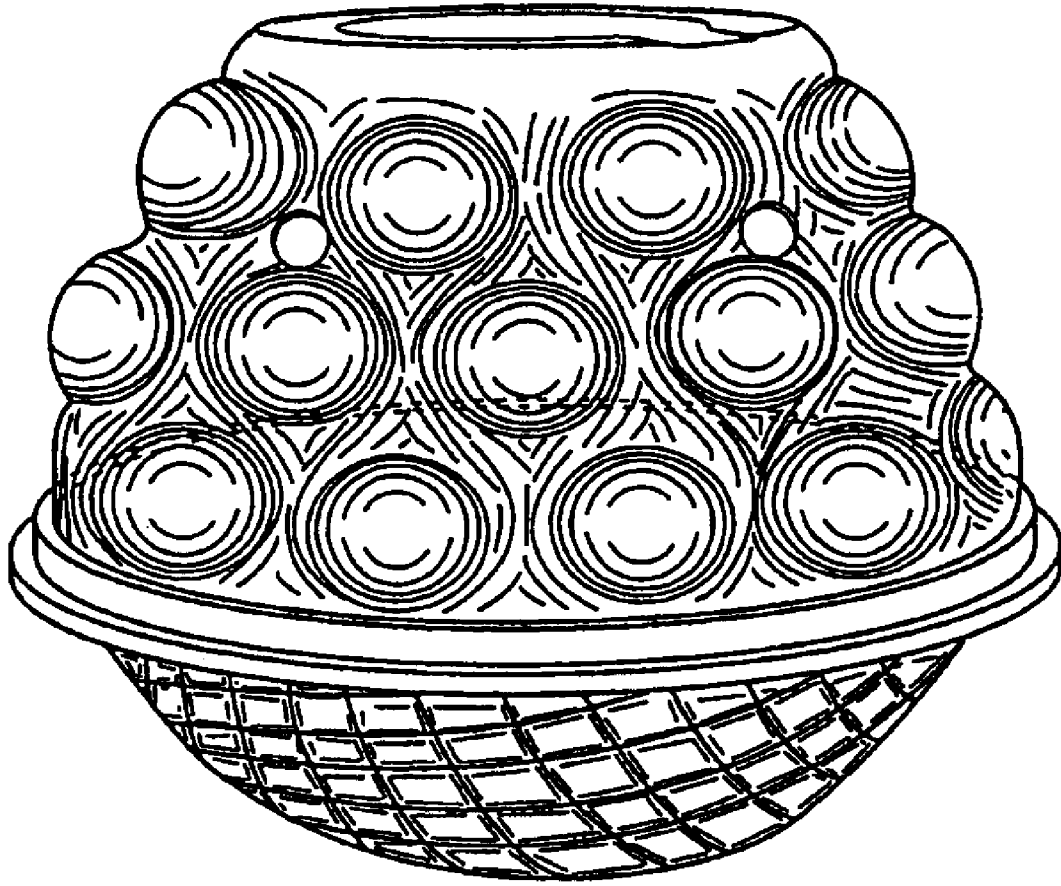

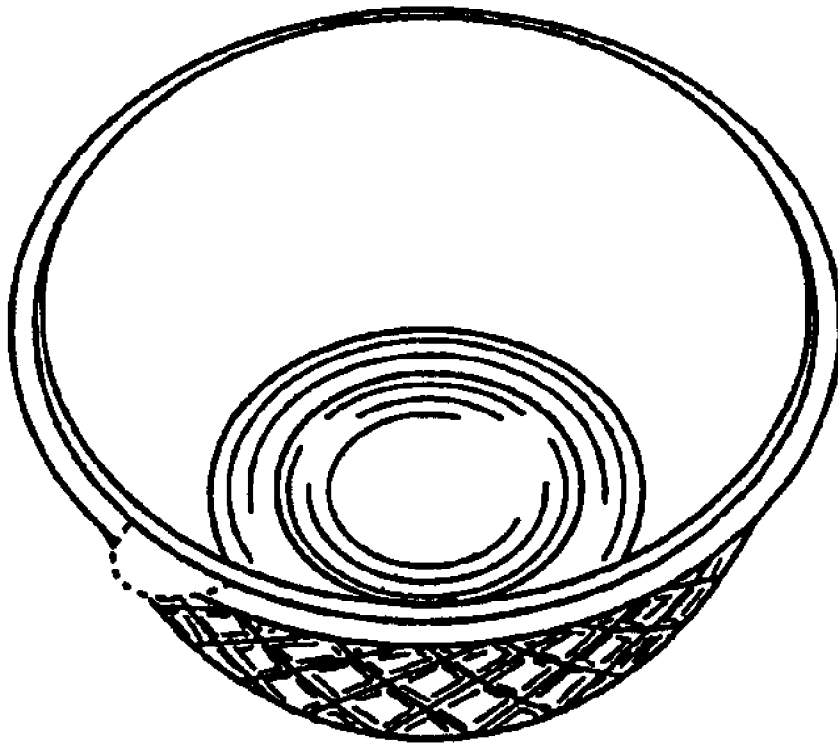

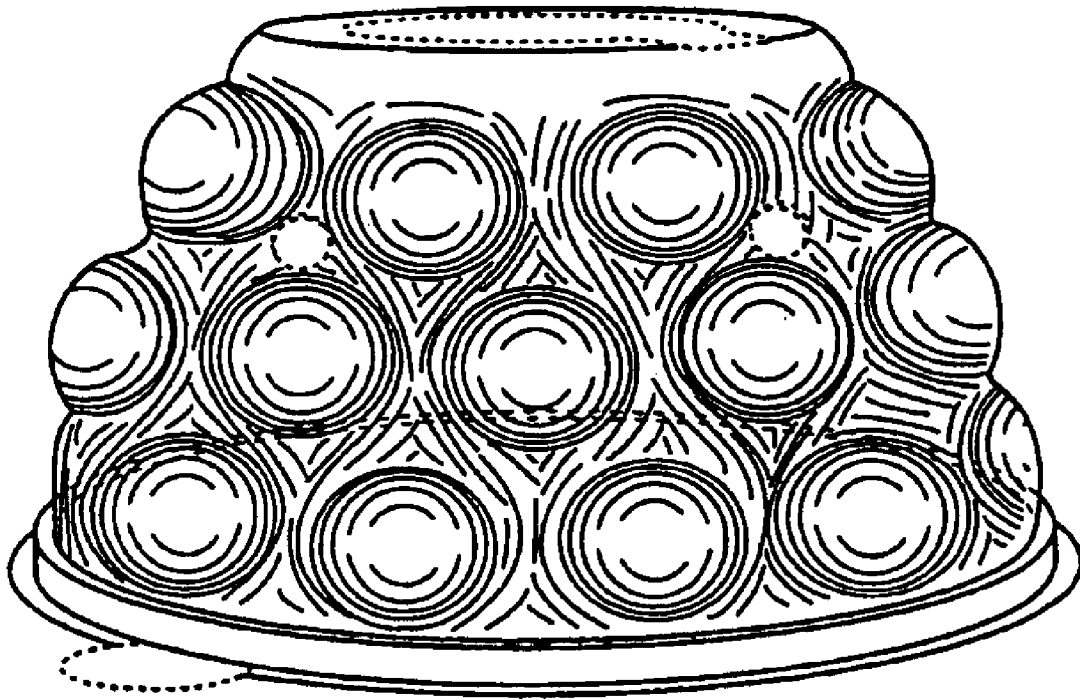
