(57) **CLAIM**

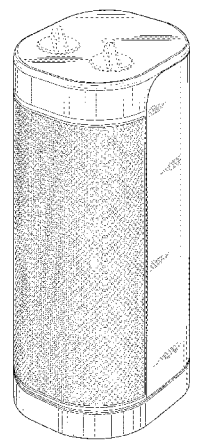
The ornamental design for a tower heater, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a tower heater showing my new design;
FIG. 2 is a front elevational view of the tower heater shown in FIG. 1;
FIG. 3 is a rear elevational view of the tower heater shown in FIG. 1;
FIG. 4 is a left-side elevational view of the tower heater shown in FIG. 1;

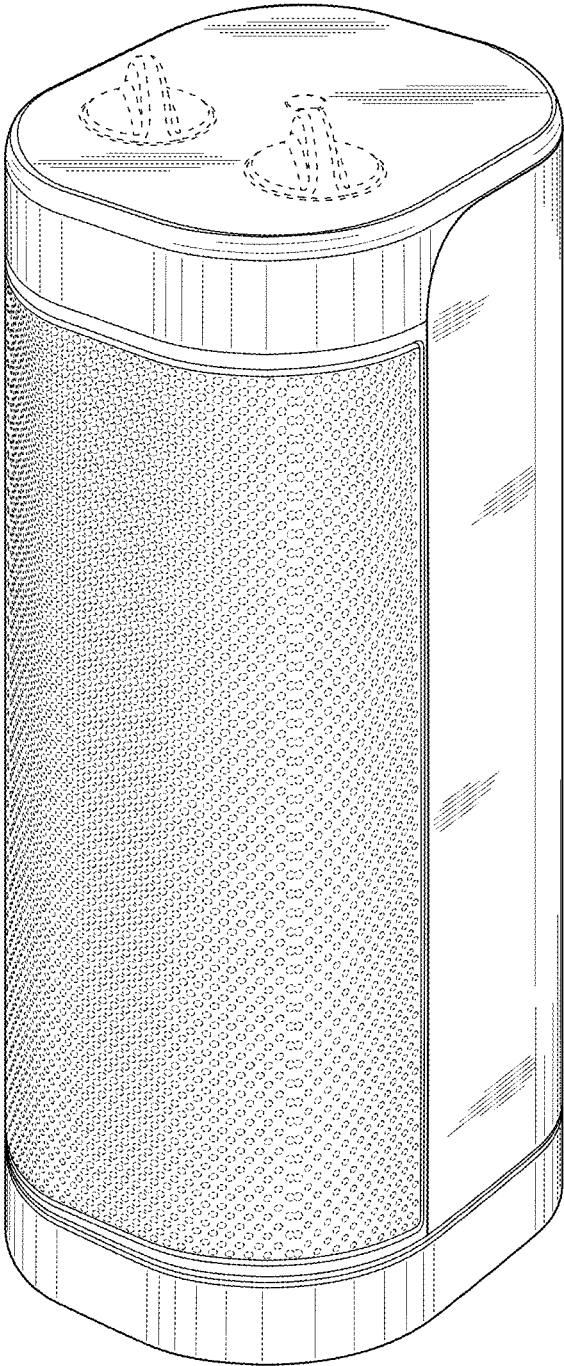

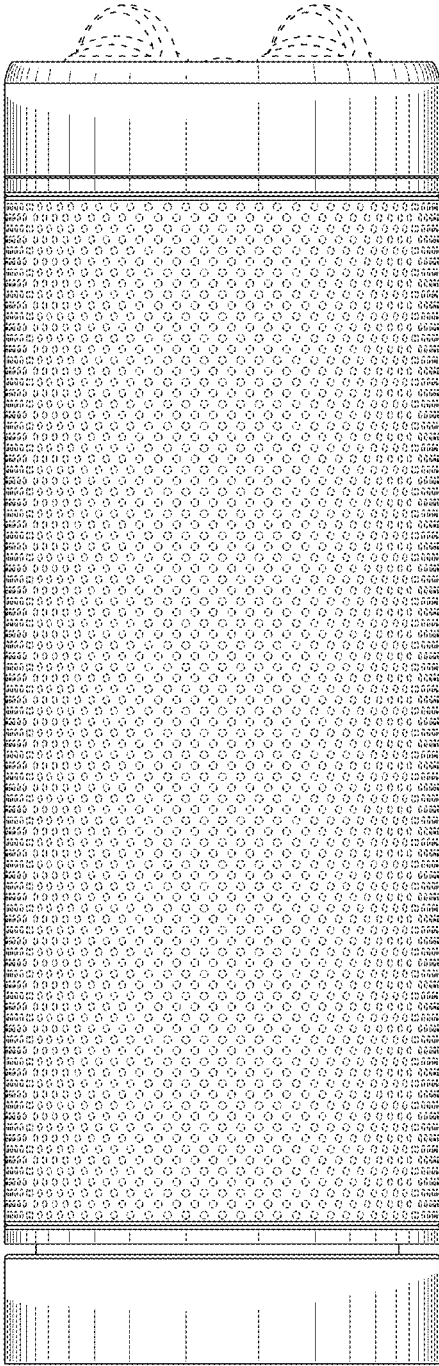

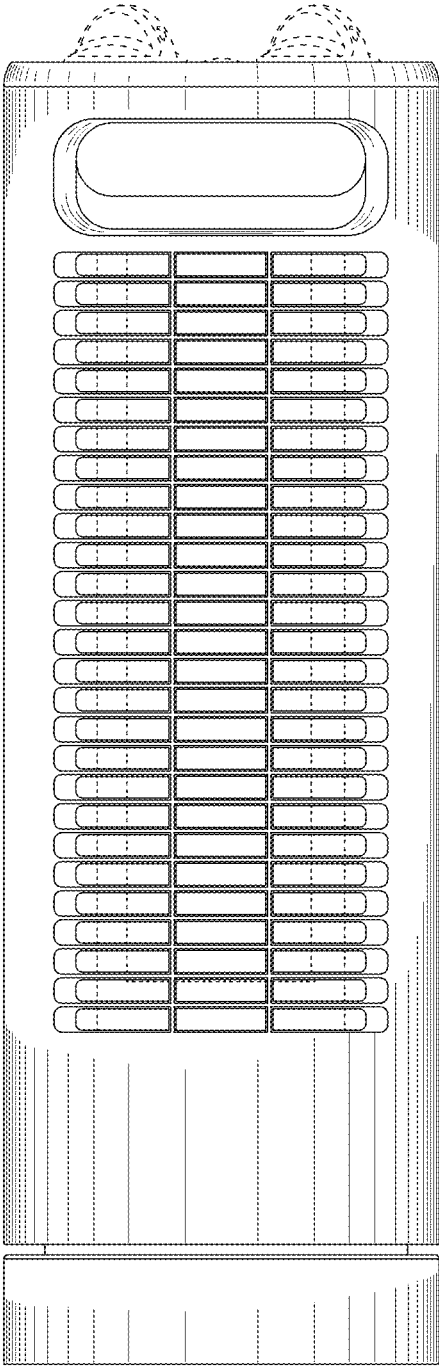

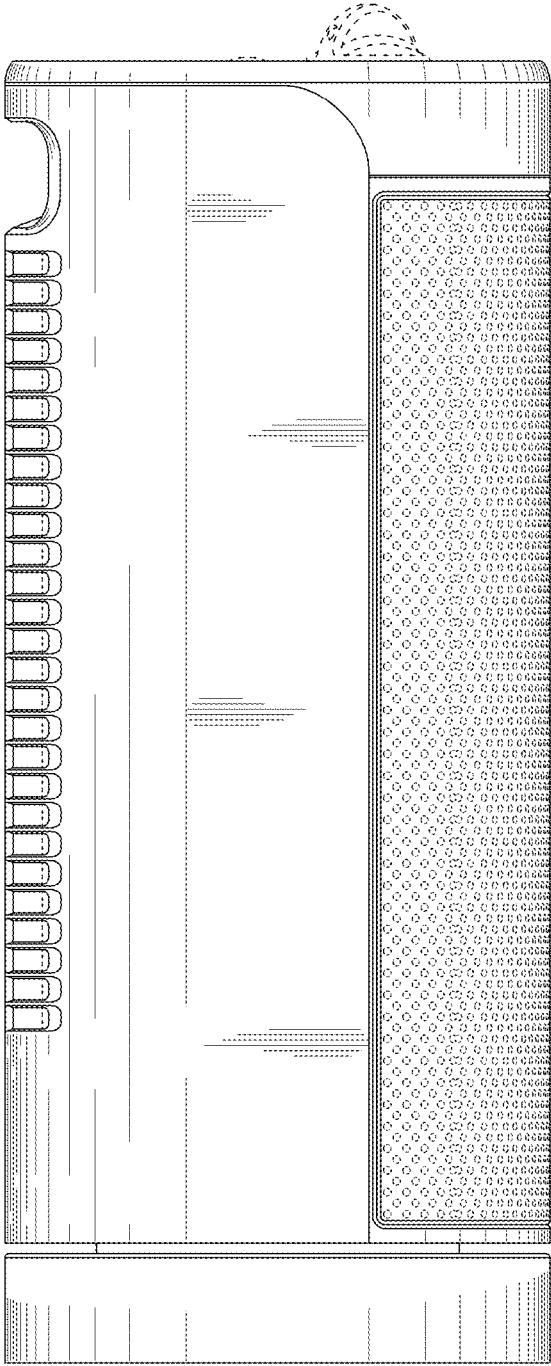

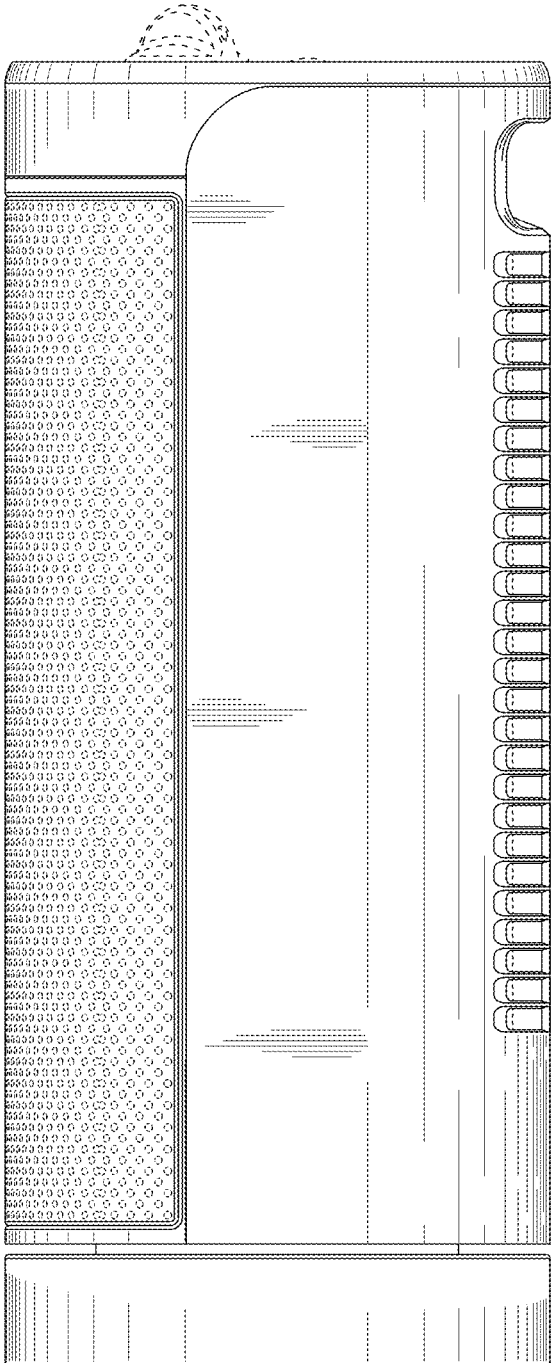

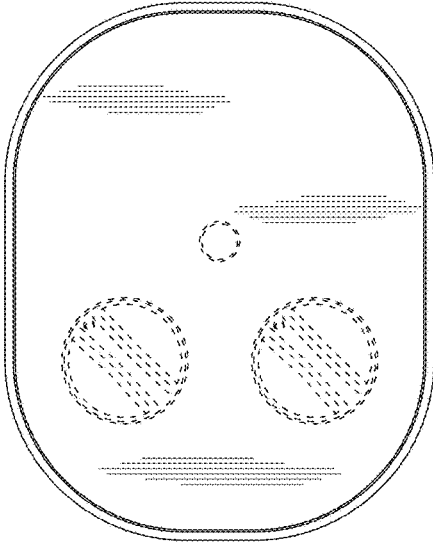

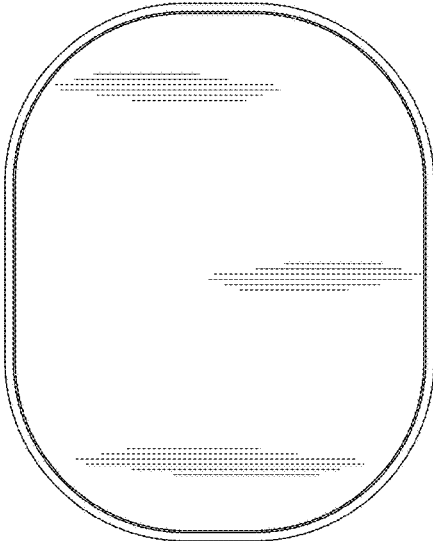
