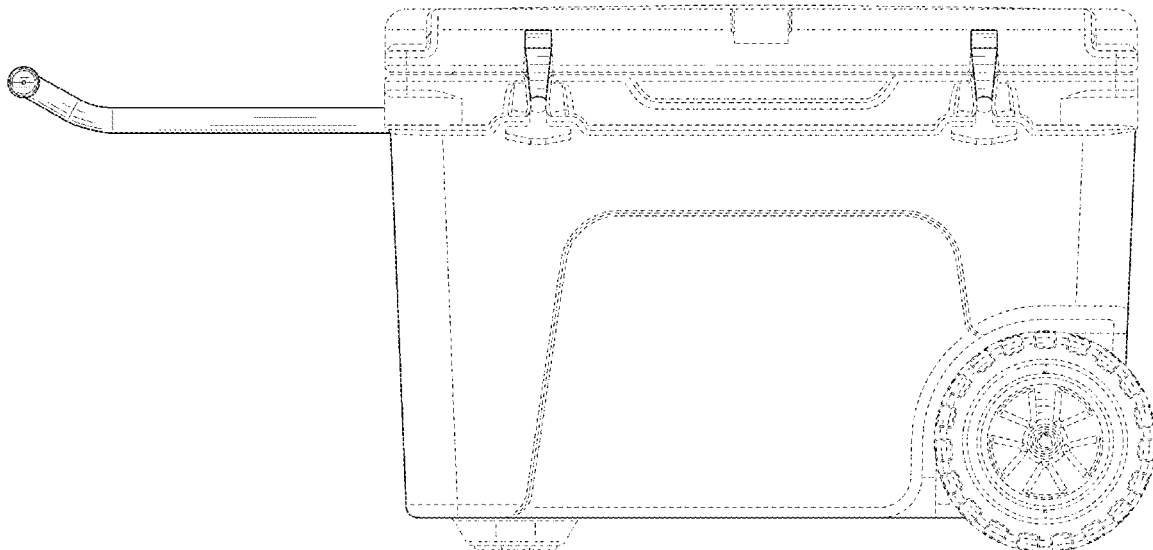
(57) **CLAIM**

The ornamental design for a portable insulating container, as shown and described.

DESCRIPTION

FIG. 1 is a front view thereof;
FIG. 2 is a rear view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a front side view of a portable insulating container showing our design in an alternate configuration; and,
FIG. 6 is a left side view thereof.
The broken lines immediately adjacent to the shaded areas define the bounds of the claimed design and form no part thereof. The remainder of the broken lines depict features of the portable insulating container that form no part of the claimed design.

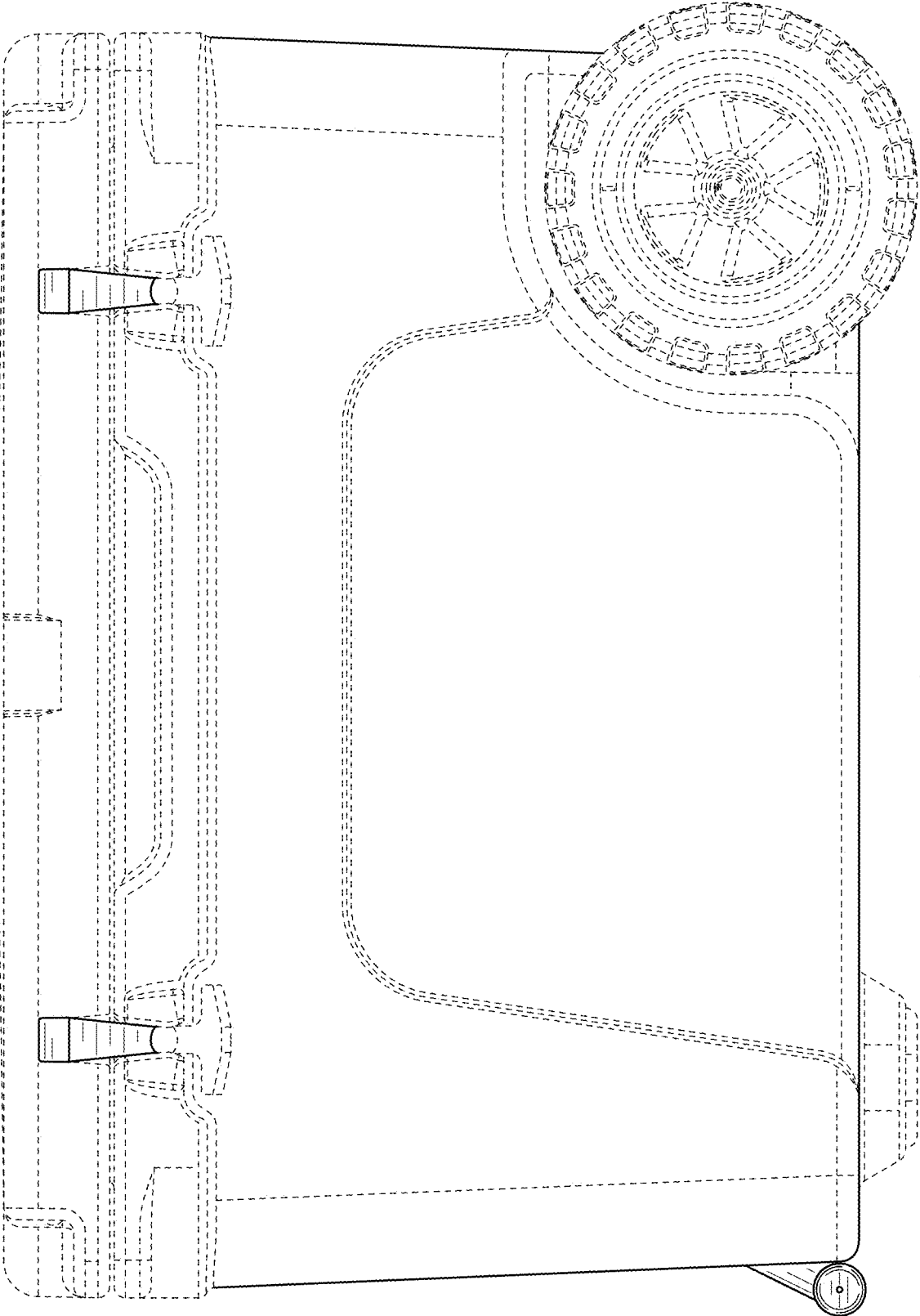

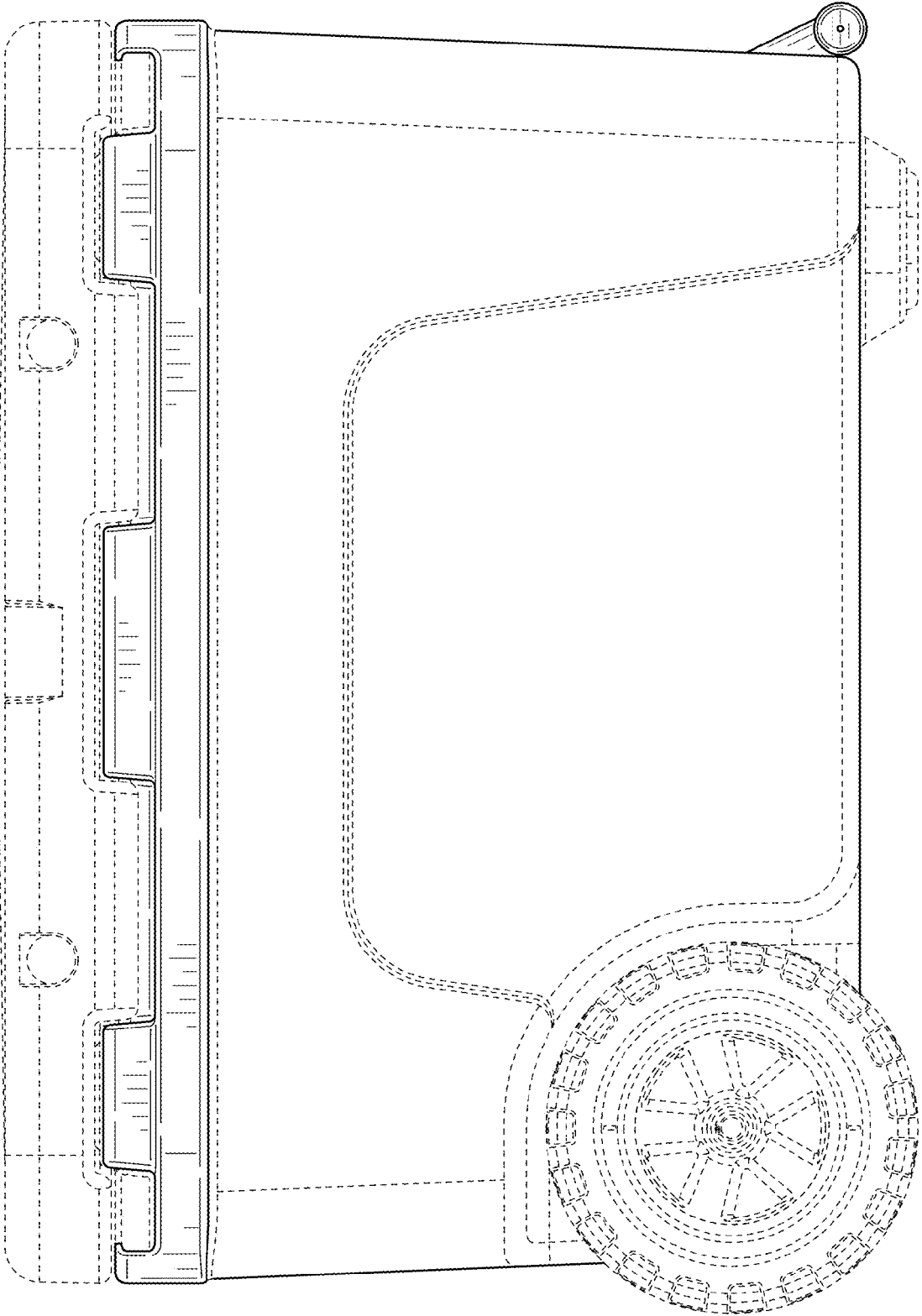

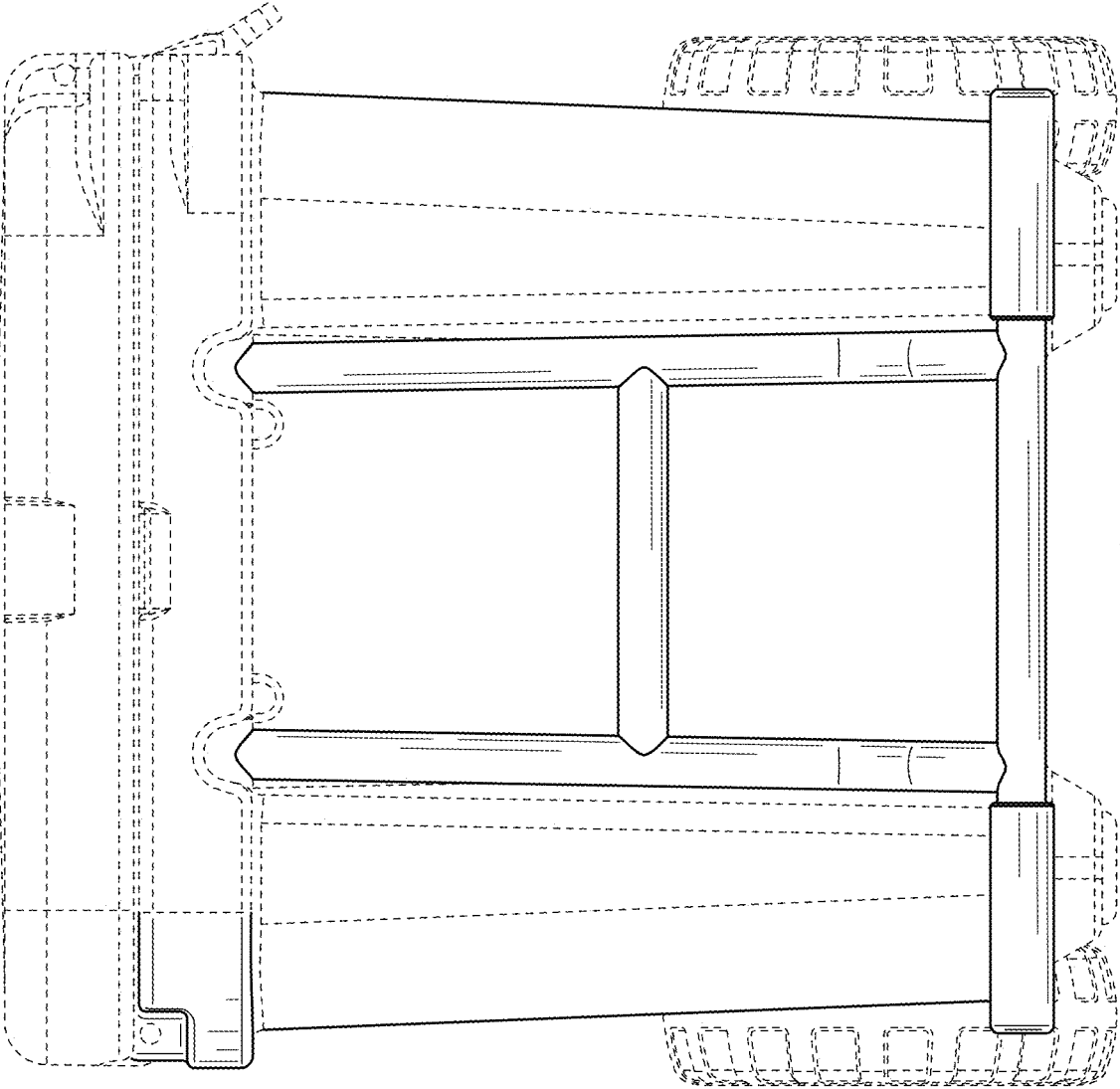

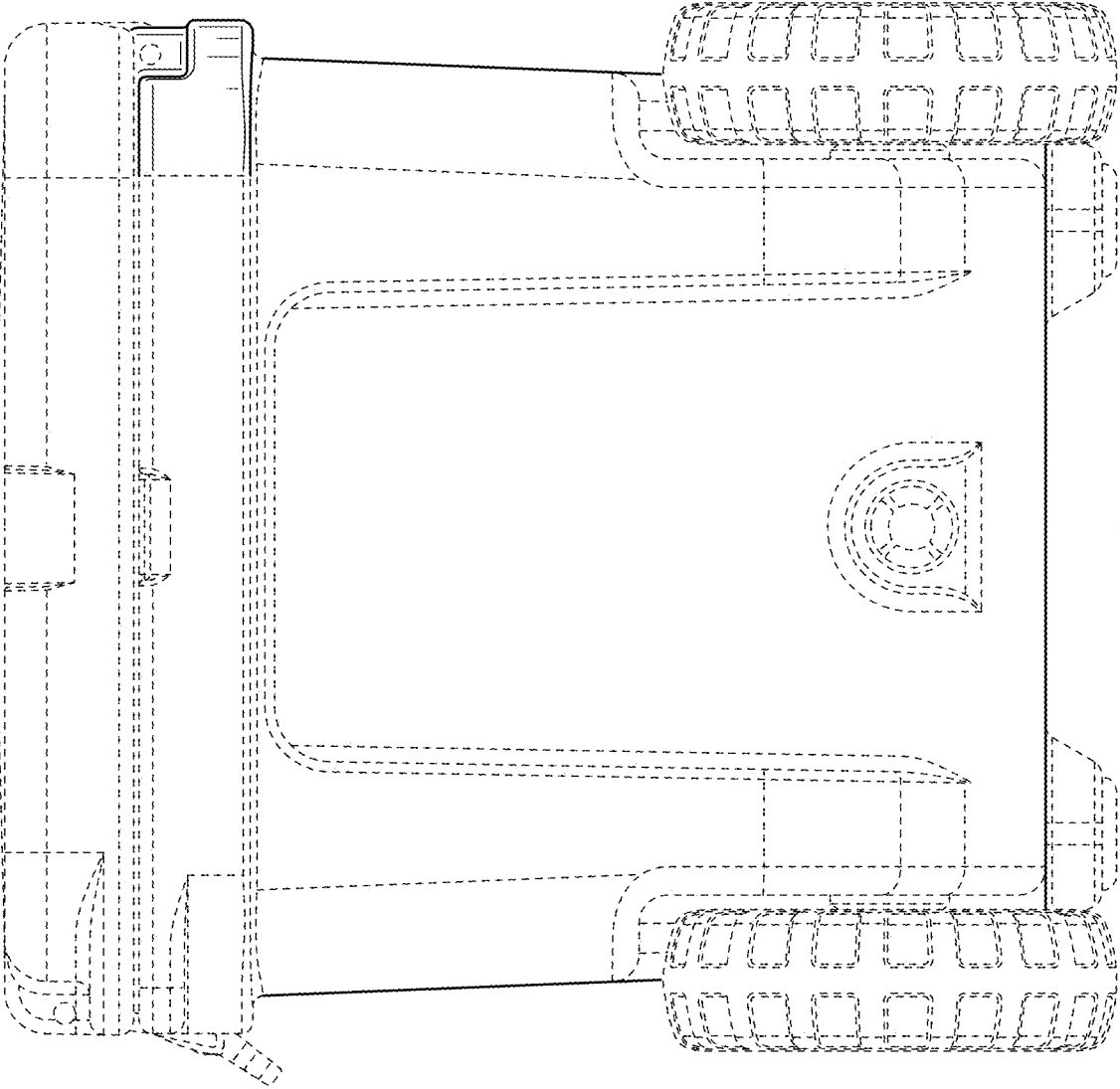

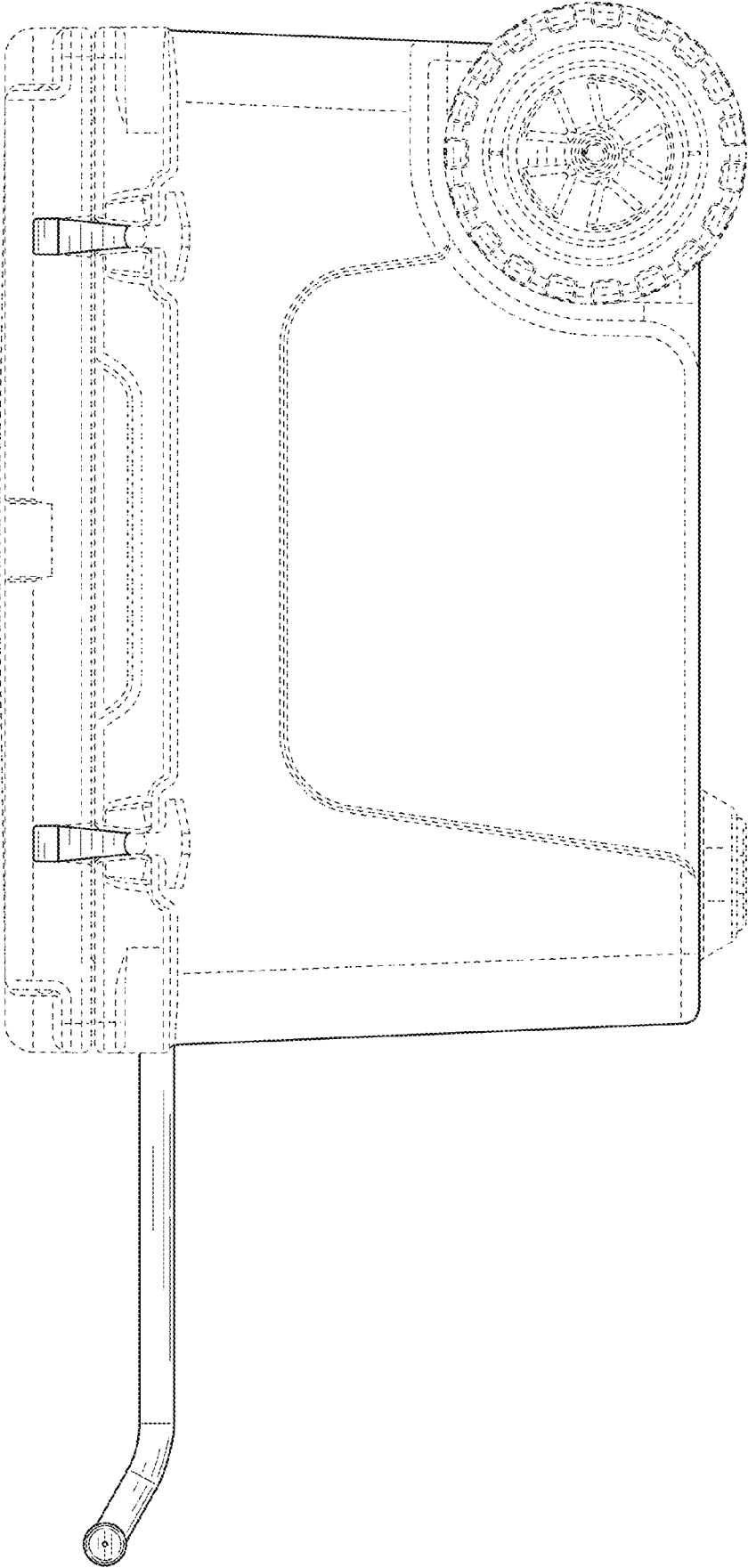

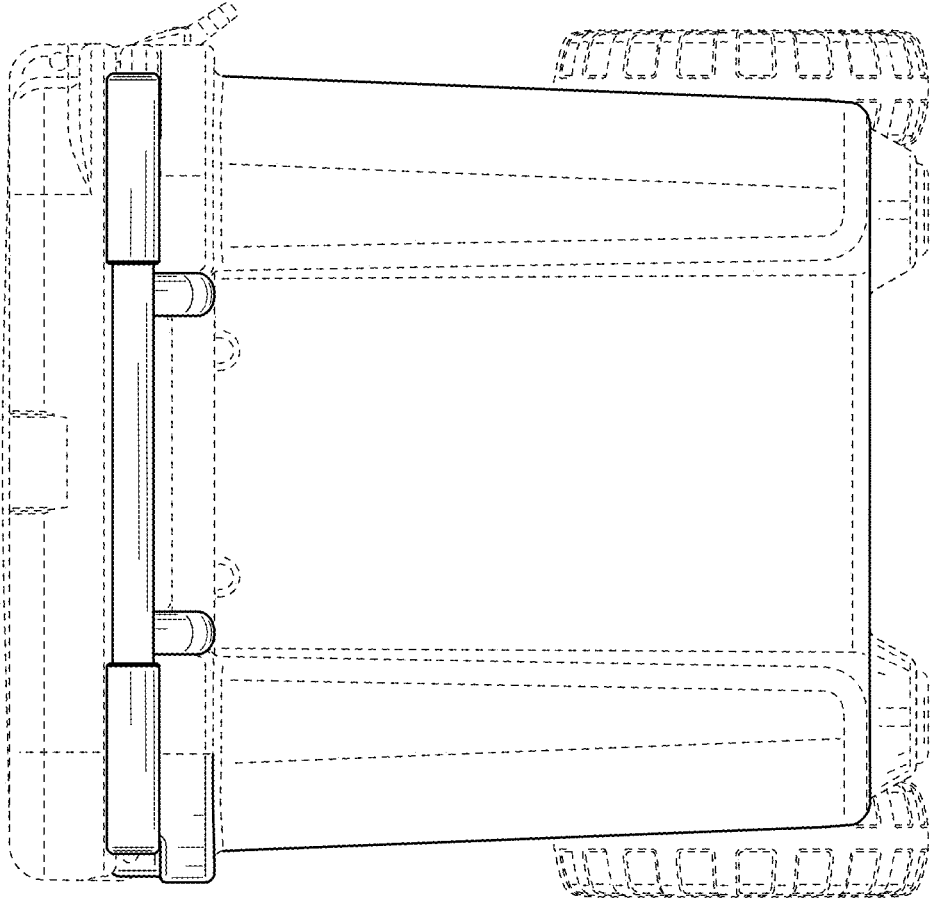
