(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface for use with a sequencing instrument, as shown and described.

**DESCRIPTION**

The FIGURE is a front view of a display screen or portion thereof with graphical user interface for use with a sequencing instrument.

The perimeters of the underlying display screen or portion thereof and the graphical user interface are understood to be flush. The broken lines showing the display screen and portions of the graphical user interface are included for the purpose of illustrating environmental structure and form no part of the claimed design.
