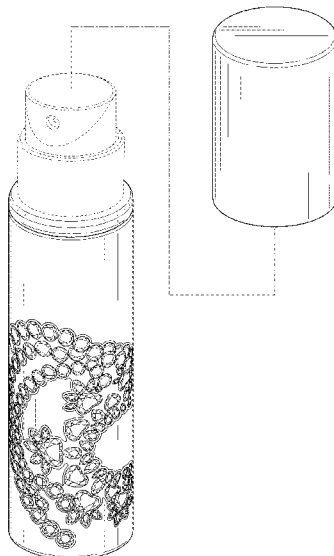
CLAIM

(57) The ornamental design for a perfume bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a perfume bottle showing my new design;

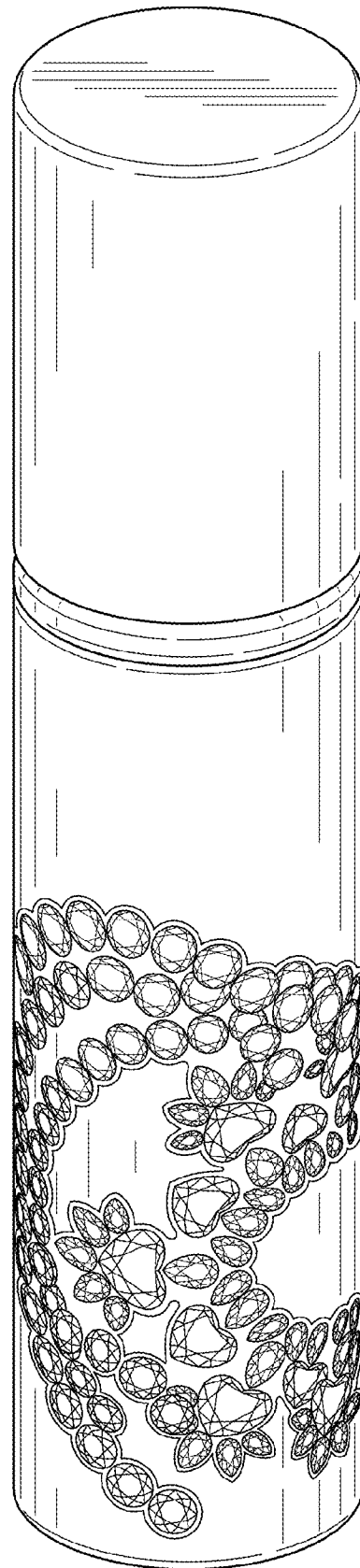

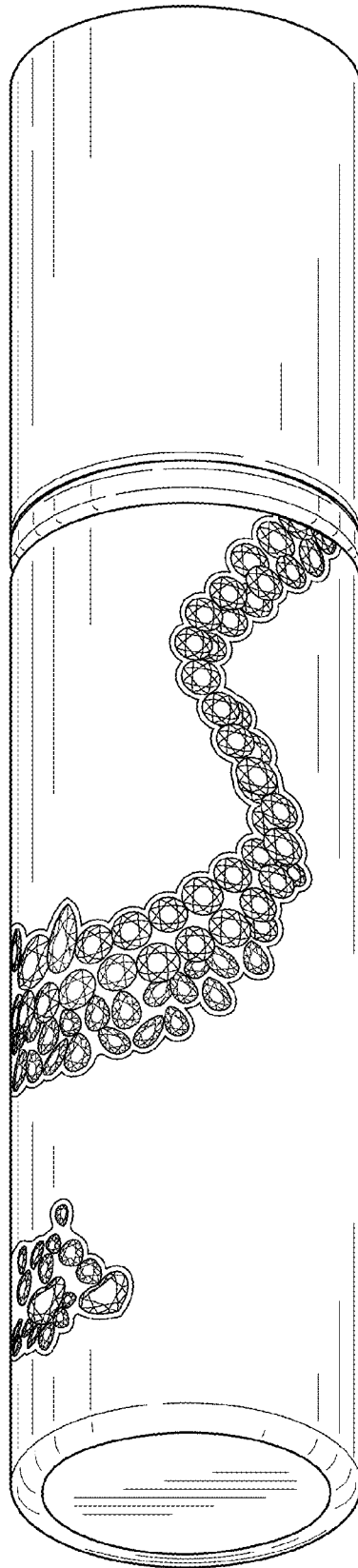

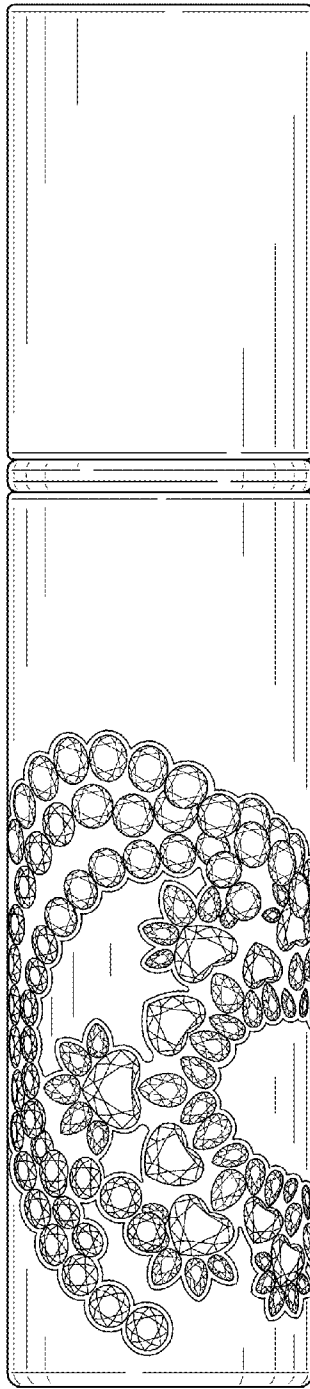

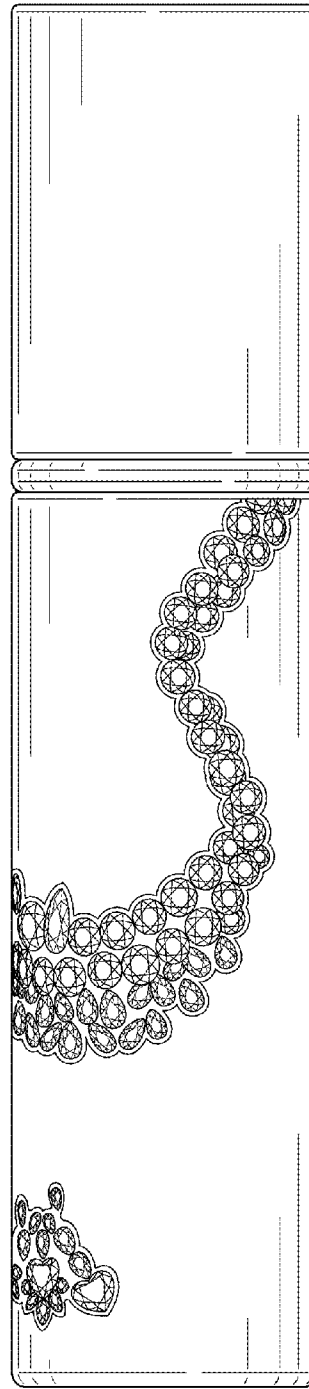

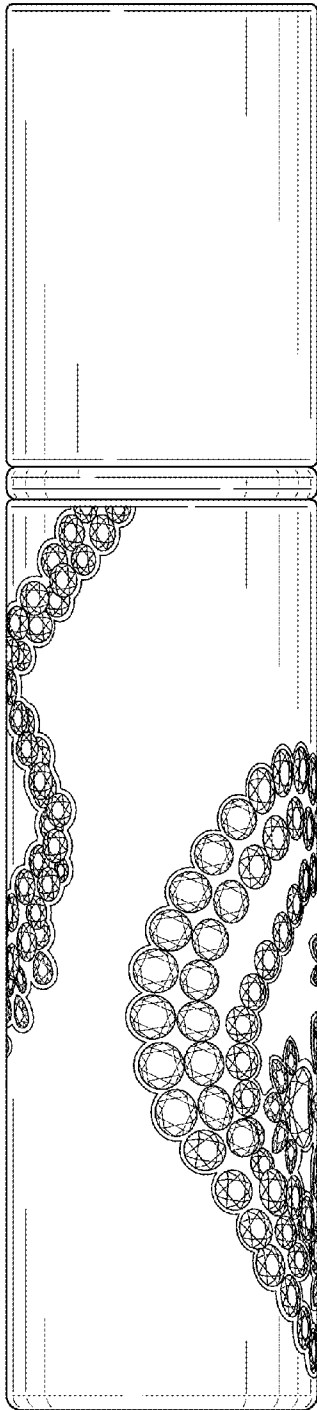

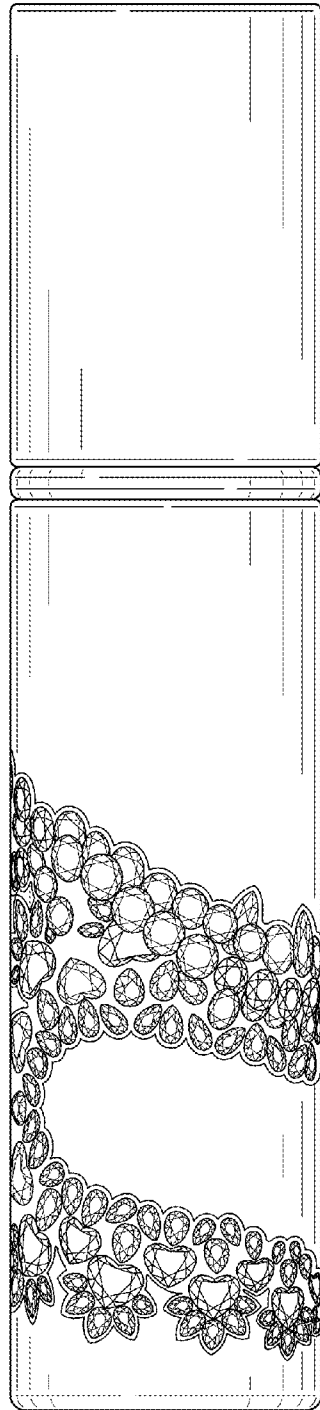

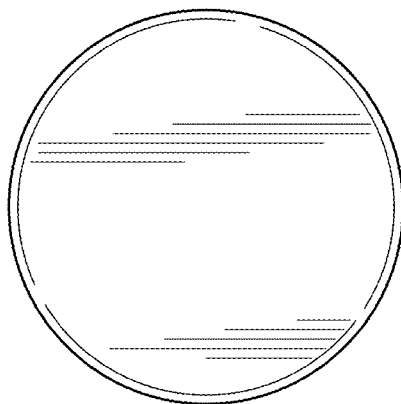

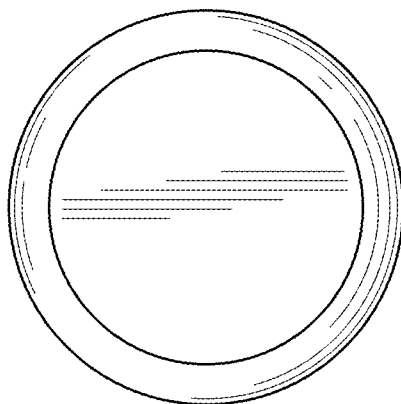

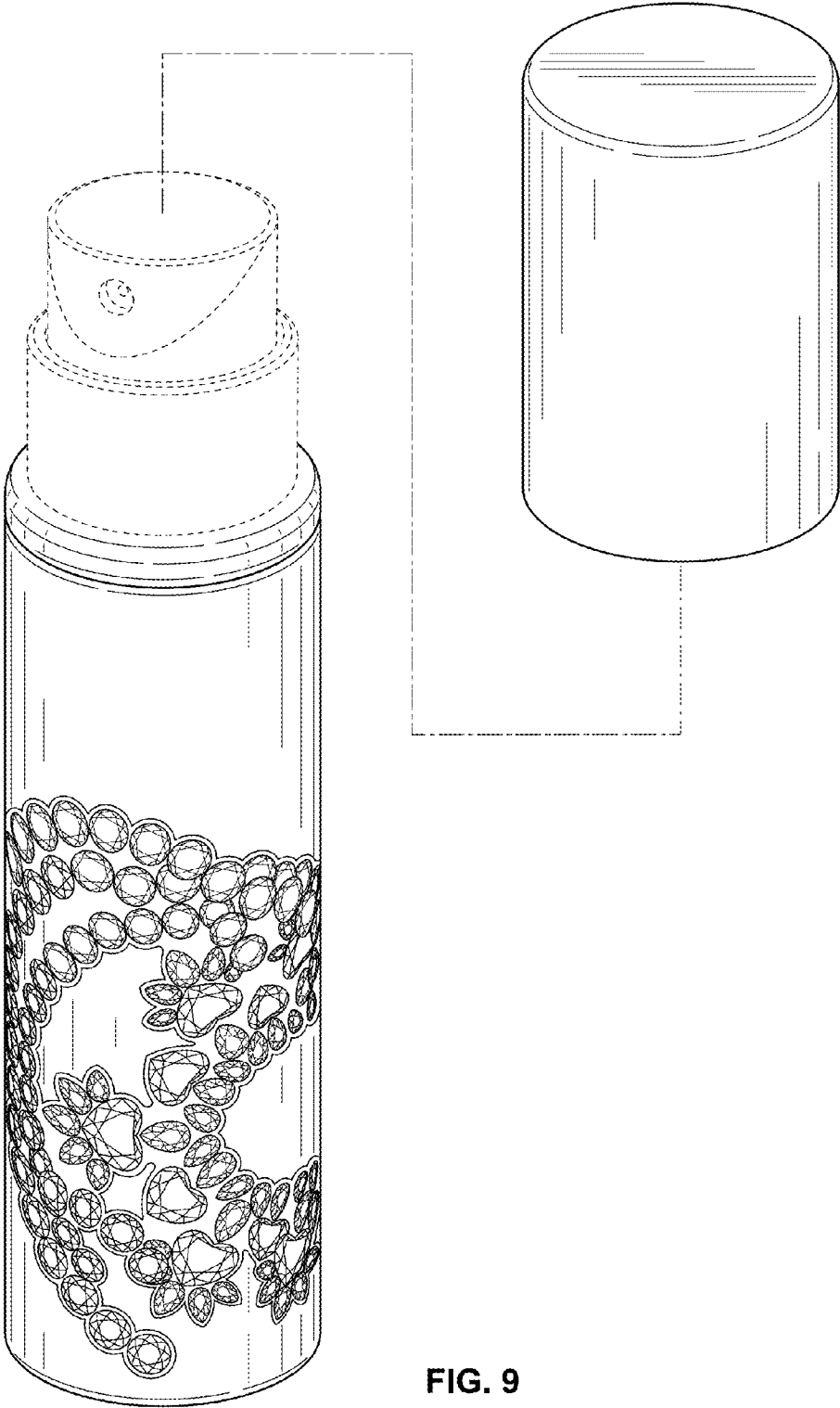
