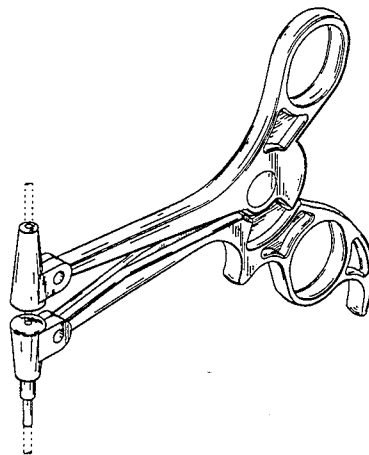

[57] CLAIM

The ornamental design for a handle portion for an endoscopic instrument, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handle portion for an endoscopic instrument showing our new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a top elevational view thereof; and,
 FIG. 7 is a bottom elevational view thereof.
 The broken line showing in the FIGS. 1 through 5 is for illustrative purposes only and forms no part of the claimed design.

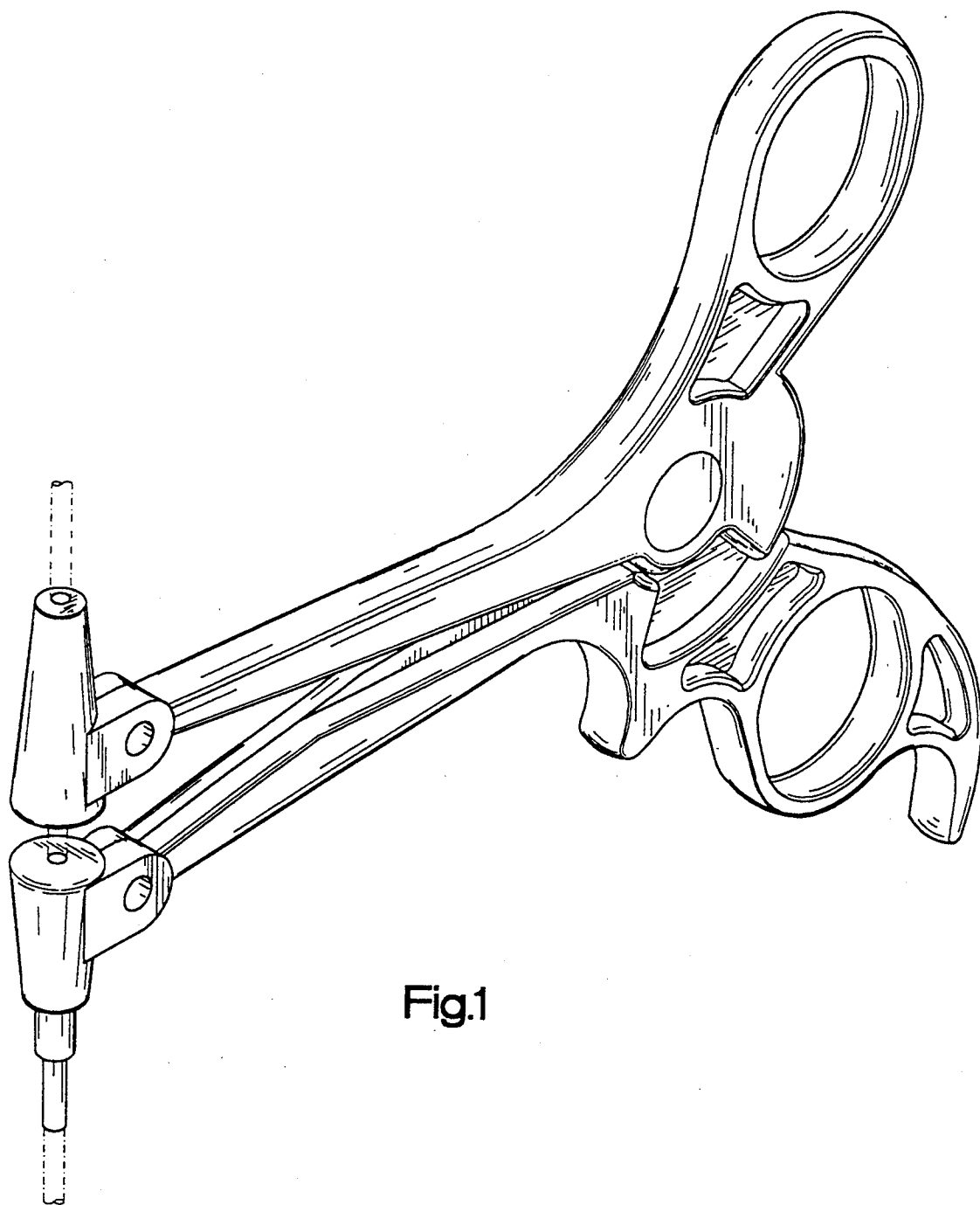

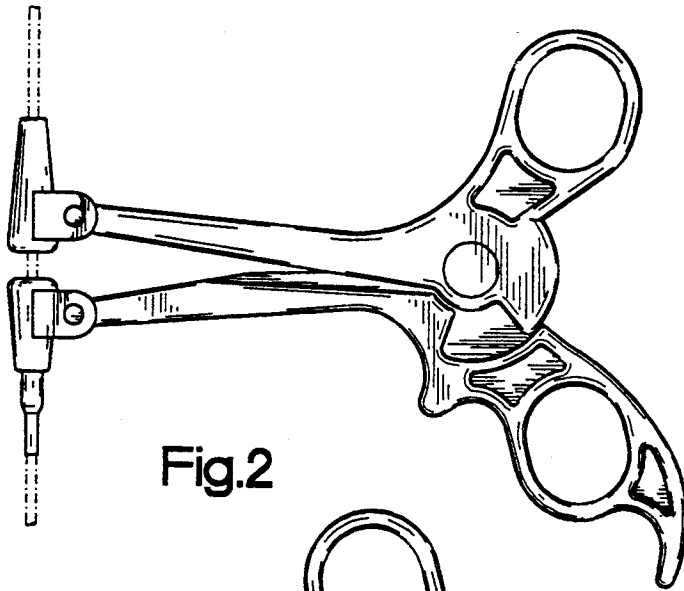

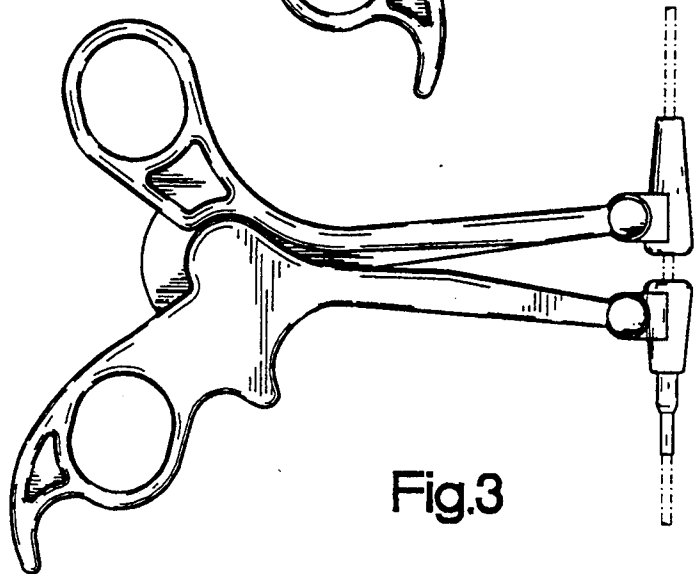

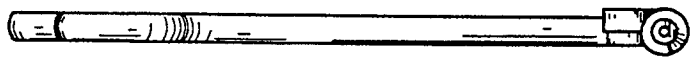

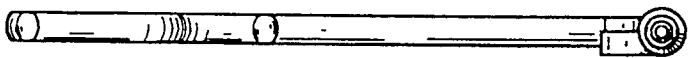
