FIG. 3 is the third image thereof;

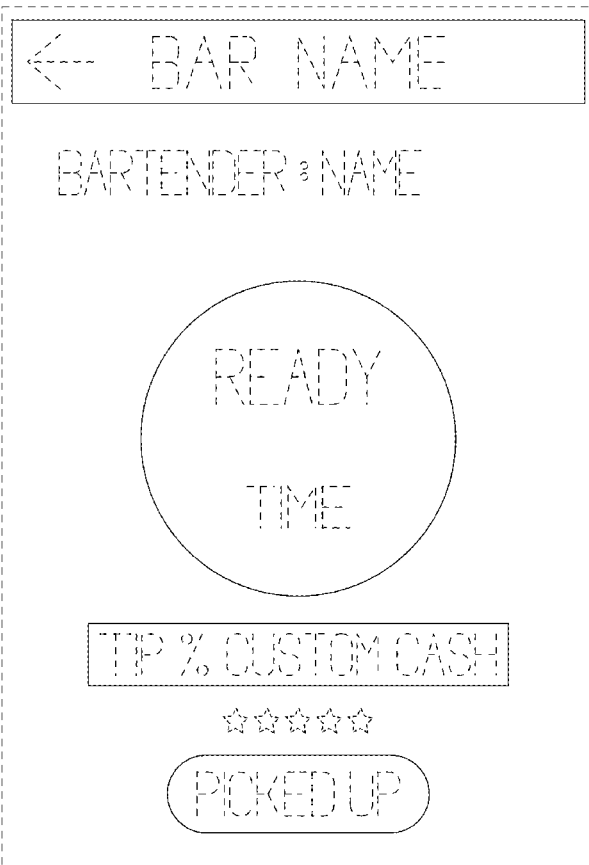
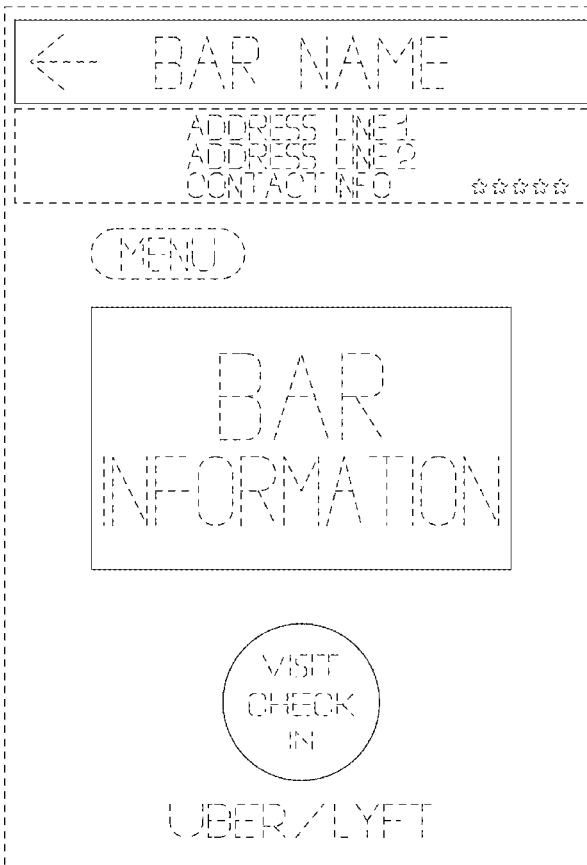
FIG. 4 is the fourth image thereof; and,

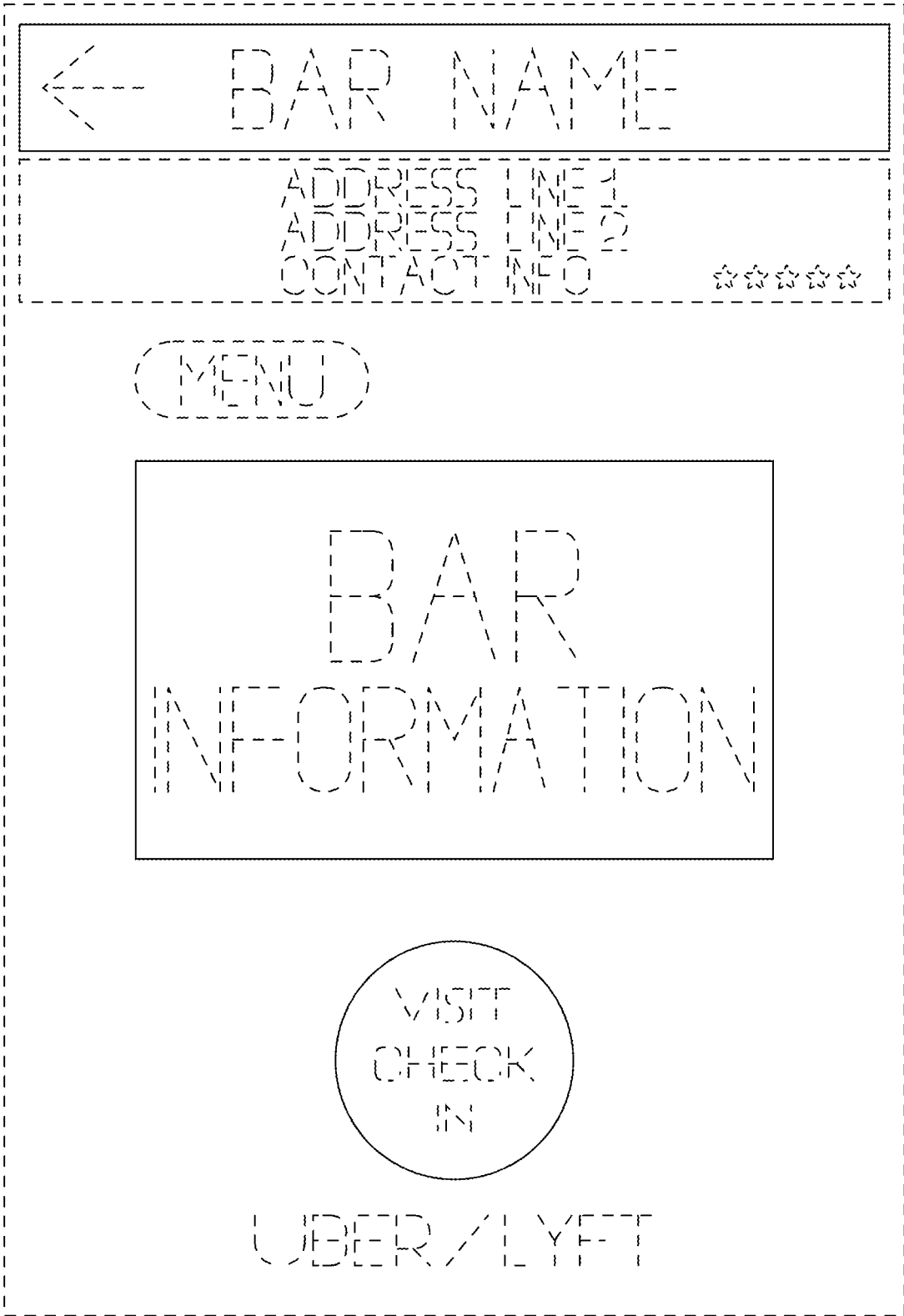

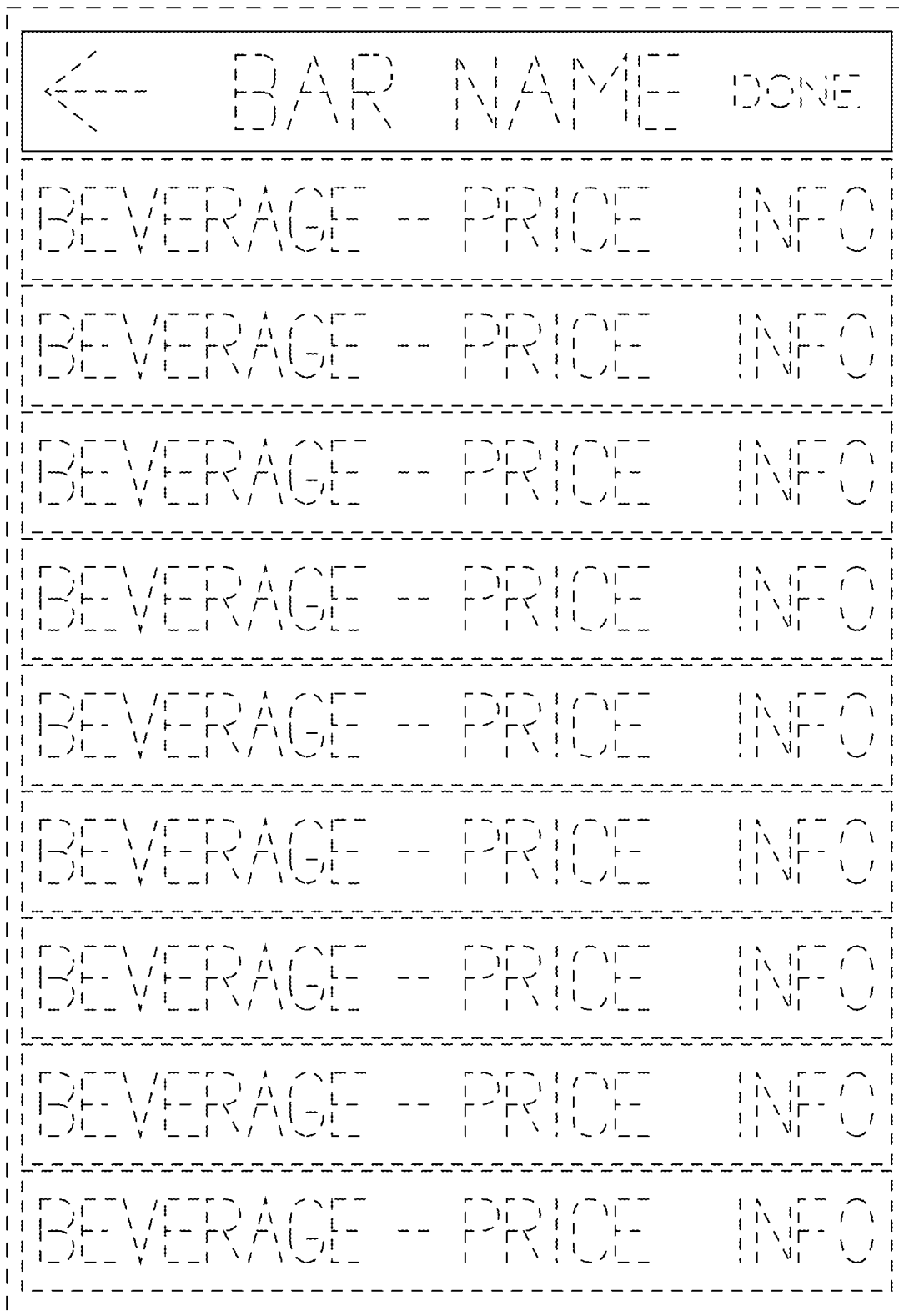

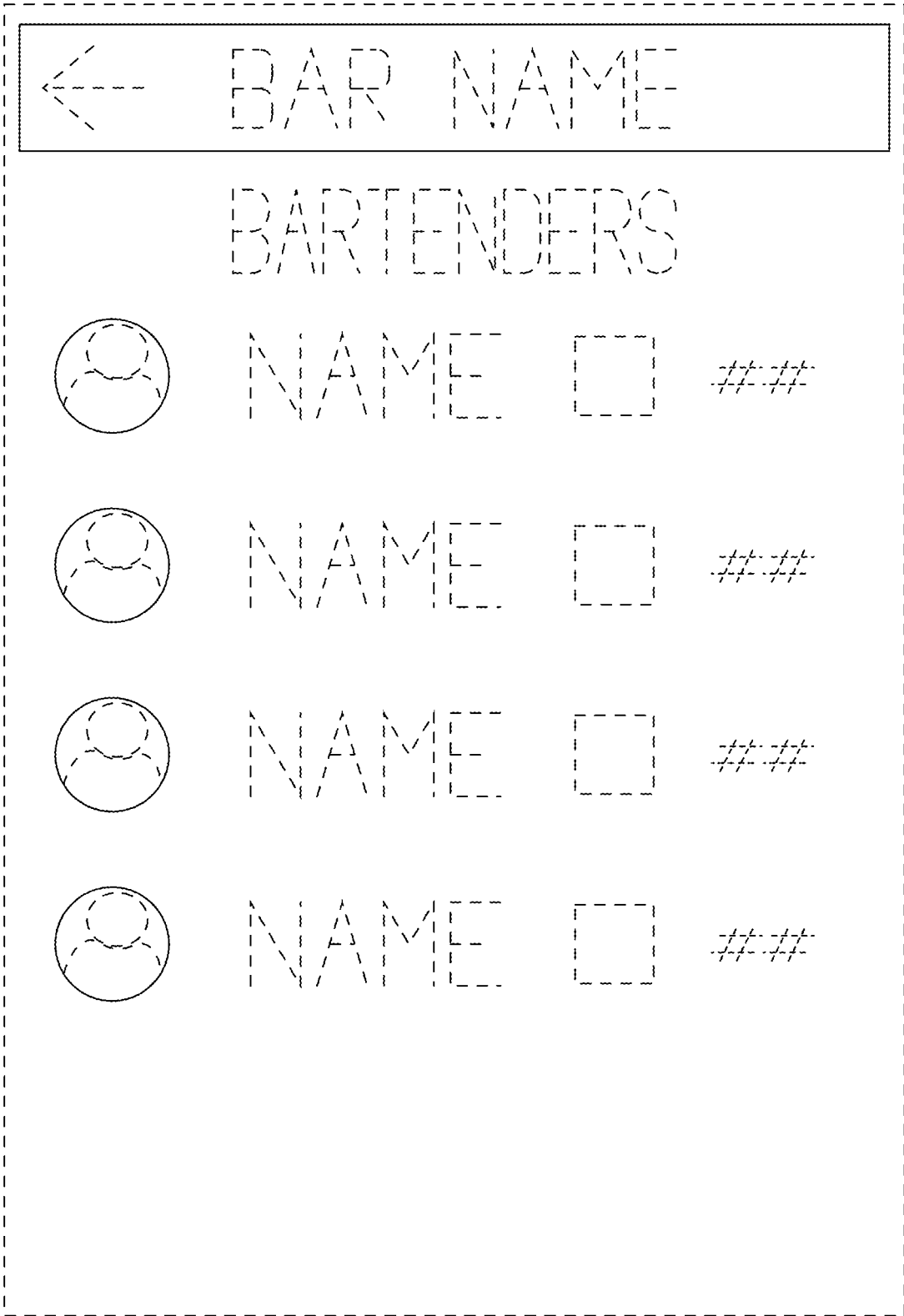
