FIG. 1 is a front view of a yoga pad showing my new design; FIG. 2 is a back view of the yoga pad shown in FIG. 1 of the drawings;

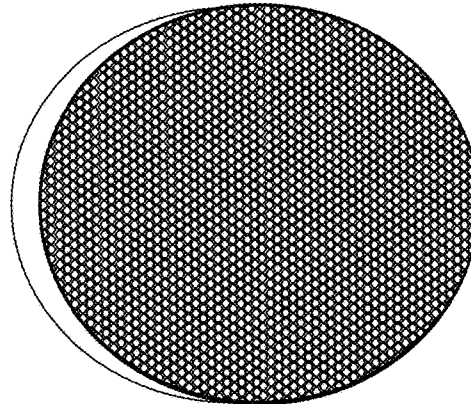
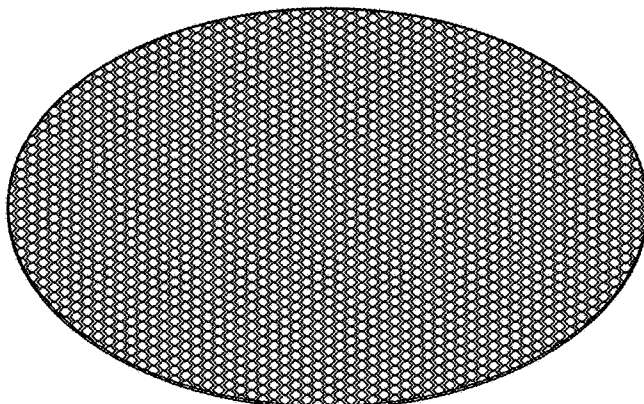
FIG. 3 is a back perspective view of the yoga pad shown in FIG. 1 of the drawings;

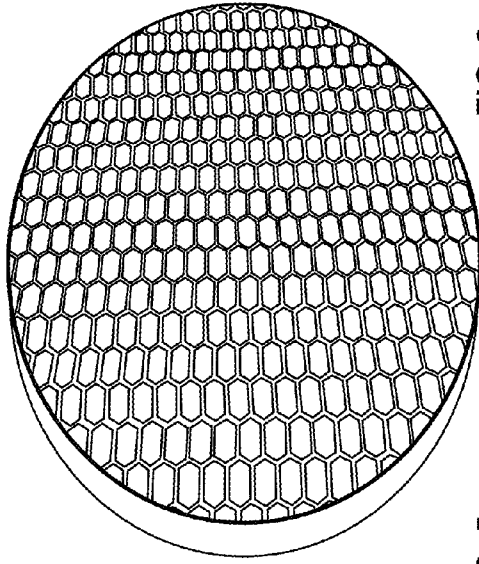

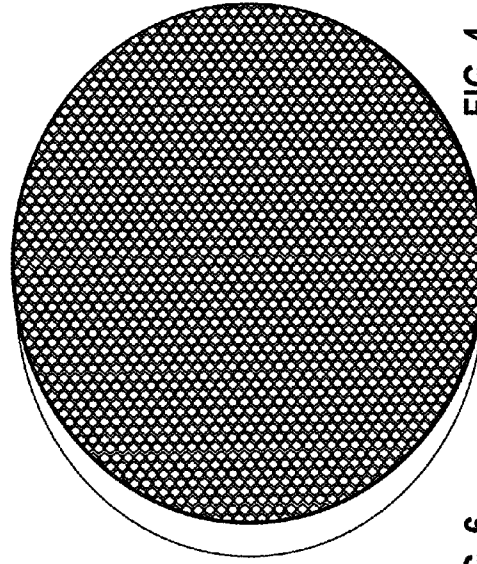

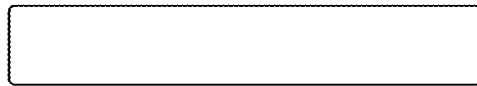

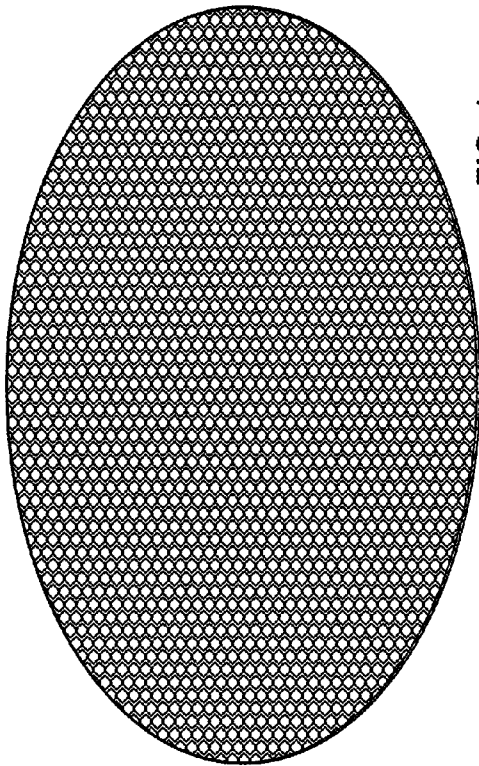

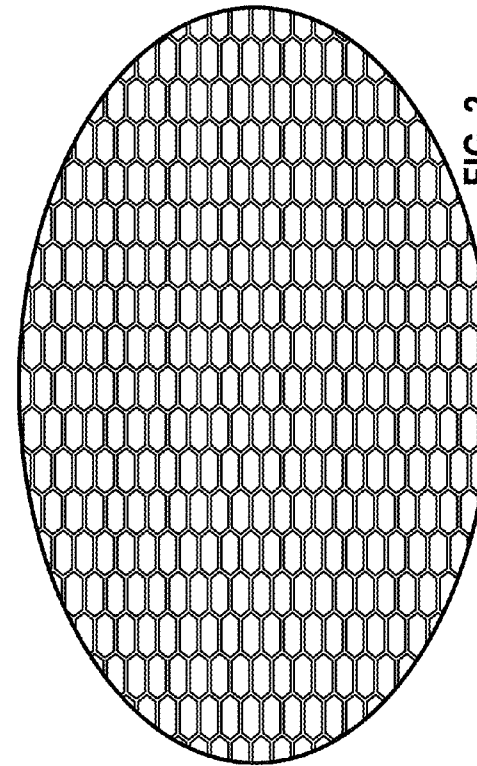
