DESCRIPTION

FIG. 1 is a front perspective view of a design of the food processor;

FIG. 2 is a front elevation view of the food processor of FIG. 1;

FIG. 3 is a first side elevation view of the food processor of FIG. 1;

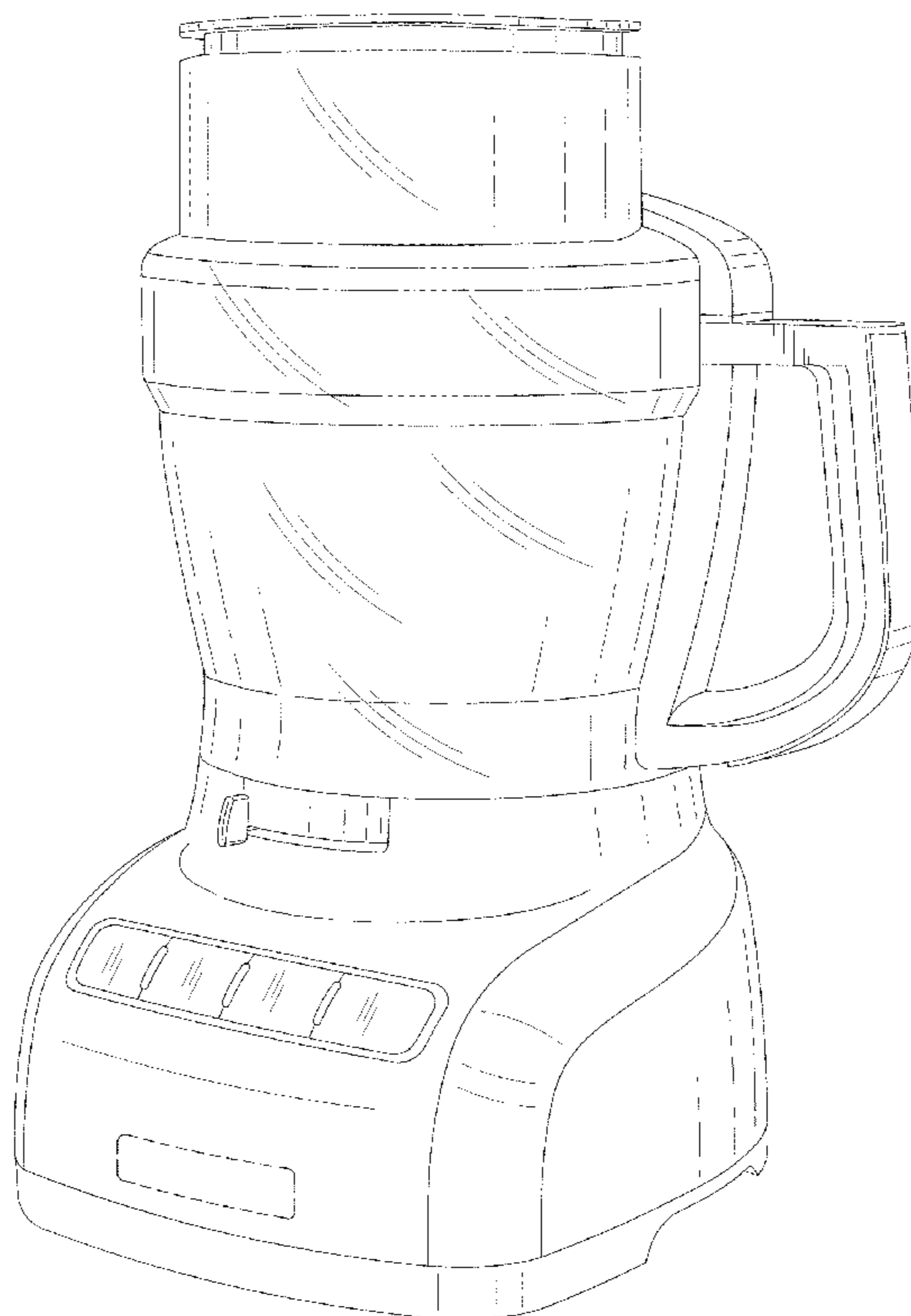
FIG. 4 is a second side elevation view of the food processor of FIG. 1;

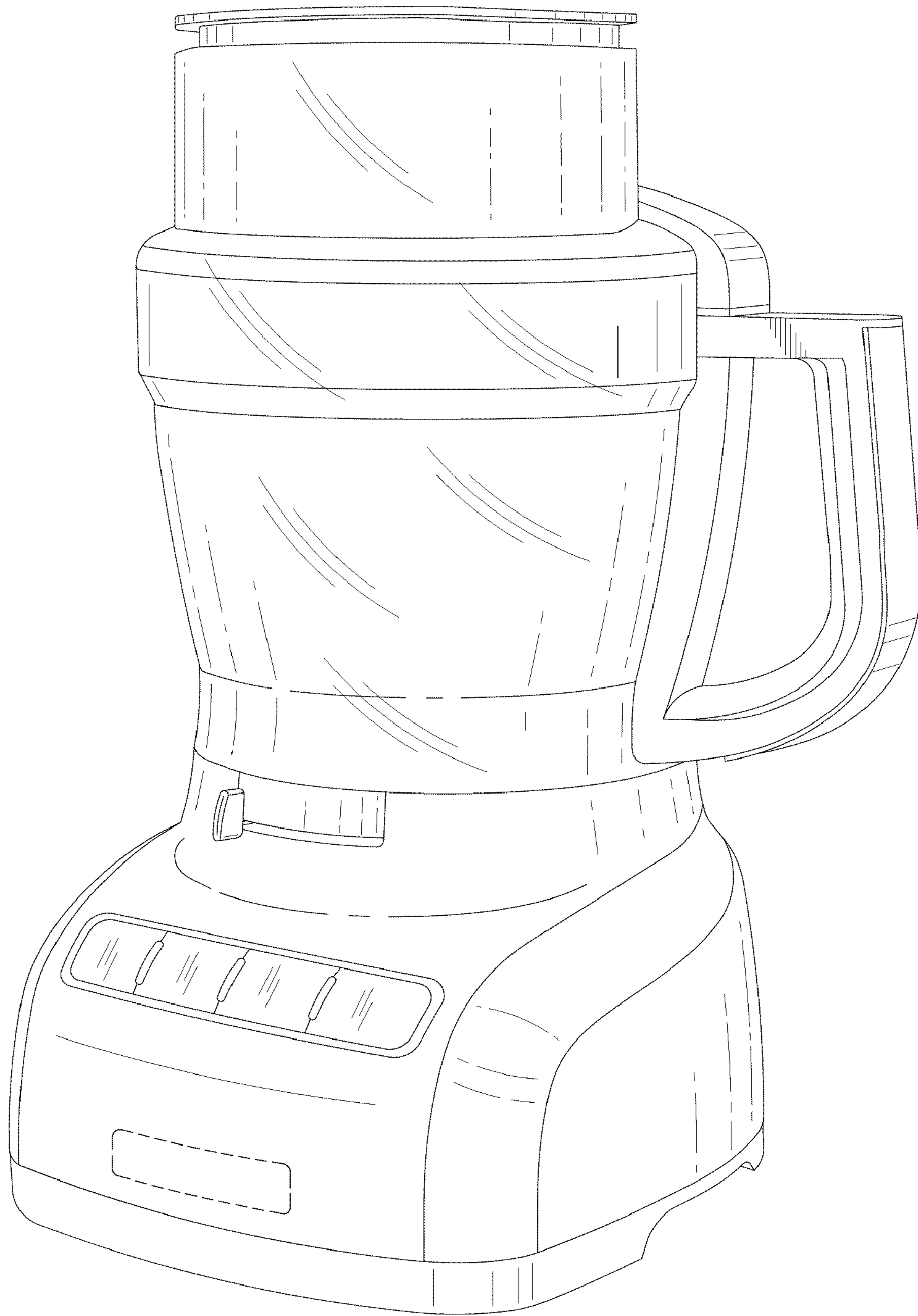

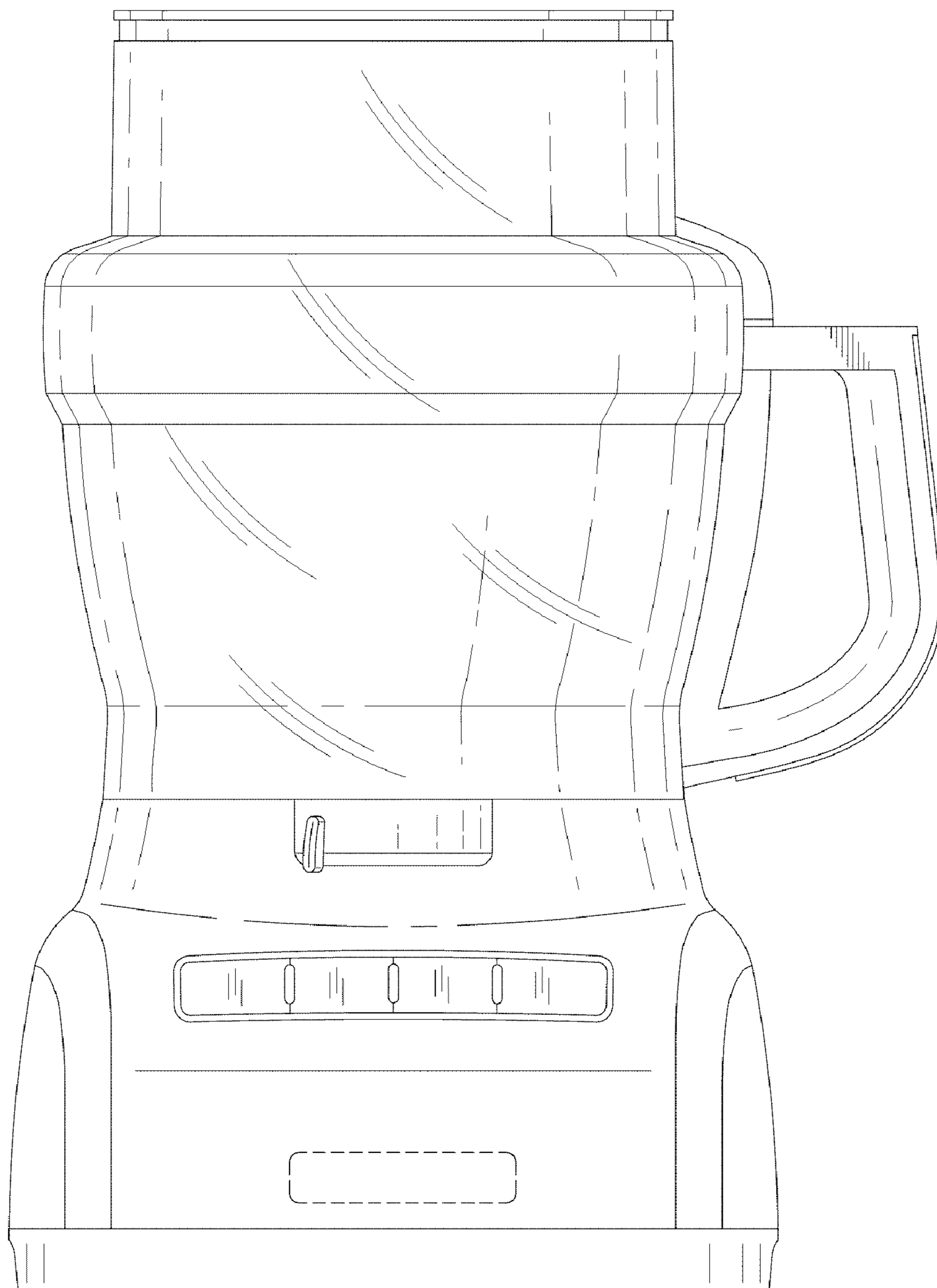

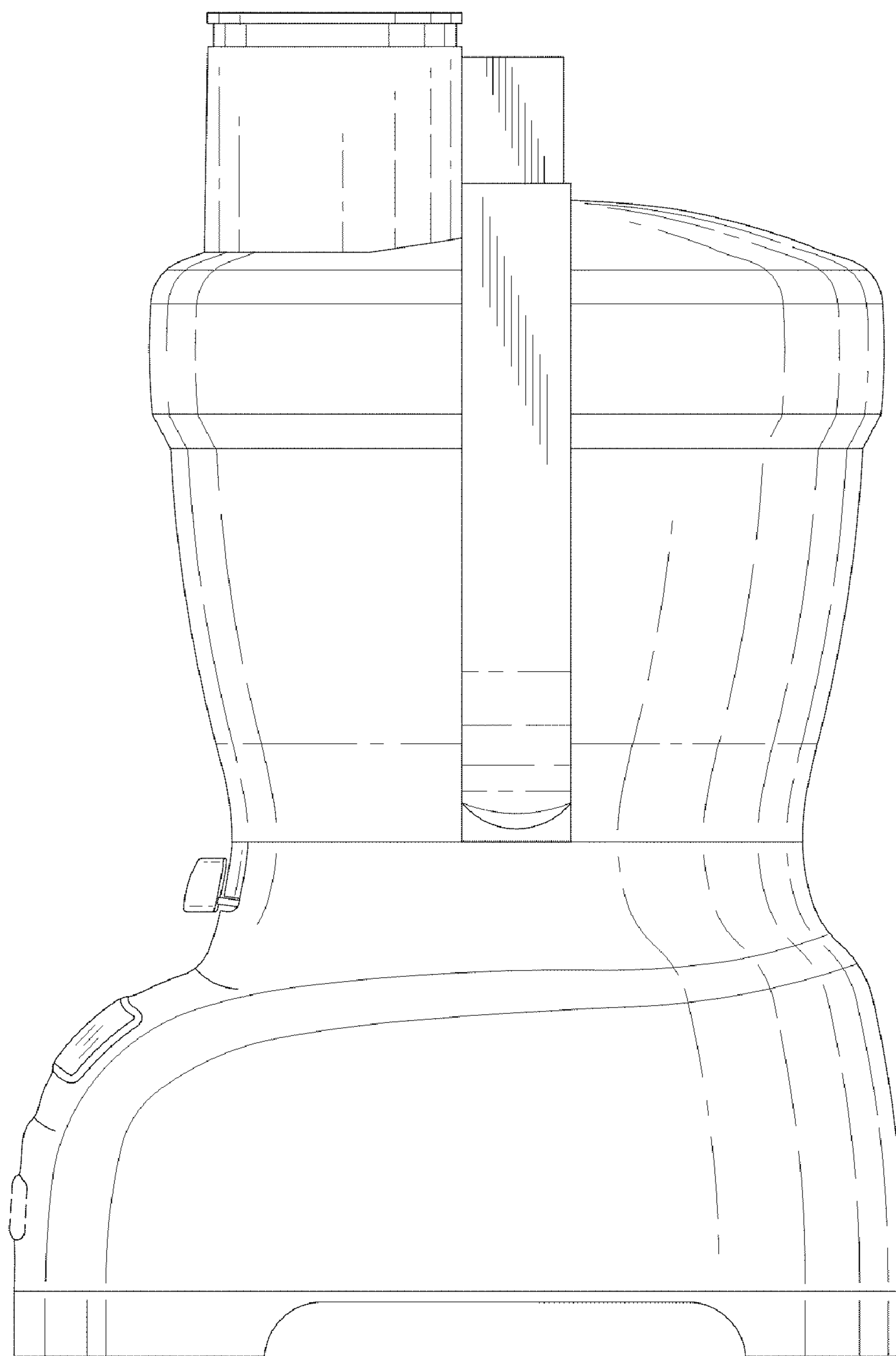

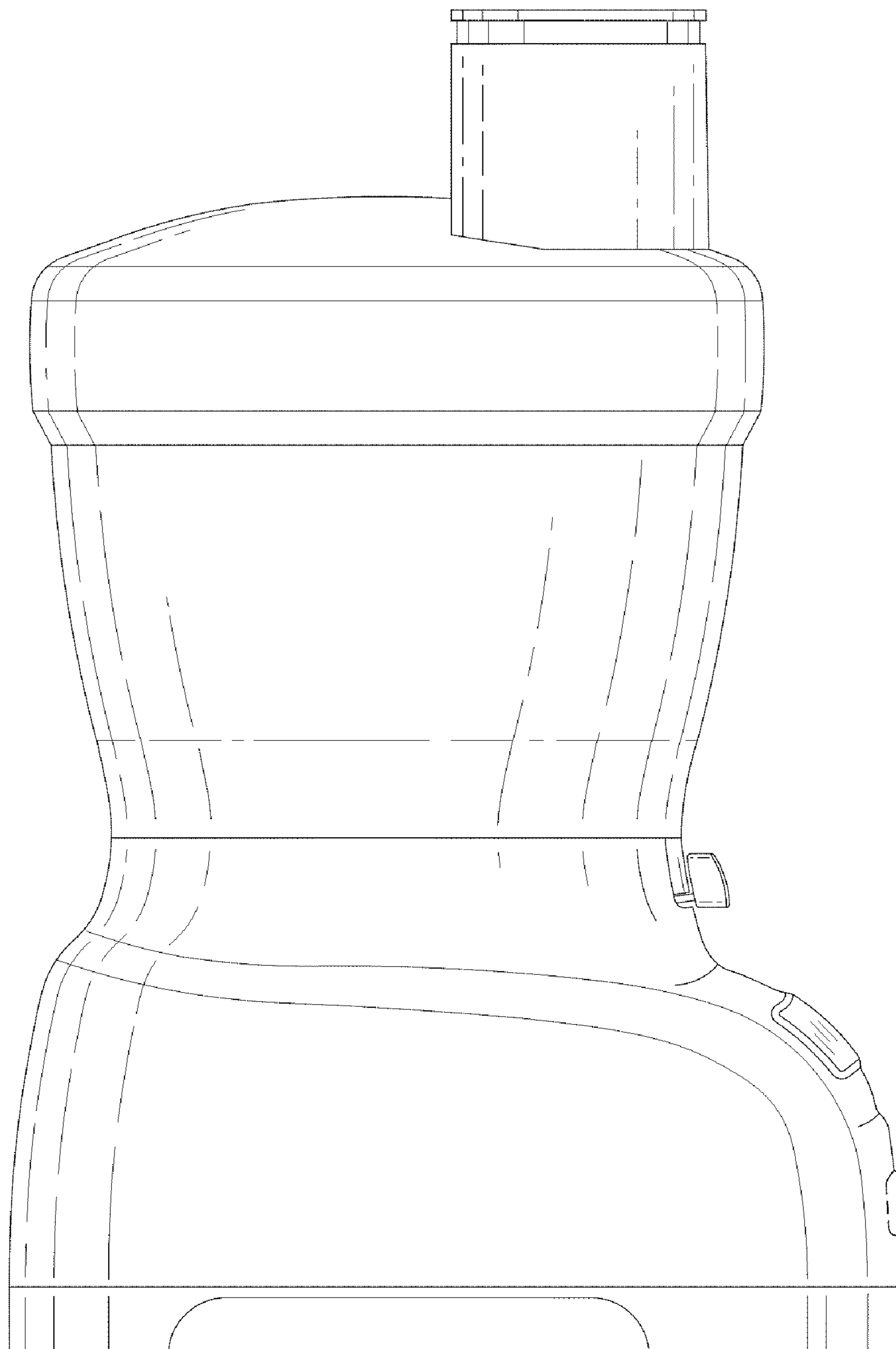

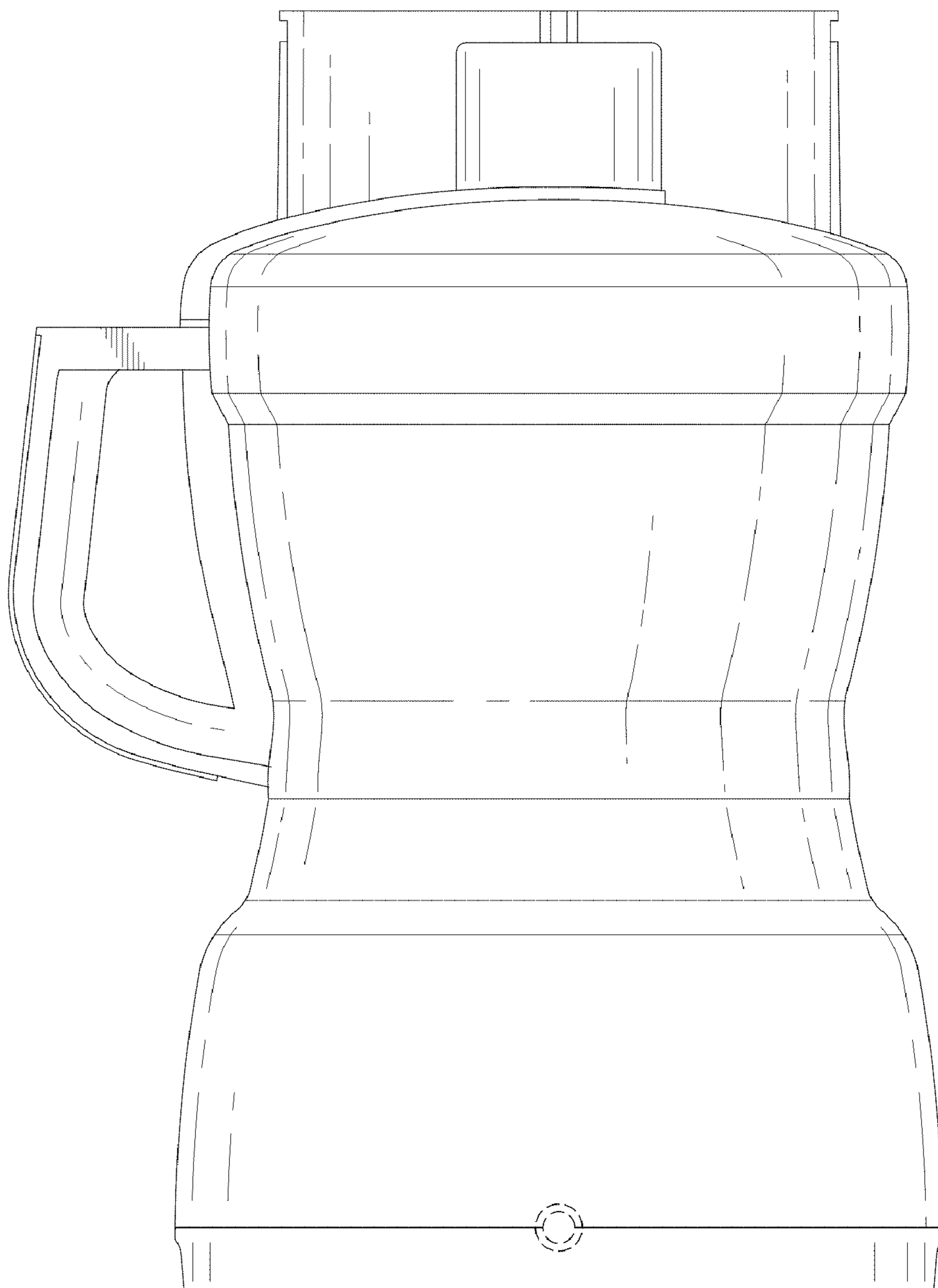

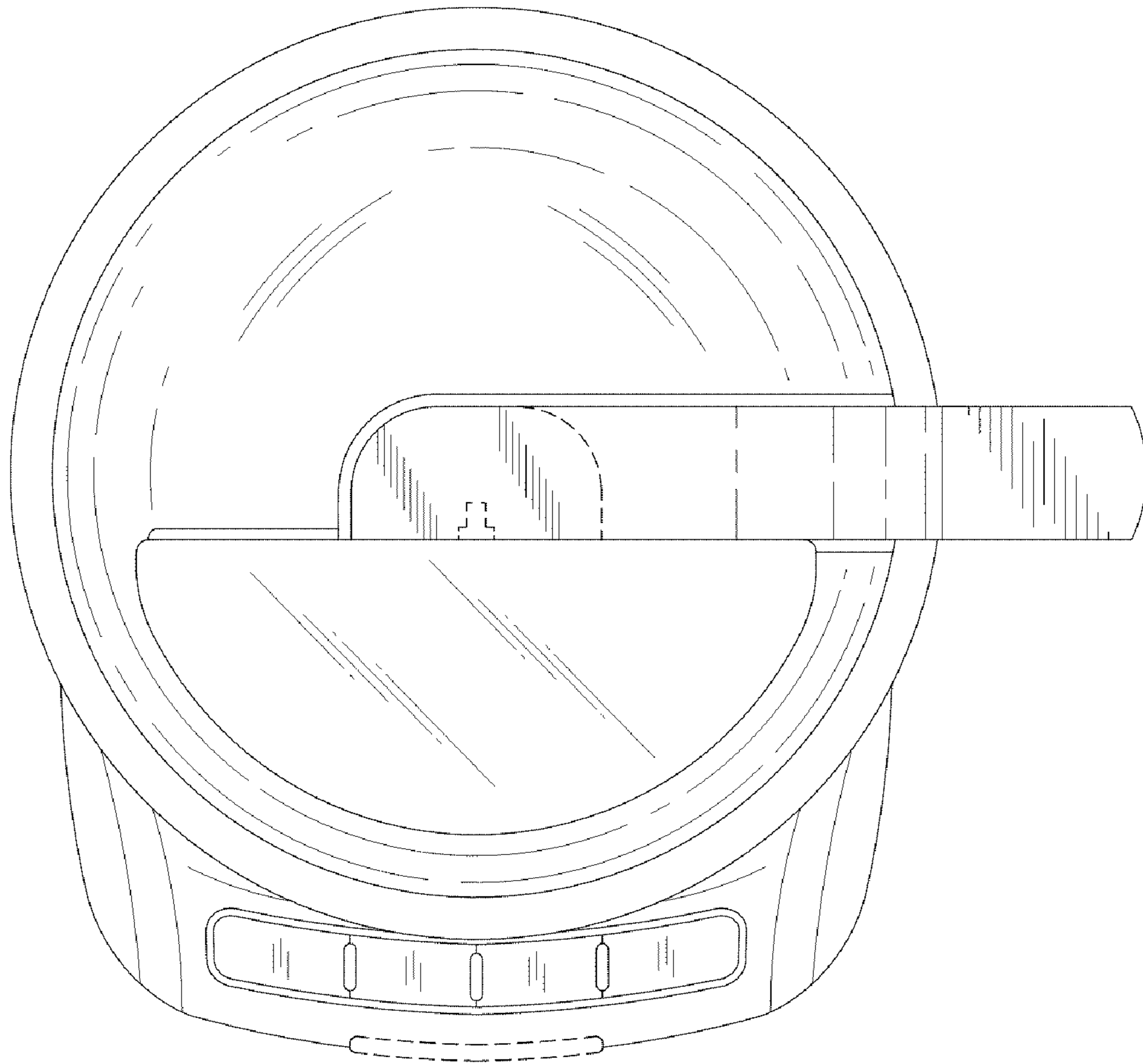

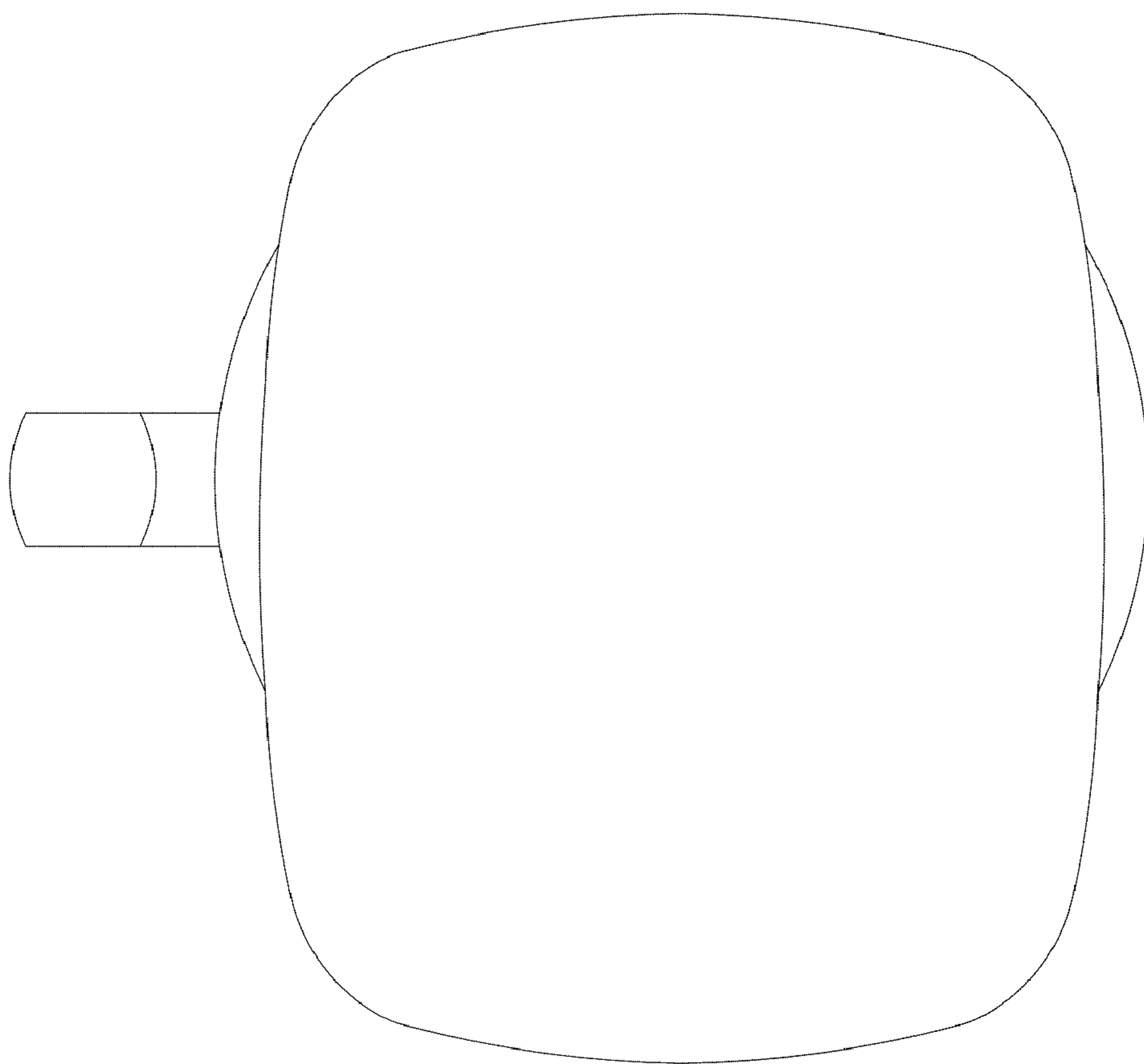
